- (iii) is 50 years of age or more, and
- (iv) retires or is retired from service.'

“(a.1) in subsection (2):

- (i) by striking out ‘20 years’, and substituting ‘10 years’, and
- (ii) by striking out ‘not more than 10 years’ and substituting ‘not more than 5 years,

“(a.2) by repealing subsection (3) and substituting the following:

(3) Where an employee, who is not entitled to a superannuation allowance under subsection (1) or (2), resigns, is dismissed or is otherwise retired from service after having reached the minimum retirement age for his group specified in section 2 (3), and after completing less than 10 years of pensionable service, he is, on application, entitled to receive

(a) a superannuation allowance, calculated under section 12, after reaching the maximum retirement age for his group, or

(b) a reduced superannuation allowance at any earlier age, that is the actuarial equivalent, on the basis of prescribed tables, of the superannuation allowance that he would be entitled to receive, under section 12, if, with the same service, he had attained the maximum retirement age of his group.’’, and

(b) in subsection (b) (dealing with the proposed subsection (6)) by deleting “under subsection (3),” and substituting “under this section,”.

Section 9 (dealing with the proposed section 16.1 (7)) is amended by deleting “after reaching age 55”.

Mr. Speaker delivered the following statement:

*Honourable Members:*

On Thursday last the Honourable Member for Atlin rose on a matter of privilege relating to a communication between a member of the Hansard staff and an official of the Church of Scientology. This communication related to a statement made by the Honourable Member during debate in Committee of Supply on the estimates of the Honourable Minister of Lands, Parks and Housing. By reason of the unusual circumstances the Chair sought additional information from the Chief of Hansard staff on the circumstances surrounding the communication in question. This was done with the approval and consent of the Honourable Member for Atlin as it is contrary to established practice for the Chair to make independent enquiries when considering a matter of privilege.

Standing Order 129 (7) places the administration of Hansard under the supervision of Mr. Speaker and it was therefore appropriate for the Honourable Member for Atlin to request an investigation by the Chair.

I have been advised by the Chief of Hansard that the Hansard staff did not transmit the full context of the speech of the Honourable Member for Atlin but revealed only such words as were necessary to verify precise spellings and the accuracy of the technical terminology on the subject of the Church of Scientology. I am further advised that the research editor who made the enquiry in question has no connection, directly or indirectly, with that Church. I believe, therefore, that no intent to breach any privilege of the House was involved and that normal research procedures were invoked only in the interests of accuracy.

Although I am satisfied that no impropriety has occurred, and I trust that the House itself will be so satisfied, the Chair is indebted to the Honourable Member for Atlin for raising this matter in a most appropriate fashion. The Honourable Member and the House may be assured that rules are in place for the guidance of Hansard whose supervision, as has been noted, rests with the Office of the Speaker. I am sure that Honourable Members will agree that the Hansard staff serve the House with diligence and integrity and the Chair accepts full responsibility for ensuring that adequate steps are taken to maintain that high level of service to the House.
