TEN O'CLOCK A.M.

Prayers by Mr. Speaker.

On the motion of the Hon. Mr. Hart, the House proceeded to the Orders of the Day, "Motions and Adjourned Debates on Motions."

Mr. Turner moved, seconded by Mr. Guthrie,-

Whereas the cessation of hostilities and the returning of the active service personnel to British Columbia, together with the continual influx to the Province of population from other parts of the Dominion, has aggravated the shortage of accommodation:

And whereas the housing shortage has not been caused solely by war conditions, but has been prevalent for many years:

And whereas it is recognized by public authorities that the results of bad housing and slum conditions are important factors contributing to the high cost of health, fire, police, and social services which constitute a heavy drain on municipal and Provincial revenue:

And whereas it has been established that the present Dominion housing legislation and methods of financing can not provide new, decent living accommodation for the lower income groups at rents which they can afford to pay:

Therefore be it Resolved, That this Legislature is of the opinion that this Government should, in the interests of health, welfare, and progress of the Province, immediately confer with the Dominion Government with the object of securing a long-term, low-interest loan, such loan to be guaranteed and administered directly by a Provincial housing authority and to be used solely for the purpose of remedying the serious housing conditions now existing in many parts of British Columbia.

Mr. Bennett moved in amendment, seconded by Mr. B. I. Johnson,-

To strike out all the words after the word "accommodation" in the fourth line, and to substitute the following:—

"And whereas the shortage of building materials of all kinds is seriously retarding the construction of new homes in our Province:

"Therefore be it Resolved, That this Legislature is of the opinion that representations should be immediately made to the Dominion Government urging the necessity of making available the necessary lumber, plumbing, electrical, and other building materials required to accelerate the completion of thousands of homes at present under construction, and the many thousands of additional homes required to properly house the people of our Province."

Mr. H. E. Winch moved in amendment to the proposed amendment, seconded by Mr. Gargrave,—

That the following words be added:-

"And be it further Resolved, That this House express its opinion in favour of the establishment of a Provincial housing authority to take advantage of Federal legislation in the interest of additional housing construction in British Columbia, and to make representations to Ottawa relative to changes required in policy and legislation in order to meet the imperative need for low-cost, low-rental housing."

Amendment to the amendment negatived.

Amendment agreed to.

Motion as amended agreed to.

Mr. Speaker said that his attention had been called to Motion No. 22, standing in the name of the honourable member from Kaslo-Slocan, and Motion No. 28, standing in the name of the honourable member from North Okanagan. Both of these motions dealt with the subject of divorce and both had the same purpose in view; that is, the widening of the grounds upon which a divorce might be obtained. He stated that it is contrary to the Rules for two motions dealing with the same subject-matter to be on the Order Paper at the same time. He therefore ruled Motion No. 28, standing in the name of the honourable member for North Okanagan, out of order.

Mr. Turner moved, seconded by Mr. Gargrave,-

Whereas during the war years there have been rapid advances in fire-prevention and fire-fighting techniques:

And whereas the recent acquisition and distribution throughout the Province of new fire-fighting equipment calls for the maximum use and care of such equipment:

And whereas professional assistance in matters of basic training, periodic checkups, and the dissemination of new fire-prevention and fire-fighting methods are necessary for the fullest protection of life and property:

Therefore be it Resolved, That this House recommends to the Government for its consideration the immediate appointment of a small committee to include representatives of the Fire Marshal's office, the Attorney-General's office, an organized professional fire department, and a volunteer fire brigade to inquire into and report to the Government on the possibilities and practicability of a reorganization of the fire-inspection, fire-prevention, and fire-fighting services and facilities of the Province.

A debate arose.

By leave of the House, the motion was withdrawn.

Mr. E. E. Winch moved, seconded by Mr. McInnis,-

Whereas under the provisions of the "Old Age Pensions Act" the pension of a blind pensioner who marries a blind person is substantially reduced:

And whereas such penalty is discriminatory in that a similar reduction is not enforced in the case of a sighted pensioner:

Therefore be it Resolved, That this House recommend to the Provincial Government that it urge upon the Dominion Government the removal of the present regulations which reduce the pension payable to blind pensioners upon marriage to another blind person.

Motion agreed to.

Mr. Corsbie moved, seconded by Mr. Rowland,-

Whereas marketing legislation has proven of great benefit to the primary producers and has demonstrated its value in stabilizing markets and prices for agricultural products:

And whereas Provincial boundaries and jurisdiction often hinder the attainment of the full advantages of organized marketing:

And whereas marketing legislation can not be made completely effective without the enabling legislation of a "Dominion Marketing Act":

Therefore be it Resolved, That this House affirms its belief that Dominion and Provincial marketing legislation are necessary if farm products are to be marketed in an orderly and economical manner:

And be it further Resolved, That this House commends to consideration of the Government the need for strongly urging the Federal Government to improve the methods and practices of the marketing of agricultural products in the realm of interprovincial and export trade by the enactment of Federal legislation.

The Hon. Mr. *Putnam* moved in amendment, seconded by the Hon. Mr. *Carson*,—
To strike out all the words after "Act" in the third paragraph, and to substitute the following:—

"And whereas the Hon. the Premier of this Province will soon be attending the Dominion-Provincial Conference in Ottawa at which time Dominion-Provincial relations will be discussed:

"Therefore be it Resolved, That this House respectfully request the Hon. the Premier to bring the importance of this matter to the attention of the proper authorities at that time."

Amendment agreed to.

Motion as amended agreed to.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Gargrave was withdrawn:—

That briefs presented to the Cabinet by recognized labour organizations be referred to the Select Standing Committee on Labour and that the Committee be authorized to hear any further representations on matters contained therein and report its findings to this House.

Mr. H. E. Winch moved, seconded by Mr. Corsbie,-

Whereas the Vancouver News-Herald reports in its publication of March 26th a statement made by Senator Magnuson of the United States to the effect that he understood the Canadian Government would close the military highway (Alaska Highway) to civilian travel and limit its use only to army training purposes when title to the highway changes on April 3rd:

And whereas it is understood that Canada formally takes possession of the highway from the American Army in a ceremony at White Horse, Yukon Territory, on that date:

And whereas the news report conveys the intimation that the information released by Senator Magnuson is based on an informal discussion with Finance Minister Ilsley of the Federal Government:

And whereas the closing of the Alaska Highway to civilian traffic would work a terrific hardship on the citizens of British Columbia resident in the Peace River area in view of the fact that the military highway commences at Dawson Creek and goes through several hundred miles of British Columbia territory:

And whereas restriction on travel over this road would be detrimental to the development of the resources in the Northern Peace River area:

And whereas the Province of British Columbia is now spending approximately \$6,000,000 to connect Prince George with the Alaska Highway and any restriction on passage to the Yukon Territory would be detrimental to tourist traffic through British Columbia from the United States to the Alaskan territory:

And whereas no public pronouncement has yet been made relative to any negotiations of the Provincial Government with the Federal authorities relative to keeping the Alaska Highway open to the public:

And whereas the maintenance of and through travel over the Alaska Highway is of the utmost importance to the residents of Peace River in particular and the citizens of British Columbia in general:

Therefore be it Resolved, That this House resolve itself into Committee of the Whole for the purpose of discussing all matters relating to the Alaska Highway and of recommending to the Government that strong representations be made to the Federal authorities in order that policies governing the maintenance and control of the highway may be such as to serve the best interests of British Columbia.

The motion was negatived.

Mr. Corsbie moved, seconded by Mr. Rowland,-

Whereas there is a shortage of veterinarians practising in British Columbia:

And whereas the development of British Columbia will necessitate the services of more in the profession, thereby presenting now the need for training many in this field of endeavour:

And whereas young men should be encouraged to train as veterinarians:

Therefore be it Resolved, That this House commends to the consideration of the Government the opinion that assistance should be given those seeking training through scholarships to students showing aptitude and desire for the veterinary profession.

The Hon. Mr. *Putnam* moved in amendment, seconded by the Hon. Mr. *Carson*,—
To strike out all the words after "veterinarians," in the third paragraph, and to substitute the following:—

"And whereas a recent survey of facilities shows that until the year 1950 there will be no openings in the Veterinary College at Guelph, Ontario:

"And whereas a faculty of medicine is to be established at the University of British Columbia:

"Therefore be it Resolved, That this House recommends that additional facilities be provided at the University of British Columbia to take care of the training of students in Veterinary Science."

Amendment agreed to.

Motion as amended agreed to.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Rowland was withdrawn:—

Whereas the system of colouring gasoline for agricultural and industrial purposes proved satisfactory during the war:

And whereas the system of tax rebate on gasoline for agricultural and industrial purposes is a great inconvenience to the users and the Government:

Therefore be it Resolved, That this House commends to the Government the consideration of colouring gasoline sold for agricultural and industrial purposes a different colour than that sold for general purposes and at a price minus the Provincial road-tax.

Mr. Brett moved, seconded by Mr. Gargrave,—

Whereas in many instances the fisheries on the Pacific Coast are prosecuted jointly by British Columbia and United States fishermen:

And whereas extensive credit facilities are available in the United States to the fishermen of that country, enabling them to acquire large, modern vessels and up-to-date equipment:

And whereas bank credit being too costly for the average fisherman to avail himself of, the only other credit available to British Columbia fishermen is through the medium of the various large fish companies which, through its very nature, tends to break down the independence of the fishermen:

And whereas by reason of this discrepancy British Columbia fishermen are placed in an unfair economic position in relation to the fishermen of the United States:

Therefore be it Resolved, That this House recommends to the Government for its consideration the establishment of a fishermen's loan board which would include representatives of the organized fishermen and the fishermen's co-operatives with power to make loans to bona-fide fishermen to purchase or improve boats and other equipment necessary to prosecute the industry.

The Hon. Mr. Hart rose to a point of order.

Mr. Speaker reserved his decision.

Mr. H. E. Winch moved, seconded by Mr. E. E. Winch,-

That, in the opinion of this House, persons employed in domestic service should not be exempt from the provisions of the "Hours of Work Act," the "Female Minimum Wage Act," and the "Workmen's Compensation Act."

The motion was negatived.

Mr. Harding moved, seconded by Mr. Corsbie,-

Whereas the law relative to divorce and matrimonial causes applicable in British Columbia is not in accord with modern conditions and public opinion, more particularly in respect of the grounds for dissolution of marriage:

Therefore be it Resolved, That this Legislature petition the Dominion Government to enact a Statute relative to divorce and matrimonial causes similar in its provisions to the English "Matrimonial Causes Act, 1937," and that failing endorsement by the Legislatures of other Provinces of Canada the said Statute be made applicable to British Columbia.

The motion was negatived.

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-day.

And then the House adjourned at 1.05 p.m.

HALF-PAST TWO O'CLOCK P.M.

Mr. Speaker delivered his reserved decision on the point of order raised by the Hon. Mr. Hart on the 10th instant on the following notice of motion standing on the Order Paper in the name of Mr. Brett:—

Honourable Members,—The Honourable the Premier has raised a point of order with reference to Motion No. 20 standing in the name of the honourable member for Prince Rupert.

In my opinion this motion is out of order on the ground that it is, in effect, a direction to the Government to bring in a Bill, and that it dictates Government policy. There are good reasons for the rule that a private member may not dictate the policy of the Government.

The Honourable the Leader of the Opposition advances the contention that there is no dictation of policy here but simply a recommendation that the Government give consideration to the establishment of a fishermen's loan board.

If this contention is sound the rule against a private member dictating Government policy could be evaded in every instance. There are numerous authorities to the contrary which I feel bound to follow.

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

MR. SPEAKER:

April 10th, 1946.

Your Select Standing Committee on Forests and Fisheries begs leave to report as follows:—

Your Committee held four meetings and all requests for information were complied with and several departmental officials were interviewed with regard to the same.

Mr. Richmond, Forest Entomologist, in charge of the Victoria Laboratory, Dominion Government Science Service, attended the second meeting on Wednesday, March 27th, and furnished the Committee with explanatory material on forests, pests, and controls, including primary damage in Eastern Canada, European larch sawfly on the Coast, and British Columbia hemlock looper damaging great areas. Control of pests by spray and chemical dust was discussed and full explanation thereof was given by Mr. Richmond.

Mr. Orchard, Chief Forester of the Province, attended the third meeting on April 2nd and the fourth meeting on April 5th. He dealt principally with certain sections of the Sloan Report during the third meeting and at the fourth meeting followed the Sloan Report with an instruction on forests and their protection.

We wish to commend the co-operation of these Government officials.

The Hon. Mr. Carson presented a corrected answer to a question asked by Mr. Love on April 1st. The reply to question No. 3 should read as follows:—

"3. 267,948 tons of ore were mined in Grand Forks Mining Division from January 1st, 1900, to January 1st, 1920; 168,144 tons were mined from January 1st, 1920, to January 1st, 1940."

Mr. Bennett asked the Hon. the Attorney-General the following questions:-

- 1. How many persons took out automobile drivers' licences in British Columbia during the year 1945?
- 2. How many of these persons reported or became involved in motor accidents during the year 1945?
- 3. How many of these persons were convicted of manslaughter in connection with motor accidents in 1945?
- 4. How many of these persons were convicted or found liable for negligence in connection with motor accidents in 1945 (other than convictions of manslaughter)?
- 5. How many of these persons had their licences suspended or cancelled in connection with motor accidents during 1945?
- 6. How many of these persons whose licences had been suspended or cancelled had their licences restored in 1945?

The Hon. Mr. Wismer replied as follows:-

- "1. At December 31st, 1945, 188,115.
- "2. 10,967; These were involved in accidents which resulted in 101 fatalities; 2,955 persons being injured and 7,911 having property damage only. In addition to this number there were 344 drivers who were unlicensed and were involved in motorvehicle accidents which resulted in ten fatalities, 138 persons receiving personal injuries and 196 having property damage only. Two hundred and sixty-nine drivers involved in motor-vehicle accidents were non-residents and the accidents they were involved in resulted in one fatality, ninety-six persons being injured and 172 having property damage only. There were also eighteen drivers involved in accidents which resulted in seven fatalities, four persons receiving personal injury and seven having property damage only, concerning whom we have no particulars as to whether they were licensed or not.
 - "3. Five.
- "4, 5, and 6. Lack of sufficient staff prevents the obtaining of this information at this time. Question No. 4 would require the searching of 7,067 records and questions No. 5 and No. 6 the searching of approximately 13,000 records."
- Mr. H. E. Winch asked the Hon. the Attorney-General the following questions:-
- 1. What action, if any, has been taken to grant members of the British Columbia Police and gaol wardens three weeks' holidays after ten years' service in conformity with holiday-leave as provided for Civil Servants under the provisions of the "Civil Service Act, 1945"?
 - 2. If no such action has been taken, is any contemplated and, if not, why not?
- 3. What action, if any, has been taken to extend to members of the British Columbia Police and gaol wardens the same sick-leave and retiring-leave consideration as provided for Civil Servants under the provisions of the "Civil Service Act, 1945," and regulations adopted pursuant thereto?
 - 4. If no such action has been taken, is any contemplated and, if not, why not? The Hon. Mr. Wismer replied as follows:—
- "1, 2, 3, and 4. So far as the Provincial Police are concerned section 77 of the Police Regulations (1945) provides for a month and a half sick-leave on pay for every five years' service; section 78 provides for three weeks' annual leave for those with

ten or more years' service; and section 122 provides for retiring-leave on the recommendation of the Attorney-General. These benefits start as of the first of this year. Since the approval of Order in Council No. 2512 (December 11th, 1945) providing for retiring-leave for Civil Servants, the same rule has applied in the Police; namely, one month's leave on pay for more than twenty but less than twenty-five years' service; two months for those with over twenty-five but less than thirty years' service; and three months for those with over thirty years' service. Pending revision of the gaol regulations to include these provisions, Warden Millman of Oakalla Gaol was advised on December 17th, 1945, that, starting at the first of this year, the gaol service would be governed by the same regulations as the Police in these matters."

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:—
"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these
Bills."

Then Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 97) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious speech:—

Mr. Speaker and Members of the Legislative Assembly:

In relieving you of your legislative duties and in closing the first session of the Twenty-first Parliament of British Columbia, I do so confident in the knowledge that the forward-looking measures that have been enacted will assist further to establish firmly that new era of prosperity and security for which my Government has so wisely planned. I wish also to express my sincere appreciation of the attentive manner with which you have addressed yourselves to the business of this House and the sincerity that has marked your deliberations.

The proceedings of this House have been marred by the unexpected death of the Honourable R. L. Maitland, K.C., who administered the portfolio of Attorney-General in so able a manner and whose wise counsel was so highly valued by my Government. The Legislature and the people alike have lost a great public servant, who devoted the greater part of his life to the interests of his fellow-men. I take this opportunity of extending my sincere sympathy and that of the people to the members of his family.

In order that public business might be carried on without undue delay or interruption, the immediate appointment of a successor became necessary. The choice of the Honourable Gordon S. Wismer, K.C., for the post of Attorney-General will be accepted, I feel sure, with general approval since he has administered this department so ably in the past and has an intimate knowledge of Dominion-Provincial affairs.

Amendment of the "Constitution Act" to provide for the appointment of two more Ministers will bring the personnel of the Executive Council to ten. It has long been recognized that the responsibilities now assumed by our public men are becoming ever more arduous. Increasing the membership of the Cabinet therefore should have the salutary effect of lightening the burden that has fallen all too heavily on a few.

I am gratified to observe that the recommendations of the Royal Commission on the Cost of Education have been implemented, which will result in the raising of the standard of education and the lightening of the costs on real property.

It is also gratifying to note that facilities at the University of British Columbia have been expanded to include a Faculty of Law; that provision has been made for a pre-medical course, new buildings, and generous assistance in establishing temporary accommodation for ex-service personnel.

The appointment of a Royal Commission to inquire into Provincial-Municipal spheres of responsibility I feel sure will be welcomed by the various cities, municipalities, and villages throughout the Province.

Likewise the decision to appoint a Royal Commission to examine the problems confronting the irrigation, drainage, and dyking districts will commend itself to those engaged in agriculture.

Increase in borrowing-power to \$20,000,000 for the British Columbia Power Commission will enable the carrying-out of an ambitious programme of rural electrification and power expansion which will stimulate development of the Province.

Expenditure of \$35,000,000 on important public works also will open up new

country and resources, thereby creating a wider field of opportunities.

I am pleased to learn that it is my Government's intention to make a thorough and scientific survey of the potential resources contiguous to the proposed extension of the Pacific Great Eastern Railway in order to ascertain if the necessary tonnage is available to justify the expenditure of \$20,000,000. In this respect, I am gratified to note it is proposed to make an immediate survey with a view to locating a satisfactory railway grade between Hudson Hope and Dawson Creek.

Adoption of many of the recommendations of the Royal Commission on Forestry and assurance that other findings will be given careful study will be most acceptable to the people, particularly those interested in establishing this industry on a sustained-yield basis.

Amendments to labour legislation and the "Workmen's Compensation Act," thereby bringing about a shorter work-week, holidays with pay, and reduction in compensation payments by employees are measures which will prove beneficial to the great majority.

The careful attention given to the preparation of British Columbia's briefs presented to the Dominion-Provincial Conference has enabled the public to obtain a clear conception of the position occupied by the Province within Confederation and the fairness of the arguments submitted. I am hopeful that when the representatives of my Government attend the meeting of the Co-ordinating Committee to be held in Ottawa on April 25th, further progress toward a settlement of these important problems will result.

Further improvements have been made in British Columbia's financial position, particularly in connection with its credit rating, and the wisdom of reserving operating surpluses to finance long-deferred public works is now evident.

I thank you for the adequate provision you have made for the public services and believe that many benefits will result therefrom.

In relieving you of your labours, I trust the blessing of Divine Providence will accompany you to your homes.

The Hon. Mr. Pearson, Provincial Secretary, then said:-

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
