The Hon. Mr. Wismer presented the Annual Report of the Provincial Game Commission for the Year ended December 31st, 1937.

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

1. What number of game birds, if any, were purchased this year for the Game Department by Game Warden G. W. Williams (Abbotsford) from a farmer named J. Kazantzef?

2. What number of such birds were raised and offered for sale to the Game Warden by the above named?

3. Were the numbers purchased proportionate to the number raised in comparison with purchases from other breeders? If not, why?

4. What was the minimum and maximum ages of birds taken from other breeders?

The Hon. Mr. Wismer replied as follows:—

"1. The Game Department has purchased to date during 1938, 177 pheasants from John Kazantzef, of Abbotsford, B.C.

"2. As a result of a departmental investigation on September 8th, of this pheasant farmer's stock of some 700 birds, same were found to be not fit for purchase. The Department does not guarantee to buy pheasants, and retains the right to refuse any birds not considered suitable for liberation.

"3. In the circumstances, yes.

"4. The Department does not accept birds less than twelve weeks old. Breeding birds average one year old."

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

1. What action (if any) has been taken to prevent use of poison by trappers since Game Commission Report of 1936?

2. What action (if any) has been taken since 1936 to prevent the sale of tanned moose-hides to and by fur-traders, as prohibited by the "Game Act"?

The Hon. Mr. Wismer replied as follows:—

"1. Every possible step has been taken to prevent the use of poison by trappers in every section of the Province. Investigations have been conducted in regard to a number of complaints of poison being purchased and allegedly used, but sufficient information has not been obtained that would warrant laying charges under the 'Game Act.'

"2. Under present 'Game Act' it is not illegal to sell tanned moose-hides, but all such sales are carefully checked by the Game Department to see that no irregularities occur with respect to same."

Mr. Paton asked the Hon. the Minister of Finance the following questions:—

1. What was the total Governmental expenditure for advertising in daily newspapers during the last fiscal year?

2. What was the total Governmental expenditure for advertising in weekly newspapers during the last fiscal year?

3. What was the total Governmental expenditure for advertising in monthly magazines and periodicals during the last fiscal year?

The Hon. Mr. Asselstine (Minister of Trade and Industry) replied as follows:—

"1. \$29,832.63.

"2. \$12,852.65.

"3. \$13,036.84."

Mr. Eyres asked the Hon. the Minister of Finance the following questions:—

1. Do the oil companies of British Columbia retain a percentage of the gas tax collected?

2. If so, what percentage?

3. How much did that percentage amount to during 1937?

The Hon. Mr. Hart replied as follows:—

"1 and 2. The Government of the Province pays oil companies a 2-per-cent. commission for revenue collections effected by them on account of gasoline tax.

"3. \$70,622.50."

Mr. *E. E. Winch* asked the Hon. the Attorney-General the following questions:—

1. What action (if any) has been taken since the Game Commission Report of 1936 to prevent poaching on registered trap-lines?

2. What action (if any) has been taken since 1936 to restock potential beaver-grounds?

The Hon. Mr. *Wismer* replied as follows:—

"1. The 'Game Act' was amended in 1935, making the penalty to be imposed upon any one found poaching on another's trap-line not less than \$100. This has been a great deterrent against such poaching.

"2. The following number of live beaver have been trapped during the years mentioned on the Bowron Lake Game Reserve and transplanted in the sections of the Province referred to, where assurance was given that they would be rigidly protected: September 14th, 1936, Queen Charlotte Islands, 6; September 14th, 1936, Merritt, 4; September 16th, 1936, Quesnel, 3; September 28th, 1936, Merritt, 4; October 16th, 1936, Lower Nicola, 3; September 4th, 1937, Lac la Hache, 2; September 4th, 1937, Bowron Lake, 2; September 10th, 1937, Pasulko (Dead) Lake, Lillooet, 4.

"NOTE.—Owing to changing levels of water successful trapping seriously curtailed.

"August 17th, 1938, Williams Lake, 7; August 26th, 1938, Clinton, 4; September 15th, 1938, Kamloops, 4; September 17th, 1938, Clinton, 4; November 6th, 1938, Courtenay, 1.

"NOTE.—The beaver trapped at Courtenay was found doing damage and was taken alive and liberated in another portion of the district.

"In 1934, 8 beaver, and in 1935, 25 beaver were trapped alive on the Bowron Lake Game Reserve and liberated in various suitable areas in the Province."

Mr. *E. E. Winch* asked the Hon. the Attorney-General the following questions:—

1. What steps (if any) have been taken since 1936 for better supervision and protection of trap-lines?

2. Have additional Game Wardens in the northern area of the Province been appointed, as recommended by the Game Commission Report for 1936-37?

3. If yes, how many?

The Hon. Mr. *Wismer* replied as follows:—

"1. Careful and continuous patrol-work has been undertaken in regard to supervision and protection of trap-lines. Since January 1st, 1936, a number of prosecutions have taken place in respect to various phases of trapping, as noted hereunder.

And whereas the above-mentioned brief wholly failed to take into account the changing economic requirements of modern times and the necessity of reconstituting Canada on a firm national basis for the purpose of using the national wealth to satisfy human needs:

Therefore be it Resolved, That this Legislative Assembly regrets the unconstructive and parochial character of the brief presented by the Government to the Royal Commission on Dominion-Provincial Relations.

And be it further Resolved, That this House is of the opinion that any future representations made by the Government to the above-mentioned Commission should be based on the principle of planned national reconstruction.

Mr. Speaker delivered the following decision on the point of order raised by the Hon. Mr. *Pattullo* on the 23rd instant:—

Honourable Members,—A point of order was raised with reference to motion No. 4, standing in the name of the honourable member for North Vancouver.

The motion is, in part, to the effect "That this House is of the opinion that any future representations made by the Government to the above-mentioned Commission should be based on the principle of planned national reconstruction."

The motion therefore urges that the Government in its future representations to the Rowell Commission follow a certain policy.

The motion is therefore a mandatory motion dictating Government policy, and as such may not be moved by a private member. (See the authorities referred to in Mr. Speaker Perry's decision, Journals of the House, March 12th, 1936.)

Prayers by Mr. Speaker.

Mr. *Perry* rose to a question of privilege with regard to an editorial in a certain newspaper, and moved, seconded by Mrs. *Smith*,—

That this Legislature regrets the publication of the editorial in the newspaper mentioned.

By leave of the House, the motion was withdrawn.

With reference to the same article, Mr. Speaker read the following statement:—

“No exception could be taken to an attack in the Press upon a political party or upon a Government dealing with the conduct of public affairs.

“But the editorial in question does not raise a question of party or of policy.

“It charges Speakers of this Legislature in recent years with partisanship and makes reference to what it is pleased to call ‘the progressive decadence of the membership.’

“To quote from a recognized authority on parliamentary practice:—

“‘The Speaker is the representative of the House itself, in its powers, its proceedings, and its dignity.’

“Any reflection, therefore, on the Speaker is a reflection on the House itself, and is, moreover, a reflection on our democratic system of Government under which the Speaker is elected by the representatives of the people themselves.

“The freedom of the Press is a precious thing, but newspapers have a responsibility not to exercise that freedom in such a manner as to bring into contempt our democratic institutions and system of government. Particularly is this so at the present time, when our democratic ideals have been attacked as never before, both within and without our own country. It is regrettable that the journal which published this editorial should have failed to take this responsibility seriously.

“In view of the fact that the House, although realizing the gravity of the offence, has not expressed a wish to take any drastic action such as calling the author of the article before the Bar of the House, I think the House is entitled to expect that the newspaper will publicly retract.”

On the motion of the Hon. Mr. *Pattullo*, the House proceeded to the Orders of the Day, “Public Bills and Orders.”

6. What number, if any, are "squatting"?
7. How many of these saltries are owned by Japanese?
8. How many are owned by Canadian holding companies representing Japanese interests?
9. What taxes are paid by these saltries?

The Hon. Mr. *Pearson* replied as follows:—

"1 and 2. If these questions mean how many plants are equipped to operate only as herring-saltries, this question is difficult to answer. Herring-saltries do not always operate only as such, but may be operated in conjunction with other plants, such as canneries, salmon-saltries, etc. During the current season two herring dry-saltries have been licensed to operate by the Provincial Department of Fisheries. There are approximately twelve plants owned as herring-saltries in British Columbia which have operated as such in past years, in addition to which numerous canneries and plants of other categories have also been licensed as herring-saltries.

"3, 4, 5, and 6. Information not available in the Department of Fisheries.

"7. The herring-saltery licences issued in the current season are to Tanaka & Company, Limited, and the Pacific Sea Products Exporters, Limited, both registered British Columbia Companies, presumably owned by Japanese.

"8. Information not available in the Department of Fisheries.

"9. Information not available in the Department of Fisheries."

Mr. *Hunter* asked the Hon. the Provincial Secretary the following questions:—

1. Did Dr. Allon Peebles make a tour to investigate health insurance?
2. If so, upon what date did he leave and upon what date did he return?
3. What countries and places did he visit?
4. How long was he in each particular country visited?
5. What was the total expense of his tour to the Province?

The Hon. Mr. *Weir* replied as follows:—

"1. Yes.

"2. Left March 1st, 1938, and returned June 10th, 1938.

2. Does a man with one cow and an unsanitary barn have the same vote as a man with thirty cows and an up-to-date sanitary barn?

3. Who issued the regulations outlining and controlling the ballot?

The Hon. Mr. *MacDonald* replied as follows:—

"1. 'Producer' as defined in the scheme and registered with the Lower Mainland Dairy Products Board.

"2. Only producers conforming with the regulations under the 'British Columbia Milk Act' and registered under the 'Milk Marketing Scheme of the Lower Mainland of British Columbia' are entitled to vote.

"3. The Lower Mainland Dairy Products Board under the supervision of the Provincial Marketing Board."

Mr. *Hunter* asked the Hon. the Provincial Secretary the following questions:—

1. (a.) How many officers and other employees at Tranquille Sanatorium have been dismissed since December 1st, 1933? (b.) What position did they occupy?

2. (a.) How many officials or other employees at Tranquille Sanatorium Farm have been dismissed since December 1st, 1937? (b.) What position did they hold?

Whereas the treatment of delinquency in British Columbia fails to take into account the physical condition and economic backgrounds of those who are technically termed as delinquents; and

Whereas there is a lack of psychiatric service, sound educational programmes, and training facilities in our gaols:

Therefore be it Resolved, That the Government be requested to formulate and to put into effect a scientific policy for the treatment of delinquency, having as its purpose the prevention and cure of crime rather than the present policy of punishment and isolation of delinquents.

Mr. Speaker delivered the following reserved decision on the point of order raised by the Hon. Mr. Pattullo on the 23rd instant:—

Honourable Members,—A point of order has been raised with reference to motion No. 11, standing in the name of the honourable member for Burnaby.

The motion requests the Government "to formulate and to put into effect a scientific policy for the treatment of delinquency, having as its purpose the prevention and cure of crime rather than the present policy of punishment and isolation of delinquents." This motion is out of order for the reason given in my reserved decision with respect to motion No. 4—that is, that it is a mandatory motion dictating Government policy. In addition to the authorities referred to in my decision yesterday, I would refer honourable members to the decision of Mr. Speaker Davie, appearing in the Journals of the House, March 28th, 1931, at page 129, where he said of a bill under consideration that it "strikes at the foundation of the parliamentary law principle that policies of the Crown cannot be directed or even suggested by a private member."

I again point out, as I did last year, that this principle of parliamentary law does not apply to the general debates such as debates on the Address or on the Budget or to the discussion of Estimates in Committee.

Trade and Industry: A study of the supply of raw materials for industrial purposes, and the domestic and foreign distribution of manufactured goods:

And whereas the Dominion Government has now provided funds for low-rental housing projects, and as it is expedient that these projects should be protected by adequate zoning laws, provided by Provincial enabling legislation, the Provincial Governments should be impressed with the advisability and necessity of establishing Provincial Planning Bureaus for more economical and efficient planning and zoning throughout their domain:

Therefore be it Resolved, That this Legislature resolve itself into a Committee of the Whole House to consider the advisability of appointing a committee to consider the question of the Government adopting a long-term planning programme, with a view to the orderly and efficient development of the natural resources of the Province; and that to this end a Central Planning Bureau be established to carry on all phases of Province-wide planning, and to act in an advisory capacity to the municipalities and unorganized districts of the Province.

- "3. Average producer's returns vary according to the methods of marketing adopted by the producer and depending upon the area within which the product is sold.
- "4. (a.) For Greater Vancouver the average butter-fat price paid by the consumer for fluid milk includes the producer's returns of between 40 and 50 cents a pound plus the distributor's spread and the wholesale and agent's office profits. (b.) The price of butter-fat for the manufactured product depends upon the commodity produced. The average price for butter-fat in cheese or butter is considerably less than the average price paid by the consumer for butter-fat in ice-cream, which is also a manufactured product."

Mr. *Telford* asked the Hon. the Minister of Agriculture the following questions:—

1. Is such wheat as is designated No. 4 or No. 5 Grades in the Market Bulletin, issued by the Government, Dominion Government inspected?
2. Are ground feed-screenings inspected?
3. If yes, by what Department?
4. What is the difference in the price of No. 4 wheat for domestic consumption and for export?

The Hon. Mr. *MacDonald* replied as follows:—

- "1. The 'Canada Grain Act,' under section 24, established statutory grades and commercial grades of grain which are referred to in schedules 1 and 2 of the Act. Under section 57 of the same Act is set forth the provision by which the grain is understood to be Dominion Government inspected.
- "2. Yes. See sections 3, 8, 9, and 10 of the 'Canada Feeding Stuffs Act.'
- "3. By the Dominion Department of Agriculture.
- "4. These questions should be referred to the Department of Trade and Commerce, Ottawa, for information on export prices."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

MR. SPEAKER:

Your Select Standing Committee on Standing Orders and Private Bills begs leave to report as follows:—

By Order of the House, Public Bill (No. 9) intituled "An Act to amend the 'Engineering Act'" was referred to your Committee.

Representations were heard in favour of the Bill on behalf of the Association of Professional Engineers of British Columbia.

The Architectural Institute of British Columbia was represented and its opinions on the Bill carefully noted.

The British Columbia Loggers' Association was represented and objections made to those parts of the Bill which expanded the rights of registered professional engineers and consequently restricted the employment of competent and experienced employees in the logging industry.

The major amendments made in the Bill by your Committee are in striking out the main part of section 3 and the Schedule on the grounds that further time and publicity should be given to consideration of these proposed sections which, in the opinion of your Committee, may unduly expand the rights of the engineering profession and restrict the rights of employment of competent people now in employment.

Your Committee returns the said Bill with amendments thereto as reported herewith, and recommends that same be allowed to proceed and be reprinted forthwith.

All of which is respectfully submitted.

1. Are records available showing the trade or occupation of employable persons on relief at a given time, and the number or percentage of each such trade or occupation?

2. If yes, (a) what was the date of such record, (b) the total number of employables, (c) heads of families, (d) single, (e) number or percentage of each trade or occupation, (f) number of unemployables, (g) heads of families, (h) single at the same period?

"2. (a.) August, 1938. (b.) 13,643, including dependents 16 years and over. (c.) 7,746. (d.) 4,267 over 21; 1,630 over 16. (e.) Farming, 1,335; fishing, 140; hunting, 13; logging, 1,038; mining, 1,001; communication, 64; construction, 2,340; finance, 74; general labour, 645; manufacturing, 1,961; service, 1,113; trade, 1,013; transportation and storage, 1,220. Note: Figures for each industry include labourer, semi-skilled, and skilled. (f.) 7,822. (g.) 1,686. (h.) 2,787."

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

The House resumed the adjourned debate on the second reading of Bill (No. 7) intituled "An Act to amend the 'Married Women's Property Act.'"

Bill read a second time, and *Ordered* to be committed at the next sitting.

On the Order being called for the second reading of Bill (No. 27) intituled "An Act to amend the 'Woodmen's Lien for Wages Act,'" the Hon. Mr. *Pattullo* rose to a point of order.

Mr. Speaker reserved his decision.

On the second reading of Bill (No. 43) intituled "An Act to amend the 'Mental Hospitals Act'" a debate arose, which was, on the motion of the Hon. Mr. *Weir*, adjourned to the next sitting.

On the second reading of Bill (No. 47) intituled "An Act to amend the 'Lunacy Act'" a debate arose, which was, on the motion of the Hon. Mr. *Weir*, adjourned to the next sitting.

On the motion that Bill (No. 48) intituled "An Act to amend the 'Female Minimum Wage Act'" be now read a second time, a debate arose.

The motion was negatived.

On the Order being called for the notice of motion standing on the Order Paper in the name of Mrs. *Steeves*, as follows:—

Whereas the Prime Minister has stated that the "Health Insurance Act" is not being put into operation because the Government is waiting for the report of the Rowell Commission:

And whereas in the brief presented by the Government to the Rowell Commission no request is made that health insurance become a matter of Federal jurisdiction, and no specific request is made for a Federal conditional grant for health insurance:

And whereas there is complete unanimity amongst all representative groups of the people of British Columbia on the matter of the urgent necessity of health insurance for this Province:

Therefore be it Resolved, That a Select Committee of this House be set up to inquire into all possible ways and means of making health insurance, on a sound actuarial basis, operative in British Columbia, and to report the result of its findings to this House.

Mr. Speaker delivered the following reserved decision on the point of order raised by the Hon. Mr. *Pattullo* on the 23rd instant:—

Honourable Members,—I have carefully considered the point of order raised by the Hon. the Premier with respect to motion No. 16, standing on the Order Paper in the name of the honourable member for North Vancouver.

The preamble to the motion recites that the "Prime Minister has stated" certain things, and that "there is complete unanimity amongst all representative groups of the people." Mr. Speaker Perry held similar expressions to be equivalent to citing matters and documents not before the House in two decisions which will be found in the Journals of March 23rd, 1935, and March 31st, 1936. The preamble also refers to the brief presented by the Government to the Rowell Commission, which is a document not before the House.

The rule against citing matters and documents not before the House is similar to the rule in Courts of Law against hearsay evidence. It would be as dangerous for one tribunal as for the other to attempt to arrive at a sound judgment on such evidence. The practice of citing such material in written motions ought to be discouraged on the ground also that it is apt to create wrong impressions in the public mind. It is a simple matter for honourable members to draw their motions without resorting to this practice.

The motion asks that a Select Committee be set up to inquire into ways and means of making health insurance on a sound actuarial basis operative in British Columbia. It is a well-known parliamentary principle, as Mr. Speaker Davie said in a decision appearing in the Journals of February 19th, 1931, that "the House will not entertain reflections which impute discredit to itself." *May*, 13th ed., p. 323, says: "Disrespectful or abusive mention of a Statute would seem to be partly open to the same objections as improper language applied to Parliament itself, for it imputes discredit to the Legislature which passed it and has a tendency to bring the law into contempt."

A Statute can only be condemned in debate on a motion for the repeal of the Statute.

Whether or not the honourable member in whose name the motion stands intended to suggest that the "Health Insurance Act" is not actuarially sound, that inference would unfortunately be drawn from the words "on a sound actuarial basis." The words reflect on a Statute passed by this House, which under the authorities referred to is the same as reflecting on the House itself.

For the reasons stated above the motion is out of order.

N. W. WHITTAKER, *Speaker*.

The House resumed the adjourned debate on the motion moved by Mr. *E. E. Winch* on the 23rd instant, as follows:—

Whereas the Twenty-sixth Report of the Medical Inspection of Schools states there are 675 retarded and underprivileged children now attending school (exclusive of 450 attending special classes in Vancouver); and

Whereas it is not feasible to economically provide adequate facilities for the supervision and training of such children in schools and districts where only a few reside; and

Whereas it is essential to the best interests of the children and society in general that such children shall, so far as possible, be equipped during their formative years to adapt themselves to school and, later, adult life, and thereby enable them to become social assets instead of liabilities:

Therefore be it Resolved, That this House resolve itself into a Committee of the Whole for the purpose of considering the desirability of recommending that the Provincial Secretary and Minister of Education obtain special statistical reports from School Medical Officers, School Boards, Public Health Officers, and Social Service Officials relative to the nature and prevalence of mental and physical handicap among children of school and pre-school age for the purpose of devising ways and means to provide suitable and adequate facilities for special treatment, training, and education of such children, in order to assist them toward a self-supporting status in adult life.

The Hon. Mr. *Weir* moved in amendment, seconded by the Hon. Mr. *Wisner*, as follows:—

To strike out all the words after the word "Vancouver" in the third line and to insert in lieu thereof the following:—

"Whereas the Government is already doing its best to provide for the supervision and training of such retarded and underprivileged children:

"And whereas yearly reports thereon are furnished through the School Medical Officers, School Boards, Public Health and Social Service Officials, and the Public Health Nurses:

"And whereas the Government, being cognizant of the difficulties to be overcome owing to the great extent of territory, the sparseness of population, and the lack of facilities in

districts where only a few persons reside, is already taking into consideration the adoption of a policy that will permit of a thorough personal examination of isolated schools and resident pupils:

"Therefore be it Resolved, That this House endorses the efforts of the Government in this regard and approves of the extension of the service from time to time as funds become available for the purpose."

On the motion of Mr. *H. E. Winch*, the debate was adjourned to the next sitting.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. *Cameron* was withdrawn:—

That an Order of the House be granted for a Return to be made by the Hon. the Attorney-General of the log-book of the police-boat "*Morci*," and said log-book be referred to the Select Standing Committee on Public Accounts.

Mr. *Kenney* presented the First Report of the Select Standing Committee on Public Accounts, as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

November 30th, 1938.

MR. SPEAKER:

Your Select Standing Committee on Public Accounts begs leave to report as follows:—

Your Public Accounts Committee, to which was referred charges for investigation and report as contained in the Resolution of the Hon. Mr. *MacPherson* in the Votes and Proceedings recorded on Wednesday, November 23rd, reading as follows:—

"Whereas the first member for Vancouver East stated in this House that an over-payment approximating \$300,000 had been made in connection with the price of steel used in fabricating the structure known as the Pattullo Bridge."

A large number of witnesses were examined and documents presented by witnesses and departmental officials and all members of the Committee, including Mr. *Telford*, were given every opportunity to examine such witnesses and documents, and no evidence of any over-payment having been produced, Mr. *Telford* requested permission to withdraw his charges, and, on resolution, this was unanimously agreed to by the Committee.

The report was read and received.

By leave of the House, the rules were suspended and the report adopted.

The House resumed the adjourned debate on the motion moved by Mr. *Eyres* on the 23rd instant, as follows:—

Whereas the Governments of Canada are endeavouring to find efficient ways and means to combat the great enemy, forest fires, which are depleting our timber resources:

Therefore be it Resolved, That this House urge upon this Government the advisability of making early arrangements with the Federal authorities for the use of our aerial defence machines for spotting and for dropping fire-extinguishing chemical bombs upon forest fires at their very beginning.

The Hon. Mr. *Gray* moved in amendment, seconded by the Hon. Mr. *Pearson*, as follows:—

To strike out all the words after the word "Resolved," and to substitute therefor the following:—

"That this House commend this Government for its active and progressive policy in developing an efficient and effective forest-protection service; for its progressive attitude in adopting in this service the most modern equipment of proved value, such as tractors, fire-ploughs, pumps, and aeroplanes; for its active interest in experimental measures, such as the use of chemicals, fog-sprays, and weed-exterminators; and for the recent progressive legislation designed to promote more effective protection and forest conservation."

On the motion of Mr. *Maitland*, the debate was adjourned to the next sitting.

Mr. Bruhn moved, seconded by Mr. Macintosh,—

Whereas it is becoming more and more difficult, particularly for old persons, to be absorbed into useful, productive life of the Dominion, making it difficult for them to maintain themselves in comfort and decency:

And whereas Canada is a country richly endowed with natural resources capable of maintaining our population in a reasonably high standard of living:

Therefore be it Resolved, That this House would welcome a declaration of policy by this Government recommending to the Dominion Government that the Dominion Government adopt a policy which will lower the present pensionable age-limit for old-age pensioners from 70 years to 65 years, to the end that the older generation may be retired earlier from industrial employment and thereby create opportunity for the younger generation to be usefully and gainfully employed; and that such a policy be assisted by compulsory contribution by all employed persons between the ages of 20 years and 65 years.

And be it further Resolved, That a copy of this Resolution be sent to the Federal Government.

A debate arose, which was, on the motion of the Hon. Mr. Pearson, adjourned to the next sitting.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Guthrie was withdrawn:—

That an Order of the House be granted for Returns by the Hon. the Minister of Labour of the names of all those engaged in the administration of relief in the Province, with their respective salaries.

Mr. Maitland moved, seconded by Mr. Bruhn,—

Whereas it is essential that the Trans-Canada Highway be a National Canadian Highway uniformly maintained throughout Canada:

And whereas a large section of the said highway has been built in British Columbia by the Federal Government as part of the said National Highway:

Therefore be it Resolved, That this House is of the opinion that the whole of the construction and future maintenance of the Trans-Canada Highway be paid for by the Federal Government.

And be it further Resolved, That a copy of this Resolution be forwarded to the Federal Government.

A debate arose, which was, on the motion of the Hon. Mr. Pattullo, adjourned to the next sitting.

Mrs. Steeves moved, seconded by Mr. Telford,—

Whereas the Board of Governors of the University of British Columbia raised the attendance fees for students from \$150 to \$175, thereby making university education prohibitive for a large section of our youth:

And whereas the estimates and accounts of the University are not open to the senate of that body, nor to the public of British Columbia:

Therefore be it Resolved, That this Legislative Assembly regrets that the Board of Governors of the University of British Columbia took the action of raising the attendance fees.

And be it further Resolved, That this House resolve itself into a Committee of the Whole to consider the question of how the University can be made to serve the cause of democratic education more adequately in the future.

A debate arose, which was, on the motion of the Hon. Mr. Weir, adjourned to the next sitting.

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

And then the House adjourned at 10.58 p.m.
