FIRST REPORT

OF THE

SELECT STANDING COMMITTEE ON PUBLIC ACCOUNTS.

Mr. Speaker:

Your Committee on Public Accounts beg leave to submit their first report:—

- 1. Items in detail of "Miscellaneous Receipts," from 1st July, 1886, to 31st December, 1887.
- Items in detail of "Sale of Government Property," from 1st July, 1886, to 31st December, 1887.
- 3. Statement of sums due on 31st December, 1887, not brought to account at the Treasury at that date.
- 4. Copy of Report of the Committee of the Executive Council, with reference to the payment of \$37,500 as a bonus to the Canadian Pacific Railway Company for building the branch line to New Westminster.

Your Committee report that: With regard to the sum of \$37,500 paid as a bonus as above, they find that the appropriation was made by the Legislature on 1st April, 1886, under the following conditions: That no Chinese were to be employed, either directly or indirectly, in or about or concerning the work, in any manner whatever; and that in the event of any violation of this agreement, the Government should not be liable or responsible in any way for the payment of the sum, or of any portion thereof; and, further, that no portion of the sum of \$37,500 was to be paid by the Government until the Chief Commissioner of Lands and Works reported in writing to the Executive Council that this condition had been fully and faithfully complied with, and the said branch line properly constructed and in running order.

That a Report of a Committee of the Executive Council, which was approved by His Honour the Lieutenant-Governor on 21st April, 1886, recommended that the Canadian Pacific Railway Company be paid the sum named, upon the completion by the Company of a branch railway connecting the City of New Westminster with the Canadian Pacific Railway, as provided in clause 13 of an agreement made the 23rd day of February, 1885, between the Chief Commissioner of Lands and Works and the Canadian Pacific Railway Company, and that the Company should be informed that the Government had undertaken to pay such sum in accordance with the said agreement.

That the sum of \$37,500 was paid on the 30th June, 1887, under authority of a warrant approved on the 29th June, 1887.

Your Committee find that in consequence of the refusal of the Canadian Pacific Railway Company to proceed with the construction of the said branch railway (which refusal was based on the condition contained in the resolution of April 1st, 1886, viz., that no Chinese should be employed thereon), the Government, which had, previously to the passing of the said resolution, under the instruction of this House, entered into an agreement with the Canadian Pacific Railway Company for the building of the said branch, in order to secure its construction under that agreement ignored the condition of the resolution of April 1st, 1886.

Copy of a Report of a Committee of the Honourable the Executive Council, approved by His Honour the Lieutenant-Governor on the 21st day of April, 1886.

The Committee of Council recommend that there be paid to the Canadian Pacific Railway Company the sum of \$37,500 (thirty-seven thousand five hundred dollars) out of the Consolidated Revenue of the Province, upon the completion by the Company of a branch line of railway connecting the City of New Westminster with the Canadian Pacific Railway Company, as provided in clause 13 of an agreement made the 23rd day of February, A.D. 1885, between Her Majesty Queen Victoria, represented by the Honourable the Chief Commissioner of Lands and Works of the Province of British Columbia of the one part, and the Canadian Pacific Railway Company of the other part, and that the Company be informed that the Government has undertaken to pay such sum, in accordance with said agreement.
