- 3. If the 1 cent per day deduction as required by the Act is not sufficient to cover the doctor's bill and hospital account of members of the C.P.R. Employees' Medical Association, is the C.P.R. Employees' Medical Association liable to further assessment; if so, to what extent?
- 4. Is the C.P.R. Company as employers of labour liable for any assessment covering the doctor and hospital accounts of members of the C.P.R. Employees' Medical Association; if so, to what extent?
- 5. How much cash contributions are paid by the C.P.R. Company to the C.P.R. Employees' Medical Association for its maintenance?
- 6. On account of this agreement being made with the C.P.R. Employees' Medical Association, is the Canadian Pacific Railway Company relieved of any assessments that other companies and corporations in the Province are required to pay?
- 7. Has the Compensation Board power under the Act to compel one who is not a member of the C.P.R. Medical Association to join this association?
- 8. Has the Compensation Board power under the Act to authorize the Canadian Pacific Railway Company to deduct more than 1 cent per day from its employees?
 - 9. What medical officers have been approved of under the Act?
 - 10. Can a member of the C.P.R. Employees' Medical Association employ any of these?
- 11. Can any other workmen coming under the "Workmen's Compensation Act" employ any or all of these doctors?

The Hon, Mr. Oliver replied as follows:--

"1. At the time of the coming into operation of the present 'Workmen's Compensation Act' the C.P.R. Employees' Medical Association had a plan for providing medical aid in force between the employer and themselves, which they asked the Board to approve in accordance with subsection (4) of section 21 of the Act. The Board accordingly investigated the facts surrounding this plan, and found that slightly over 95 per cent. of the present employees of the Canadian Pacific

Railway Company had formed the 'C.P.R. Employees' Medical Association.' This association is operated under a board of management of eight elected from their members, including president and vice-president. Six of this board are employees other than officials of the company, and two are officials of the company. The plan, after a number of amendments, covers the supplying of all the requirements by the association to an injured workman in the company's employ outlined in subsection (1) of section 21 of the Act. This plan as amended was approved by the Board. The plan carries with it the treatment of all employees of the company for accidents that happen outside the workman's employment as well as within the employment to the workman and the members of his family, as well as all sicknesses outlined in the plan.

- "2. There is no authority in the Act permitting any collection by the Board from those who are members of the approved plan.
- "3. The plan referred to in question 1 covers the supplying of all medical aid specified in subsection (1) of section 21 of the Act.
- "4. Under subsection (2) of section 30 of the Act, the Board is prohibited from collecting anything from the company where there is an approved medical plan, as pertains in this case.
- "5. Under the plan in question the Canadian Pacific Railway undertakes to pay the cost of specialists, hospital treatment, nursing, medicines, artificial limbs, transportation of injured employees and their attendants where necessary, as well as transportation of doctors where necessary, or such other things as the Board may direct.
 - "6. Answered by No. 4.
- "7. The approval of the plan carries with it the treatment to be supplied to all employees of the company who by virtue of the approval become members of the association.

Then the Honourable Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—

MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government, and humbly beg to present for Your Honour's acceptance Bill (No. 71) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:-

Almost immediately after summoning you together for the business of the Session, the Legislature decided to adjourn to permit the late Premier to journey to Ottawa to attend a conference of the Provincial Premiers called by the Prime Minister of Capada. With profound sorrow my Government has had to record that on his return journey the Premier contracted an attack of pneumonia, from which he succumbed on the first day of March. The estimable personal character and high political ideals of the late Premier merited and received the esteem and confidence of the people to an unusual degree, and his untimely death called forth universal expressions of sorrow. A by-election to fill the seat in the Legislature made vacant by his death will be held in due course.

The death of the Leader of the Government made necessary the choice of a successor in the office of Premier. I called upon one of the members of the late Government to accept the responsibility of choosing a Ministry, and am pleased to advise you that all the Ministers holding portfolios in the previous Administration accepted office in the present Government.

It affords me much pleasure to approve the energy you have devoted to the work of the Session and the care bestowed upon the matters submitted for your deliberation. New and timely measures, well calculated to meet present Provincial exigencies, as well as numerous amendments to existing legislation, have received your approval.

An Act providing for the fullest measure of co-operation with the Dominion Government in the serious task of settling upon the lands of the Province and assisting in establishing in productive industry those returned soldiers who may choose such vocation will simplify one of the grave problems with which my Government is confronted. The amendments to the "Civil Service Act," with its early proclamation, also will assist materially in re-establishing the returned soldiers in civil life.

Amendments to the "Land Act" permitting settlement only in surveyed areas will conduce to closer settlement, with a corresponding beneficial result.

Amendments to the "Water Act" will render the irrigation of larger areas practicable, affording further expansion of productive settlement in the Dry Belt.

The Act vesting the ownership of the Pacific Great Eastern Railway in my Government places my Government in a position to consider the completion of this line of railway as a public enterprise or otherwise negotiate its completion and operation so as to provide transportation facilities for which the railway was designed at the earliest date and on the most favourable terms practicable.

A measure providing for a bounty on iron and steel ores produced in the Province affords means to facilitate the establishment of this important industry.

A measure respecting the cutting of spruce timber for aeroplane-construction provides means for placing at the disposal of the Allies the vast timber resources of the Province.

A "Proportional Allotment Act" will aid in the solution of difficult situatious in relation to land held under agreement of sale.

The "Seed-grain Act" will result in greater agricultural production.

Amendments to the "Taxation Act" are designed to adjust the burden of the public debt and public service so as to bear more equitably upon the taxpayers.

A measure providing for an eight-hour day in certain occupations will improve materially the conditions of labour, while the amendments to the "Coal-mines Regulation Act" and the "Labour Regulation Act" are calculated to further advance these interests.

Amendments to the "Workmen's Compensation Act" will prove beneficial to Government employees engaged in hazardous occupations.

An Act providing a minimum wage for women should inaugurate improved conditions for those whom it is designed to assist.

Provision for the relief of South Vancouver Municipality and the Acts securing the bonds of certain dyking districts will afford appreciable relief to these burdened districts.

The amendments to the "Schools Act" and the regulations framed thereunder will have a beneficial effect.

I thank you for the provision you have made for necessary expenditures in carrying on the public works and providing for the general needs of the Province, and trust that the result of your deliberations may lead to the social and material welfare of the Province.

Since the Legislature assembled the Allied Nations have been subjected to a further sustained attack by the Central Empires upon their Western Front. I am pleased to note your appreciation of the valour and heroism of our own soldiers and your expression of confidence that the honour and traditions of our Empire will be maintained.

In now taking leave of you, let me assure you of my best wishes for your welfare, earnestly trusting that the result of your labours may prove conducive to the best interests of the people of British Columbia.

The Hon. Dr. MacLean, Provincial Secretary, then said:-

Mr. Speaker and Gentlemen of the Legislative Assembly:-

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
