The Committee has carefully considered the said draft and suggestions mentioned and has agreed to certain amendments which, in the opinion of the Committee, will be conducive to the regularity and dispatch of the business of the House; and submit herewith the draft rules as amended and as part of this report.
 - (3.) The Committee recommends:-
 - (a.) That the Rules as amended be adopted as the Standing Orders of the House.
 - (b.) That the existing Rules, Orders, and Forms of Proceeding be repealed.
