Prayers by Mr. Speaker.

Order called for the consideration of the report of the Select Committee appointed to investigate the dispute between the Dolly Varden Mines Company and the Taylor Engineering Company, Limited, presented and read on 22nd March.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Dr. King, it was Resolved,—

That the report be referred back to the Committee with instructions to hear such further evidence as the Committee shall consider advisable, and to report back to this House not later than the opening of the evening Session, and that the Committee have power to sit during the sitting of the House, and that such report be placed on the Orders of the Day for consideration at to-morrow morning's Session.

Mr. Bowser asked the Hon. the Minister of Finance the following questions:-

- 1. In how many soldiers' estates was an application made under the "Succession Duty Act" for a remission of the duty chargeable on account of the property of the deceased soldier?
 - 2. In how many cases was it allowed, with particulars?
 - 3. In how many cases was it refused, with particulars?

The Hon. Mr. Hart replied as follows:-

- "1. Thirty-nine to date, in thirty-four of which action has been taken by the Government on the recommendation of the Inspector of Trust Companies, Probate and Succession Duties, who made careful inquiry into the circumstances of each case, and in five of which decision is pending.
- "2. Seventeen. In each instance the Department was satisfied that the legatees were dependent on the deceased soldier.
- "3. Seventeen. In each instance the Department did not find from the facts disclosed that the legatees were dependent on the estate of the deceased soldier, or that they were at all dependent on him during his lifetime."

On the motion of the Hon. Mr. *Hart*, Bill (No. 35) intituled "An Act to amend the 'Vancouver and Districts Joint Sewerage and Drainage Act'" was introduced, read a first time, and *Ordered* to be read a second time at the next sitting.

The petition from E. A. Carew-Gibson, of Vancouver, re certain coal licences, was received.

On a question of privilege, Mr. Cowper moved, seconded by Mr. Burde,—

That this House censures Walter Hepburn, Provincial Censor of Moving Pictures, for addressing statements to the public reflecting upon the dignity of this House.

The motion was withdrawn.

Mr. McGeer presented the following report:—
MR. SPEAKER:

Your Select Committee, consisting of Messrs. McGeer, Giolma, Anderson, Whiteside, and MacKenzie, appointed by Resolutions of the 20th and 24th days of February, 1919, for the purpose of considering suggestions made with the view to rehabilitating returned soldiers, begs leave to submit its final report.

The Committee held the following meetings: February 25th, in the Ministers' Room at 10 a.m.; February 26th, in the Ministers' Room at 8 p.m.; February 27th, in the Ministers' Room at 8 p.m.; March 3rd, in the Ministers' Room at 8 p.m.; March 5th, in the Ministers' Room at 8 p.m.; March 10th, in the Ministers' Room at 8 p.m.; March 10th, in the Ministers' Room at 8 p.m.; March 17th, in the Ministers' Room at 8 p.m.; March 21st, in the Ministers' Room at 8 p.m.

The soldiers' organizations whose representatives appeared before your Committee were as follows: The British Campaigners, represented by Major Bapty, President, and Mr. Edwards, Secretary; the Comrades of the Great War, represented by a delegation consisting of Messrs. Kidner, Gutten, and McIntosh; the Provincial Great War Veterans, represented by Captain Whittaker, President, and Mr. Walter Drinnan, Organizer; the Empress of Asia Soldier Settlement Community, represented by Messrs. Kirchner and Walker.

Others appearing before your Committee consisted of the Chairman of the Provincial Land Settlement Board, Mr. Nelems; the late Comptroller of Water for the Province, Mr. William H. Young; several Members of the Legislature, and citizens and soldiers representing private views and interests having to do with the matter under consideration by your Committee.

In submitting its final report, your Committee wishes to emphasize the fact that, in working out the great problem of rehabilitation and assisting the soldiers engaged in the conflict between His Majesty and his Allies and the Central Powers of Europe to return to civil life, the closest co-operation possible be developed between the soldier organizations and the Government, with a view that the representations of the soldier organizations may meet with immediate active and sympathetic consideration, and that steps be taken so that the representative soldier organizations may at all times be made conversant with the work that the Government is performing in the many branches of this all-inclusive problem. This particularly applies in conjunction with that feature of rehabilitation known as land settlement. Your Committee is of the opinion that it is advisable that proper representatives of the soldier organizations should be made conversant with any area which it is proposed shall be open to soldier settlement, so that through the medium of their own organizations the soldiers contemplating settling on such lands may have first information as to the character and general circumstances surrounding such area. It is the opinion of your Committee that if such a course is followed it will prove of tremendous value in allaying any feeling of distrust which might arise as the result of unfair and unwarranted criticism made by irresponsible persons not possessed of the full knowledge of the facts. It is in our opinion essential that this be done owing to the fact that many of the areas possible of soldier settlement at the present time are some distance from transportation, and in a great many instances so far from the centres of population that a personal inspection of the lands could not be made by all of the individuals contemplating settlement thereon.

Many of the representations made with a view to assisting the returned soldier to civil life have already been dealt with in interim reports of this Committee and by former action of the Government. In the consideration of the many proposals submitted to your Committee having to do with the rehabilitation of soldiers, your Committee is of the opinion that, if rehabilitation is to meet with the success that it merits, it must be participated in by the individual, the municipality, the Provincial Government, and the Dominion Government, each in the opinion of your Committee having a duty to perform, the greatest of which being the putting forward of co-operative effort, having one and only one end in view, and that being the making possible the re-establishing of the returned soldiers in civil life as easy and as quickly as possible.

Your Committee is strongly impressed with the necessity of the securing of an organized effort on the part of the individuals of the community, believing that by so doing much assistance can be extended where necessary along the lines of assisting returned men in the task of getting settled, particularly with reference to men who are partially disabled. Your Committee is of the opinion that through the medium of the Soldiers' Aid Commission already recommended much of the necessary organization-work can be carried on in conjunction with the Government Labour Bureaus and the soldiers' organizations. The problem of rehabilitation is all-inclusive in so far as human affairs are concerned, and your Committee in consequence has considered specifically only some of its many features, particularly those whereby it was believed some measure of assistance could be extended to meet general circumstances and situations.

Taxes.—It was represented by many of the delegations of soldier organizations appearing before your Committee that the payment of arrears of taxes accumulating as a result of the provisions of certain Acts of this Legislature, particularly the "Moratorium Act," would work a grave and serious hardship on many men who will find themselves in a short time no longer protected in the manner above mentioned. Your Committee, in view of the representations made, communicated with the different municipalities throughout the Province of British Columbia with a view to ascertaining the actual amount of taxes due on the lands and the actual amount of taxes levied on the homes and holdings of soldiers and their dependents. At the time of the preparation of this report sufficient returns were not as yet at hand to permit your Committee to make a statement as to the actual amount of such taxes, but from the information to hand it is the opinion of your Committee that the amount is not so great as to prevent the consideration of the total exemption from taxes during the period of enlistment of a soldier of his home with a view to action being taken before the expiration of the "Moratorium Act" in 1920; subject to the provision that the exemptions shall be limited to a value per home of \$5,000. Your Committee is of the opinion that the homes of totally disabled soldiers, the widows and children of soldiers, and widowed mothers of soldiers totally dependent upon a soldier who has made the supreme sacrifice should be exempt from taxation during the period of the war, and where the taxes had been paid those taxes should be remitted to the persons it is proposed to benefit. In the matter of dealing with taxes on holdings other than homes, the payment of which is deferred by the above-mentioned Acts, it is recommended to the consideration of the Government that a provision be made whereby these taxes may be paid off in instalments stretching over a period of time, making the payment of such taxes as easy as circumstances will permit. It is also recommended by your Committee that full and ample provision be made for the prevention of others benefiting by such exemptions, particularly mortgagees, and that a provision be made whereby in the event of any home or holding under which the above-mentioned provisions or exemptions would apply being foreclosed, that in such event taxes exempted shall become due and payable.

Orphans.—Representations were made to your Committee with reference to children known as war orphans. On investigation the Committee ascertained that the number of actual orphans occasioned by the war was not extremely large. The Committee ascertained that the Dominion authorities are taking steps to find homes for these children, and which in the main it is believed by your Committee is proving a satisfactory solution for this problem. However, your Committee ascertained that there were a large number of children whose fathers had been killed overseas, and it is the opinion of your Committee that the general orphanage problem of the Province will be substantially aggravated thereby. Your Committee therefore recommends to

the consideration of the Government the establishment of what is known as cottage homes for orphans; these homes to be established in different parts of the Province where necessary. The home to be such as will accommodate from eight to fifteen children, superintended by a nursing sister who has seen active service, assisted by the necessary help, affording to the children placed in such a home an opportunity to enjoy the benefits and advantages of a home-life such as the child would enjoy were it in the home of its parents. The homes to be established in places and in the vicinity of satisfactory schools, so that the children will be able to receive the benefit of the general educational facilities provided for the children of the community.

Civil Servants.—Strong representations were made to your Committee on behalf of the reinstatement of Civil Servants who had left the employ of the Government for active service, and your Committee strongly recommends to the consideration of the Government a policy of reinstatement of all Civil Servants who so left the service, on their return, or the finding of employment equal or better than that which was left at the time of enlistment. In connection with the administration of the "Civil Service Act," your Committee recommends to the consideration of the Government the advisability of adopting a policy in the matter of the examination of candidates for positions by which no soldier will be debarred from a fair consideration of his merits to fulfil any such position for which he has an application, and that, as far as circumstances will permit, age limit as provided in the "Civil Service Act" be removed with respect to soldier candidates. In many positions which will become open from time to time, it is the opinion of your Committee that, as far as soldier candidates are concerned, a viva voce examination would prove more acceptable than the written examination at present prescribed.

Pensions.—While this is a matter which is exclusively under the control of the Federal Government, representations were strongly made to your Committee asking for the co-operation of the Provincial Government on behalf of the men entitled to or in receipt of pensions, resident in this Province, with a view to having the pensions increased so that the pensioner may be in receipt of an amount which will be the equivalent, as far as it is possible, of the difference between what he is able to earn and what constitutes fair and proper living allowance, having in mind that throughout the different parts of Canada the cost of such living varies substantially. Your Committee therefore humbly recommends that the Provincial Government recommend to the Dominion Government a complete revision of the pension system, so that in its revised state it will meet with the approval of the soldier organizations who have made representations in regard to this all-important question, and whose representations, resolutions, and recommendations have already been forwarded to the Dominion Government.

Aliens and Enemy Aliens .-- Representations have been made to your Committee that there are resident in the Province of British Columbia numbers of persons from the central countries of Europe and elsewhere who evince no desire either to speak or encourage their children to speak the English language or to conform to British ideals or to adopt Canadian citizenship. Such persons being, by reason of religion, habits of life, and standard of living, aliens to the best interests of the community and prejudicial to Canadian national development; and, further, that many persons of enemy nationality during the past years of war have enjoyed inviolate the security and freedom common to citizens of the Dominion, and yet such persons, by reason of divers acts, speeches, treasonable and seditious—such action and speeches being destructive to the security and welfare of this Dominion and in violation of its laws—have shown themselves to be enemies and undesirable citizens, your Committee therefore recommends that the Provincial Government urge upon the Dominion Government a policy of immigration making impossible the indiscriminate entry of aliens to the Dominion of Canada, which the immigration laws permit, as being contrary to the best interests of the Dominion, continuing to endanger our national ideals. Your Committee further recommeds that the Provincial Government urge upon the Dominion Government the passing of legislation providing for the deportation to their respective countries of all such enemy aliens at the earliest possible moment.

Working Conditions.—Representations were made to your Committee with regard to the conditions applicable to the workers in the Province of British Columbia, and particular stress was laid upon the possibility of considerable unemployment obtaining as a result of the discontinuing of works carried on as a part of the war activities and the return of large numbers of men who have been on active service, seeking employment, endangering the worker to exploitation, submitting him to less happy working conditions and lower rates of wages. It was represented that the presence in the Province of British Columbia of large numbers of Orientals

largely engaged as workers whose standard of living is low, whose hours of labour are excessive, and whose wages are small, worked to the disadvantage and the detriment of the Canadian workmen and women. Your Committee therefore humbly recommends to the Department of Labour that the whole question of the conditions of the workers in the Province be taken under advisement, and it is humbly recommended to the Government that it consider the advisability of bringing down legislation with a view to establishing a minimum wage for certain workers throughout the Province, and with a view to regulating the hours of labour and the conditions of labour, and with a view to prohibiting the system of indentured labour which your Committee believes is largely adopted as the medium through which Orientals are employed.

Cost of Living.—Representations were made to your Committee with reference to the high cost of living, and particularly the high cost of foodstuffs in the Province of British Columbia at this time. Your Committee, while fully appreciating the efforts of the Dominion Government along lines of regulating the sale and distribution of foodstuffs, is of the opinion that the Provincial Government is in a position to assist in a measure in attacking this vital problem, and without going into the many ramifications of such a problem, your Committee recommends that the Government take into its consideration the advisability of laying down a policy for the assisting of municipal organizations to own and operate their own cold-storage plants. It is suggested that the aid extended to the construction of cold-storage plants by the Dominion Government could be supplemented, as far as a municipality or city is concerned, by similar assistance from the Provincial Government.

In submitting its final report, your Committee wishes to express its humble appreciation to the representatives of the returned soldier organizations that appeared before it, and to state that your Committee received at the hands of these representatives most ample assistance and consideration, your Committee finding in the representatives of the soldier organizations a sincere desire to co-operate and assist in a most reasonable and satisfactory way, not what is now the great Provincial problem, but what is and will continue to be for some time the great national problem of Canada.

- 3. Was the said Brady also employed as Engineer for a portion of that time locating roads in the same district?

The Hon. Dr. King replied as follows:-

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

Then the Honourable Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—

MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government, and humbly beg to present for Your Honour's acceptance Bill (No. 87) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

In relieving you of your sessional duties, I wish to express my appreciation of the earnest, painstaking spirit in which you have dealt with the many matters placed before you for consideration.

I am pleased to note that through the medium of resolutions and various statutory provisions you have expressed your appreciation of the great service rendered to the Empire by all who have participated in the present war.

I firmly believe that the action of the Government in co-operating with the Federal Government in caring for the returned service men and women will be productive of the best possible results.

Especially I thank you for your liberality in providing a substantial amount for the disposition of the Returned Soldiers' Aid Commission.

The co-operative efforts of the Provincial and Federal Governments in placing returned soldiers upon the land and the determination of the soldier settlers will, I am sure, result in greatly increased agricultural production in the very near future.

The "Direct Legislation Act" will afford a means by which the electorate of the Province can more effectually give effect to their wishes.

The "Public Utilities Act" will furnish a means by which a much more equitable relationship can be maintained between public service corporations and the public.

Your authorization of loans for works of a productive nature is very timely, and the funds provided will enable the Government to carry on many necessary works and relieve hardships which otherwise might result from unemployment.

The Acts authorizing grazing and control of public ranges will do much to promote the growth of the stock industry in the Province.

The works authorized under the provisions of the "Better Housing Act" will improve housing conditions generally and be of great assistance to soldiers and their dependents.

The "Company Towns Act" providing for means of ingress and egress will do much to allay existing dissatisfaction in connection with company towns.

The amendments to the "Water Act" will have a beneficial effect upon the districts affected thereby.

The work to be carried on under the provisions of the "Coal and Petroleum Appropriation Act" I trust will lead to valuable discoveries and have a far-reaching beneficial effect upon the prosperity of the Province.

Amendments to the "Coal-mines Regulation Act" and the establishment of minimum-wage districts will, I trust, have a beneficial effect upon coal-mining conditions within the Province.

Your legislation making provision for smelting of iron ores for experimental purposes I

hope will demonstrate the feasibility of an iron and steel industry on a sound economic basis.

The administration of the "Venereal Prevention Act" I trust will result in the suppression and elimination of this class of disease.

The establishment of libraries throughout the Province no doubt will produce very beneficial results.

Amendments to the "Land Settlement Act" giving powers of expropriation will enable the Land Settlement Board to promptly meet the constantly increasing demand for agricultural lands, and I confidently hope will result in the placing of large numbers of prosperous settlers within the Province.

The powers granted for co-operation with the Dominion Government in acquiring privately owned lands for settlement purposes I believe will result in a much closer settlement than otherwise would be possible, and will tend to economy in providing necessary roads, bridges, and other means of transportation.

The powers granted to local communities to organize for the suppression of the mosquito and gopher pests no doubt will have a beneficial effect.

Legislation providing for the establishment of a Department of Industries I confidently hope will tend to the creation of new industries, and will be an important factor in providing employment under satisfactory conditions for many ex-service men.

The provision you have made in aid of the University of British Columbia, together with expected assistance from the Federal Government, will enable the Board of Governors to meet the constantly increasing demand for higher education, and especially to provide for vocational training for the many returned soldiers who are applying therefor.

I thank you for the provision you have made for carrying on the necessary business of the Province, and trust that the result of your deliberations will tend to advance both the commercial and material welfare of the whole people of the Province. The Hon, Dr. MacLean, Provincial Secretary, then said:-

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
