### REPORT.

LEGISLATIVE COMMITTEE ROOM,
March 15th, 1960.

MR. SPEAKER:

Your Special Committee on Trading Stamps begs leave to report as follows:—
Pursuant to motion on February 2nd, 1960, your Committee was appointed to examine and inquire into the subject of the use of trading stamps in connection with marketing of consumer goods in the Province of British Columbia.

The terms of reference of your Committee were as follows:-

Therefore be it Resolved, That a Special Committee of this House be appointed to examine and inquire into the subject of the use of trading stamps in connection with the marketing of consumer goods in the Province and to report to the Legislature its observations thereon and its recommendations with regard to the public policy to be adopted with reference to such use, the desirability of legislation within the competence of the Province being enacted with respect thereto, and, if it is recommended that legislation be enacted, the proposed context of the legislation.

Your Committee immediately became aware that a large number of organizations and individuals were concerned about the question of the use of trading stamps. As a result, the Committee heard submissions or were presented with submissions from the following individuals and organizations: Automotive Retailers' Association, Better Business Bureau, British Columbia Co-operative Unions, British Columbia Co-operative Wholesalers Society, British Columbia Federation of Labour, Burnaby 5¢ to \$1.00 Ltd., Canadian Association of Consumers, Canadian Association of Stamp Companies, Co-operative Women's Guilds of British Columbia, George C. Henderson Company Limited, Home Oil Distributors Limited, Low Cost Food Markets, Donald H. McKay, Pay Less Stores, Photolec Limited, The Retail Merchants' Association of Canada, B.C. Incorporated, Sperry & Hutchinson Company, Vancouver Board of Trade, Vancouver and District Labour Council, Victoria Chamber of Commerce, Victoria Community Grocers Co-operative Association, Washer Parts and Service Company Limited.

The Committee first addressed itself to the problem of determining the legis-

lative background associated with the use of trading stamps.

1. The Committee discovered that few jurisdictions have placed a ban upon trading stamps through the use of legislation.

2. Several jurisdictions have indicated through the Departments of the Attorneys-General of the Provinces concerned that trading stamps are not welcome.

- 3. The Minister of Justice, Canada, has indicated the degree of Provincial responsibility which is applicable to the trading stamp situation as follows: If a trading stamp scheme in its nature or operation comes within any of the fields which are proper for inclusion in the criminal law, it would be the responsibility of the Dominion Parliament to enact any necessary legislation to deal with the situation. In so far, however, as such claims are merely merchandising devices and relate exclusively to the terms and conditions upon which a customer buys and a merchant sells his goods, then their regulation or prohibition becomes a matter within the field of contract or detailed regulation of trade which is within the exclusive jurisdiction of the Provincial legislators. From this point of view the only authorities who can control, regulate, or abolish trading stamps as such are the Provincial legislators acting under their exclusive jurisdiction over the laws relating to such matters as contract and the sale of goods.
- 4. Several of the States of the United States of America have various methods of inhibiting the use of trading stamps through punitive taxation levies.

5. The problem has been acted upon by Alberta and Saskatchewan. The operative features of the legislation in both Alberta and Saskatchewan involves an indirect prohibition on trading stamps and other retail promotional devices through Provincial licensing procedures.

The Committee became satisfied after much diligent study that the following observations might usefully be made on the subject of trading stamps:—

- (1) The cost of the stamp plans must inevitably be borne by either the consumer or the retailer. Although promoters of trading stamps and opposition groups to trading stamps would disagree that the cost of a stamp plan is borne by the consumer, both agree that stamp plans do increase costs by from 2 to 4 per cent. There is ample evidence to establish the fact that trading stamp plans create absolutely no new business in any trading area although there may be a momentary advantage enjoyed by the firm initiating the scheme. Therefore, in the long run, the admitted increase of costs must be borne by either the retailer or the consumer in the trading area involved in the trading stamp business.
- (2) Stamp plans once initiated by a retailer are difficult to discontinue.
- (3) Stamp plans are a form of sales promotion which can be quickly neutralized by a competitor's stamp plan and, therefore, stamp plan saturation results. Additional advertising costs then become an important factor in the trading area involved. Promoting of the stamp plan then becomes the emphasized feature of advertising and information and emphasis on price and quality diminishes.
- (4) All stamp plans create problems in handling and book-keeping for the retailer.
- (5) A stamp plan causes a retailer to emphasize the promotional gimmick at the expense of emphasizing merchandise values, stores services and facilities.
- (6) Stamp plans deter a retailer from the pursuit of natural competition.
- (7) The stamp plan introduces the third party between the customer and the retailer. This third party group, the trading stamp company, uses established retail machinery to operate a highly profitable business, the cost of which must be borne by the consumer or the retailer.
- (8) The value of premiums offered by trading stamp companies represents an insignificant percentage of the value of purchases required to obtain the premium.

While trading stamp plans seem to have focused attention on the sales promotion methods now in use, the Committee feels that many sales promotion methods serve only to create a distraction from the serious and vital business of distributing goods.

The Committee feels that the "gimmick should never become more important than the two real values of goods, that is, price and quality."

The Committee, therefore, recommends that the House consider the advisability of enacting legislation on the matter of trading stamps with somewhat the following text:—

- 1. This Act may be cited as the "Trading Stamp Act."
- 2. (1) In this section "trading stamp" means any form of cash receipt, receipt, coupon, premium ticket, or other device designed or intended to be given to the purchaser of goods by the vendor thereof or on his behalf, and to represent a discount on the price of goods or a premium to the purchaser thereof, but does

- not include (a) a trading stamp as defined in the Criminal Code or (b) an offer, endorsed by the manufacturer upon a wrapper or container in which goods are sold, of a premium or reward for the return of that wrapper or container to the manufacturer.
- (2) Everyone who, by himself or his employee or agent, directly or indirectly, issues, gives, sells, or otherwise disposes of, or offers to issue, give, sell, or otherwise dispose of trading stamps to a merchant or dealer in goods for use in his business is guilty of an offence under this Act.
- 3. (1) In this section, "trading stamp" means any form of cash receipt, receipt, coupon, premium ticket, or other device designed or intended to be given to the purchaser of goods by the vendor thereof or on his behalf and to represent a discount on the price of goods or a premium to the purchaser thereof, but does not include an offer, endorsed by the manufacturer upon a wrapper or container in which goods are sold, of a premium or reward for the return of that wrapper or container to the manufacturer.
- (2) An agreement made before the coming into force of this Act whereunder trading stamps are to be given, issued, sold, distributed, or otherwise dealt with in any manner is void from and after the coming into force of this Act.
- (3) An agreement made after the coming into force of this Act whereunder trading stamps are to be given, issued, sold, distributed, or otherwise dealt with in any manner is void.
- (4) This section is retroactive to the extent necessary to give full force and effect to its provisions.

## Provisions as to Constitutionality, Intent of Legislature.

4. The purpose and intent of the Legislature is to confine the provisions of this Act within the competence of the Legislature, and all the provisions thereof shall be construed so as to give effect to such purpose and intent. If any provision or section is held or found to be beyond the powers of the Province, such provision or section shall be read distributively, and the provision or section so far as it deals with matters within the competence of the Legislature shall stand and be valid and operative, and shall have the same effect as if the provision or section had dealt with such matters exclusively; and the remaining provisions and sections of this Act shall not be deemed or held to be inoperative or *ultra vires*, but shall stand and be valid and operative, and shall have the same effect as if they had been originally enacted as separate and independent enactments and as the only provisions of the Act; and all the provisions of the Act that are within the powers of the Province shall remain in full force and effect, notwithstanding that some provisions are held to be *ultra vires*, the intention of the Legislature being to give separate and independent effect to the extent of its powers to every enactment and provision in the Act contained.

#### Commencement.

5. This Act shall come into force on a day to be fixed by the Lieutenant-Governor by his Proclamation.

"6. Section 23 is amended

"(a) By striking out subsection (1) and substituting:—

"'(1) In the case of every bill of sale which is registered under this Act and which subsists as security for an amount owing or in respect of a liability, a renewal statement and affidavit in respect thereof shall be registered in accordance with the requirements of this section within three years from the first date on which the bill of sale or a copy thereof was registered.'

"(b) By striking out subsection (3) and substituting:—

"'(3) The renewal statement and accompanying affidavit shall be registered by filing an original thereof with each Registrar in whose office the bill of sale or a copy thereof has been registered pursuant to the provisions of this Act.'

- "(c) By adding the following as subsections (7), (8), (9), and (10):—
- "'(7) Save as provided in subsections (8) and (9), this section does not apply to a bill of sale made by a company.
- "'(8) In the case of a bill of sale made by a company which was not required to be filed in the office of the Registrar of Companies or particulars of which were not required to be filed in the office of the Registrar of Companies, the renewal statement next falling due after the 1st day of May, 1960, shall be filed in the office of the Registrar of Companies and, save as provided in subsection (9), not with each Registrar in whose office the bill of sale or a copy thereof has been registered.
- "'(9) Where a bill of sale comprises a motor-vehicle, renewal statements in respect thereof shall in all cases be filed with the Superintendent of Motor-vehicles.
- "'(10) In the case of a bill of sale comprising a trailer or tractor, or both, made prior to the 1st day of May, 1960, and not filed in the office of the Superintendent of Motor-vehicles in respect of such trailer or tractor, or both, the renewal statement falling due next after the 1st day of May, 1960, and every subsequent renewal statement shall be filed in the Office of the Superintendent of Motor-vehicles in addition to the filing thereof with any other Registrar as required by this section."
- Section 21: To strike out section 21 and to substitute therefor the following:—
  "21. (1) Part I of this Act comes into force and effect on the 1st day of May, 1960.
- "(2) Part II of this Act comes into force and effect on a day to be fixed by the Lieutenant-Governor by his Proclamation."

Ordered, That the said Message, and the amendments accompanying the same, be referred to a Committee of the Whole House forthwith.

By leave of the House, the Hon. R. G. Williston (Minister of Lands and Forests) tabled the Report on Project III by His Honour Judge C. W. Morrow, Commissioner appointed pursuant to Order in Council No. 130, being advice to the Provincial Government on the question therein outlined.

Mrs. Haggen asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

With reference to page 167 of the Annual Report of Mental Health Services, 1957, have the three additional social workers and one supervisor now been employed as recommended?

The Hon. E. C. F. Martin replied as follows:-

"It is assumed that the reference is to the recommendation on page 168; (a) Supervisor of Welfare—Grade 1 appointed November 1st, 1959; (b) one position of Social Worker—Grade 3 added to establishment on November 1st, 1959 (position filled); and (c) two positions of Social Worker—Grade 3 provided for in 1959/60 estimates (to be recruited)."

Mr. Harding asked the Hon. the Minister of Social Welfare the following questions:—

With reference to the \$25 supplementary allowance known as the Royal bonus provided for from Consolidated Revenue by Order in Council No. 1662, 1959:—

1. Did every old-age pensioner in receipt of an allowance under Vote 314 receive the Royal bonus?

- 2. If the answer to No. 1 is no, how many did not receive it and why was it withheld?
- 3. Did those old-age pensioners who received the bonus all receive the full amount of \$25?
- 4. If the answer to No. 3 is no, how many received less than \$25 and for what reason?
- 5. Was the full \$25 paid to all old-age pensioners in receipt of allowance under Vote 314 who were residents in such institutions as Provincial infirmaries, homes for the aged, nursing and boarding homes, hospitals or sanatoria?

6. If the answer to No. 5 is in the negative, (a) how many received less than \$25 and (b) how many, if any, did not receive any bonus?

- 7. Did every eligible recipient of Social Allowance under Vote 314 receive the full amount of Royal bonus?
- 8. If the answer to No. 7 is in the negative, (a) how many received less than the full amount and for what reason and (b) how many, if any, did not receive any bonus?
- 9. How many old-age pensioners were in receipt of a supplementary allowance under Vote 314 during the month of July, 1959, and what was the total amount paid to said pensioners by way of Royal bonus?
- 10. How many recipients of Social Allowance were there under Vote 314 during the month of July, 1959, and what was the total amount paid to them by way of Royal bonus?
- 11. Were any grants paid to children's aid societies as part of the Royal bonus and, if so, in what total amount?
- 12. What was the total amount paid out to eligible recipients by way of this bonus?

## The Hon. W. D. Black replied as follows:—

- "1. Yes; all who were carried on the rolls as at July 1st, 1959, and who were the responsibility of the Province of British Columbia and residing in British Columbia.

- "3. Yes; except those being cared for in Provincial institutions, where \$10 was paid as an additional comforts allowance on the recommendation of the respective superintendents of the institutions.
  - "4. See answer to No. 3.

  - "8. Answered by No. 7.
  - "9. 33,762; see No. 12.
- "10. 33,135, including single persons, heads of families, and dependents; see No. 12.
  - "11. Yes; \$23,065.
  - "12. \$1,323,065."

Mr. Gregory asked the Hon. the Minister of Lands and Forests the following questions:—

With reference to tree-farm licences:—

- 1. Is stumpage paid by the licence-holder determined annually by negotiation with the Minister and, if not, how is it determined?
- 2. What factors are considered in determination of stumpage paid by licence-holders?
- 3. In the case of Licence No. 22, granted B.C. Forest Products and involving only the former Clayoquot Working Circle, what was average stumpage charged small operators in each year from 1950 to the time the working circle was transferred to B.C. Forest Products and what has been average stumpage paid by B.C. Forest Products on timber from former Clayoquot Working Circle since this firm acquired its licence?

The Hon. R. G. Williston replied as follows:—

- "1 and 2. The Crown timber on tree-farm licences is appraised by the Forest Service in the same manner as Crown timber offered for sale under normal timber sale procedure, except that, in the case of the tree-farm licence, forestry costs are included as a part of the cost of production. The method of appraisal is described in detail on pages 456 to 461, inclusive, of the 1956 Report of the Royal Commission on Forestry and on pages 469 to 472, inclusive, forestry costs on tree-farm licences are discussed. Currently, the average forestry cost for tree-farm licences in the Vancouver Forest District is about 30 cents per 100 cubic feet.
- "3. Complete details of the stumpage prices appraised for each cutting permit by species are published monthly in the statement of timber sales awarded. Copies are available to the interested public on subscription, or may be seen at any District Forester's office or the Forest Service offices in Victoria. A statement of average stumpage prices actually paid is not available and would require the services of several people for a number of weeks to compile as a special project. The Forest Service has no definition for the relative term 'small operator.'"

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. What was the total number of psychiatric social workers employed in the Mental Health Services as at December 31st, 1959?
- 2. Did any psychiatric social workers resign from the Mental Health Services during 1959?
- 3. If the answer to No. 2 is yes, (a) what was the total number of resignations, (b) in what departments did the resignations take place, and (c) what were the reasons, if any, given for resignation?

The Hon, E. C. F. Martin replied as follows:—

- "1. Forty-two.
- " 2. Yes.
- "3. (a) Twelve; (b) seven from Mental Health Centre, Burnaby, Children's Clinic; two from Mental Health Centre, Burnaby, Adult Clinic; two from Provincial Mental Hospital, Essondale; and one from The Woodlands School; (c) one left British Columbia, seven to other employment, one for job dissatisfaction, two to further education, and one for family reasons."

Mr. Gargrave asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

1. What was the total number of psychiatrists employed at the Provincial Mental Hospital at Essondale as at December 31st, 1959?

2. What was the total number of patients in the Provincial Mental Hospital at Essondale at December 31st, 1959?

The Hon. E. C. F. Martin replied as follows:-

- "1. Eleven psychiatrists, including one who serves as consultant in neurology and electroencephalography and one who serves as radiologist; specialist staff also includes one pathologist and one tuberculosis specialist; in addition, there are twenty-one resident physicians in training—nineteen in psychiatry, one senior medical resident, and one senior surgical resident.
  - " 2. 3,078."

Mr. Cox asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With reference to the extension of The Woodlands School at Tranquille:-

- 1. How many patients are now in residence?
- 2. What is the total number of staff employed?
- 3. With reference to staff, how many (a) resident psychiatrists are employed, (b) phychiatric nurses are employed, and (c) psychiatric aides are employed?

The Hon. E. C. F. Martin replied as follows:—

- "1. 109.
- "2. 49.
- "3. (a) Nil, (b) 5, and (c) 19."

Resolved, That the House, at its rising, do stand adjourned until 8 o'clock p.m. to-day.

And then the House adjourned at 5.59 p.m.

"5. The explanations for the increase in expenditure are listed as follows:-

"Grading contracts are bid according to the unit price system. Original estimates of contract items are made during the location investigations.

"In recent years the Materials Engineers Branch has been developed to provide more accurate data on problems of slope stability, identification of solid rock in future excavations, areas of unsuitable materials, and general foundation problems.

"Unfortunately the estimates for these contracts were made without the bene-

fits accruing from these new techniques.

"Due to lack of information on unsuitable soil types, estimates were often found to be in error during construction.

"Many landslides have occurred during construction which were not anticipated when original estimates were prepared, resulting in rather large expenditures.

"In an endeavour to meet deadlines set for completion of the Trans-Canada Highway, estimates were prepared from old surveys, which did not contain sufficient engineering information, thus necessitating an estimate based on the design engineer's knowledge of the particular area, which in some instances was insufficient.

"In general, throughout the Fraser Canyon area, construction of the highway conflicts with the Canadian Pacific and Canadian National Railway right-of-way. Invariably, in order to meet the requests of the railways, revisions of grade and alignment, change of slope design, and change of structure design was necessitated."

## "Ben Ginter Construction Co.

"Project No. 617.—The materials encountered during construction varied from those anticipated at the time the schedule of quantities was prepared for tender. This necessitated a revision of roadway design, increased granular base, and additional drainage structures.

"Project No. 648.—Increased quantities of solid rock were encountered during construction. Additional gravel was crushed for following year's paying. Owing

to the very dry summer and in an endeavour to control the dust, water was sprinkled throughout the detour (12 miles).

"Project No. 788.—This project included two major cuts of approximately 900,000 cubic yards with the maximum depth in each about 150 feet. The original surveys and soil investigation indicated only a small amount of rock occurring in some of the lesser cuts. The two major cuts contained a considerable quantity of rock well below the surface and in various forms so that it had to be classified according to the Department's general specifications. This resulted in an over-run of rock considerably in excess of the estimated quantity.

"Project No. 778.—On completion of grading, construction tests were made of the sub-grade strength. The tests indicated an increase in granular material was required with resultant overexpenditure. Increased roadway and drainage quantities are attributed to the necessity for a revision of alignment on Mud Hill when

a slide of fairly large proportions occurred.

### " Union Contractors Ltd.

"Project No. 819.—Material encountered during construction varied from those anticipated when the original estimate for the project was prepared, which necessitated a redesign of slopes and increased quantities of granular borrow material to ensure a stable road-bed. One half-mile section was added to the contract (Kay Falls, Eagle River Bridge Section).

### "R. & L. Construction Co. Ltd.

"Project No. 881.—Subsequent to advertising the work and prior to the award of tender an addendum was added to the contract, all contractors were advised by telegram that in the event it was necessary to quarry sandstone for 2-inch crushed material, the Department would negotiate same with the low tenderer. This was done with a resultant increase in cost over the tender amount.

## " McClay Construction Co. Ltd.

"Bridge Project No. 222.—Considerable amount of approach fill construction which had originally been intended to be done by Department forces was added to the bridge construction contract."

Mr. Strachan asked the Hon. the Premier and President of the Council the following questions:—

With reference to the transmission-line being built by the British Columbia Hydro to connect its system with that of the West Kootenay Power & Light Company near Summerland:—

- 1. Has the construction of the transmission-line been halted?

The Hon. W. A. C. Bennett replied as follows:-

"2, 3, and 4. Negotiations concurrently under way with West Kootenay Power & Light Company."

- Mr. Gregory asked the Hon. the Minister of Finance the following questions:—
- 1. In the year ended March 31st, 1959, what was the total of Provincial taxes, licences, and fees of all sorts collected at the following regional offices: (a) Vancouver, (b) Victoria, (c) New Westminster, (d) Prince George, (e) Kelowna, (f) Nelson, (g) Dawson Creek, (h) Penticton, and (i) Kamloops?
- 2. (a) In the year ended March 31st, 1959, what total sum of money was paid or rebated to merchants or others for services rendered in collecting the 5-per-cent sales tax, and (b) in the same year, what was the total cost, if any, to the Department of Finance by way of staff, inspectors, etc., in the collection of the 5-per-cent sales tax?
- 3. In each year since 1952, what sum was collected, in arrears, of the above tax?
- 4. In each year since 1952, (a) how many prosecutions were instituted in connection with the above tax and (b) of these, how many were successful?

The Hon. W. A. C. Bennett replied as follows:—

- "No letter from 'Peace River Development Company.' A letter from Wenner-Gren B.C. Development Company Limited was transmitted to the British Columbia Power Commission for consideration. The said Commission elected to defer a definite answer."
- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With respect to the Geriatric Division of the Mental Health Services:—

- 1. Is there a full-time medical assistant on staff at the present time in the Homes for the Aged in (a) Vernon, (b) Terrace, and (c) Coquitlam?
- 2. Are there any social workers on staff at the present time in the Homes for the Aged in (a) Vernon, (b) Terrace, and (c) Coquitlam?
  - 3. If the answer to any portion of No. 2 is yes, how many in each home?

The Hon. E. C. F. Martin replied as follows:—

- "1. (a) No, community physician is on call; (b) no, community physician is on call; and (c) yes, Medical Superintendent and two resident physicians.
  - "2. (a), (b), and (c) No."

The Hon. W. N. Chant replied as follows:-

"1. (a) No and (b) yes.

"2. \$14,350 to date this fiscal year."

Mrs. Haggen asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With respect to the nursing staff at The Woodlands School:—

- 1. What was the total number of nurses employed as at December 31st, 1959?
- 2. (a) How many are graduate psychiatric nurses and (b) how many are registered nurses?
  - 3. Did any nurses resign during the year 1959?
- 4. If the answer to No. 3 is yes, (a) how many were graduate psychiatric nurses and (b) how many were registered nurses?

The Hon. E. C. F. Martin replied as follows:—

- " 1. 225.
- "2. (a) 219 and (b) 6.
- " 3. Yes.
- "4. (a) 44 (getting married, pregnant, health or personal, 26; left British Columbia, 11; other employment, 4; retired, 3) and (b) none."

Mr. Shelford asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. How many serious cases of polio are reported from the Burns Lake area?
- 2. How many non-paralytic cases of polio are reported from the Burns Lake area?
  - 3. How many of these cases were reported from the Village of Burns Lake?
- 4. How many of these cases were reported from the surrounding areas outside of the Village of Burns Lake?
- 5. Are polio shots available to people of all age-groups within the presently affected area?
- 6. Has the Cariboo Health Unit sufficient personnel in the Burns Lake area to cope with the present outbreak?

The Hon. E. C. F. Martin replied as follows:—

- "1. There has been a total of eleven cases of paralytic polio with one death reported in the Burns Lake area.
- "2. Non-paralytic cases are no longer reportable. At a Dominion-Provincial agreement in 1955 it was agreed that, because of the difficulties of confirmation of diagnosis of non-paralytic poliomyelitis and the fact that so many other conditions presented similarly clinical symptoms, all reporting for the future would be confined solely to paralytic poliomyelitis.
- "3. There have been five cases of paralytic polio reported so far in the Village of Burns Lake.
- "4. There have been six cases reported from the surrounding areas outside of the Village of Burns Lake.
- "5. Poliomyelitis immunization has been re-emphasized in the area as one of the more desirable preventive measures. Clinics are in operation to offer vaccine to all age-groups.
- "6. Departmental inquiry from the Director of the Cariboo Health Unit indicates sufficient personnel are available to cope with the present situation. One of the assets of health unit service is the staff flexibility which permits staff, in emergencies, to be moved from one community to another; this would be done within the Cariboo Health Unit in this case, if necessary. In addition, the Department advised the Director of the Cariboo Health Unit of a willingness to loan further additional staff if it was deemed necessary. So far this has not been requested."

- Mr. Gregory asked the Hon. the Minister of Agriculture the following questions:—
- 1. How many, if any, licences have been granted for the sale of reconstituted milk in the Province?
- 2. If any such licences are in existence, what volume of reconstituted milk was sold in each year of the licences' existence?
  - 3. On what basis is a licence to sell reconstituted milk granted?

The Hon. N. P. Steacy replied as follows:—

- "1. 1953, two permits; 1954, two permits; 1955, three permits; 1956, five permits; 1957, four permits; 1958, three permits; 1959, four permits; 1960, three permits. One cancelled in July, two later cancelled, one not used, fresh milk sufficient. A temporary permit was issued to Lakelse Dairy in Kitimat in July, 1959, due to a shipping strike.
- "2. From 6,500 to 7,000 gallons per month at Ocean Falls, and 17,000 gallons per year at Kemano. Other permits have covered deficiency periods to make

up shortages of fresh milk.

- "3. Permits are issued under authority of section 15 of the 'Milk Industry Act' for such time and in such quantities as conditions warrant, having regard to available supplies of fresh fluid milk within a reasonable distance from the market where it is proposed to sell the reconstituted milk."
- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With reference to public health nursing services:—

- 1. Has a public health nurse been appointed at the Williams Lake Health Centre?
- 2. If the answer to No. 1 is no, (a) why not and (b) is such an appointment to be made?
  - 3. Has a public health nurse been appointed at Quesnel?
- 4. If the answer to No. 3 is no, (a) why not and (b) is such an appointment to be made?

The Hon. E. C. F. Martin replied as follows:—

"1. Yes; there are two public health nurses located at Williams Lake and a third nurse will be appointed April 8th, 1960.

"2. Answered by No. 1.

"3. There are two public health nurses located at Quesnel. After April 8th additional public health nursing service will be available by the appointment of a third nurse with headquarters at Williams Lake, who will serve both districts.

"4. Answered by No. 3."

- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—
- 1. What was the percentage turnover for the entire staff of Mental Health Services for the year 1959?
- 2. What was the percentage turnover for the entire staff of psychiatric nurses in the Mental Health Services for the year 1959?

The Hon. E. C. F. Martin replied as follows:—

- "1. 19.5 per cent.
- "2. 17.3 per cent.
- "Note.—The percentages shown above have been calculated against year-end staff totals in both cases."

Mr. Dowding asked the Hon. the Premier and President of the Council the following questions:—

With reference to the Pacific Great Eastern Railway Company 1958/59 balance-sheet and the item "Traffic Accounts Receivable, \$2,360,030":—

- 1. To what period of time do these accounts pertain?
- 2. Did any firms accumulate more than \$20,000 in outstanding liabilities represented in the said \$2,360,030 and, if so, which firms?
- 3. If the answer to No. 2 is in the affirmative, was any debt or portion thereof owing by such firms written off by the Pacific Great Eastern Railway Company and, if so, which firms were involved?
- 4. If the answer to No. 3 is in the affirmative, in the case of each firm involved, what was the amount written off by the Pacific Great Eastern Railway Company?
- 5. With respect to No. 3 and No. 4, have any of the firms involved gone into bankruptcy, receivership, or liquidation and, if so, which firms?
- 6. If the answer to No. 5 is in the affirmative, who was the respective trustee in bankruptcy, liquidator, or receiver in each case?

## The Hon. W. A. C. Bennett replied as follows:—

- "1. Approximately 40 per cent of the items are current, 25 per cent are thirty days and 35 per cent are sixty days and over.

## Mr. Gregory asked the Hon. the Premier the following questions:--

- 1. Will the Premier please indicate in a general way what persons or organizations, etc., regularly receive copies of the publication British Columbia Government News?
- 2. Were copies of the November, 1959, issue (Volume 7, No. 9) sent to any schools other than those which regularly receive the publication or in greater than regular quantities and, if so, (a) why were copies of that issue sent, (b) how many copies were sent, and (c) to what schools were copies sent?

# The Hon. W. A. C. Bennett replied as follows:—

- "1. Any person or organization may regularly receive copies.
- "2. Yes. (a) The issue contained an article outlining the programme under which loans and bursaries are available to students desiring to further their education. In order to inform eligible students of this programme sufficient copies were sent to senior high schools for distribution to Grade XII students. With the approval of the Alma Mater Society of the University of British Columbia and of Victoria College, copies were also sent to the University and to the College for distribution. (b) Approximately 10,000. (c) See 2 (a) above."

Mr. Dowding asked the Hon, the Minister of Health Services and Hospital Insurance the following questions:—

With reference to the regional dental consultant for Central and Northern Vancouver Island:—

1. Did the consultant resign recently?

2. If the answer to No. 1 is yes, will a replacement be made for the consultant and, if not, why not?

The Hon. E. C. F. Martin replied as follows:—

- "1. The regional dental consultant serving the three health units of Vancouver Island resigned on January 18th, 1960, to accept a similar appointment with the Government of Tasmania.
- "2. Prior to this resignation it was planned that clinical preventive dental services provided by the health units of this Province could be best expanded by their being carried out by the resident family dentists of the communities. Total clinical services available to the younger children of the Vancouver Island health units are greater this school-year than ever before. Consultant services to these health units will continue, but will be provided direct by the Division of Preventive Dentistry, Health Branch, Victoria. The appointment of regional dental consultant to the Vancouver Island health units will not be refilled immediately since this position in establishment is now filled by a similar appointment to the northern health units of the Province where the urgent need for such services has become a matter of most serious concern."

Mr. Gregory asked the Hon. the Premier and president of the Pacific Great Eastern Railway the following questions:—

With reference to the condensed statement of accounts of the Pacific Great Eastern Railway Company, as at December 31st, 1959, filed in the House on February 16th, 1960:-

1. How much, if any, of the \$2,360,030 shown as an asset on the balancesheet as "Traffic Accounts Receivable" was owing the railway by W. L. Laird

Distributors Limited and how long had any part of it been owing?

- 2. How much, if any, of the \$101,154.90 owing the railway by W. L. Laird Distributors Limited as at August 9th, 1957, had been paid by December 31st, 1960?
- 3. How many days' credit, if any, does the railway extend to W. L. Laird Distributors Limited?
- 4. What type of freight, if any, does the railway carry for W. L. Laird Distributors Limited and have there been any reductions in freight rates charged on that type of freight since one Walton, of Gunderson, Stokes, Walton & Company, became its president during the year 1959; if there have been any such freight rate reductions, what were they and when and why were they made?

The Hon. W. A. C. Bennett replied as follows:—

- "1. \$30,605 representing amounts due for August and September, 1959.
- "2. It has not been possible to identify this figure on the books of the railway company. It may, however, be stated that the business with the firm of W. L. Laird Distributors has been of the magnitude of \$155,000 in 1958 and \$166,000 in 1959.
  - " 3. None.
- "4. Type of freight—general commodities. Numerous freight rate reductions have been made from time to time in accordance with the company's policy of meeting competition. These changes are all set forth in various published tariffs and are applicable to all shippers."

- Mr. Gregory asked the Hon. the Premier and president of the Pacific Great Eastern Railway the following questions:—
  - 1. Since 1956, has the Pacific Great Eastern Railway purchased any used rail?
- 2. If so, where did this rail originate and from whom did the railway purchase it?
  - 3. Was the rail purchased f.a.s. or f.o.b. and what price per ton was paid?
  - 4. What was the weight of the rail?
  - 5. Where was it installed in the system?
  - 6. Since 1956, has the railway sold any used rail?
  - 7. If so, were tenders called?
  - 8. To whom was the rail sold, at what price per ton, and at what point?

The Hon. W. A. C. Bennett replied as follows:--

- "1. Yes.
- "2. Fort Rouge; Canadian National Railways.
- "3. F.o.b.; \$89.56 per net ton.
- "4. 115 pounds per lineal yard.
- "5. Tracks in new shops buildings at North Vancouver and Squamish.
- " 6. Yes.
- " 7. Yes.
- "8. Benjamin Chechik, \$76.50, f.o.b. North Vancouver; Atlas Iron & Metals Ltd., \$80.10, f.o.b. North Vancouver; Benjamin Chechik, \$52.60, f.o.b. North Vancouver; Atlas Iron & Metals Ltd., \$41.50, f.o.b. North Vancouver; Atlas Iron & Metals Ltd., \$41.50, f.o.b. North Vancouver; Atlas Iron & Metals Ltd., \$36.90, f.o.b. Clinton; Atlas Iron & Metals Ltd., \$31.66, f.o.b. North Vancouver; B.C. Brokerage Co. Ltd., \$24.65, f.o.b. Pavilion; and B.C. Brokerage Co. Ltd., \$30.25, f.o.b. North Vancouver."

Mrs. Haggen asked the Hon. the Minister of Agriculture the following questions:—

- 1. Is there a Provincial Government veterinary presently located at (a) Penticton and (b) Nelson?
- 2. If the answer to No. 1 is yes, (a) what are their names and (b) when did they commence at said centres?
- 3. If the answer to No. 1 is no, (a) is it the intention to appoint veterinaries at these centres and (b) if so, when?

The Hon. N. P. Steacy replied as follows:—

- "1. (a) No; official veterinary service provided by a Federal veterinarian stationed at Penticton and by the Provincial Veterinary Inspector from Kamloops. A qualified veterinarian resides and practises in the area; he can be used as a Provincial Deputy Veterinary Inspector when necessary. (b) No. A Federal Veterinary Inspector and a private practising veterinarian, both located at Creston, provide service for the East and West Kootenays. A Provincial Veterinary Inspector visited all outlying areas of those regions this winter to carry out certain responsibilities not otherwise handled.
  - "2. See answer to No. 1.
- "3. (a) It is not intended to appoint a Provincial Veterinary Inspector at Penticton. A Provincial Veterinary Inspector will be located probably at Nelson to carry out official responsibilities in the Kootenay-Grand Forks-Boundary areas. (b) Approximately in May or as soon thereafter as the progress of the brucellosis-control programme in the Lower Mainland permits."

Mr. Strachan asked the Hon. the Minister of Agriculture the following questions:—

- 1. Did any milk shippers have their licences cancelled during the calendar year 1959?
- 2. If the answer to No. 1 is yes, (a) if so, how many and (b) how many licences were cancelled in (i) the Fraser Valley and (ii) Vancouver Island?

The Hon. N. P. Steacy replied as follows:—

- " 1. Yes.
- "2. (a) 194; (b) (i) Fraser Valley, 166, of which 117 resulted from discontinued operations which resulted mainly from the sale of entire milking herds to new owners who had the daily quotas transferred to them. In such cases it was necessary to cancel the licence of the former owner. In some cases the sale or lease of a farm was involved. Forty-nine of the cancellations were from unsatisfactory farm premises or milk quality which could be reinstated on complying with regulations. (ii) Vancouver Island, ten, of which seven resulted from discontinued operations and three from unsatisfactory farm premises or milk quality which could be reinstated on complying with regulations."

Mr. Gargrave asked the Hon. the Premier and President of the Council the following questions:—

- 1. Why is the British Columbia Toll Highways Authority not using for the Vancouver-Victoria ferry system the wharf facilities provided by the Federal Government at Sidney?
- 2. Is the Federal wharf at Sidney used by the Washington State Ferries all year around?
  - 3. What has been the total cost of establishing a ferry terminal at Swartz Bay

for (a) wharf, (b) road approaches, and (c) other facilities?

4. Would the provision of a ferry designed for double-ended control and propulsion have enabled the present Sidney wharf to be used?

The Hon. W. A. C. Bennett replied as follows:-

"1. Not adequate.

"2. Not under Provincial jurisdiction.

"3. Not completed.

"4. Present ferry recommended for this service."

Resolved, That the House, at its rising, do stand adjourned until 8 o'clock p.m. to-day.

#### MR. SPEAKER:

Your Select Standing Committee on Public Accounts and Printing begs leave to report as follows:—

Moved by Mr. Strachan, seconded by Mr. Harding, that the Committee be authorized to carry on an investigation of vouchers and that requests for vouchers be made to the Chairman. Motion carried.

Your Committee held several meetings to peruse the accounts and is pleased to advise that all accounts examined were found to be in order.

Your Committee is pleased to report that progress has been made in the method of accounting in the Department of Highways as is shown in the report of that Department.

Your Committee noticed the wide difference between the total price given in accepted tenders for some highway construction and the final over-all cost of the work done. Therefore, your Committee recommends that, in fairness to all contractors bidding on such work, the greatest possible effort should be made by the Engineering Department to have original quantity estimates as called for in bids as close as possible to the quantities which are to be handled in the completion of the job.

Your Committee commends the Comptroller-General for his co-operation in making available to your Committee all vouchers and matters that were requested

of him and is pleased with the operation of his department.

Your Committee summoned Mr. Willard E. Ireland, Chairman of the Public Documents Committee, established by the "Public Documents Disposal Act," as amended by chapter 27 of the Statutes of British Columbia, 1953, and, having heard the submission on behalf of the Public Documents Committee, recommends that, in accordance with the provisions of the "Public Documents Disposal Act," approval be given for the destruction of the various public documents as listed in the submission of the Public Documents Committee in so far as the following departments of Government are concerned:—

#### REPORT.

LEGISLATIVE COMMITTEE ROOM, March 16th, 1960.

MR. SPEAKER:

Your Select Standing Committee on Forestry and Fisheries begs leave to report as follows:—

Pursuant to motion of February 26th, 1960, your Committee was ordered convened to study the following matter:—

"To consider special bidding practices which might be introduced for timber sales which occur in seriously overcommitted public working circles and to hear such persons as may wish to make representation on this and related matters."

Four meetings were held by your Committee and representations were heard from the following:—

(1) Mr. Swannell, of the Department of Lands and Forests.

- (2) Mr. Battle, representing the Cariboo—P.G.E. Lumber Manufacturers.
- (3) Mr. McRae, of the Cariboo—P.G.E. Lumber Manufacturers.

(4) Mr. Ian McQueen, consulting forester.

(5) Mr. John Bene, president of the Western Plywood Company.

(6) Mr. C. D. Grove-White, representing Mr. Bycyek.

(7) Mr. Dunham, president of the B.C. Loggers Association.

(8) Mr. Hodgins, representing B.C. Loggers Association.

It was established that there are three types of managed areas which could be described as follows:—

(1) Hopeless—such as the Okanagan.

(2) Controlled—where sustained yield can be applied.

(3) Border-line—such as the areas under consideration—namely, Lac la Hache and Williams Lake.

These areas are being badly overcut, which has brought about very competitive bidding for the available timber. This has resulted in such timber being bid beyond economic limits and some solution was sought to resolve the situation where too many operators were pursuing too little timber.

Your Committee feels that the area should be retained as a sustained-yield unit. The possibility of cutting small trees was not considered feasible unless a pulp-mill were established at the present time, and there seems to be no danger that an appreciable amount of timber will be lost by overmaturity although the possibility does exist that the cut may be increased after a comprehensive survey.

The question of enlarging working circles was suggested but is impossible to implement because of the fact that this would necessitate encroachment on other working circles. The grouping of several working circles would also not necessarily solve anything but would only extend the problems to other units.

The facts of the matter were crystal clear to your Committee, and they feel that they achieved in their recommendations, which this report will reveal, measures which contain not only a practical but also a humane approach to a very difficult situation.

Livelihood of people is involved, with all the built-in factors such as desire to live in a certain area, community development, education of children, and future development. We do not consider that these matters are unrelated to the cold economics inherent in this problem.

Your Committee is hopeful that the main premise of our submission—namely, sealed bids with first refusal to the initiator—will enable a gradual easement of the prevailing situation with the least amount of serious disruption to the general economy of the areas concerned, coupled with a real desire to see that fair treatment to all is not only intended but, all things being considered, very apparent.

As a result of submission and our own deliberations, your Committee is recommending at this time the following proposals:—

- (1) Where the present cut in a sustained-yield unit exceeds 150 per cent of the allocated cut, that area shall be declared an emergency area.
- (2) That in emergency areas quota holders be entitled to put up timber sales by either of the following methods:—
  - (a) By public auction, in which event anyone might bid on the sale.
  - (b) By sealed tender, in which event quota holders in the sustainedyield unit only may bid on the sale, with the quota holder who initiates the sale retaining the right of first refusal on the top bid.

- (3) That consideration for compensation be made in timber-sale contracts to reimburse present quota holders for certain residual values of fixed assets that will be used by the successful bidder in the event that the quota holders are unsuccessful, this to be done in a manner similar to the practice presently in effect concerning resales.
- (4) Your Committee recognizes that the problem of overcutting within emergency areas is of such magnitude that a careful review of the proposed legislation is warranted by the Forest Service and the Select Standing Committee on Forestry and Fisheries at the 1961 sitting of the Legislature.

All of which is respectfully submitted.

MR. SPEAKER:

Your Select Standing Committee on Labour begs leave to report as follows:—
Pursuant to motion on February 5th, 1960, your Committee was ordered convened to study the matter of the effects of automation upon British Columbia's people and economy.

The following appeared and made submissions and written briefs:—

Submissions (listed alphabetically): British Columbia Federation of Labour, Canadian Manufacturers' Association, International Brotherhood of Railway Transport and General Workers, and International Union of Mine, Mill and Smelter Workers.

Briefs: International Railway Brotherhoods, Industrial Association of British Columbia, and Industrial Relations, Building and Construction Industries.

Statistics and information were not readily available to accurately delineate the effects of automation upon British Columbia's people and economy at this time. Many factors have to be considered.

Although the Committee was limited to considering the Provincial aspects of automation, nevertheless we recognize that the problem was substantially national in scope.

In view of the importance of the situation and the complex nature of the problem, those who presented briefs and records to the Committee required more time than the Committee was able to allow under the circumstances.

The Committee would recommend that the Government, through the appropriate Departments, especially Education and Labour, consider instituting and request and encourage others to institute extensive studies of the effects of automation so that more comprehensive data and information may be readily available.

The Committee considers it is not possible to submit a comprehensive report using as the basis for such report the material that has been received up to this time. As many other aspects and facets of the subject remain to be considered and studied, members of the Committee recommend that the effects of automation upon British Columbia's people and economy be again referred to the Select Standing Committee on Labour for further investigation.
