That there should be established in this Colony a system of Common Schools conducted by thoroughly competent trained teachers wherein the physical intellectual and moral training would be such as to make the Schools attractive to all classes of the people. That provision be made for Separate Schools for females presided over by female teachers when practicable.

That in a community such as this where religious opinions are so diversified and where the benefits of a well devised Educational System should be extended to all, the reading of the Bible or the inculcation of religious dogmas in "Common Schools" would be unadvisable.

It is to be regretted that no permanent fund for "School purposes" has yet been created by the setting apart of certain portions of Crown Lands in each district. But as the Legislature has no control over these Lands Your Committee would recommend Your Honorable House to address His Excellency the Governor praying that such provision may now be made in the settled and other districts of the Colony in view of present and future requirements.

That an appropriation be made annually out of the General Revenue for the Establishment and maintenance of Common Schools in the settled districts of the Colony and in the City of Victoria.

That in the present stage of development of the Colony the following is submitted as the most appropriate method of inaugurating and carrying out a System of "Common Schools."

- 1. That a General Board of Education consisting of nine persons should be appointed by the Governor in Council.
- 2. That there be three School Trustees elected by the Residents of each School District.
- 3. That the appointment of a paid Superintendent should be made by the said Board subject to the approval of His Excy. the Governor.
- 4. That the Board of Education with the advice and assistance of the Superintendent should be empowered to establish School districts and their boundaries, to appoint teachers, to select books and to regulate all other matters connected with the organisation and general management of "Common Schools."

Your Committee would respectfully submit the above as briefly embracing the general principles upon which A School Act should be based and they would urge upon Your Honorable House the immediate necessity of the introduction and passage of such An Act.

Resolved that A Copy of the Resolutions as amended be transmitted to His Excellency the Governor.

Ordered that Report be received.

Ordered for tomorrow.

Mr. Speaker read A Communication from His Excellency the Governor (No. 30) as follows.

No. 30

Vancouver Island Victoria, 31st Oct. 1864

To the Honble. The Speaker and Members of the Legislative Assembly Gentlemen.

I have the honor to submit for the information and consideration of the Legislative Assembly the Copy of a Despatch received from Her Majesty's Secretary of State for the Colonies.

The management of the Crown Revenues of this Colony is at present on a most unsatisfactory footing, and I would earnestly desire the final decision of the Legislature on the proposal of Her Majesty's Government with reference thereto before I assume the undivided responsibility of applying the necessary reforms. The inconveniences and injuries to the public interests arising from the present uncertain and unsettled state of this question, are serious and numerous.

The consideration of the important subject of emigration must be deferred pending its settlement. The growing difficulties with the Indian population must continue to increase while the extent of their lands is undefined and their just claims unliquidated.

The Estimates for the Year 1865 cannot for the same reason be prepared or

proper provision made for the conduct of the Government.

The House will learn from the Despatch now laid before them that it is incumbant upon me, in the event of their declining to take over the Crown Revenues, to furnish in respect of those Revenues, Estimates for the ensuing Year and Accounts of the Receipts and Expenditure for past years with a view to their being properly audited.

This course will necessitate the adjustment of the Account between the local Government and the Crown and a refund of the amount advanced from the Crown Revenues for Colonial purposes under the Resolutions of Indemnity passed by the Legislative Assembly on 2nd July 1864 together with all other Sums appropriated without due authority. There are numerous minor complications and difficulties

daily arising out of this unsettled question.

It may be proper for me to state my opinion that, whatever the decision arrived at by the House on the question, it will in no way impair the rights of the Colony or prejudice the claims asserted by the Legislative Assembly against the Hudson's Bay Co. in their Resolutions of the 27th June 1864.

#### Schedule

I, A. B. do hereby swear that I am the said A. B. mentioned in the revised list of Voters for the City of Victoria, and that I am entitled in my own right to vote for the election of a Mayor (or two Councillors for the ward of \_\_\_\_\_\_ as the case may be) in respect of (describe the nature of the qualification whether freehold or leasehold specifying the block and lot and where situated).

In the preamble, line 12 strike out the word "exceed" and insert "extend."

The foregoing Amendments were taken up seriatim, agreed to, and Read a 1st time and The Standing Orders having been suspended Read a 2nd [time] and passed.

That it be further recommended that the entire management of the improvement of Victoria Harbour be placed in the hands of a Commission of Five persons selected by the Governor from the Inhabitants of Victoria City and that the Executive be empowered to appoint an Engineer at a Salary not exceeding £500 per annum to be under the orders of the said Commissioners.

4. That this Resolution be transmitted to His Excellency the Governor. Ordered that report be adopted.

That this House deplores the unsettled condition of the Crown Lands question and the injury and inconvenience resulting to the Colony and to the Executive, therefrom; but, willing as it is to grant a liberal Civil List and to co-operate with the Executive for the efficient Government of the Colony, This House feels imperatively called upon in justice to itself to first make an appeal to the justice and consideration of H. M.'s Government.
