 - (b) annual allowable cuts and quota distribution;

(c) guaranteed wood supply for pulp-mills depending upon waste rather than wood for their raw material;

(2) the reforestation programme with relation to the needs, timing, and future plans.

On the motion for the second reading of Bill (No. 2) initialed An Act to Facilitate the Implementation of Section 3 (c) of the Agreement Made the Eighth Day of July, 1963, between Canada and British Columbia Consequential upon the Columbia River Basin Treaty Made between Canada and the United States of America a debate arose, which was, on the motion of Mr. Nimsick, adjourned to the next sitting of the House.

On the motion for the second reading of Bill (No. 3) intituled An Act to Amend the Land Act a debate arose, which was, on the motion of Mr. Harding, adjourned to the next sitting of the House.

On the motion for the second reading of Bill (No. 4) intituled An Act to Amend the Notre Dame University of Nelson Act a debate arose, which was, on the motion of Mrs. Dailly, adjourned to the next sitting of the House.

On the motion for the second reading of Bill (No. 5) intituled An Act to Amend the Provincial Home-owner Grant Act a debate arose, which was, on the motion of Mr. Strachan, adjourned to the next sitting of the House. On the motion for the second reading of Bill (No. 6) intituled An Act to Amend the Provincial Home-acquisition Grant Act and to Make Additional Appropriation for the Purposes of That Act a debate arose, which was, on the motion of Mr. Strachan, adjourned to the next sitting of the House.

8 Mr. *Perrault* asked the Hon. the Minister of Lands, Forests, and Water Resources the following questions:—

1. With respect to the Pollution Control Board, during the year ended December 31, 1967, how many (a) closed meetings and (b) open hearings were conducted by the Board?

2. Were any of the meetings convened to consider applications for the disposal of effluent in lakes, rivers, or streams in this Province?

3. If the answer to No. 2 is yes, (a) how many applications were approved and (b) how many applications were rejected?

The Hon. R. G. Williston replied as follows:----

"1. (a) 11 and (b) one.

"(NOTE.—The Director of Pollution Control conducted independently one public hearing and one inquiry.)

"2. Three meetings were convened under the first Pollution Act. Under the existing Act the issuance of permits is a responsibility of the Director of Pollution Control.

"3. (a) 40 and (b) 43."

9 Mr. *Perrault* asked the Hon. the Minister of Lands, Forests, and Water Resources the following question:—

With respect to pollution control, by fiscal years 1965/66 and 1966/67, how much money was expended (a) for pollution-control measures and (b) for studies and surveys?

The Hon. R. G. Williston replied as follows:—

"(a) \$25,651 in 1965/66, \$55,741 in 1966/67, and (b) \$18,352 in 1965/66 included in (a) and \$32,556 in 1966/67 included in (a).

"The above figures do not include water sampling which was carried out by the Department of Health."

42 Mr. Eddie asked the Hon. the Minister of Labour the following questions:---

With respect to commercial fishermen applying for workmen's compensation as independent operators during 1967:—

1. Did any apply for compensation, and, if so, how many and how many in each month?

2. What was the total number of months where compensation coverage was provided?

3. What were the total payments paid to the Workmen's Compensation Board therefor?

4. How many claims were made for the following: (a) Death claims, (b) claims for temporary total disability, (c) claims for permanent partial disability, and (d) claims for permanent total disability?

5. How many of the claims were approved and how many were rejected?

6. What was the total amount of money paid out by the Workmen's Compensation Board pursuant thereto?

7. Were any of the claims rejected solely on the grounds that the fishermen concerned had not paid a premium for coverage?

8. Did any suffer fatal accidents?

9. If the answer to No. 8 is yes, how many were covered by workmen's compensation under (a) the independent operators' plan and (b) those sections of the Act which define certain categories of fishermen as workmen?

10. Did any commercial fishermen suffer either temporary total disability, permanent partial disability, or permanent total disability, and, if so, how many of these were covered by workmen's compensation (a) as workmen under the Act or (b) as independent operators?

The Hon. L. R. Peterson replied as follows:-

"1. Yes. 1,950, as follows: January, 183; February, 85; March, 249; April, 246; May, 575; June, 349; July, 153; August, 40; September, 24; October, 32; November, 11; and December, 3.

"2. 9,737. An average of slightly under five months per individual.

" 3. \$128,186.94.

"4. (a) 2, (b) 57 approved, 6 disallowed, (c) 6, and (d) nil.

" 5. Sixty-five claims were approved and six claims were disallowed.

"6. \$116,925.96. This amount does not include any provision for amounts still to be paid on unfinalled claims or any provisions for administration charges or other special levies to the class funds.

"7. No.

"8. Yes, three.

"9. (a) Two and (b) one.

"10. Yes. (a) 133 and (b) 65.

"The context of Questions 8, 9, and 10 indicates that these pertain to commercial fishermen who suffered industrial accidents during 1967 and they are so answered."

114 Mr. *Hall* asked the Hon. the Minister of Lands, Forests, and Water Resources the following questions:—

With reference to the Pollution Control Board hearings held in North Surrey, August 21 to 24, 1967:—

1. Were any steps taken to (a) advertise the hearings publicly and (b) inform community, business, and trade-union groups?

2. If the answer to No. 1 is yes, (a) which newspapers, radio stations, and television stations were used, and what was the cost of advertising to each media, and (b) which organizations were informed?

3. What was the total number of submissions made to the hearing and who were they made by?

The Hon. R. G. Williston replied as follows:-

"1. (a) and (b) Yes.

"2. (a) The 'Notice of a Public Hearing' was advertised in the Vancouver Sun, the Vancouver Province, and the New Westminster Columbian; total cost was \$150; and (b) the organizations informed personally included each of the municipalities in the Lower Mainland region abutting the river, 24 in all; the Lower Mainland Regional Planning Board, Canadian Department of Fisheries, the Greater Vancouver Sewerage and Drainage District, the Metropolitan Board of Health, B.C. Wildlife Federation, United Fishermen and Allied Workers' Union, Fisheries Association of B.C., Department of Health and Welfare, and the information pertaining to the hearing was also deposited with the Vancouver Public Library.

"3. Eight agencies appeared at the hearing, and five of these presented written briefs, the others made verbal statements. Briefs were submitted at the hearing by the B.C. Wildlife Federation, Greater Vancouver Sewerage and Drainage District, District of Surrey, United Fishermen and Allied Workers' Union, and the Fish and Wildlife Branch. The Lower Mainland Regional Planning Board submitted a brief after the hearing. Verbal statements were made by Pacific Trollers' Association and the Boundary Health Unit."

(a) Total acreage 2,039,991 acres, of which 991,748 acres are productive vacant Crown forest land and 349,325 acres are private productive forest land, (b) a tree-farm licence contract provides for a nominal annual rental of 1 cent per acre on all productive Crown forest land in a licence area but, in addition, 'there is due and payable to the Crown, on all timber on Crown lands not held under other tenure, stumpage, inclusive of royalty, as and when the timber is cut, in such sum per unit of measurement as shall be appraised and assessed by the Forest Service.' (See subsection (20) of section 36 of the Forest Act.) For revenue purposes, the receipts from cutting permits on tree-farm licences are included with timber sales, and the information for individual tree-farm licences is not available, and (c) no information."

180 Mr. *Barrett* asked the Hon. the Minister of Lands, Forests, and Water Resources the following questions:—

Regarding forest land in British Columbia:-

1. Is any owned by Crown Zellerbach Company Limited?
