# Thursday, 20th January, 1910.

THREE O'CLOCK, P.M.

This being the first day of the first meeting of the Twelfth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour the Honourable JAMES DUNSMUR, late Lieutenant-Governor of the Province, dated the 18th day of October, 1909, the Members having been sworn took their seats.

His Honour THOMAS WILSON PATERSON, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Honourable Dr. Young, Provincial Secretary, said :---

#### Gentlemen of the Legislative Assembly :

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

Mr. *McPhillips*, Member for The Islands District, addressing himself to the Clerk of the House, moved, seconded by Mr. *Jardine*, Member for Esquimalt District, that *D. M. Eberts*, Esquire, Member for Saanich District, do take the Speaker's Chair and preside over the meeting of this Assembly, and it was so Resolved.

Mr. *Fell*, the Clerk of the House, having declared *David McEwen Eberts*, Esquire, duly elected, he was taken out of his place by the mover and seconder, and conducted to the Chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect :---

#### MAY IT PLEASE YOUR HONOUR :

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Honourable Dr. Young then said :---

#### MR. SPEAKER :

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper and prudence, he grants, and upon all occasions will recognise and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and that their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech :----

#### Mr. Speaker and Gentlemen of the Legislative Assembly:

In assuming your duties at this, the First Session of the Twelfth Parliament of British Columbia, you find the trade and industries of the Province in an exceptionally satisfactory condition, a state of affairs upon which I am greatly pleased to congratulate you and the country at large. Healthy and substantial progress has been most marked, and it is gratifying to note the great and increasing development in the northern portion of British Columbia I would impress upon you that a continuance of this prosperity will be materially aided by your efforts in the enactment of wise and progressive legislation.

During the past year the Province was honoured by an informal visit from His Excellency Earl Grey, Governor-General of Canada, and I take this occasion to advert to the very favourable impression which he created through his urbane and cordial demeanour towards all and his marked interest in the industrial affairs and social life of the community.

The visit to this Province last year of Lord Strathcona, High Commissioner for Canada, evinced the great interest which he has always taken in this part of the Dominion.

Before proceeding to outline the various matters of business with which you will be asked to deal, I count it a privilege to testify to the sterling qualities of my esteemed predecessor, the Honourable James Dunsmuir, and to assure him of the respect in which he is held by the people of British Columbia as a result of the worthiness and dignity with which he discharged the duties of his high office.

It is eminently fitting to refer to the celebration at New Westminster during the month of October last, of the fiftieth anniversary of the landing in British Columbia of the Royal Engineers, a body of men whose remarkable pioneer work in opening up the Province is most worthy of commemoration. It is gratifying that I am enabled to inform you that the financial condition of the Province is the most satisfactory in its history, showing such a substantial surplus as to permit of a considerable reduction in taxation, while not interfering with the expenditures necessary to the efficient administration of Provincial affairs.

It is also a pleasure to note that the reorganisation of the Department of Agriculture, undertaken a year ago, is already producing gratifying results.

I am pleased to observe the honours won by British Columbia fruit at the exhibitions in Canada, Great Britain and the United States, and to congratulate our fruit-growers on the success which has crowned their efforts. The fruit exhibit from this Province again won the highest honours and the gold medal at London, in competition with the whole Empire.

Several important measures will be submitted for your consideration, chief of which will be those relating to the construction of new railways and the extension of existing lines.

You will be asked to pass upon a contract providing for the building of some six hundred miles of trunk line, with provisions for branches and connections, by the Canadian Northern Railway Company, by means of which it is contemplated to furnish transportation facilities to a very extensive and valuable section of the Province, and materially reduce the cost of freight and passenger traffic.

A Bill will also be submitted to you to enable an extension of the Kettle River Valley Railway from its present terminus to Nicola. This railway, as well as the Canadian Northern, will run through districts richly endowed with timber and minerals, and with agricultural, fruit and pastoral lands, the development of which has heretofore been retarded for lack of railway communication.

Acting upon authority granted by the Legislature at the last Session, Commissioners have been appointed to revise and consolidate the Statutes of the Province, and this important work will be proceeded with immediately.

In order to secure the most suitable site for the University of British Columbia you will be asked to confirm the appointment of a Commission, composed of disinterested professional gentlemen, to whom will be assigned the task of selecting a location for that Institution.

The Forestry Commissioners have collected a great mass of valuable information and evidence bearing upon the subject of their investigations, the primary results of which will be presented to you in the form of an Interim Report.

At the request of the Imperial Government, and with a view of having uniform laws throughout the Empire relating to Companies, your assistance will be invoked in simplifying and consolidating the various Acts in relation to Companies.

As some apprehension appears to exist among licensees of timber lands as to the effect of the terms upon which licences are held, it is proposed to settle the question as to the continuity of tenure of these licences by an amendment to the Land Act.

On account of the great increase in the work of the Provincial Courts, it has been deemed advisable to call into force by Proclamation the "Court of Appeal Act, 1907." The establishment of this Court will greatly facilitate the Administration of Justice and tend to lessen the costs and avoid the delays of litigation.

As questions have arisen as to the jurisdiction, rights and privileges possessed by British Columbia in the fisheries, water rights within the Dominion Railway Belt, and as to title in the lands known as Indian Reserves, my advisors have taken steps to bring about a determination of these matters.

The Civil Service Commissioners have completed the work of grading, classifying and adjusting the salaries of the members of the Civil Service, and the results of their findings will be laid before you.

The Public Accounts for the past fiscal year will be laid before you early in the Session.

The Estimates of Expenditure for the coming year, which have been calculated with the object of securing the best results in the public interest, while having due regard for economy, will be submitted for your favourable consideration.

Gentlemen, in leaving you to your deliberations, I assure you of my confidence that the work entrusted to you will be well and faithfully performed.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Lord Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes :---

1. On Standing Orders and Private Bills;

2. On Public Accounts;

3. On Printing;

4. On Railways;

5. On Mining;

6. On Agriculture ;

7. On Municipal Matters;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons and records.

*Resolved*, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. Bowser, Bill (No. 1) intituled "An Act to amend the Public Inquiries Act," was introduced and read a first time.

To be read a second time at the next sitting of the House.

On the motion of the Hon. Mr. *McBride*, seconded by the Hon. Mr. *Bowser*,— *Resolved*, That the Speech of His Honour the Lieutenant-Governor be taken into considgration on Friday, January 21st, instant.

The Hon. the Minister of Finance presented the Public Accounts of the Province for the fiscal year ending 31st March, 1909.

The Hon. the Provincial Secretary presented the Annual Report of the Provincial Board of Health.

The Certificate of the Return of Members elected to represent the Electoral Districts of the Province in the Legislative Assembly was presented by the Clerk and Ordered placed on the Journals of the House.

Pursuant to Order, the House proceeded to take into consideration the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

Mr. Miller moved, seconded by Mr. Mackenzie,—

That an humble Address be presented to His Honour the Lieutenant-Governor, thanking His Honour for his gracious Speech at the opening of the present Session, and further assuring His Honour that :—

1. It is highly gratifying to find that upon the opening of the First Session of the Twelfth Parliament of British Columbia the trade and industries of the Province are in an exceptionally satisfactory condition, and that great and increasing development is taking place in the northern portion of British Columbia. We are convinced that a continuance of this prosperity will be materially aided by the enactment of wise and progressive legislation.

2. We have noted with pleasure the very favourable impression which His Excellency Earl Grey, Governor-General of Canada, created through his urbane and cordial demeanour towards all, and his marked interest in the industrial affairs and social life of the community, upon the informal visit which His Excellency made to this Province during the past year.

3. We were also pleased to observe that last year Lord Strathcona, High Commissioner for Canada, evinced the great interest which he has always taken in this part of the Dominion by paying a visit to British Columbia.

4. We join His Honour in testifying to the sterling qualities of His Honour's esteemed predecessor, the Honourable James Dunsmuir, and in assuring him of the respect in which he is held by the people of British Columbia, as a result of the worthiness and dignity with which he discharged the duties of his office, and we take this opportunity of congratulating the people of the Province upon the appointment of His Honour to the high office of Lieutenant-Governor of British Columbia in succession to the Honourable James Dunsmuir.

5. It was eminently fitting that in the month of October last there was celebrated at New Westminster the fiftieth anniversary of the landing in British Columbia of the Royal Engineers. We heartily agree with His Honour that they were a body of men whose remarkable pioneer work in opening up the Province is most worthy of commemoration.

6. It is gratifying to be informed that the financial condition of the Province is the most satisfactory in its history, showing such a substantial surplus as to permit of a considerable reduction in taxation, while not interfering with the expenditures necessary to the efficient administration of Provincial affairs.

7. It is also a pleasure to note that the reorganisation of the Department of Agriculture, undertaken a year ago, is already producing gratifying results.

8. We are pleased to observe the honours won by British Columbia fruit at the exhibitions in Canada, Great Britain and the United States, and to congratulate our fruit-growers on the success which has crowned their efforts—the fruit exhibit from this Province having again won the highest honours and the gold medal at London in competition with the whole Empire. 9. The important measures relating to the construction of new railways, the extension of existing lines, and the contract providing for the building of some six hundred miles of trunk line, with provision for branches and connections, by the Canadian Northern Pacific Railway Company, by means of which it is contemplated to furnish transportation facilities to a very extensive and valuable section of the Province, and materially to reduce the cost of freight and passenger traffic, will receive our most careful consideration.

10. We regard the extension of the Kettle River Valley Railway from its present terminus to Nicola as very important, as this railway, as well as the Canadian Northern Pacific, will run through districts richly endowed with timber and minerals, and with agricultural, fruit and pastoral lands, the development of which has heretofore been retarded by lack of railway communication.

11. It is, no doubt, advisable that the important work of revising and consolidating the Statutes of the Province should be proceeded with immediately.

12. In order to secure the most suitable site for the University of British Columbia we shall confirm the appointment of a Commission, composed of disinterested professional gentlemen, to whom will be assigned the task of selecting a location for that Institution.

13. We are pleased to be informed that the Forestry Commissioners have collected a great mass of valuable information and evidence bearing upon the subject of their investigations, the primary results of which will be presented to us in the form of an Interim Report.

14. We deem it proper that with a view of having uniform Company laws throughout the Empire, the various Acts in relation to Companies should be simplified, consolidated and as far as expedient brought into conformity with the "Imperial Companies Consolidation Act, 1908."

15. As some apprehension appears to exist among licensees of timber lands as to the effect of the terms upon which licences are held, we think it expedient to settle the question as to the continuity of tenure of these licences by an amendment to the Land Act.

16. On account of the great increase in the work of the Provincial Courts, we have no doubt it was advisable to call into force by Proclamation the "Court of Appeal Act, 1907," and that the establishment of this Court will greatly facilitate the Administration of Justice and tend to lessen the costs and avoid the delays of litigation.

17. As questions have arisen as to the jurisdiction, rights and privileges possessed by British Columbia in the fisheries of the Province, in water rights within the Dominion Railway Belt, and as to title to the lands known as Indian Reserves, we consider His Honour's advisors have acted in the interests of the Province in taking steps to bring about a determination of these matters.

18. We are pleased to be informed that the Civil Service Commissioners have completed the work of grading, classifying and adjusting the salaries of the members of the Civil Service, and that the results of their findings will be laid before us.

19. The Public Accounts for the past fiscal year, and the Estimates of Expenditure for the coming year, when submitted to us, will receive our most careful consideration.

A debate arose, which was adjourned until the next sitting of the House.

Resolved, That the House, at its rising, do stand adjourned until two o'clock on Monday next.
