Thursday, 20th February, 1902.

THREE O'CLOCK, P.M.

This being the first day of the third meeting of the Ninth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour the Honourable Sir HENRY GUSTAVE JOLY DE LOTBINIERE, Lieutenant-Governor of the Province, dated the ninth day of January, 1902.

His Honour the Honourable SIR HENRY GUSTAVE JOLY DE LOTBINIÈRE, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Honourable Mr. Prentice, Acting Provincial Secretary, said-

Gentlemen of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Member to preside over your Honourable Body, on account of the severe illness of the Speaker, who cannot attend. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

Mr. Price Ellison, Member for East Yale, addressing himself to the Clerk of the House, moved, seconded by Mr. Joseph Martin, Member for Vancouver, that Charles Edward Pooley, Esquire, second Member for Esquimalt District, do take the Speaker's Chair and preside over the meeting of this Assembly, and it was so Resolved.

Mr. *Fell*, Clerk of the House, having declared *Charles Edward Pooley*, Esquire, duly elected, he was taken out of his place by the mover and seconder and conducted to the Chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Presiding Member.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

MAY IT PLEASE YOUR HONOUR :

The House of Assembly having elected me as their Presiding Member though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Honourable Mr. Prentice then said-

MR. PRESIDING MEMBER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper and prudence, he grants, and upon all occasions will recognize and allow, their constitutional rights.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and that their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech :----

Mr. Speaker and Gentlemen of the Legislative Assembly:

I have much pleasure in welcoming you to the Third Session of the Ninth Parliament of British Columbia.

Since you last met the Province has been favoured with a visit from their Royal Highnesses the Duke and Duchess of Cornwall and York. The warm welcome and loyal enthusiasm which everywhere marked their reception demonstrated to them the continued and increasing devotion of his subjects in this part of the Empire to the person of His Majesty, and the very favourable impression produced on their Royal Highnesses was to me exceedingly gratifying.

I have to inform you that the Coronation of His Most Gracious Majesty King Edward VII. will take place on the 20th of June proximo. The Premiers of the several Provinces of Canada have been officially asked to attend, and it has been my pleasing duty to convey to His Excellency, on behalf of my First Minister, an acceptance of this invitation.

It is to be regretted that the war in South Africa unavoidably still continues. There is, however, every indication of hostilities being brought to a satisfactory conclusion at an early date, when an opportunity will be afforded to the citizens of this Province bearing arms there to return to their homes.

In view of the unfavourable conditions which affected the mining industry during 1901, it is especially gratifying to know that the output of the mines considerably exceeded that of any previous twelve months, and that the year closed with several detrimental causes removed, and with prospects of greatly increased activity and development.

Negotiations with the authorities at Ottawa, begun last year, have been continued by my Government, and a conference has been agreed to for the further discussion of matters affecting the relations of the Province of British Columbia and the Dominion of Canada under the Terms of Union.

A report will be laid before you concerning the results of the Commission to enquire into, and adjust where possible, freight rates on agricultural products. It is satisfactory to state, as a consequence, that substantial reductions have been made, and shipping facilities have been improved. It is also a matter of very great satisfaction that the agricultural industry in this Province is so prosperous. To further the interests of the stock-raisers of the interior, a measure will be submitted providing for the establishment of a system of cold storage in connection with abattoirs.

The subject of fishery development is one which has been receiving greatly increased attention, and the efforts of my Government are in the direction of placing the industry on a more satisfactory footing.

Steps will be taken with a view to the introduction of a fair measure of redistribution.

Measures will be submitted for your consideration having for their object the encouragement of immigration and the settlement of unoccupied lands.

A measure will also be submitted for the purpose of consolidating existing Loan Acts, and of obtaining authority thereunder for the issuance of a new loan.

Under the authority of legislation of last Session, agreements have been entered into with several companies for the manufacture of pulp and paper, and negotiations are now being carried on for the establishment of these industries.

Negotiations are being carried on for the purpose of securing the construction of a railway from Bute Inlet to Yellowhead Pass, to connect with the railway system on Vancouver Island, and for the construction of the Coast-Kootenay Railway.

Legislation will be introduced dealing with taxation and assistance to hospitals.

Estimates of Revenue and Expenditure have been carefully prepared with a view to strictest economy being exercised, and will be submitted without delay.

I now leave you to your deliberations, with the sincere trust and belief that your efforts will be productive of much good, and earnestly invoke on your behalf the Divine blessing.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Lord Bishop of Columbia.

Thomas Gifford, Esquire, Member elect for New Westminster City Electoral District, having been duly sworn, was introduced by R. McBride, Esquire, and C. W. Munro, Esquire, and took his seat.

Mr. Helmcken moved, seconded by Mr. McPhillips,-

That a Writ do forthwith issue for the election of a Member to fill the vacancy in the Assembly by the resignation and acceptance of office on the 3rd day of September, 1901, by the Honourable John Herbert Turner, one of the Members for the Victoria City Electoral District.

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

2. We learn with great pleasure that an invitation to be present at the coronation of His Most Gracious Majesty King Edward VII. on the twentieth of June next has been extended to His Honour's First Minister.

3. It is to be regretted that the war in South Africa still continues. It is most reassuring that there is every indication that hostilities will be brought to a satisfactory conclusion at an early date, and that an opportunity will thus be afforded to the citizens of this Province bearing arms there to return to their homes. 4. In view of the unfavourable conditions which affected the mining industry during 1901, it is especially gratifying to be informed that the output of the mines considerably exceeded that of any previous twelve months, and that the year closed with several detrimental causes removed, and with prospects of greatly increased activity and development.

5. It is most satisfactory that the negotiations between His Honour's Government and the Dominion authorities have resulted in an agreement that a conference shall be held for the further discussion of matters affecting the relations of the Province of British Columbia and the Dominion of Canada under the Terms of Union.

6. We shall carefully consider the report to be laid before us concerning the results of the Commission to enquire into, and adjust where possible, freight rates on agricultural products. We are pleased to be assured that as a consequence of the labours of the Commissioners substantial reductions have been made in freight rates. It is also a matter for very great satisfaction that the agricultural industry in the Province is in a prosperous condition.

7. Any measure submitted to us to further the interests of the stock-raisers of the interior by providing for the establishment of a system of cold storage in connection with abattoirs, shall receive our most careful consideration.

8. We are pleased to be informed that the subject of fishery development has been receiving greatly increased attention, and that His Honour's Government are making efforts to place the industry on a more satisfactory footing.

9. We recognize the necessity for a measure of redistribution which will ensure the fair representation of all parts of the Province.

10. We trust that the legislation of last Session, under which agreements have already been entered into with several companies for the manufacture of pulp and paper, will result in the successful establishment of this industry in the Province.

11. We have received with great satisfaction the assurance that negotiations are being carried on for the purpose of securing the construction of a railway from Bute Inlet to Yellow-head Pass, to connect with the railway system on Vancouver Island, and for the construction of the Coast-Kootenay railway.

12. Measures dealing with the encouragement of immigration, the settlement of unoccupied lands, the consolidation of existing Loan Acts, the issuing of a new loan, and with taxation and assistance to hospitals, shall have our most careful attention.

13. We thank His Honour for informing us that the Estimates of Revenue and Expenditure for the ensuing fiscal year will be submitted to us without delay. We are confident that they will be found to have been framed with every regard for economy, consistent with the efficiency of the public service.

14. His Honour may rest assured that the measures which may be brought before us shall receive our earnest consideration, and we trust that our deliberations, under the Divine guidance, will conduce to the prosperity and welfare of the people of the Province.

Mr. McBride moved in amendment, seconded by Mr. R. G. Tatlow,---

To strike out paragraph 9 and substitute the following therefor :---

"A Bill will immediately be introduced providing for a fair measure of redistribution, and will be put through its various stages with all celerity, and the House will be asked to give it precedence over all other Bills, so that it may be finally passed and assented to before any other Bills are read a second time."

A debate arose, which was adjourned until to-morrow.

That the House do adjourn to discuss the necessity for the Government bringing down, by three o'clock to-morrow, all correspondence and telegrams which have passed between any member of the Government and the Canadian Northern Railway Company and any person, and particularly the letters and telegrams received from or sent to Mr. Greenshields and relating to the proposed contract with the Canadian Northern Railway Company for the building of a line of railway from *Bute Inlet* eastward; the matter being urgent and pressing and of great public importance in discussing the proposed contract, and in order that it be properly discussed and understood in this House and by the electorate of the *City of Victoria*, where an election is now being held, in which a Minister of the Crown is a candidate, and claims that the proposed contract is his sole justification in being a candidate, and is sufficient reason why the electorate should elect him, and because there is grave doubt of the draft contract submitted to the House not having been materially modified by or through such correspondence.

A debate arose.

Mr. Speaker left the Chair at 6 o'clock.

HALF-PAST EIGHT O'CLOCK, P. M.

On the motion of Mr. Helmcken, seconded by Mr. McPhillips, it was Resolved,-

That an humble Address be presented to His Honour the Lieutenant-Governor requesting him to be laid before this House all correspondence between the Provincial Government, or any member thereof, and the Federal Government, or any member thereof, with reference to the Provincial Statutes of 1901, together with any report on the same.

The Hon. the Premier moved-

That the House, at its rising, do stand adjourned until two o'clock on Tuesday next.

Mr. McBride moved in amendment, seconded by Mr. Murphy,-

That the words "Tuesday next" be struck out, and the words "to-morrow afternoon" be inserted in lieu thereof.

Amendment negatived. Original motion agreed to.

The Hon. Edward Gawler Prior, being duly sworn, was introduced by the Hon. the Premier and the Hon. W. C. Wells, and took his place.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, and the amendment thereto moved by Mr. *McBride* on the 3rd inst.

Mr. Curtis moved in amendment, seconded by Mr. Hawthornthwaite,-

That paragraph 11 of the motion in reply to the Speech of His Honour the Lieutenant-Governor be struck out, and the following substituted therefor:—

"11. The proposed contract signed by the Canadian Northern Railway Company for the construction of a railway from *Bute Inlet* to *Yellowhead Pass* is not satisfactory, but efforts will not be relaxed to get this projected railway built.

"We hope, also, that a satisfactory arrangement will be soon made for the building of a railway to the north end of *Vancouver Island*, with a branch to *Alberni*, in which case proper control of all rates from *Victoria* to the northern terminus shall be conceded to the Province. The building of the *Coast-Kootenay* railway, either as a Government work or as a competitive line, will be arranged for, and the work of construction, if at all possible, will be begun during the coming summer."

And that the following new paragraph be added to the said motion in reply:---

"15. Measures for the re-enactment of the provisions contained in the Acts disallowed by the Dominion authorities, and known as the 'British Columbia Immigration Act, 1900,' and the 'Labour Regulation Act, 1900,' will be brought forward, and will contain additional safeguards for the protection of desirable residents of British Columbia."

And that a further new paragraph be added to the said motion in reply, as follows:----

"16. A measure will be introduced making provision that where assistance in land or money, or by valuable franchise beyond a certain estimated value, is proposed to be given by the Province to any private enterprise, such proposal shall not become effective until after the lapse of a certain time, during which the electorate of the Province, if a certain percentage thereof shall petition for a referendum, shall have such proposal submitted to the votes of the electors, and shall by a majority vote have approved of the same."

A point of order arose, as to whether the amendment could be moved at this stage.

Mr. Speaker Pooley reserved his decision.

The debate was adjourned until the next sitting of the House.

On the motion of the Hon. the Attorney-General, it was Resolved,---

That the Standing Rules and Orders be suspended, and the time limited for receiving Petitions for Private Bills be extended to the 15th March, instant.

The Hon. the Attorney-General presented the Fifth Annual Report of the Provincial Board of Health, A. D. 1901.

And whereas the Dominion of Canada and the Province of British Columbia have shown their loyalty and devotion to the cause of the Empire, and His Majesty the King has had signal proofs of such loyalty:

And whereas the people of the Province of British Columbia have an admitted grievance by reason of their attempts to protect themselves against the immigration of citizens of the Empires of Japan and China into this Province being frustrated :

And whereas the Right Honourable the Premier of the Dominion of Canada has accepted an invitation to be present at the coronation of Our Most Gracious Sovereign King Edward VII., and it is also proposed by the Colonial Premiers to hold a conference in the *City of London*, England, after the coronation:

Be it therefore Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, requesting him to communicate with the Right Honourable the Premier of Canada, asking him at such conference to bring to the attention of the Colonial Premiers this question of the admission into Canada of the citizens of the Empires of Japan and China, and to use their influence to cause the Imperial Government to take such steps with the Governments of Japan and China as will enable the question to be governed in such manner as will best accomplish this object.

A debate arose, which was adjourned until to-morrow.

On the motion of Mr. Tatlow, seconded by Mr. Green, it was Resolved, _____

That an Order of the House be granted for a Return giving an abstract of the receipts and expenditures of the Province for the half-year ending 31st December, 1901.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, and the amendment thereto moved by Mr. *McBride* on the 3rd inst., and the amendment moved by Mr. *Curtis* on the 11th inst.

Mr. Speaker *Pooley* gave the following decision on the point of order raised on the amendment moved by Mr. *Curtis*:—

The practice of dealing with the reply to the King's Speech has been varied in recent years, and it is desirable to have a definite practice laid down.

I therefore suggest to your honourable body that the following practice should be adopted upon the consideration of the reply to the Speech:--

The Speech should be dealt with as a whole.

Any member who has only spoken to an amendment may speak to the main question, and to any further amendment that may be proposed.

Only one amendment can be before the House at one time.

After an amendment to any paragraph of the reply has been put to the House, no amendment can be made to a previous paragraph.

Any member who has spoken to an amendment only may (if he has not moved or seconded a previous amendment), upon speaking to the main question, move an amendment.

The amendment moved by Mr. Curtis is, therefore, out of order at this stage.

Leave was given Mr. Curtis to move his amendment at a later stage.

Mr. Helmcken moved the following amendment :---

That this House regrets that in Your Honour's Speech no indication is given of the attitude of Your Honour's Ministry on the question relating to Mongolian and Oriental immigration, and in the absence of any protest on the part of Your Honour's advisers against the disallowance by the Dominion Government of the "Labour Regulation Act, 1900," and "British Columbia Immigration Act, 1900," which Acts should be re-enacted during the present Session.

That the Resolution to present an Address to His Honour the Lieutenant-Governor, thanking His Honour for His Gracious Speech, be referred to a Select Committee, composed as follows :---

The Honourable the President of the Council, the Honourable the Attorney-General, the Honourable the Chief Commissioner of Lands and Works, the Honourable the Provincial Secretary, and the Honourable the Minister of Mines.

The Honourable the Minister of Finance, from the Select Committee, reported an Address which read as follows :----

To the Honourable Sir HENRI GUSTAVE JOLY DE LOTBINIÈRE, Lieutenant-Governor of the Province of British Columbia:

We, His Majesty's dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Parliament assembled, humbly thank Your Honour for your gracious Speech at the opening of the Third Session of the Ninth Parliament, and assure Your Honour that :---

It is very gratifying to be informed that the warm welcome and loyal enthusiasm which everywhere marked the reception of their Royal Highnesses the Duke and Duchess of Cornwall and York upon their visit to this Province during the autumn of last year produced a most favourable impression upon their Royal Highnesses, as it demonstrated to them the continued and increasing devotion of His subjects in this part of the Empire to the person of His Majesty.

We learn with great pleasure that an invitation to be present at the coronation of His Most Gracious Majesty King Edward VII. on the twentieth of June next has been extended to Your Honour's First Minister. It is to be regretted that the war in South Africa still continues. It is most reassuring that there is every indication that hostilities will be brought to a satisfactory conclusion at an early date, and that an opportunity will thus be afforded to the citizens of this Province bearing arms there to return to their homes.

In view of the unfavourable conditions which affected the mining industry during 1901, it is especially gratifying to be informed that the output of the mines considerably exceeded that of any previous twelve months, and that the year closed with several detrimental causes removed, and with prospects of greatly increased activity and development.

It is most satisfactory that the negotiations between Your Honour's Government and the Dominion authorities have resulted in an agreement that a conference shall be held for the further discussion of matters affecting the relations of the Province of British Columbia and the Dominion of Canada under the Terms of Union.

We shall carefully consider the report to be laid before us concerning the results of the Commission to enquire into, and adjust where possible, freight rates on agricultural products. We are pleased to be assured that as a consequence of the labors of the Commissioners substantial reductions have been made in freight rates. It is also a matter for very great satisfaction that the agricultural industry in the Province is in a prosperous condition.

Any measure submitted to us to further the interests of the stock-raisers of the interior by providing for the establishment of a system of cold storage in connection with abattoirs, shall receive our most careful consideration.

We are pleased to be informed that the subject of fishery development has been receiving greatly increased attention, and that Your Honour's Government are making efforts to place the industry on a more satisfactory footing.

We recognize the necessity for a measure of redistribution which will ensure the fair representation of all parts of the Province.

We trust that the legislation of last Session, under which agreements have already been entered into with several companies for the manufacture of pulp and paper, will result in the successful establishment of this industry in the Province.

We have received with great satisfaction the assurance that negotiations are being carried on for the purpose of securing the construction of a railway from Bute Inlet to Yellowhead Pass, to connect with the railway system on Vancouver Island, and for the construction of the Coast-Kootenay railway.

Measures dealing with the encouragment of immigration, the settlement of unoccupied lands, the consolidation of existing Loan Acts, the issuing of a new loan, and with taxation and assistance to hospitals, shall have our most careful attention.

We thank Your Honour for informing us that the Estimates of Revenue and Expenditure for the ensuing fiscal year will be submitted to us without delay. We are confident that they will be found to have been framed with every regard for economy, consistent with the efficiency of the public service.

Your Honour may rest assured that the measures which may be brought before us shall receive our earnest consideration, and we trust that our deliberations, under the Divine guidance, will conduce to the prosperity and welfare of the people of the Province.

Whereas Smith Curtis, member of the Legislative Assembly for the Rossland Riding of the West Kootenay Electoral District, has upon the floor of this House, on the 18th day of March, 1902, charged "the Honourable James Dunsmuir, Premier of the Province of British Columbia, with negotiating to give an excessive subsidy—and without the proper safeguards

which he himself has heretofore declared to be necessary in the public interest—out of Provincial moneys and lands to the Canadian Northern Railway Company in aid of its building a line of railway from *Bute Inlet* to *Yellowhead Pass*, with a view either to the sale at a greater price than could otherwise be got of the *Esquimalt & Nanaimo Railway* and *Comox & Cape Scott Railway Companies'* railways and rights, or to the bringing of a much larger traffic over the last-mentioned railway lines, such lines being intended under such negotiations to be utilized in making *Victoria City* the western or Pacific Coast terminus of said Canadian Northern Railway, and the said Premier *Dunsmuir* being a large shareholder in the said *Esquimalt & Nanaimo* and *Comox & Cape Scott Railway Companies*, whereby the said Premier *Dunsmuir*, as a shareholder in said last-mentioned railway companies, would reap a large advantage:

"And also charged the said Premier Dunsmuir and his colleagues, the Hon. D. M. Eberts, Attorney-General, the Hon. W. C. Wells, Chief Commissioner of Lands and Works, and the Hon. J. D. Prentice, Finance Minister, members of the Executive Council of the Province, with grave misconduct and gross and wilful neglect of their official duty to the Province in having Mr. J. N. Greenshields appointed and continued as solicitor and accredited agent of the Province in the above-mentioned negotiations, and in the preparation and approving of the proposed contract between the said Canadian Northern Railway Company and the Province while he was at the same time acting in a similar capacity for the said Canadian Northern Railway Company and its chief promoters, Messrs. Mackenzie & Mann, and also acting as their and said Canadian Northern Railway Company's solicitor and agent in negotiating with and through the said Premier Dunsmuir for the purchase of the said Esquimalt & Nanaimo Railway and the said Premier Dunsmuir's charter rights in the Comox & Cape Scott Railway Company:

"And also charged the Hon. E. G. Prior, Minister of Mines, with grave misconduct and gross and wilful neglect of his official duty to the Province after he became a Member of the Executive Council of the Province, and having a knowledge of the negotiations of said Premier Dunsmuir for the said sale of the Esquimalt & Nanaimo Railway, and of the dual capacity in which the said Greenshields had been, and was then, and is still, acting,—in agreeing to said negotiations being continued with his (the said Prior's) active co-operation, and to the continuance of the employment of the said Greenshields to act in said negotiations on behalf of the Province.

"And also charged, lastly, that in the foregoing negotiations and matters the said Premier *Dunsmuir* has wilfully and grossly neglected his duty to the Province, as above set forth, and for no other apparent good reason except that he would thereby reap a personal benefit through the sale of the said *Esquimalt & Nanaimo Railway* and of his charter rights in the *Comox & Cape Scott Railway Company* to, or by the user of such lines of railway as the western connection or link of, the said *Canadian Northern Railway*, whereby great loss is likely to result to the Province and grave discredit is being brought upon the Legislative Assembly, and the credit and good name of the Province is being greatly injured":

And whereas such charges involve the honour of said Premier *Dunsmuir* and his colleagues in the Government, and should, in the public interest, be investigated :

Therefore be it Resolved, That a Select Committee of five members of this House, to wit: Messrs. *Martin, Ellison, McPhillips, Tatlow* and *Hawthornthwaite*, be appointed to investigate the said charges, with power to said Committee to send for persons, papers, records and documents, and to examine witnesses under oath, and to report the result of such investigation to this House.

Mr. Clifford moved in amendment, seconded by Mr. Ellison,-

That all the words after "Resolved" be struck out, and the following words inserted in lieu thereof :---

Mr. Green moved, seconded by Mr. Taylor,-

That in view of the present depressed condition of the lead market, and the disability under which the producers of lead and silver within the Province labour in not being able to have the product of their mines economically smelted and refined:

Therefore, in the opinion of this House, the public interest requires on the part of the Government the serious consideration of the establishment and operation by them of lead smelting and refining works within the Province.

The Crown having consented, as required by Rule 45, the Hon. Member was allowed to proceed.

A debate arose, which was adjourned until Monday next.

On the motion of Mr. McBride, seconded by Mr. Murphy, it was Resolved,--

The House resumed the adjourned debate on the motion moved on the 12th March by Mr. *Helmcken*, as follows :----

"Whereas resolutions have been passed by this Honourable House, praying the Dominion Government to enact such legislation as will prevent the immigration into this Province of citizens of the Empires of Japan and China:

"And whereas the Dominion Government has disallowed the Acts known as the 'British Columbia Immigration Act, 1900,' and the 'Labour Regulation Act, 1900':

"And whereas the Dominion of Canada and the Province of British Columbia have shown their loyalty and devotion to the cause of the Empire, and His Majesty the King has had signal proofs of such loyalty :

"And whereas the people of the Province of British Columbia have an admitted grievance by reason of their attempts to protect themselves against the immigration of citizens of the Empires of Japan and China into this Province being frustrated :

"And whereas the Right Honourable the Premier of the Dominion of Canada has accepted an invitation to be present at the coronation of Our Most Gracious Sovereign King Edward VII., and it is also proposed by the Colonial Premiers to hold a conference in the *City of London*, England, after the coronation:

"Be it therefore Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, requesting him to communicate with the Right Honourable the Premier of Canada, asking him at such conference to bring to the attention of the Colonial Premiers this question of the admission into Canada of the citizens of the Empires of Japan and China, and to use their influence to cause the Imperial Government to take such steps with the Governments of Japan and China as will enable the question to be governed in such manner as will best accomplish this object."

Mr. McInnes moved in amendment, seconded by Mr. Gilmour (the Crown consenting)-

That all the words after the word "Whereas," in the first line, be struck out, and the following substituted therefor :—

"The presence of large numbers of Chinese and Japanese in this Province creates a condition of economic slavery against which it is impossible for the European race to compete, and degrades the standard of British citizenship by odious methods of living:

"And whereas it is the settled conviction of this House that unless the immigration and employment of Chinese and Japanese be promptly and effectively checked, not only will labourers and artisans of the European race be driven from the Province, but all trades and industries will practically fall into the hands of Chinese and Japanese, and this important portion of the Empire will thereby be filled with an inferior and un-British people:

"And whereas this House, prior to 1900, passed various Acts for the purpose of mitigating the evil consequences of the presence of Chinese and Japanese in this Province, and has repeatedly urged the Dominion Government to legislate on the subject according to its jurisdiction:

"And whereas the Dominion Government, upon representations from the Imperial Authorities, disallowed the said Acts:

"And whereas in said representations by the Imperial Government the Colonial Secretary declared on July 20th, 1898, 'You should not fail to impress upon them the importance, if there is any real prospect of a large influx of Japanese labourers into Canada, of dealing with it by legislation of the Dominion Parliament, on the lines of the accompanying Natal Act, which is likely to be generally adopted in Australia,' and on March 23rd, 1899, 'They (Her Majesty's Government) hope that your Ministers will be able to arrange for the cancellation of the objectionable provisions, and the substitution of a measure which, while it will secure the desired exclusion of undesirable immigrants, will obtain that result by means of some such general test as that already suggested in my dispatch, No. 214, of the 20th of July, 1898,' and on April 19th, 1899, 'There is no difference between Her Majesty's Government and the Government of British Columbia as regards the object aimed at by these laws, namely, to insure that the Pacific Province of the Dominion shall be occupied by a large and thoroughly British population, rather than by one in which the number of aliens largely predominates, and many of the distinctive features of a settled British community are lacking.'

"And whereas, in compliance with these suggestions and sentiments of the Imperial Government, this House passed the 'British Columbia Immigration Act, 1900,' and the 'Labour Regulation Act, 1900':

"And whereas the said Acts have, nevertheless, been disallowed by the Dominion Government, for 'Imperial reasons':

"And whereas similar and even more drastic legislation has been allowed to go into operation, and is to-day being enforced, for the protection of British subjects in other parts of the Empire :

"And whereas the people of British Columbia have been discriminated against in this matter, and are unable, under the circumstances, to understand what legislation, while effective, would be acceptable to the Imperial authorities:

"And whereas legislation as aforesaid is absolutely necessary, and must be enacted and enforced, if British Columbia is to be developed and occupied by a large British population :

"And whereas the Rt. Hon. the Premier of the Dominion of Canada has accepted an invitation to be present at the Coronation of our Most Gracious Sovereign, King Edward VII., and it is also proposed by the Colonial Premiers to hold a conference in the *City of London*, England, after the Coronation:

"Be it therefore Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, requesting him to communicate with the Rt. Hon. the Premier of Canada, asking him at such conference to bring to the attention of the Colonial Premiers the necessity, from an Imperial as well as Provincial standpoint, of steps being taken at once to check the employment and immigration of Chinese and Japanese, the circumstances attending the passing and disallowing of the legislation of this House upon the subject, and to urge accordingly that means be adopted whereby suitable legislation by the Dominion Government and this House may be allowed to go into effect without Imperial interference."

A debate arose, which was adjourned until to-morrow.

The Hon. Mr. Dunsmuir replied as follows:-

"No such decision has been reached. The subject matter is being considered by the Government."

Mr. Garden asked the Hon. the Chief Commissioner of Lands and Works the following question:----

What amount has been expended to date on the Provincial Reformatory—1st, on the road and clearing of site; 2nd, on the foundation of building; 3rd, and whether it is the intention of the Government to push to completion at an early date this urgent public work?

The Hon. Mr. Wells replied as follows :---

"1. \$5,882.47.

"2. \$5,499.80.

"3. Yes."

Mr. Curtis asked the Hon. the Chief Commissioner of Lands and Works the following question:-----

Whether the Mr. S. A. Rogers, stated by him, the Honourable Chief Commissioner, on the 23rd April, 1901, in answer to a question of Mr. Martin, to be the lessee of certain Government lands, is the Mr. S. A. Rogers who sits in this House as one of the Members for the Electoral District of Cariboo?

Mr. Gilmour asked the Hon. the Attorney-General the following questions :----

1. How many special police have been engaged by the Government since March, 1901

2. If any were engaged during the trackmen's strike on the C. P. R., how many ?

3. Did any of said special police take the place of the strikers or act as watchmen on the C. P. R. track or bridges?

4. If so, why did the Government take the part of the company against the men?

The Hon. Mr. *Eberts* replied as follows :----

"1. It is almost impossible to answer this question, as the services of special constables are being continuously employed.

"2. During the trackmen's strike on the C. P. R. in the summer of 1901, some thirtyfive or forty special constables were sworn in for the protection of the railway by Chief Constable Lister, of New Westminster. When the Department ascertained that this had been done, instructions were given that it was not necessary for the Department to intervene in the matter, and that if the Canadian Pacific Railway authorities required men to look after their property, they should have them sworn in as constables under the "Railway Act," and pay for their services. This was done. None of the specials appointed were paid by the Government.

"3. I am not aware that any of the said constables, appointed as above, took the place of strikers or acted as watchmen on the C. P. R. track or bridges.

"4. The Government did not take the part of the Company against the men."

Mr. Hayward asked the Hon. the Minister of Agriculture the following question :--

Will the Government take steps at once to place the supplying of stumping powder to bonâ fide farmers on a practical basis, thus enabling them to procure the same at all times at actual cost price?

The Hon. Mr. Prentice replied as follows :---

"Mr. Palmer was instructed on 3rd March to investigate and report, without delay, the question of the supply and distribution of powder to farmers."

Mr. Curtis asked the Hon. the Chief Commissioner of Lands and Works the following questions:---

1. What amount of money has been spent by road foremen at *Mara* and *Enderby*, respectively, during the year 1901?

2. To whom were such moneys paid?

3. What amount did each receive during each month of the year?

THOMAS KIDD, Chairman. Mr. *Hall* presented a Petition from *James N. Greenshields*, *T. G. Holt*, *Harold B. Robertson* and *James Mitchell*, for leave to introduce a Private Bill to incorporate "The Victoria and Seymour Narrows Railway Company."

Laid on the table.

The House resumed the adjourned debate on the motion moved by Mr. Green on the 20th March, as follows:----

"That in view of the present depressed condition of the lead market, and the disability under which the producers of lead and silver within the Province labour in not being able to have the product of their mines economically smelted and refined :

"Therefore, in the opinion of this House, the public interest requires on the part of the Government the serious consideration of the establishment and operation by them of lead smelting and refining works within the Province."

A debate arose, which was adjourned until to-morrow.

On the motion of Mr. *Garden*, Private Bill (No. 29) intituled "An Act to amend the 'Vancouver and Westminster Railway Company Act, 1900,'" was introduced and read a first time.

Referred to the Railway Committee.

On the motion of Mr. *Ellison*, Private Bill (No. 30) intituled "An Act to amend the 'Pacific Northern and Omineca Railway Act, 1900," was introduced and read a first time. Referred to the Railway Committee.

Mr. Gifford moved, seconded by Mr. Neill-

That an Order of the House be granted for a Return showing-

1. What tenders have been received by the Government for the construction of the substructure of the *Fraser River Bridge*, with particulars of sum tendered, of person or persons, company or companies, tendering, and of the security or securities deposited by the different tenderers.

2. What tenders have been received by the Government for the construction of the superstructure of the *Fraser River Bridge*, with particulars of sum tendered, of person or persons tendering, and of the security or securities deposited by the different tenderers.

3. What tenders have been received for the construction of both substructure and superstructure of the *Fraser River Bridge*, with full particulars asked in 1 and 2.

A debate arose, which was adjourned until to-morrow.

Mr. Houston asked the Hon. the Chief Commissioner of Lands and Works the following questions :--

1. Is the West Kootenay Power and Light Company in arrears for fees under the provisions of the "Water Clauses Consolidation Act, 1897?"

2. If so, for what amount?

The Hon. Mr. Wells replied as follows :---

"1. Yes.

"2. The amount to be paid by the Company is a matter which is now under consideration."

Mr. Fulton asked the Hon. the Chief Commissioner of Lands and Works the following questions:-

1. Have any instructions been given by the Hon. Chief Commissioner during the last four months relative to the appointment of a road foreman at Salmon Arm?

2. If so, what were such instructions?

The Hon. Mr. *Eberts* moved the second reading of Bill (No. 21) intituled "An Act for the Redistribution of British Columbia into Electoral Districts."
