- 3. If the answer to No. 2 is yes, (a) why has payment been withheld and (b) in what amount in each case?

Mr. Brothers asked the Hon. the Minister of Lands and Forests the following questions:—

The Hon. D. Fulton recently made a statement that it might be possible to develop power from the proposed High Arrow Dam.

1. Has the Province of British Columbia entered into any engineering studies

of this possibility?

2. If the answer to No. 2 is yes, (a) by what method could power be developed, (b) how much power could be developed, (c) where could this power be used, and (d) would the development of this power be made and (or) operated by the British Columbia Power Commission?

The Hon. R. G. Williston replied as follows:—

"1 and 2. The possibility of producing at-site power from the proposed High Arrow Dam is not receiving detailed engineering study at the present time because power installation at this project will probably be one of the last developments to take place on the river—possibly twenty to twenty-five years from now. However, the engineering designs presently under way for the dam as a storage project include provision for future installation of generating facilities when they are required. Because of the fluctuating head at this site, the power would be developed, using adjustable-blade turbines. Depending upon economics and other conditions of power supply and use at the time the generating facilities are installed, the amount of power that could be produced would be between 100,000 and 200,000 kilowatts. The power would probably be fed into the then existing Provincial transmission system for use in meeting Provincial loads generally. It is likely the power installation would be made and operated by the British Columbia Power Commission, since it has been named as the hydro-operating entity on the river."

Mr. Carnell asked the Hon. the Minister of Recreation and Conservation the following questions:—

1. Has the parcel of land necessary for establishment of a camp-site and picnic-site at Kiskatinaw River, Mile 20 on the Alaska Highway, been acquired?

2. If the answer to No. 1 is yes, what date did this action take place?

The Hon. E. C. Westwood replied as follows:-

This motion is out of order on several grounds, but I would particularly refer you to Standing Order No. 35, section 6, clause (c): "The motion must not revive discussion on a matter which has been discussed in the same Session." The motion proposed clearly revives a matter fully canvassed in both Throne and Budget debates.

Referring to the last paragraph of the statement submitted by the Hon. the Leader of the Opposition, I might also point out that the interim report of the British Columbia Energy Board was tabled in this House several days ago and, therefore, the matter could have been brought to the attention of this House at an earlier date than to-day (see May, 16th Ed., p. 370, paragraph (2) (b)).

Therefore, I have no alternative but to rule this motion out of order.
