On the motion of the Hon. Mr. Sloan, Bill (No. 61) intituled "An Act to amend the 'King's Counsel Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

By leave of the House, the motion moved by Mr. H. E. Winch on the 9th instant with regard to venereal diseases, and the amendment thereto moved by the Hon. Mr. Weir on the same day, was withdrawn.

Mr. H. E. Winch moved, seconded by Mrs. Steeves,-

Whereas unemployment and lack of opportunity have prevented His Majesty's youthful subjects and other youthful persons resident in the Dominion of Canada from rendering their country the service which they owe it, and have inspired discouragement among the said youthful subjects and residents to the point of national emergency and concern:

And whereas it is expedient in the public welfare that substantial encouragement and opportunity be offered the said youthful subjects and residents in Canada to be of use in the country's development:

And whereas 456 delegates, representing 330 church, political, student, unemployed, and other youth organizations, did meet in Conference in Ottawa in May of this year for the purpose of discussing the problems of Canadian Youth:

And whereas said Conference did unanimously accept in principle a proposed Canadian Youth Act which has since been sent to all youth organizations for discussion and amendment:

And whereas members of Parliament are being approached in regard to the introduction of this Act into Parliament at its next Session:

Therefore be it Resolved, That this House views with alarm the breakdown of morale and lack of economic security experienced by so many of our youth, and desires to go on record as supporting the spirit and principles of the following "Proposed Canadian Youth Act":—

"HIS MAJESTY, by and with the advice and consent of the Senate and the House of Commons of Canada, enacts as follows:---

"1. This Act shall be known as the 'Canadian Youth Act.'

- "2. (1.) A Commission, to be known as the 'Canadian Youth Commission,' is hereby constituted, and shall consist of a Chairman and members, both male and female, who shall be appointed by and whose salaries shall be fixed by the Governor-General in Council.
- "(2.) The number of Commissioners and the number thereof necessary to constitute a voting majority shall be fixed by the Governor-General in Council, and shall represent the following groups in the following proportion without duplication of representation of organization:—
  - "(a.) One-third to be representatives of farm and labour organizations:
  - "(b.) One-third to be elected representatives of Youth organizations:
  - "(c.) The remainder to be representatives of social service, education, recreation, and consumers' organizations.
  - "3. The Commission shall have the power and authority:---
    - "(a.) To make such arrangements with the Provincial Governments as may be necessary to administer this Act:
    - "(b.) To appoint and fix salaries of local boards for the purpose of local administration in such districts as the Commission may assign within each Province, which boards shall be constituted in the same manner as the Commission in accordance with the proportions prescribed in section 2 (a) hereof: Provided that the one-third membership reserved for farm and labour representation may in case of rural and urban districts be varied to give all or a greater part of this membership to farm or labour representatives in accordance with the nature of the district:
    - "(c.) To make such regulations as may be deemed necessary for the administration of this Act generally, not inconsistent with the terms hereof, which regulations shall have the same force and effect as if enacted herein.
  - "4. The Commission shall:-
    - "(a.) Provide funds in the form of scholarships and bursaries for needy students in secondary, high, vocational, and technical schools, which scholarships shall cover fees for tuition and books, together with living expenses as may be deemed necessary in each case. These scholarships and bursaries shall provide for a sum which, apart from tuition and books, shall in no case be less than dollars per month:

- "(b.) Provide funds for needy undergraduate and graduate students in institutions of higher learning in the form of scholarships and bursaries similar to those described in section 4 (α) hereof; but no such scholarship shall provide a sum which, apart from tuition, shall be less than dollars per month:
- "(c.) Institute college projects for the employment of needy undergraduate and graduate students at regular rates of wages hereinafter provided, save that such wages shall in no case be less than dollars per month:
- "(d.) Provide funds for the extension and development of systems of vocational training and vocational guidance:
- "(e.) College projects shall, wherever possible, be such as shall approximate the training which such students are receiving in their respective academic pursuits.
- "5. (1.) The Commission shall institute public works and enterprises for the employment, at rates of wages hereinafter provided, of unemployed young persons, including young sons and daughters of farmers not remuneratively employed at home, who are not attending school.
- "(2.) The said public works and enterprises shall be designed to provide for the youth employed, apprenticeship training in trades, professions, and agriculture under the direction of qualified instructors: Provided that while receiving such training the youth shall receive wages at rates hereinafter provided; and, further, shall not replace or otherwise interfere with the employment of trained persons, either youth or adult.
- "(3.) The said public works and enterprises shall, in the interest of public health, provide for the extension and development of such facilities as hospitals, sanatoria, clinics, nurseries, and other socially useful projects, with special attention given to rural areas.
- "(4.) The said public works and enterprises shall further include the establishment and maintenance of parks, playgrounds, swimming-pools, and musical, dramatic, and recreational centres, with special attention given to rural areas; and, in addition, in larger centres of population, shall provide for the demolition of slum dwellings and the construction in their stead of adequate and suitable housing facilities.
- "(5.) Young sons and daughters of farmers shall, in preference to public works, be assisted to establish themselves on homesteads.
- "6. The rate of wages fixed by the Commission for the foregoing projects shall not be less than that recognized by labour organizations or fair-wage laws for the work performed in the localities affected.
- "7. 'Young persons' and 'students' referred to in this Act shall mean male and female persons and students, including sons and daughters of farmers, who have attained their sixteenth birthday and have not yet attained their twenty-sixth birthday; and this Act shall cover all such persons without regard to sex, race, origin, colour, creed, or political belief or affiliation.
- "8. (1.) There shall be available for the work of the Commission such funds as Parliament shall vote from time to time, including those funds which shall be raised by Parliament by appropriate Statutes of taxation upon large incomes, gifts, and inheritances.
- "(2.) The Commission shall make an annual report to Parliament through the Minister of Labour."

And be it further Resolved, That a humble petition be presented to His Honour the Lieutenant-Governor, praying that copies of this Resolution and the preambles thereto be forwarded to the Honourable the Secretary of State and other officials of the Government of Canada.

A debate arose.

The Hon. Mr. Pattullo moved in amendment, seconded by the Hon. Mr. Pearson,-

To strike out all the words after the word "Whereas" in the first line, and insert the following:—

"The problem of employment for all our citizens is of great concern to the State as a whole; and

"Whereas, notwithstanding very decided improvement in business and industrial conditions, a considerable number of our people have been unable to obtain employment:

"Therefore be it Resolved, That it is the opinion of this House that a generous programme of public undertakings of various character should be undertaken, not only to provide employment for our people, but also to serve the needs and requirements of public service. And that

special consideration should be given to the planning of adequate measures to ensure that the youth of our country shall have opportunity for advancement and progress in every avenue of human endeavour—economic and cultural."

Amendment agreed to.

Motion as amended agreed to.

# Mr. E. E. Winch moved, seconded by Mr. H. E. Winch,—

Whereas the Provincial Legislature did on the 9th of August, 1900, adopt a Resolution the effect of which has been to embody into Government contracts a clause commonly known as the "fair-wage clause"; and

Whereas the application of the operations of this clause has been mainly, if not entirely, restricted to operations carried on at the site of the works or to the buildings or structures thereon; and

Whereas it is, in the opinion of this Legislature, just and right that the intended benefits to the workmen provided for in the aforesaid clause shall apply with equal force to all work performed in direct connection with fulfilment of the contract:

Therefore be it Resolved, That in the opinion of this House that section in all Government contracts commonly known as the "fair-wage clause" shall be understood to:—

- (a.) Apply to all work incidental to the making, manufacture, or preparation of all fixtures, fittings, or furnishings which are specifically made for and necessary to the completion of the building or other work covered by the contract:
- (b.) That the same schedule of rates of pay for workers engaged in the construction of the building or other works shall also apply to those engaged in similar trades as provided for in clause (a), unless the current rate already operating shall be higher, in which event the latter shall prevail.

A debate arose.

On the motion of the Hon. Mr. Pearson, the debate was adjourned to the next sitting.

The Hon. Mr. Pattullo rose to a point of order, with reference to the following notice of motion by Mr. E. E. Winch:—

Whereas on March 28th, 1936, this Legislature did consider the following motion:-

"Whereas it has been brought to the attention of this Legislative Assembly that hospital employees are alleged to be working excessive hours and receiving exceedingly low rates of pay; and

"Whereas the employees in hospitals are anxious to have their conditions of working

greatly improved:

"Therefore be it Resolved, That in the opinion of this House all hospital staffs should be brought immediately within the scope of the 'Hours of Work Regulations' and the 'Minimum Wage Acts.'"

And whereas the following amendment by the Hon, the Minister of Labour was agreed to:--

"To strike out all the words after the word 'pay' in the third line, and to insert in lieu thereof the following:—

"' Therefore be it Resolved, That this House draw the attention of the Board of Industrial Relations to the allegations and ask that they be investigated."

And whereas the conditions complained of have not been remedied:

Therefore be it Resolved, That all hospital staffs be immediately brought within the scope of the "Hours of Work Regulations Act" and the "Minimum Wage Act."

Mr. Speaker reserved his decision.

The Hon. Mr. Pattullo rose to a point of order, with reference to the following notice of motion by Mr. E. E. Winch:—

Whereas it has been reported in this House that the staffs of many hospitals in the Province contain an inadequate number of properly trained graduate nurses, which condition, should it exist, may tend to result in patients failing to receive, promptly and continuously, a

sufficiency of skilled treatment at a time when their lives may depend upon such skill and service:

Therefore be it Resolved, That in the opinion of this House every hospital should be required to employ a sufficiency of graduate nurses, the number of which, in relation to the number of beds available for the accommodation of patients, shall not be less than one graduate for every five beds, and the total nursing staff (graduate and in training, inclusive) shall not be less than one nurse for three beds.

Mr. Speaker reserved his decision.

On the motion of Mr. Murray, seconded by Mr. Savage, it was Resolved,-

Whereas the Honourable Shinkichi Tamura, member of the Japanese House of Peers, has passed away at Kobe, Japan; and

Whereas he was a pioneer in trade on the North Pacific and was first to introduce Canadian flour and British Columbia wood products into the Japanese Empire; and

Whereas he was the first Trade Commissioner from Canada to Japan, being so appointed by the Government of the late Sir Wilfrid Laurier; and

Whereas he devoted much of his life to promoting good-will on the Pacific between the Oriental and Occidental nations:

Therefore be it Resolved, That this House express its regret at the passing of this distinguished Japanese, and that the Department of State at Ottawa be requested to communicate expressions of sympathy to his family.

The House resumed the adjourned debate on the motion that Bill (No. 11) intituled "An Act to amend the 'Game Act'" be now read a second time.

The motion was negatived.

On the motion that Bill (No. 12) intituled "An Act to amend the 'Marriage Act'" be now read a second time, a debate arose.

Honourable Members,—On motion No. 10 being called a point of order was raised, that it would affect public expenditure. The motion reads as follows:—

"Therefore be it Resolved, That all hospital staffs be immediately brought within the scope of the 'Hours of Work Regulations Act' and the 'Minimum Wage Act.'"

As institutions such as Tranquille and Essondale are Government institutions, any increased expenditure entailed by bringing the hospital staffs within the scope of the abovementioned Acts would be a charge upon Government revenues.

Under Standing Order 66, Resolutions incurring expenditure cannot be received by the House unless recommended by the Crown.

However, to rule the motion out of order on the above grounds would mean I was assuming the staffs of Governmental hospitals were working longer hours and receiving less wages than if they were brought under the said Acts. The staffs may, so far as I may know, be working less hours now and receiving more wages now than they might if brought under the said Acts. I have no reason to assume what hours or what wages would be established by the Board of Industrial Relations which has the administration of the said Acts. They may be more or less than at present.

It therefore follows that I cannot assume the expenditures imposed upon the Government by the passing of the Resolution will be either increased or decreased.

I rule the motion is in order.

Therefore be it Resolved, That in the opinion of this House every hospital should be required to employ a sufficiency of graduate nurses, the number of which, in relation to the number of beds available for the accommodation of patients, shall not be less than one graduate for every five beds, and the total nursing staff (graduate and in training, inclusive) shall not be less than one nurse for three beds.

Honourable Members,-On motion No. 11 being called a point of order was raised.

"Therefore be it Resolved, That in the opinion of this House every hospital should be required to employ a sufficiency of graduate nurses, the number of which, in relation to the number of beds available for the accommodation of patients, shall not be less than one graduate for every five beds, and the total nursing staff (graduate and in training, inclusive) shall not be less than one nurse for three beds."

This motion if passed would be inoperative until its purport was incorporated into a Statute.

A Resolution passed by the House cannot supersede a Statute.

The motion is therefore a mandatory motion dictating Government policy, and in effect is a direction to the Government to bring in a Bill.

A private member cannot direct the Government to bring in a Bill, which is a privilege and duty devolving upon himself, subject, of course, to the limitations imposed by the Standing Orders of this House.

# LEGISLATIVE COMMITTEE ROOM,

MR. SPEAKER:

November 18th, 1936.

Your Select Standing Committee on Forestry begs leave to report as follows:-

1. The Select Standing Committee have held several meetings. We have heard Forest Branch experts speak on forestry and forestry administration; also representatives of the industry itself have given us their views on forestry and trade.

2. We commend the Government for increasing the Forest Protection Grant. This action

is very desirable and necessary in the interests of forest protection and conservation.

3. We note with satisfaction that the Young Men's Forestry Training Plan has experienced another successful term. We recommend that their practical training be extended so that they may be better prepared to fit into positions in our forest industry.

4. We deplore the rapidity with which our fir forests are being depleted. We urge greater attention to the wealth of our forests in relationship to present-day markets and their future

possibilities.

- 5. We recommend that the Trade Extension vote be increased in order to develop overseas markets for our cedar and hemlock lumber, and that an independent trade bureau be set up to this end.
- 6. We regret that the University Department of Forestry has been allowed to lapse. We urge that, as this industry represents one of our greatest assets, the University of British Columbia be encouraged to develop a Department of Forestry for the purpose of training our young men for positions in our forest industry and service.

The Hon. Mr. Weir presented the Annual Report of the Mental Hospitals for the Year ended March 31st, 1936.

Mr. H. E. Winch asked the Hon. the Minister of Lands the following questions:

- 1. What is the amount of accessible Douglas fir stands for commercial purposes?
- 2. At what rate is this being depleted?
- 3. Has the Province sold any timber limits in the last six months? If so, to whom, and at what price?
  - 4. Would it be possible to obtain an area of forest for demonstration purposes?
- 5. What is the net revenue obtained by the Province from the forests during the last fiscal year?

The Hon. Mr. Gray replied as follows:-

- "1. 28,243 million board-feet (see page 11 of 1935 report of the Forest Branch).
- "2. Ten-year average ending December 31st, 1935, 1,243 million board-feet.
- "3. Yes; 626 sales of timber were made throughout the Province between May 1st and October 30th, in parcels varying from 4 to 1,670 acres, and at stumpage rates varying from 50 cents to \$4 per M. feet. Complete record, which is too voluminous for inclusion in this answer, is on file in the office of the Chief Forester.
- "4. Unoccupied and unreserved Crown lands may be leased 'for any industrial or other special purpose, with the approval of the Lieutenant-Governor in Council,' in accordance with the provisions of the 'Land Act.'
- "5. \$2,900,403.42 for calendar year ended December 31st, 1935. (See page 26 of 1935 report of the Forest Branch for details.)"

Mr. Pooley asked the Hon. the Provincial Secretary the following questions:-

- 1. Are sanitary conditions in British Columbia logging camps investigated by the Provincial Board of Health, or any official or officials of such Board?
- 2. If yes, how many such logging camps were so investigated during the fiscal year ended March 31st, 1936, on Vancouver Island?
- 3. How many such logging camps were so investigated during the same period on the Mainland?
  - 4. What was the total number of inspections made during the said year?

The Hon. Mr. Weir replied as follows:-

- "1. Yes, by Chief Sanitary Officer and by the Provincial Police.

  - 2. If so, are his full-time services engaged by the said University?
  - 3. What salary is paid to him?
- 4. What were the travelling expenses of the said F. M. Clement during the years 1933, 1934, 1935, 1936 to October 31st?
- 5. Has the said F. M. Clement been employed during the said years, or any part of them, by or on behalf of the Coast Vegetable Marketing Board, the B.C. Fruit-growers' Association, the Associated Dairies, or the Fraser Valley Milk Producers' Association?
- 6. If so employed by such associations or board, has he been paid remuneration for such services?
- 7. What expenses, if any, have been paid by the said board or associations to the said F. M. Clement?
- 8. What other expenses, if any, have been paid by the University of British Columbia during the said years to the said F. M. Clement?
- 9. How many days, if any, in each of the scholastic terms in each of the said years has the said F. M. Clement been absent from the University of British Columbia?

The Hon. Mr. Weir replied as follows:-

- "2. Yes.
- "3. \$5,612.80.
- " 4. \$218.49.
- "5. No.
- "6. Answered by No. 5.
- " 7. Nil.
- "8. From the Carnegie Corporation Grant: (a) Adult education, \$876.23; (b) attending meetings of learned societies, \$500.
- "9. He has not been absent except on official business or because of illness. No record is kept of such absence."

Mr. Bruhn asked the Hon. the Minister of Lands the following questions:-

- 1. What is the total acreage of the University Endowment Lands at Point Grey?
- 2. On what date was the land-clearing first undertaken on this property?
- 3. On what date, approximately, were lots first offered for sale?
- 4. How many acres of land have been cleared on the area up to September 30th, 1936?
- 5. How many miles of streets have been: (a) Graded; (b) paved or hard-surfaced?
- 6. How many miles of sidewalks have been constructed, and of what materials?
- 7. Has a domestic water system been installed?
- 8. Has a drainage and sewer system been constructed?
- 9. Is there a golf-course in connection with the Endowment area? If so, what is the area of such golf-course, and what was the total cost thereof?
- 10. How many lots have been (a) sold and (b) leased from date of first sale up to September 30th, 1936?

Mrs. Steeves asked the Hon. the Minister of Labour the following questions:—

  - 3. If yes, what amount?

The Hon. Mr. Pearson replied as follows:--

  - "2. Yes.

Mr. Bruhn asked the Hon. the Premier the following questions:-

- 1. What amount of money or other consideration is the Dominion Government to pay to the Province of British Columbia for the transfer of the present bridge over the Fraser River at New Westminster to the Government of the Dominion of Canada?
- 2. What rates of tolls on different classes of traffic are to be charged on the new bridge crossing the Fraser River at New Westminster and which is now under construction?

The Hon. Mr. Pattullo replied as follows:--

- "6. Yes, the Department's Bridge Engineer and a specially appointed Supervising Engineer, W. G. Swan, who supplies at his own expense such further engineering services as are necessary.
- "7. See Public Accounts; the Department has no information as to the remuneration paid by Mr. Swan to his employees."

Mr. Pooley asked the Hon. the Minister of Public Works the following questions:-

Has the Department of Public Works conducted investigations, or had such investigations instituted by the research department of the University of British Columbia, into the utilization of (a) Vancouver Island coal-tar products and (b) Interior coal-tar products for the treatment of road-surfacing upon the roads and highways of the Province?

Since 1931 nearly one and one-half million gallons of tar have been used in road-construction for different purposes, and the results have been found to be, generally speaking, satisfactory. The cost entailed for chemical and physical analysis by other than Government employees was \$175.10."

Mr. Uphill asked the Hon. the Minister of Labour the following questions:—

- 1. Have any unemployed men been given free transportation from British Columbia to other Provinces?
  - 2. If so, how many, and what has been the cost of such transportation?
- 3. Does the Provincial Government contribute anything to the cost of transporting men to other Provinces?

- 4. If so, who tendered, what was the amount of each tender, and which firm is doing the work?
- 5. What is the total amount paid to September 30th, 1936, for fill in connection with approaches to the bridge?
- 6. Re answer to question No. 1, Votes and Proceedings Nos. 10 and 11, page 5, in the name of the honourable member for Delta: Did the Government pay any part of the damage caused by the high water to the New Westminster Bridge; and, if so, what amount?

The Hon. Mr. MacPherson replied as follows:-

- "2. Yes. (a.) Dominion Bridge Co., Ltd.; Western Bridge Co., Ltd. (b.) Amounts of tenders based on estimated quantities at unit prices: Dominion Bridge Co., Ltd., \$2,722,101.62; Western Bridge Co., Ltd., \$2,854,094.10. (c.) Dominion Bridge Co., Ltd.
  - "3. Filling of approaches included in contract.
  - "4. See answers to Nos. 2 and 3.
  - "5. This information will be available to the Public Accounts Committee in due course.
- "6. Replacement where necessary of scoured material around piers is being carried out but is uncompleted meantime."

Mr. Burns asked the Hon. the Attorney-General the following questions:

What annual revenue will be required to meet interest and sinking fund requirements on the new bridge across the Fraser River at New Westminster for every \$1,000,000 spent in the construction of said bridge and its approaches, based on interest and sinking fund requirements on money already borrowed for such purposes?
- 10. Have arrangements been completed for the complete financing of the construction of the said new bridge over the Fraser River at New Westminster under the authority of the Act of 1935, authorizing such borrowings and financing?
- 11. If so, with whom have such arrangements been made, and (a) at what rates of interest, and (b) for what term or terms of years, and (c) whether by bonds, securities, debentures, or Treasury notes?

The Hon. Mr. Hart replied as follows:-

- "1. Borrowed to reimburse expenditure from Consolidated Revenue, \$1,000,000 net under Loan Act, 1902,' and \$18,382.87 under 'Loan Act, 1903.'
  - "2. Cannot determine apportionment of sundry borrowings.

- "9. Present issue of \$2,000,000 for construction of the new bridge over the Fraser River is a short-term issue without sinking fund provisions, dated July 8th, 1935, due July 8th, 1938, at  $3\frac{1}{2}$  per cent.

What new text-books are issued free to the schools by the Department of Education, and what has been the total cost of each free distribution to September 30th, 1936?
- 2. To carry out efficiently the revised curriculum for Grades I. to VIII., inclusive, as set forth in the new programme of studies, what is the total cost of equipment, supplies, and library books, respectively, for each of the following typical schools, to September 30th, 1936:
  (a) Average rural ungraded school; (b) average rural municipal grade school, six divisions (Grades I. to VIII.); (c) average city municipal grade school, ten divisions (Grades I. to VIII.)?
- 3. What additional aid, if any, is being granted or is to be granted to School Boards on account of the increased expenditures necessary to provide adequate facilities to carry out the revised curriculum?
- 4. Since October 1st, 1933: (a) What has been the total cost of the revision of the curriculum, exclusive of the salaries and expenses of permanent employees of the Department of Education; (b) to what persons have such moneys been paid?
- 5. Up to October 31st, 1936, what is the total cost of printing and distributing to the public schools copies of the revised programme of studies covering Grades I. to IX.?

The Hon. Mr. Weir replied as follows:-

- "1. (1.) (a.) Elementary schools (Grades I. to VIII.): World Geography for Canadian Schools, \$1.20; General Science, \$1.05; it is likely that Canadian Book of Prose and Verse, Books I. and II., 80 cents each, which for several years have been in use in junior high schools, will be used also in Grades VII. and VIII. of all elementary schools next year. (b.) High schools: Modern Composition, 70 cents, replacing books costing \$1.20; Civilization in Europe, \$2.15; Lessons on the British Empire, 25 cents; General Science, \$1.05, replacing a book costing \$1.50; Physics Laboratory Manual and Work Book, 55 cents, replacing a manual which had been on the list since 1913. (2.) New text-books issued free on the lending plan:—Highroads to Reading: Primer, and Books I., II., III., IV., V., and VI., replacing five Canadian Readers which had been in use for twelve years. Primer, \$5,076.60; Book I., \$5,614.42; Book II., \$7,189.26; Book III., \$7,183.35; Book IV., \$6,963.20; Book V., \$8,297.38; Book VI., \$7,366.44; Junior Mathematics, Book I., \$5,452.33; Dominion Language Series, Book II. (for Grades V. and VI.), \$14,087.04. In addition to the above, many other books were issued on a free basis. For total cost see Public Accounts for the years concerned.
- "2. (a.) A school equipped to carry out efficiently the old Programme of Studies can carry out efficiently the new Programme of Studies with approximately the same annual appropriations for equipment, supplies, and library books as heretofore. (b.) Answered by (a). (c.) Answered by (a).
- "3. There is no change in the amount of assistance rendered by the Department in respect of school library books and purchase of laboratory equipment.
- "4. \$9,611.51, which covers the travelling and other expenses necessarily incurred by 136 members of Curriculum Revision Committees during the period March, 1935, to October, 1936, inclusive; also 50 per cent. of the salaries and expenses of two temporary officials for the period April, 1935, to October, 1936, inclusive.
- "5. Cost of printing Programme of Studies, \$7,858. The cost of the distribution of the Programmes is not kept separate from the cost of distributing text-books and other supplies,"
