REPORT No. 16.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:—

Representations for the promoter have been carefully considered, and also the arguments of the petitioners against the proposed Bill.  $\neq$ 

Perhaps the most important point regarding this Bill is the fact about which there is no dispute, that it had been agreed by the counsel for the City of Victoria when appearing before the Judicial Committee of the Privy Council on the case affected by this Bill: "That in the end an account shall be made up in which credit shall be given to the contractors for every cent they are entitled to and that from that shall be deducted the cost of the work. That will be the final settlement between the parties and that is not concluded." Further, "That the person to make up this final statement under clause 15 of the contract should be an independent engineer."

An engineer, Mr. W. Bell, was mutually agreed upon, and your Committee called Mr. Bell, who stated in answer to questions by your Committee that he was appointed in May. 1919, in accordance with the above-mentioned undertaking, but did not go into the accounts after advice from the City Solicitor of Victoria.

This appears the crux of the whole question—namely, that the engineer agreed upon did not actually go into the accounts and the petitioner seeks to compel this course to be followed.

It appears to your Committee that no matters in dispute have been specifically drawn to the attention of the City of Victoria by the Westholme Company, and consequently there has never been any matter raised in respect of which the decision of a neutral engineer should be obtained. It further appears that if the Westholme Company were to submit specific questions in dispute to the engineer, such questions could still be adjudicated upon.

To clarify the question as to who shall instruct Mr. Bell to act and as to when, and to bring finality to this matter for the satisfaction of all parties affected, your Committee reports the preamble of the undermentioned Bill has been proved, and the Bill ordered to be reported with amendments.

Bill No. 56—"An Act relating to the Westholme Lumber Company, Limited, and the Corporation of the City of Victoria."

All of which is respectfully submitted.

#### MR. SPEAKER:

Your Select Committee on the "Greater Vancouver Water District Act" begs to report as follows:—

Your Committee discussed fully all the clauses of the Bill and respectfully makes the following recommendations to the House:—

- (a.) Clause 2: To delete all words after the word "Provided" in the twelfth line thereof up to and including the word "Legislature" in the sixteenth line thereof.
- (b.) To amend section 7 of the said Bill, altering clause (c) of subsection (2) by adding thereto the following words: "But in no case shall the rates so prescribed be less than the rates from time to time charged by the Corporation under substantially similar circumstances for water supplied to municipalities within the district."

All of which is respectfully submitted.

The report was read and received.

On the motion of Mr. I. A. Mackenzie, it was Ordered that Bill (No. 29) intituled "An Act to amend the 'Greater Vancouver Water District Act'" be placed on the Orders of the Day for second reading at the next sitting of the House.

With the leave of the House, the following question standing in the name of Mr. Jones on the Order Paper of to-day was withdrawn:—

"What is the total assessed value of lands which have reverted to the Crown by reason of non-payment of taxes and now remain vested in the Crown?"

With the leave of the House, the Hon. Dr. MacLean presented a Return in answer to question No. 2 standing on the Order Paper of the 3rd instant, in the name of Mr. Jones, as follows:—

"2. Through what firms was such amount invested, giving particulars as to what proportion each firm handled?"

Mr. Jones asked the Hon. the Minister of Finance the following questions:—

- 1. What amount has been invested on sinking fund account since April 1st, 1925?
- 2. Through what firms was such amount invested, giving particulars as to what proportion each firm handled?
  - 3. What rate of commission was paid?
  - 4. What is the total amount of commissions paid?

The Hon. Dr. MacLean replied as follows:—

- "4. None."

- Mr. Pooley asked the Hon. the Minister of Public Works the following questions:-
- 1. Were tenders called for on the Alexandria Bridge on the Fraser Canyon Highway?
- 2. Who tendered, and the amount of each tender?
- 3. If the tenders were on a unit basis, what was the approximate amount of each tender?
- 4. Who got the contract?

The Hon. Dr. Sutherland replied as follows:-

- "1. Tenders were invited for the piers and towers.
- "2 and 3. Bids were on unit basis, estimated as follows: Robertson Bros., \$29,808.63;
- A. B. Palmer Company, Ltd., \$29.872; Pacific Engineers, \$29,960.97; Stewart & Barber, \$32,419;
- E. H. Shockley, \$33,633.75; Public Works Department, \$30,222.75.
  - "4. A. B. Palmer Company, Ltd."

Mr. Catherwood asked the Hon. the Minister of Lands the following questions:-

- 1. Is one Stanley W. Brown employed by the Department of Lands? If so, in what capacity and at what salary?
  - 2. Under whose direction is he employed and from whom does he receive orders?
  - 3. What were his expenses for the month of June, 1925?
  - 4. Give his movements for the month of October?
- 5. Are the duties entrusted to this man such that they could not be carried out by Forest Rangers? If so, state in what particular.

The Hon. Mr. Pattullo replied as follows:-

Mr. Wallinger asked the Hon. the Minister of Finance the following questions:-

- 1. What was the amount of 2-per-cent. mineral-tax paid in 1924?
- 2. What coal royalties were paid in 1924?
- 3. What income-tax, in addition to the mineral-tax and royalties, was payable in 1925 on 1924 profits?
- 4. What amount of tax on personal property is payable by mining companies and individuals operating mines in 1925, based on 1924 operations?

The Hon. Dr. MacLean replied as follows:—

- "1. \$298,729.54.
- "2. \$153,623.66.
- "3. \$398,517.33.
- "4. Mining companies and mining individuals, as such, do not pay personal-property tax."

Mr. W. A. McKenzie asked the Hon, the Minister of Agriculture the following questions:-

- 1. Has any definite action been taken to arrange for the sale of lands comprising the bed of Sumas Lake as required by section 9 of the "Sumas Drainage, Dyking, and Development District Act," chapter 87, Statutes of 1920?
- 2. By what amount will the sale of said lands reduce the capital charges incurred for the works constructed?

The Hon. Mr. Barrow replied as follows:-

- "1. No. Under agreement between the Government of the Dominion of Canada and the Government of the Province of British Columbia, transfer of lands was deferred until the same were effectively reclaimed. The work was not completed to such extent until late in the year 1924, and on May 16th, 1925, formal transfer from the Crown in the right of the Dominion of Canada to the Crown in the right of the Province of British Columbia was executed. A Bill is now before the Legislature providing for the transfer of the lands concerned from the Province to the Dyking Commissioners of the Sumas Drainage, Dyking, and Development District.
- "2. By the amount for which the lake-bottom lands are sold in excess of the amount of the capital charges assessed against such lands."

- Mr. W. A. McKenzie asked the Hon, the Minister of Agriculture the following questions:—
- 1. Were any persons appointed to act as an Advisory Board on behalf of the owners of lands in the Sumas Dyking Scheme to advise the Commissioners as provided for by section 12 of the "Sumas Drainage, Dyking, and Development District Act"?
  - 2. If so, who were appointed, and when?
  - 3. If answer is No, why were none appointed?

The Hon. Mr. Barrow replied as follows:-

- "1. No. An Advisory Board of six members was appointed by the property-owners some three months before the Land Settlement Board was formally appointed as Dyking Commissioners. This Advisory Board continued to function on behalf of the owners throughout the programme of the work of reclamation.
- "2. R. H. S. Cresswell, Chairman; W. L. Blatchford, Secretary; Fred Fooks, Angus Campbell, J. L. Atkinson, and C. E. Eckert.
- "3. In view of the existence of an active Advisory Board at the time the Land Settlement Board became Commissioners, it did not appear to be necessary for the Commissioners to avail themselves of the authority granted to them in section 12, 'Sumas Dyking, Drainage, and Development Act,' and no application for the appointment of an Advisory Board under section 12 of the 'Sumas Drainage, Dyking, and Development District Act.'"

Mr. Lister asked the Hon. the Attorney-General the following questions:-

- 1. How many gaols and penitentiaries were operated in British Columbia during each of the years from 1912 to 1925, inclusive?
- 2. What was the total number of inmates in gaols and penitentiaries in British Columbia separately for each of the years 1912 to 1924, inclusive?
- 3. What was the average number of inmates in gaols and penitentiaries in British Columbia separately for the years 1912 to 1923, inclusive?

The Hon. Mr. Manson replied as follows:-

- "1. Dominion Penitentiary, 1. Provincial gaols: 1912 and 1913, 6; 1914, 7; 1915, 1916, and 1917, 5; 1918, 3; 1919 to 1925, 2.
- "2. Provincial gaols: 1912, 3,175; 1913, 3,363; 1914, 2,711; 1915, 1,494; 1916, 1,312; 1917, 996; 1918, 845; 1919, 686; 1920, 1,003; 1921, 1,670; 1922, 1,690; 1923, 1,582; 1924, 1,353. Records of inmates in penitentiaries are not available as the Penitentiary is a Dominion institution.
- "3. Provincial gaols: 1912, —; 1913, 554.69; 1914, 595.54; 1915, 317.11; 1916, 245.96; 1917, 174.064; 1918, 148.133; 1919, 161.639; 1920, 229.37; 1921, 320.67; 1922, 368.62; 1923, 332.87. Records of inmates in penitentiaries are not available as the Penitentiary is a Dominion institution."

Mr. Lister asked the Hon. the Minister of Public Works the following questions:—

- 1. When did the Government decide to lease departmental offices in the Casorso Building, Kelowna?
  - 2. On whose advice was the change made from offices occupied for years?
- 3. What was the total monthly rental paid for departmental offices in Kelowna previous to leasing rooms in Casorso Building?
  - 4. What is the total monthly rental for offices in the Casorso Building?
  - 5. For what term has the lease been taken?
  - 6. Why was the change made?

The Hon. Dr. Sutherland replied as follows:-

- "1. May, 1925.
- "2. Executive Council.
- "3. Average \$112 per month, exclusive of usual services. Public Works Department occupied Government Building.
- "4. \$200 per month, inclusive of usual services (old Government Building rented to the Casorsos at \$25 per month).
  - "5. Ten years.
  - "6. To obtain Court-room and to bring all Government departments together."

Mr. Wallinger asked the Hon. the Minister of Agriculture the following questions:-

- 1. When did the Land Settlement Board buy land west of Cranbrook?
- 2. How many acres were purchased?
- 3. When does the Board propose to drain this land and make it available for agriculture and consequently tax-paying?

The Hon. Mr. Barrow replied as follows:--

- "1. October 1st, 1919.
- "2, 629.97 acres.
- "3. Under consideration."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

Mr. Perry presented the Seventeenth Report of the Select Standing Committee on Private Bills and Standing Orders, as follows:—

#### REPORT No. 17.

Legislative Committee Room, December 4th, 1925.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:—

Bill (No. 52) intituled "An Act to ratify and confirm an Agreement between the Corporation of the City of Victoria and The Esquimalt Water Works Company, providing for the Expropriation of the Undertaking of the Water Works Company."

Your Committee has carefully considered the arguments and exhibits of both the petitioners for and against the Bill, and at once expresses its appreciation of the earnestness and public-spiritedness of all the parties affected by the Bill. The fact that the public interest of one part of the district appeared to conflict with the public interest of another part has added to the perplexity of your Committee in arriving at a decision which we trust will work out justly and equitably to all parties concerned.

Representations were heard from the City of Victoria, Municipalities of Saanich and Esquimalt, District of North Saanich, citizens and others both for and against the Bill, and over sixty exhibits were filed.

The following questions appear as the most vital ones to be considered and that need be reported herein:—

The Right of the City of Victoria to expropriate the Esquimalt Waterworks.—On this point your Committee feels there can be no doubt of the right of the city to expropriate the undertaking under powers given by the Acts of 1873 and amending Acts.

The Submitting to the Ratepayers of a By-law authorizing the Purchase of the Esquimalt Waterworks.—The Council felt the urgency of the matter warranted prompt action, and your Committee feels that in acting promptly good business judgment was exercised, but that it is unfortunate the ratepayers could not have been consulted as-there appears little objection to the purchase itself, but rather against the violation of a well-established custom that in matters involving the future credit of a municipality the ratepayers shall be consulted.

It is argued that the purchase is being made from the revenues of the water-users and not from the ratepayers, but in the opinion of your Committee the purchase is being made possible by the credit of the ratepayers. No useful purpose could be served by your Committee recommending that the purchase be still referred to the ratepayers, particularly as no public objection appears against the Mayor responsible for this transaction, as evidenced by his recent re-election by acclamation.

That the Amount to be paid by the City would be more than the Amount set out in the Bill.—The city has filed amendments to correct any such apprehension.

That the Cost of Water to Victoria Users will be Higher.—A contract existed between the Esquimalt Waterworks Company and the City of Victoria by which the former supplied 5,000,000 gallons per day at 6 cents per M. Whatever the cost to the consumer in Victoria may be, whether higher or lower, on account of this purchase will depend primarily upon management, and the ratepayers by their franchise will have full opportunity to select those best fitted to conduct the business in their interests.

Supply of Water to Esquimalt Peninsula.—Esquimalt Municipality argued that not one drop of water more than 5,000,000 gallons per day could be taken outside the Esquimalt Peninsula.

If this right existed it belonged to the Esquimalt Waterworks Company, who are parties to the sale, and as the City of Victoria has agreed to supply the requirements of Esquimalt Peninsula this objection appears without merit.

Recommendations.—Your Committee believes that the preservation of an adequate water-supply and the distribution of same is of general public interest and recommends amendments to the Bill based upon the following principles:—

That no unfair monopoly shall exist.

That a satisfactory supply of water shall be available to all Greater Victoria, Esquimalt and Saanich Peninsulas, and contiguous territory.

That it shall be obligatory upon the City of Victoria to supply the reasonable needs of neighbouring municipalities for water *pro rata* with the City of Victoria according to the supply available.

That the water shall be available at a fair and reasonable price.

That the City of Victoria shall be entitled to receive as the selling-price of water supplied the cost of production, wholesale distribution, maintenance and depreciation, sinking fund requirements, and a profit of not more than 5 per cent. over above gross costs.

Pending the establishment of a Greater Victoria Water Board we recommend that the Board of Arbitration under the "Arbitration Act" shall have the right to examine into and decide upon the costs as above mentioned and fix the price to be charged for water supplied.

Your Committee respectfully submits above recommendations and reports progress, and will submit amendments based upon above recommendations in a further report.

All of which is respectfully submitted.

Mr. *Uphill* asked the Hon. the Minister of Public Works the following question:— What amount was expended on the Kaisner Road, Elk Prairie, during the year 1925? The Hon. Dr. *Sutherland* replied as follows:—

<sup>&</sup>quot;No expenditure made on Kaisner Road, but Wilson Creek-Mansfield Road extended to give Kaisner better access; cost of work, \$1,800."

Mr. W. A. McKenzie asked the Hon. the Minister of Lands the following questions:—

  - 3. What is the area of each watershed?
  - 4. What is the estimated quantity and value of the timber in such reserve (if any)?
- 5. Is it the intention of the Government to lift the reserve, or any part thereof, for disposal of the timber thereon?
- 6. Are logging operations now being carried on in Capilano or Seymour Valley above the water intake? If so, by whom?
- 7. Under what authority are logging operations being carried on (if any), and what area estimated, quantity of timber and the special regulations (if any) imposed in connection with such operations?
  - 8. Was any part of the watershed or reserved lands destroyed by fire in 1925?
  - 9. If so, what extent of area was burned, and what quantity of timber was destroyed?
  - 10. What was the cause of such fire (if any), and the date of same?
- 11. Were logging operations being carried on in the Capilano or Seymour at the time of the outbreak of such fire?
- 12. What area (if any) was burned over in the lands under reserve, and what is the location of such burned area?
  - 13. Did the City of Vancouver own any of the burned area (if any) or timber thereon?
- 14. Has any area or timber lands been recently purchased from the Crown by the City of Vancouver?
  - 15. If so, what was the price paid for the same?
  - 16. If so, was the timber on this area affected by the fire (if any), and to what extent?
- 17. If there has been a loss of timber on any area owned by the City of Vancouver, is it the intention of the Government to compensate the said city for such loss, or to assess it for a share of cost of fighting such fire (if any)?
- 18. Are there any Crown timber lands in either the Capilano or Seymour watersheds not now under reserve?
- 19. If so, is it the intention of the Government to dispose of such timber lands to any person, firm, or corporation, other than the City of Vancouver?
  - 20. What (if any) is the estimated quantity and value of such timber lands?
- 21. Are any negotiations now under way or offers made for the purchase of such timber lands (if any) by private persons?
- 22. What negotiations have been carried on by the Minister of Lands with the City of Vancouver with a view to the reserving or acquiring of all unalienated Crown lands on either Capilano or Seymour Creek watersheds?

- 23. Will the citizens of Vancouver be fully protected in any further logging operation or alienation of timber lands in these watersheds?
- 24. What (if any) assurances will be made that these watersheds will be reserved and fully protected for watershed purposes?

- "5. The enrolment in the first year in all faculties is 586; second year, 292; third year, 205; fourth year, 173; unclassified, 94; students taking teacher-training and post-graduate work, 94.
- "6, 7, and 8. In the Arts, Science, and Agriculture Courses there are 73 professors, 7 instructors, 5 lecturers, 28 assistants, and 3 workshop instructors and assistants employed. Of the 73 professors, 24 are employed in Arts only, 10 in Applied Science only, and 14 in Agriculture only. The remaining 25 give instruction in more than one faculty.
- "9, 10, and 11. The appropriation for Faculty of Arts is \$217,860; for Faculty of Applied Science, \$82,805; for Faculty of Agriculture, \$111,908; for administration, including summer session, Capital Account, etc., \$234,502.92. Not including cost of administration, etc., the average cost per student in Arts Course is \$195; Applied Science Course, \$422; Agriculture Course, \$2,152."

Mr. Wallinger asked the Hon. the Minister of Public Works the following questions:-
