The Speaker delivered the following reserved decision on the point of order raised by Mr. H. E. Winch on the 16th instant:—

Honourable Members,—On the point of order raised by the Leader of the Opposition at last night's sitting on the rights of a private member, who had given a notice of introduction of a Bill standing on the Order Paper in the name of the private member: Yesterday, being Thursday, private Bills in the hands of private members have precedence over other Bills (Standing Order 25). It is the right of a private member to present a Bill for introduction at the proper time.

On yesterday's Order Paper, there were two private members' Bills—one in the name of the honourable the third member for Vancouver-Point Grey and the other in the name of the honourable member for Rossland-Trail.

After the Leader of the Opposition had raised his point of order, the Attorney-General raised the objection that it was not competent for the Leader of the Opposition or any other private member, except those concerned, to demand that these Bills be called. He argued that if the right of the honourable member for Vancouver-Point Grey or the honourable member for Rossland-Trail to introduce the Bills, standing in their respective names, was infringed upon, any objection to this course must come from the member involved. He pointed out that at the time the Leader of the Opposition raised his objection the member for Vancouver-Point Grey was not in her seat in the House. A member who has filed notice to introduce a Bill is not obliged to do so.

I think I have said enough to indicate clearly the rights of private members on private members' days in regard to Bills standing in their names.

Upon these facts, it is my opinion that the point of order raised by the Leader of the Opposition should be disallowed, and I so rule.

Prayers by Chaplain Pegler.

The Hon. Mr. Wismer made the following statement:-

Some days ago in the Legislature I told the Honourable Leader of the Opposition that the question of an appeal from the judgment of the Board of Transport Commissioners, dated March 1st, 1950, was under consideration by the Government. The judgment, as you are aware, approved a 16-per-cent. increase in freight rates in place of the 8-per-cent. interim increase previously allowed.

Since the time I spoke the Provinces of Manitoba, Saskatchewan, Alberta, New Brunswick, and Nova Scotia have decided to appeal this order and, from the latest reports, the matter is still under consideration by the Province of Prince Edward Island.

The Government has now decided to join with the other Provinces in an appeal to the Governor in Council.

One of the reasons why the appeal is being launched is that the railways have appealed to the Supreme Court of Canada on matters of law involving certain legal questions arising out of the hearing. We therefore feel that there should be an appeal on the facts.

The Supreme Court of Canada has no jurisdiction to consider any question of fact and the only tribunal which has jurisdiction is the Governor in Council. Therefore the appeal will be made to that body.

It will involve the following and perhaps other questions of fact:---

- (a) The Board erred in failing to comply with the direction of Your Excellency in Council contained in P.C. 4678 of October 17th, 1948, directing that an investigation should be made by the Board in order to determine the apportionment to be made of dividends between rail earnings and other income:
- (b) The Board erred in allowing to the Canadian Pacific Railway, as a requirement out of rail earnings only, a surplus of \$15,235,000, being an amount fixed without the application of any principle therefor:
- (c) The Board erred in failing to determine whether or not there are included in the so-called "other income" of the Canadian Pacific Railway certain items which should have been classified as rail income:
- (d) The Board erred in not making a proper investigation to determine whether or not maintenance charges submitted by the Canadian Pacific Railway were excessive for rate-making purposes:
- (e) The Board erred in authorizing a general horizontal or flat percentage increase, disregarding and accentuating existing disparities in the freight-rate structure, and the Board further erred by failing to limit the authorized increase to flat maxima amounts or by other exceptions, or otherwise.

REPORT.

LEGISLATIVE COMMITTEE ROOM, March 20th, 1950.

MADAM SPEAKER:

Your Select Standing Committee on Municipal Matters begs leave to report as follows:---

Several meetings of this Committee were duly held.

The executive of the Union of British Columbia Municipalities appeared before the Committee and requested amendments to the "Municipal Act," the "Village Municipalities Act," the "Municipal Elections Act," and the "Local Improvement Act." The Department of Municipal Affairs submitted amendments to the "Municipal Act," the "Village Municipalities Act," and the "Town Planning Act."

4

Interested parties were given a hearing. Accompanying the executive of the Union of British Columbia Municipalities were representatives of fourteen municipalities and these drew attention to the mounting costs of education, having particular reference to the increase in the 1950 school budgets as compared with the figures for the year 1949. If the fears of the municipal representatives are borne out, it would indicate that further study will need to be given to the problem of educational finance.

A number of amendments to the various Acts were approved which will, in due course, be submitted to the Legislature for enactment.

The members of your Committee were impressed with the number of amendments being put forward for conferring additional powers on villages and are of the opinion that the time has arrived when the advisability of consolidating the "Municipal Act" and the "Village Municipalities Act" should be seriously considered. It is, therefore, recommended that expert advice be obtained for the necessary study and preparation of such a consolidation. The recommendations contained in the Goldenberg Report on the need of further urban classification for municipalities could at the same time be implemented.

All of which is respectfully submitted.
