HALF-PAST TWO O'CLOCK P.M.

Prayers by the Rev. F. P. Chadwick.

The Hon. the Minister of Lands presented copy of correspondence between the Department of Lands, Victoria, and the Department of the Interior, Ottawa, in regard to proposed Kootenay Reclamation Scheme.

The House resumed the adjourned debate on the motion moved on February 24th by Dr. *McIntosh*, as follows:—

That this Legislature resolve itself into a Committee of the whole House to consider the question of "State Health Insurance," with a view to discussing the advisability of appointing a Committee to bring in a Bill before the close of this Session of the House.

And on the amendment thereto moved by Mr. Cowper on March 3rd, as follows:-

To strike out all the words after the word "consider" in the first line, and to substitute therefor the following: "the following Resolution: Resolved, That the Committee rise and report, recommending the introduction of legislation providing for State Health Insurance."

The Hon. Dr. MacLean moved in amendment,-

To strike out all the words after the word "That" in the first line thereof, and substitute the following: "Resolved, That in the opinion of this House the early consideration by the Government of legislation with respect to State Health Insurance, Mothers' Pensions, and the broadening of the provisions of the 'Workmen's Compensation Act' is desirable."

The debate continuing was, on the motion of the Hon. Mr. Sloan, adjourned to the next sitting.

On the motion of Mr. Weart, seconded by Mr. Pauline, it was Resolved,-

That the report of the Select Standing Committee on Public Accounts, presented and received by the House on Monday, March 3rd inst., be adopted.

The Rules were suspended to allow the following motion to be moved without notice:—Mr. Pauline moved, seconded by Mr. Weart,—

Whereas a member of the Public Accounts Committee has given his certificate in writing, under Rule 108, to the Chairman of said Committee, that he believes Robert Walmsly and G. Young are necessary and important witnesses to appear before the said Committee in connection with Vote 150 (Kaslo District), item pay-lists, \$17,576.95, in the Public Accounts 1917-18:

And whereas it appears that the said Committee is also desirous of investigating the said pay-lists for the said district up to the present date:

And whereas it is advisable and necessary to inquire fully into the said matters:

Therefore be it Resolved, That the said Committee have power:-

- (a.) To compel the attendance of the said Robert Walmsly and G. Young and all other persons deemed by them necessary to be examined in connection with the said matters:
- (b.) To examine said persons under oath or affirmation, and to enforce the production of all books, letters, papers, documents, telegraph or telephone messages, or any other evidence material to the inquiry; and that the said Committee be instructed to allow counsel to appear before the Committee, and that no communication, oral or written, shall be kept from the Committee, whether the same shall be claimed to be confidential or personal or otherwise; and that the Committee report their findings and the evidence to the House.

A debate arose, which was, on the motion of the Hon. Dr. King, adjourned to the next sitting.

## Mr. Hanes moved, seconded by Dr. McIntosh,-

Whereas by chapter 34 of the Statutes of British Columbia, 1912, and chapter 36 of the Statutes of British Columbia, 1912, and amending Acts, it was provided that the moneys arising from Government-guaranteed securities should be paid to the Pacific Great Eastern Railway Company in "the proportion of work done and materials and supplies purchased for the said railway as compared with the whole work done and to be done thereon, pending completion of the said line":

And whereas in breach of the said Statutes: (a) The entire amount of such securities has been negotiated; and (b) the entire proceeds paid over to the railway company; notwithstanding that said line is only partially completed:

And whereas the amount of publicly guaranteed money paid to the railway company is in excess of that spent in construction of said railway by several millions of dollars, out of which excess, or out of said moneys, the sum of \$500,000 was paid to one D'Arcy Tate for political purposes, and hundreds of thousands of dollars were diverted for other uses—as, loan to Bloedell, Stewart & Welch for \$240,000 and loan to Lloyd, Allan & Stewart for \$150,000, eight cheques for \$50,000 each in August, 1914, etc.—and as a result the promoters were not only financed out of public funds, but admit on statement by themselves that they made a profit, as appears by their own figures, of over \$5,000,000:

And whereas John Callaghan, chief engineer of said railway company, did prepare and sign estimates to be presented to the Government for payment, which were false and misleading:

And whereas said estimates were signed by R. D. Thomas, secretary-treasurer of said company:

And whereas by said false estimates the Government were defrauded out of hundreds of thousands of dollars, some of the following included: (a) The sum of \$150,000, approximately, was overpaid by wrongfully classifying "excavating" as "excavation in foundations"; (b) the sum of \$120,000, approximately, was overpaid in payments for ballasting; (c) the sum of \$90,000, approximately, was overpaid on wrongful classification by allowing approximately 10 per cent. of solid rock on approximately 1,000,000 cubic yards of clay:

And whereas in contravention or breach of said Statutes the Government overpaid the company \$5,705,316:

And whereas D'Arcy Tate, vice-president of said Pacific Great Eastern Railway Company and chief counsel thereof, and W. J. Bowser, then Attorney-General of this Province, did arrange and procure said overpayments or part of same in contravention to or in breach of abovementioned Statutes:

And whereas the above-mentioned facts were laid before this House in a report dated May 1st, 1917, and signed by J. W. de B. Farris:

And whereas this House did on May 19th, 1917, adopt said report:

And whereas the breaches of Statute aforesaid constitute an offence under the Criminal Code of Canada:

Be it therefore Resolved, That the facts set forth be laid before His Majesty's Attorney-General, with a direction that every person concerned in the offences aforesaid be forthwith prosecuted according to law, including the persons above mentioned.

Mr. Speaker *Keen* ruled the motion out of order, the House having already this Session expressed its opinion on the question. (*See* February 27th and March 5th. Speakers' Decisions, 52, 95 to 99.)

SIR.—The undersigned citizens of Hope have learned with feelings of deep appreciation the fact that you voluntarily tendered your professional services for their benefit during the recent epidemic of influenza which afflicted our community. The fact that the epidemic has been widespread, the mortality alarming, and the difficulties in the way of obtaining the benefit of trained assistance almost unsurmountable, especially in a small community such as ours, renders us doubly grateful for the fact that a man of your professional attainments should have come to our assistance. Your presence here, coupled with our knowledge of the quiet and efficient way in which you took charge, allayed our feelings of panic and gave the assurance that you were indeed a friend in need. The success which attended your efforts meets with our heartfelt appreciation, to which we wish to give tangible expression by asking you to accept the accompanying gifts that may in the future remind you of our gratefulness. - "'(c.) An additional sum of three dollars and fifty cents for each full month or part of a month during the whole or such part of the period of twelve months following the termination of the said period of one year as is elapsed at the date of payment; and
- "'(d.) An additional sum of five dollars for each full month or part of a month during the further period (if any) between the expiration of the said period of twelve months and the date of payment."

## MR. SPEAKER:

Your Committee was attended on by representatives of the Provincial Great War Veterans' Association in the person of Captain Whittaker, President of that association, and Walter Drinnan, Esquire, Field Organizer of that association in the Province of British Columbia, and representatives of other soldier bodies, who made representations to your Committee with reference to the conditions and circumstances surrounding the rehabilitation of soldiers returning to the Province of British Columbia, and particularly with reference to the necessity of the maintenance of an organization financially assisted by the Provincial Government for the purpose of extending relief to and the assistance of soldiers' dependents who are in need of relief and assistance from time to time.

Your Committee on investigation find that, while considerable work along this line has been done by the Soldiers' Aid Commission of the Province, the Labour Bureaus established or in course of establishment throughout the Province, soldier organizations such as the Great War Veterans' Association, the Comrades of the Great War, the Army and Navy Veterans' Association, the British Campaigners' Association, and other associations, yet your Committee is of the opinion that the growing burden will prove altogether too heavy for these associations and bodies without a further substantial measure of relief and assistance from the Provincial Government.

Your Committee, therefore, humbly recommends to the Government that the body known as "The Soldiers' Aid Commission" be reorganized, that it be established as consisting of seven members—a Chairman, a representative of the Government; three civilians, representing the civilian population; and three returned soldiers, representing the returned soldiers and their dependents.

That the Commission be given full and sweeping powers to extend aid and relief to soldiers and their dependents, either by extending relief directly to the individuals or through the medium of soldier organizations; and, further, that the Commission shall have power to assist in the maintenance of soldier organizations having as their interest the welfare of the soldiers, either returned or returning to British Columbia.

It is further recommended that a vote of \$250,000 be placed in the Estimates of this Session and voted and placed at the disposal of the said Commission.

Provided, further, however, that the Commission be given power to raise moneys by public subscription or donation to supplement such funds.

And whereas that gratitude should find expression in sincere endeavour to rehabilitate with the utmost speed those who have served, and in sincere endeavour to obviate to the greatest degree any loss, physical, financial, or otherwise, which they may have sustained through the service they have rendered:

And be it further Resolved, That in the opinion of this House Canada should, through its appropriate governing bodies, see to it that nothing is left undone in the matter of caring for its aforementioned returned citizens and making good to them their loss through service.

And be it further Resolved, That in the opinion of this House Canada should similarly, through its appropriate governing bodies, see to it that nothing is left undone in the matter of caring for the dependents of those who have fallen or been incapacitated in naval or military service.

And be it further Resolved, That, in so far as this Province is concerned, this House is of the opinion that every possible preference should be shown to our aforementioned returned citizens not only in the Civil Service, but in the matter of public employment.

And be it further Resolved, That in the opinion of this House the Government of this Province should co-operate with and encourage private employers in giving every possible preference in the matter of employment to our aforementioned returned citizens.

Mr. F. J. A. MacKenzie moved in amendment, seconded by Dr. McIntosh,-

To add the following paragraph:-

"And be it further Resolved, That in the opinion of this House the Government should proceed at once in this Session with a definite financial policy in the form of expenditures of moneys for public works or otherwise with a view to giving immediate practical relief to the returned soldiers and their dependents."

On objection taken by the Hon. the Premier, Mr. Speaker *Keen* ruled the amendment out of order as dealing with the expenditure of public money and Government policy. (*See* section 52, Constitution Act; *May*, 12th ed., 437; Speakers' Decisions, 80, 81.)

Mr. MacKenzie appealed from the ruling of the Chair.
