Prayers by the Rev. G. R. Easter.

Mr. Speaker delivered his reserved decision on the point of order raised by Mr. Gargrave on the 22nd instant, as follows:—

Honourable Members,—On resuming the adjourned debate on the motion "That Mr. Speaker do now leave the chair for the House to go into Committee of Supply" the honourable member for Mackenzie rose on a point of order, as follows:—

"My point is that after study of the budget and estimates presented by the Minister of Finance, I find provisions of the budget are in contravention of the 'Constitution Act Amendment Act, 1946,' being chapter 15 of the Statutes of 1946, which states only ten Ministers of the Crown shall receive a salary. The budget provides for eleven Ministers receiving salary.

"Since this is unconstitutional, my point of order is that this whole debate is unconstitutional and out of order and cannot continue until this grievous error is corrected or notice is given that it is the intention of the Government to create another ministry."

The Estimates of Revenue and Expenditure submitted by the Minister of Finance are for the consideration of the members of the Legislature, to be dealt with in Committee of Supply.

The Committee of Supply is fully competent to amend the estimates submitted, or any item therein, by way of making a reduction in same.
