Dr. Wrinch presented the First Report of the Select Standing Committee on Agriculture, as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

February 2nd, 1928.

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:—

The representatives of the Advisory Board of Farmers' Institutes and associates laid certain recommendations bearing upon the development of the agricultural industry before this Committee on February 2nd. After careful consideration your Committee respectfully submits the following:—

- (1.) Noxious-wccd Problem.—It is recommended that an active campaign of an educational and publicity nature be carried on through the Department of Agriculture to lead to and awaken a greater sense of responsibility in the control of noxious weeds throughout the Province. They recommend the Department to circularize all agricultural organizations, particularly within municipal areas, to enable them to assist in this work. Also that all field officers of the Department be instructed to include this subject in their lectures.
- (2.) Sheep Industry.—We recommend further encouragement be given to the extension of the sheep industry and desire to point out the very satisfactory increase in sheep throughout the Province. The first District Sheep Fair in the Province was organized and held on Vancouver Island last year, being a gratifying success.
- (3.) Amendment to the "Sheep Protection Act."—We recommend that the word "may" should be changed to read "shall" in section 17 (1), line 1, of the "Sheep Protection Act." 1926–27, it being desirable in our opinion that it shall be clearly shown that it is compulsory rather than optional to pay for damages under this Act. Therefore, line 1 should read: "The Council of any municipality shall provide for the licensing of all dogs."
- (4.) Oriental Problem.—The following resolution was submitted and is endorsed: "That consideration be given to measures to be taken to solve the problem of the encroachment of the Oriental into every line of industrial activity in British Columbia, particularly through the further issuance of statistical records as well as other means; and that measures be taken to convince and awaken interest in other Provinces as well as the Federal authorities in this very serious question."

Your Committee believe the report on Oriental activities within the Province presented to the Legislature in 1927 provided valuable information, and similar reports should be prepared for the purposes of comparison, as such records would indicate any further inroads by the Oriental

All of which is respectfully submitted.

"Between September 1st, 1912, and February 2nd, 1914, the Company sold \$14,234,805 of 4½-per-cent. guaranteed stock in London, from which the net sum of \$13,231,241.02 was received. The difference, \$1.003,563.98, represents discounts, underwriters' commissions, brokerage, exchange, and expenses—under authority of Order in Council approved November 16th, 1914, the balance of the guaranteed stock—namely, \$5,925,125—was pledged to the Union Bank with authority to sell at not less than 8 per cent. discount for loan of \$4,800,000 bearing interest at

Resolved, That a Supply be granted to His Majesty, and that the Committee rise and report the Resolution.

The Resolution was reported and adopted.

On the motion of the Hon, the Minister of Finance, seconded by the Hon, the Minister of Public Works, it was Resolved.—

That this House will at its next sitting resolve itself into a Committee of Supply.

Mr. I. A. Mackenzie moved, seconded by Mr. Leary,-

Whereas the forest wealth of British Columbia is one of our greatest natural resources:

And whereas in the past few years there has been a great increase in the demand for our forest products:

And whereas it would appear that the next decade will bring an even greater demand for our forest products:

And whereas it is of paramount importance to conserve this valuable asset as far as possible: Therefore be it Resolved, That the Standing Committee on Forestry be directed to investigate, during the present Session, this important problem, hear all necessary evidence, and report to the House their findings in regard to forest conservation.

A debate arose, which was, on the motion of Mr. Leary, adjourned to the next sitting.

Mr. Kergin moved, seconded by Mr. I. A. Mackenzie,-

Whereas the northern half of the Province of British Columbia and the whole of the Yukon Territory are bounded on the west by Alaska from 54° 40′ north latitude to the Arctic Ocean, a distance of approximately 1,300 miles:

And whereas the Province of British Columbia is bounded on the west by that part of Alaska known as the "Panhandle" from the 54° 40′ north latitude in a north-westerly direction to the 60th parallel of north latitude, a distance of approximately 600 miles:

And whereas said Panhandle of Alaska is in width approximately 30 miles, and acts as a barrier and is detrimental to the development of the northern half of this Province:

And whereas as a result of friendly diplomatic overtures between the Dominion of Canada and the United States previous differences of opinion in respect to the Alaskan-Canadian boundary were formally adjusted by the Alaska Boundary Tribunal on October 20th, 1903;

And whereas we believe it would be in the interests of both the United States of America and Canada that a readjustment of the Alaskan-Canadian boundary be made:

Be it therefore Resolved, That this House is of the opinion that negotiations should be opened between the Dominion of Canada and the United States of America having in view a readjustment of the Alaskan-Canadian boundary.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of this Resolution and Preamble be transmitted to the Honourable the Secretary of State or other proper official at Ottawa.

A debate arose, which was, on the motion of Mr. Twiyg, adjourned to the next sitting.

Mr. Davie moved, seconded by Mr. Peck,-

Whereas the Parliament of Canada, by an Act assented to on March 31st, 1927, enacted certain provisions dealing with the subject of old-age pensions:

And whereas it was by the said Act provided that the Canadian Government pension authority would make payment of a pension to such persons who, *inter alia*: (1) Had attained the age of 70 years; and (2) were not in receipt of an income of as much as \$365 per year:

And whereas the payment of the said pension to any person is by the said Act conditioned upon: (a) The right of the said pension authority to make the interest of any pensioner in his or her dwelling-house subject to be realized upon for the repayment to the said pension authority

of the amount of all payments made to such pensioner, together with interest on such payments at the rate of 5 per cent. per annum compounded annually; and (b) the right of the said pension authority to recover out of the estate of any deceased pensioner, as a debt due by the said pensioner to the pension authority, the sum of the payments made to such pensioner, together with interest on such payments at the rate of 5 per cent. per annum compounded annually:

And whereas the said provisions of the said Act have in effect: (1) The virtual pauperization of all successful applicants for an old-age pension; (2) the denial of a pension to any persons who, not having reached the age of 70 years, are nevertheless by reason of premature old age entitled to a pension equally with persons who have reached the age of 70 years; and (3) the granting of aid in many cases only out of the assets which the pensioner may be able to furnish, thus pauperizing such pensioner's dependents:

And whereas the aforesaid conditions are inimical to the interests of many persons who should be entitled to apply for old-age pensions as well as to the interests of their dependents:

Be it therefore Resolved, That this Legislative Assembly, endeavouring to represent the just cause of the aged persons of this Province and of their dependents, humbly petition the Canadian Government to alter the said Act so as to provide: (a) That the dwelling-house of any pensioner shall not be subjected to the repayment of any amounts paid to such pensioner by said pension authority; (b) reduction of the pension age from 70 to 65 years; (c) that an applicant for a pension shall be entitled to same regardless of such applicant's income up to an amount of at least \$365 per annum; and (d) exemption of the estate of a pensioner from repayments to the pension authority of amounts paid by way of pension in all such cases where such pensioner leaves him surviving any dependent.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause to be conveyed to the Secretary of State for Canada the foregoing Preamble and Resolution.

The Hon. Mr. Manson rose to a point of order.

Mr. Speaker reserved his decision.

Mr. Twigg moved, seconded by Mr. Jones,-

That an Order of the House be granted for the production of: (a.) The brief or briefs prepared and used by or on behalf of the Government of British Columbia in the inquiry before Mr. Justice Martin. (b.) All correspondence between the Government of British Columbia and the Government of Canada during the life of the Government in regard to the said inquiry both before and after the same took place.

A debate arose.

With the leave of the House the motion was withdrawn.

With the leave of the House, on the motion of Mr. Stoddart, the following motion was withdrawn:—

Whereas the Cariboo, in which Quesnel is an important factor, has had its development seriously retarded for many years by two factors, namely: (a) The lack of rail connection with Prince George and the Grand Trunk Pacific Railway; and (b) the uncertainty as to the future of the Pacific Great Eastern Railway:

And whereas lack of completion of the said Pacific Great Eastern Railway to Prince George is seriously hindering development within the area traversed by the said Pacific Great Eastern and beyond:

And whereas an aggressive railway policy has already greatly assisted the said railway by increasing both freight and passenger traffic and reducing operating loss:

And whereas powerful interests are even now at work with the intention of diverting Northern British Columbia business from the Pacific Great Eastern Railway:

And whereas the Government has stated that it will complete the railway if private interests do not acquire it:

And whereas we see no immediate prospect of the Pacific Great Eastern Railway being taken over by private interest or transcontinental lines:

Now the Quesnel Board of Trade, in general meeting, formally goes on record as urging the Government to complete the said railway to Prince George without any further delay, in the

strong belief that such action will bring prosperity to the Cariboo, cause the immediate development of natural resources, produce additional freight and passenger traffic, aid in the upbuilding of Coast points, and be of general benefit to the Province.

Mr. Poolcy moved, seconded by Mr. Twigg,--

That an Order of the House be granted for a Return of all correspondence passing between the Premier or other Minister of the Crown with any person or corporations dealing with any proposal for the sale of the Pacific Great Eastern Railway.

A debate arose, which was, on the motion of the Hon. Dr. MacLean, adjourned to the next sitting.

Mr. Hinchliffe moved, seconded by Mr. Pooley,-

That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a Bill be submitted to the House at this Session of the Legislature providing for the amendment of the "Provincial Elections Act," so as: (a) To do away entirely with absentee voters' ballots and votes; (b) to allow any elector to vote at any polling division within the riding upon whose list of voters his name appears; (c) to make provision for the taking of an advanced poll for certain classes of voters and under proper restrictions.

Where, during the renewal term of any lease renewed under subsection (1), the Minister of Lands is of opinion that the holder of the lease has developed a mine on the lands held under the lease, and is mining coal, petroleum, or natural gas therefrom, the Minister of Lands may give to the holder a notice requiring the holder to make application for and obtain a Crown grant pursuant to section 24 within sixty days from the giving of the notice; and if the holder fails or neglects to apply for and obtain the Crown grant within the time stated in the notice, the Minister of Lands may cancel the lease and all rights of the holder thereunder."

Add to said Bill the following section:-

"4. The amendments of said chapter 162 enacted by this Act shall apply retrospectively to every lease the original or renewal term of which had not expired on the twenty-seventh day of January, 1928, and to every lease in respect whereof the three months' period within which an application to purchase may be made pursuant to section 24 of said chapter had not expired on the twenty-seventh day of January, 1928; and in the case of such leases applications either for renewal under section 23 of said chapter or for purchase under section 24 of said chapter, as those sections are amended by this Act, may be made subsequent to the expiration of such term or period; but no application for renewal or for purchase in the case of any such lease made after the expiration of such term or period, as the case may be, shall be received or acted upon unless the application is duly made and filed with the Lieutenant-Governor in Council or the Minister of Lands before the expiration of thirty days after the coming into force of this Act."

Ordered, That the said Message, and the amendments accompanying the same, be referred to the Committee of the Whole House forthwith.

And whereas the Province of British Columbia is bounded on the west by that part of Alaska known as the "Panhandle" from the 54° 40′ north latitude in a north-westerly direction to the 60th parallel of north latitude, a distance of approximately 600 miles:

And whereas said Panhandle of Alaska is in width approximately 30 miles, and acts as a barrier and is detrimental to the development of the northern half of this Province:

And whereas as a result of friendly diplomatic overtures between the Dominion of Canada and the United States previous differences of opinion in respect to the Alaskan-Canadian boundary were formally adjusted by the Alaska Boundary Tribunal on October 20th, 1903:

And whereas we believe it would be in the interests of both the United States of America and Canada that a readjustment of the Alaskan-Canadian boundary be made:

Be it therefore Resolved, That this House is of the opinion that negotiations should be opened between the Dominion of Canada and the United States of America having in view a readjustment of the Alaskan-Canadian boundary.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of this Resolution and Preamble be transmitted to the Honourable the Secretary of State or other proper official at Ottawa.

Resolution agreed to.

The House resumed the adjourned debate on the motion moved by Mr. I. A. Mackenzie on February 8th, as follows:—

Whereas the forest wealth of British Columbia is one of our greatest natural resources:

And whereas the trolling fishermen in this Province are also in active competition with the trolling fishermen in the American fleets, who use as many lines as they desire and whose fishing in the open sea is unrestricted: And whereas the before-mentioned restriction would be disastrous to the trolling fishermen of this Province:

Therefore be it Resolved, That a respectful Address be presented to His Honour the Lieutenant-Governor, praying that a copy of this Resolution and Preamble be transmitted to the Honourable the Secretary of State, or other proper official at Ottawa.

 - 8. What has been the cost of selling the lots—either salaries or commissions?
- 9. Has the Government an office building in the area? If so, what has been the average monthly and annual cost of keeping the same?
 - 10. What was the cost of such office building?
- 11. What has been the total cost of planning, developing, and operating this area since its commencement to January 1st, 1928?
 - 12. What have been the total receipts in cash received from this area to January 1st, 1928?

The Hon. Mr. Pattullo replied as follows:—

- "1, 390 acres.
- "2. (a) Clearing, \$262,134.31; (b) grading property, \$9,062.36; (c) subgrading roads, \$82,100.45 for 55,000 lineal feet; (d) pavements, \$200,663.68 for 91,000 square yards; (e) cement walks, \$24,473.10 for 141,716 square feet; (f) curbs and gutters, \$60,898.85 for 65,525 lineal feet.
 - "3. Unit No. 1, 243; Unit No. 2, 106.
- "4. Forty-seven lots sold and thirty-eight lots leased, not including some eighteen agreements cancelled for non-performance.
- "5. Value of lots sold under existing agreements, \$96,111; value of lots leased under existing agreements, \$94,410.
- "6. Net amount from sales, including interest, \$69,151.07; net amount from leases, including interest, \$7,995.98.
 - "7. Yes. Resident Engineer and Agent, Major McPherson.
- "8. It is not practicable to apportion the time actually spent on sales, as general administration is carried on in same office. Total amount paid as commissions to registered real-estate agents is \$8,697.27.
- "9. No. Office quarters rented in a business block situate on Unit No. 1 and owned by H. R. Budd, C. Tweedale, and G. L. T. Sharpe. Monthly rental last year, \$110. This year increased accommodation is required and monthly rental will be \$160.
 - "10. See No. 9.
- "11. Total expenditure to January 1st, 1928, including loans, refunds, and commissions, is \$1,439,145.28.
 - "12. Total gross revenue to January 1st, 1928, including repayments on loans, is \$133,046.48."

Mr. W. A. McKenzie asked the Hon. the Minister of Lands the following questions:—

- 1. Was a sixteen-page folder with foreword "British Columbia Invites You," directing attention to British Columbia opportunities for investors and settlers, prepared by the several departments of the Government?
 - 2. If yes, what was the cost of preparation and printing?
 - 3. How many copies were printed?
 - 4. How many were supplied to the Provincial Bureau of Information?
 - 5. How were these distributed?
 - 6. How many were supplied to the Agent-General, London, for distribution?
 - 7. What disposition was made of any remainder?
 - 8. What quantity remains available for distribution?

The Hon. Mr. Pattullo replied as follows:-

- " 1. Yes.
- " 2. \$2,077.48.
- "3. 9,600.
- "4. Two.
- "5. Answered by No. 4.
- "6. None.
- "7. (a) 200 (pages 1-16) distributed; (b) 1,000 (pages 13-14, Big Game of B.C.) to Provincial Game Warden.
 - "8. 9,400 less 1,000 of pages 13-14."

Mr. Jones asked the Hon. the Attorney-General the following questions:-

- 1. Did the Government institute a system of checking automobiles in the Province by issuing stamp certificates?
 - 2. If so, what was the cost?
 - 3. How many certificates were issued?
 - 4. How many have been used?
 - 5. Has the said system been abandoned, and why?

The Hon. Mr. Manson replied as follows:-

- "1. Yes
- "2. Cost not determinable as work done by Provincial Police in the course of their duty, with the addition of some special constables.
 - "3, 75,000.
 - "4. 19,591, approximately.
 - "5. No."

Mr. Jones asked the Hon, the Minister of Public Works the following questions:—

- 1. What sums have been borrowed and fully expended for road-building purposes from January 1st, 1917, to March 31st, 1927?
- 2. What sums have been borrowed and fully expended for road-building purposes from April 1st, 1927, to January 1st, 1928?
- 3. What sums have been received by the Provincial Government from the Federal Government since April 1st, 1917, for road-building purposes?

The Hon. Dr. Sutherland replied as follows:-

- "1. See Public Accounts.
- "2. Borrowed for roads and bridges, \$2,680,231, fully expended.
- "3. \$1,251,955, in accordance with provisions of 'Canada Highways Act, 1919.'"

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

And then the House adjourned at 5.21 p.m.
