HALF-PAST EIGHT O'CLOCK P.M.

The House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

The debate continued.

On the motion of Mr. *Maitland*, the debate was adjourned to the next sitting of the House.

The following Bills were read a second time, and *Ordered* to be committed at the next sitting:---

Bill (No. 35) intituled "An Act to amend the 'Workmen's Compensation Act."

Bill (No. 6) intituled "An Act to amend the 'South Westminster Dyking District Aid Act.'"

Bill (No. 5) initialed "An Act to amend the 'Vancouver and Districts Joint Sewerage and Drainage Act.'"

Bill (No. 34) intituled "An Act to authorize the Refunding of Certain Indebtedness of the City of Enderby."

Bill (No. 7) intituled "An Act to amend the 'Delta Drainage Act, 1936.'"

Bill (No. 30) intituled "An Act to amend the 'Vancouver Enabling Act, 1935."

Bill (No. 27) intituled "An Act to amend the 'Poll Tax Act.'"

Bill (No. 29) intituled "An Act to amend the 'Succession Duty Act.'"

Bill (No. 19) intituled "An Act to amend the 'Food Products Minimum Loss Act."

The Hon. Mr. Weir presented the Annual Report of the Work done in pursuance of the "Teachers' Pensions Act" for the Year ended March 31st, 1939.

Mrs. Steeves asked the Hon. the Provincial Secretary the following questions:-

1. How many books were loaned out through the Provincial Library mailing service in 1939 and in 1938?

2. Has there been any method of publicizing the Provincial Library mailing service to British Columbia residents?

The Hon. Mr. Weir replied as follows:-

"1. 22,372 volumes in 1938; 23,366 in 1939, up to October 31st. During the period July to October, 1939, circulation was 44 per cent. higher than in the corresponding period in 1938.

"2. Within the last 18 months a poster has been sent to practically every post-office in the Province, and many smaller notices, placed in outgoing books for the purpose, have been handed to neighbours by readers. Every teacher in the Province, except those employed in the cities of Victoria and Vancouver, has been circularized in 1939."

Mrs. Steeves asked the Hon. the Minister of Education the following questions:-

1. Do School Boards purchasing books from the Text-book Branch of the Department of Education receive the benefit of dealers' discount?

2. Do individual schools, when making such purchases, receive the benefit of dealers' discount?

The Hon. Mr. Weir replied as follows:-

"1. Yes; on all purchases in districts where there are no dealers. In districts where there are dealers, School Boards are not supplied with prescribed text-books, but the Boards may obtain supplementary and reference books at discount from the Text-book Branch.

"2. If schools place their orders to the Text-book Branch through the secretary of the School Board or the Official Trustee, the orders are completed as in No. 1."

Mr. Maitland asked the Hon. the Attorney-General the following questions :---

1. What are the total receipts to date for car inspection under the "Motor-vehicle Act"?

2. What are the total receipts to date from drivers' examinations under the "Motor-vehicle Act"?

The Hon. Mr. Wismer replied as follows :--

"1. Nil. The only car inspections made by Provincial authorities are those made in check-ups on the road, for which no charge is made.

"2. \$104,971, to November 10th, 1939."

Mr. E. E. Winch asked the Hon. the Minister of Trade and Industry the following questions:-

1. What quantities of (1) apple pectin, (2) fruit-juices, (3) honey, (4) charcoal, (5) turpentine, and (6) rock-wool were respectively (a) produced, (b) imported, and (c) exported by the industries of the Province during each of the past two years?

2. What action, if any, has been taken by the Department towards establishing new or enlarging the capacity of existing plants for the purpose of building up a home and export trade in these commodities?

The Hon. Mr. Asselstine replied as follows:-

"1. (1.) Apple-pectin: (a.) No complete statistical information available. (b.) Not separately shown in Dominion trade statistics. (c.) Not separately shown in Dominion trade statistics.

"(2.) Fruit-juices: (a.) Production not separately shown in available statistics; included with numerous other products. (b.) In period April, May, June, 1939, 98,389 gallons of pineapple and grapefruit juice imported through British Columbia ports not necessarily for consumption. Information not available for earlier years. (c.) No record of any exports during 1939; information not available for earlier years.

"(3.) Honey: (a.) 1937, 1,427,475 lb., valued at 214,121; 1938, 1,583,120 lb., valued at 234,468. (b.) 1937, from other countries, 647 lb.; from other Provinces, 624,243 lb. 1938, from other countries, 11,241 lb.; from other Provinces, 609,810 lb. (c.) No exportation, but delivery for ships' stores amounted to 1,276 lb. in 1937 and 1,555 lb. in 1938. These statistics are taken from the Agricultural Statistics Report prepared by the Provincial Department of Agriculture.

"(4.) Charcoal: (a.) No production reported in British Columbia. (b.) From foreign countries: Animal charcoal, 1937, 112 tons; 1938, 121 tons. Wood charcoal, 1937, 288 tons; 1938, 212 tons. (c.) No exports reported.

"(5.) Turpentine: (a.) No production reported. (b.) Water-borne imports from foreign countries were as follows: 1937, $174\frac{1}{2}$ tons; 1938, 5,508 tons; additional imports may have entered the Province by rail. (c.) No exports reported.

"(6) Rock-wool: (a.) No commercial production reported. (b.) No importation from any foreign countries during the first six months of 1939 and information applying to earlier years is not available. The extent of importation from other Provinces is not known. (c.) No exports reported.

"2. Apple-pectin: The Department has not been approached by growers or others for assistance in this connection. The patent rights for the manufacture of pectin are held in Eastern Canada and it is in this area that the larger market exists for pectin for use in jammanufacture, etc. For such amounts of pectin as are used commercially in this Province it would not be economical under present conditions to encourage further local manufacture.

"Fruit-juices: The Department has built up a considerable file on fruit-juices with particular reference to apple-juice, and through the year has been in touch with the growers and with the holders of patent rights in the United States and elsewhere. While some progress has been made, production has not really passed the experimental stage. If or when a process is found which allows packing and storing of the juice without fermentation or cloudiness, the machinery of the Department is available for home and export markets.

"Honey: The average production of honey per colony of bees in British Columbia is much lower than among producers in other Provinces. Accordingly, British Columbia does not produce economically sufficient honey to supply its own domestic requirements, and the reason that we import from other Provinces is not one of indifference or inattention to possibilities.

"The prices paid for honey on the British market are ordinarily less than the British Columbia bee-keepers can obtain on their home market, and even if we had a surplus to ship at competitive prices, f.o.b. seaboard, the cost of shipping from British Columbia to the United Kingdom would be excessive compared with the rates available to Eastern Provinces from ports on the Atlantic seaboard.

"The Department has investigated this situation closely during the past year in co-operation with the Provincial Apiarist, the Canadian Manufacturers' Association, the office of the Acting Agent-General, and the Canadian Trade Commissioners in London and Australia.

"Charcoal: All processes would depend on the commercial outlet for charcoal and investigations have shown that a charcoal industry or a by-product operation producing only one product has not much chance of success. Ordinary charcoal finds limited uses, but the Bureau of Industrial and Trade Extension has in recent months built up an interesting file on the possibilities of manufacture of active carbon from cedar or other sawdust. This has been done in co-operation with the Forest Products Laboratories, Vancouver, the Timber Commissioner in London, the National Research Council, and the holders of patents in Europe and elsewhere. The market is limited, but the file has been reopened since the outbreak of war in view of the possibility of use of a high grade of active carbon in the manufacture of gas-masks.

"Turpentine: The question of the possibility of tapping our trees for gum resins has been raised many times and was investigated by Dr. Harris when he was attached to the Department for research purposes last year.

"It is generally conceded that the average yield from Western conifers is low as compared to other species such as Southern pine and that commercial utilization under present conditions would not be profitable.

"In addition there is competition from synthetic turpentines manufactured from mineral oils.

"Rock-wool: In co-operation with the Department of Mines, the Bureau of Industrial and Trade Extension has investigated market conditions throughout the building industry for the manufacture of mineral wool from natural deposits of limestone and dolomite. There has also been correspondence with United States interests in regard to possible branch establishment. The Bureau also investigated the commercial possibilities of slag deposits in the manufacture of rock-wool for insulating purposes, and active negotiations with a manufacturing concern in this connection were suspended only on the outbreak of war."

Mrs. Steeves asked the Hon. the Provincial Secretary the following questions:-

1. Has a Welfare Institutions Board been set up under the "Welfare Institutions Licensing Act"?

2. If yes, who are the members appointed to this Board?

3. (a.) Have any inspections of welfare institutions, as authorized by sections 9 and 10 of the Act, been held by the Board since its inception? (b.) If yes, how many under section 9 and how many under section 10? (c.) Which types of institutions have been inspected?

The Hon. Mr. Weir replied as follows :--

"1. Yes.

"2. Mr. P. Walker, Deputy Provincial Secretary (Chairman); Miss I. Harvey, Superintendent of Neglected Children; Dr. J. S. Cull, Acting Provincial Health Officer; Mrs. A. G. Westman, Superintendent of the Industrial School for Girls; Dr. A. S. Lamb, Division of Tuberculosis Control. (Miss L. Holland is Chief Inspector under the 'Welfare Institutions Licensing Act.')

"3. (a.) Yes. (b.) Under sections 9 and 10, 57 (April 1st, 1938, to March 31st, 1939). (c.) Organized institutions (for children, for aged and handicapped, hostels, homes for unmarried mothers), and boarding-homes (for children, for aged and handicapped)." Mr. Maitland asked the Hon. the Attorney-General the following questions :---

1. Has the attention of the Attorney-General been called to the finding of Commissioner F. A. McGregor that four companies have been parties to the formation and operation of a combine within the meaning of section 2 of the "Combines Investigation Act"?

2. Has the Attorney-General proposed to prosecute in relation thereto?

The Hon. Mr. Wismer replied as follows:----

"1 and 2. A report of Mr. F. A. McGregor, Commissioner under the 'Combines Investigation Act,' has just been received, but neither myself nor officials of my Department have had, as yet, an opportunity of perusing and studying same. When this has been done, such action will be taken as the evidence and findings indicate."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

1. In connection with the construction of the Island Highway Diversion east of Cobble Hill, has the Government paid any money by way of compensation, severance or otherwise, to: (a) W. H. Stuart, Cobble Hill, Vancouver Island; (b) Margaret Patterson Matthews, Cobble Hill, Vancouver Island?

2. If yes, how much?

The Hon. Mr. Pattullo replied as follows:--

"1. (a.) Yes. (b.) Yes.

"2. To W. H. Stuart, \$432; to Margaret P. Matthews, \$381."

Mr. Maitland asked the Hon. the Minister of Public Works the following questions:-

1. Was a new ferry constructed for the Kelowna-Westbank service?

1. In how many buildings in the City of Victoria has the Provincial Government rented space?

2. What are the names of these buildings?

3. What departments or branches of departments are housed in each one?

4. What, if any, additional space has been rented during 1939?

5. What is the annual rental cost to the Province in each of these buildings?

6. Why has it been found necessary to rent space outside of the Government Buildings themselves?

The Hon. Mr. Pattullo replied as follows:-

"1. The Public Works Department rents space in six buildings on behalf of the Provincial Government.

"2 and 3. B.C. Land Building; tenants, the Law Society of British Columbia. Royal Jubilee Hospital; tenants, Spencer Clinic. Dominion Bank Building; tenants, Department of Municipal Affairs. Belmont Building; tenants, Civil Service Commission, Superannuation Commission, and Labour Department. Weiler Building; tenants, Welfare Department, Forestry Department, and Economics Department. Eight rooms are occupied by the Education Department in the Central Building during the present Session of the Legislature.

"4. The Law Society of British Columbia, B.C. Land Building; Spencer Clinic, Royal Jubilee Hospital; Department of Municipal Affairs, Dominion Bank Building; Education Department, Central Building (during Session only); and one extra room for the Superannuation Commission in the Belmont Building.

"5. B.C. Land Building, \$120; Royal Jubilee Hospital, \$630; Dominion Bank Building, \$1,800; Belmont Building, \$4,008; Weiler Building, \$4,800; and Central Building (during Session of Legislature), \$155.60 per month.

"6. To provide accommodation not available in the Parliament Buildings."

Mr. Eyres asked the Hon. the Attorney-General the following questions:-

1. Has the Provincial Police jurisdiction on Indian reserves in this Province?

2. Who pays for policing of Indian reserves in the Province?

3. Are there special police appointed to police Indian reserves in this Province?

4. If so, what was the cost to the Province in 1938?

The Hon. Mr. Wismer replied as follows :----

"1. Yes.

"2. The Province, as far as the Provincial Police are concerned.

"3. Not by the Province.

"4. Answered by No. 3."

Mr. Finland asked the Hon. the Minister of Public Works the following question :---

What did it cost to construct the guard-rail constructed in 1938 on the Island Highway, Vancouver Island, between Mile 27 and Mile 29?

The Hon. Mr. Pattullo replied as follows:---

"No guard-rail was constructed between Mile 27 and Mile 29 on the Island Highway during the year 1938."

Mr. Eyres asked the Hon. the Attorney-General the following questions:-

1. What was the total cost of the Macdonald Report to the Province up to 1939?

2. What are the present monthly expenses of the Coal and Petroleum Control Board?

The Hon. Mr. Wismer replied as follows:-

"1. This question should be addressed to the Hon. the Provincial Secretary.

"2. This question should be addressed to the Hon. the Minister of Finance."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

Prayers by the Rev. N. E. Smith.

Mr. Speaker delivered the following decision with reference to the introduction of public Bills by private members:---

Honourable Members,—A question has arisen in the House with respect to public Bills introduced by private members.

Can a point of order be raised on the motion for leave to introduce the Bill, attacking it on the ground that it is not one which may be initiated by a private member, or is leave granted as a matter of course, points of order being raised at a later stage?

Parliament imposes certain restrictions upon private members originating or proceeding with legislation.

Section 52 of the "Constitution Act," R.S.B.C. 1936, chapter 49, is as follows: "The Legislative Assembly shall not originate or pass any vote, resolution, address, or Bill for the appropriation of any part of the Consolidated Revenue Fund, or of any tax or impost, to any purpose which has not been first recommended by a Message of the Lieutenant-Governor to the Legislative Assembly during the Session in which the vote, resolution, address, or Bill is proposed."

Our Standing Order 67 is to the same effect, except that it uses the word "adopt" instead of "originate."

See also section 54 of the "British North America Act" which is extended to the Provincial Legislatures by section 90 of the same Act.

B.C. Standing Order 76 provides that "Any Bill affecting the Constitution must be introduced by a member of the Government or with the sanction of the Government."

A careful perusal of the sections and rules above referred to as well as of the numerous authorities on the subject, will show that certain Bills require the Crown's consent while others must be recommended by the Crown.

Speaking in broad terms, Bills affecting the prerogatives, rights, and patronage of the Crown require the Crown's consent, while those involving public expenditure or imposing any tax or impost can only be initiated on the Crown's recommendation.

Failing the Crown's consent or recommendation, it is customary to raise a point of order when the Bill is called for second reading.

Where consent is required, it may be given at any time before the final question for passing the measure is proposed. (*Desjardins*, Quebec Decisions, 249.)

Where, however, recommendation by Message is required, it must precede the introduction of the measure. (*Desjardins*, 231, 387.)

Although the House has power to refuse leave for the introduction of a Bill, in practice leave is granted as a matter of course.

In British Columbia the formal motion for leave is still necessary (S.O. 74). But in England the procedure has been simplified. There the member may now either follow the old procedure of moving for leave or he may introduce the Bill by simply presenting it at the table, after previous notice but without any order of the House. If he adopts the procedure of simply presenting the Bill at the table it is not necessary for him to present the actual text of his proposal. He may present a form, called a "dummy Bill," upon which is written only the title of the Bill and the name of the member proposing it. (*Redlich*, vol. 3, pp. 86-87.) In this Province, however, no Bill may be introduced in blank (S.O. 75).

The formal nature of the procedure of introduction is indicated in the following quotation from *Redlich*, vol. 3, p. 86: "It is exceptional, save in the case of great Government measures, for the minister in charge to go into much detail in explaining to the House what it is being asked to admit to its deliberations. Even if a full summary is given, it is not customary to have a debate at this stage, unless it is desired to prevent the Bill even from being introduced. Of course, no question of the kind arises on the great majority of Bills. In consequence the preliminary stage generally takes but little time, and is attended with few difficulties. But from time to time the Opposition does take the opportunity of making an attack on some measure . . . when leave is asked to introduce a Bill. . . . If the motion is not treated in this very exceptional way the whole transaction is merely formal; leave is given and a day is fixed for introduction and first reading."

I rule, therefore, that points of order, if any, should be raised, not on introduction, but after the first reading.

In the interest of the prompt dispatch of the business of the House, I respectfully suggest that private members should not attempt to usurp the functions of Government by introducing, without previous discussion with the Government, legislation which, under the Constitution and the Standing Orders, can only be initiated upon the recommendation of the Lieutenant-Governor by Message, or can only become law with consent of the Crown. No good purpose is served by so doing. It does not serve to promote discussion of the measures because such measures are almost invariably ruled out of order before any discussion takes place. A private member has, of course, every right to introduce legislation which does not come within the prohibited classes, and my remarks have no reference to Bills which may be properly introduced by private members.

The following is an extract from *Todd* on Parliamentary Government, 2nd edition, vol. 2, pp. 368-370:---

"It has only been by degrees, since the passing of Reform Acts, in 1832, that it has come to be an established principle, that all important Acts of legislation should be originated and their passage through Parliament facilitated by the advisers of the Crown. The necessity for systematic and enlightened legislation for the improvement of our political and social institutions and for the amelioration of the laws, in accordance with the wants of an advancing civilization, together with the difficulty experienced by private members in carrying Bills through Parliament, have led to the imposition of additional burden upon the Ministers of the Crown, by requiring them to prepare and submit to Parliament whatever measures of this description may be needed for the public good. . . . On the other hand, it should be freely conceded to private members that they have an abstract right to submit to the consideration of Parliament measures upon every question which may suitably engage its attention, subject only to the limitations imposed by the prerogatives of the Crown or by the practice of Parliament. Bearing this in mind, it must be admitted that the rule that all great and important public measures should emanate from the Executive, has of late years obtained increasing acceptance."

"And whereas many farmers' organizations are already taking advantage of this method of securing feed-grains and grain by-products at cost:

"Therefore be it Resolved, That this House instruct the Select Standing Committee on Agriculture to make an examination of the operation of Canadian Freight Association Tariff No. 145 and to report its findings and recommendations to this Legislature."

On the motion of Mr. H. E. Winch, the debate was adjourned to the next sitting.

Mr. H. E. Winch moved, seconded by Mrs. Steeves,-

Prayers by the Rev. J. L. W. McLean.

On the motion of the Hon. Mr. *Pattullo*, the House proceeded to the Orders of the Day, "Public Bills in the Hands of Private Members."

On the Order being called for the second reading of Bill (No. 32) intituled "An Act respecting Annual Holidays with Pay," Mr. Speaker delivered the following decision on the point of order raised by the Hon. Mr. *Pattullo* on the 22nd instant:---

Honourable Members,—The Honourable the Premier has raised a point of order respecting Bill (No. 32) initialed "An Act respecting Annual Holidays with Pay."

Standing Order 67 provides that it shall not be lawful for the House to adopt or pass any Bill for the appropriation of any impost to any purpose which has not first been recommended to the House by Message of the Lieutenant-Governor.

Section 4 of the Bill provides that the Board of Industrial Relations constituted under the "Male Minimum Wage Act" may direct that employees shall be entitled to such holidays as the Board in its discretion may order. Such an order must, under section 5, provide for payment of wages during the period of the holiday. It follows that if the Bill were to become law, any order made by the Board would inevitably result in an impost upon a section of the public, namely, employers of labour. Under Standing Order 67, above referred to, it is not within the competence of a private member to introduce a Bill of this nature.

Members of the Opposition have argued that I cannot assume that the Board would make an order, as section 4 is permissive only. In answer to this I would point out that section 5 is not permissive, and I can not assume the Act would never be invoked. They argue further that it can not be assumed that employers would pay more if obliged to give holidays 3 GE0. 6

with pay than they would pay if no holidays were given. It seems to me, however, that it is impossible to escape the conclusion that an order of the Board would impose an added financial burden on the employer.

I therefore rule that the Bill is out of order in the hand of a private member.

Section 7 of the Bill confers powers on the Lieutenant-Governor in Council. Even if the Bill were otherwise in order this section could not be allowed to stand without the consent of the Crown. (See B.C. Journals, 1932, page 75.)

Prayers by the Ven. Archdeacon A. E. deL. Nunns.

On the motion of the Hon. Mr. *Pattullo*, the House proceeded to the Orders of the Day, "Public Bills in the Hands of Private Members."

Honourable Members,—The Honourable the Premier has raised a point of order with reference to Bill (No. 36) intituled "An Act to amend the 'Public Schools Act."

The present section 13 (e) of the "Public Schools Act," R.S.B.C. 1936, chapter 253, provides that it shall be lawful for the Council of Public Instruction from time to time, with the approval of the Lieutenant-Governor in Council, to conduct and maintain a school for the deaf and the blind children of the Province.

Section 2 of the Bill under consideration seeks to authorize the Council of Public Instruction, with the approval of the Lieutenant-Governor in Council, to provide sight-saving classes for children threatened with blindness and to admit to these schools children so threatened, as well as those who are totally blind.

It seems likely that this extension of the present service would require an additional expenditure of public money. Without deciding this, however, I must find section 2 of the Bill out of order on the ground that it confers additional powers on the Lieutenant-Governor in Council and so requires the sanction of the Crown.

By section 3 of the Bill, the Boards of School Trustees of municipal school districts are given power to provide educational facilities for deaf and blind children and those threatened with blindness, either through the establishment of schools and sight-saving classes or through monetary assistance to enable such children to attend Provincial schools established for the purpose. If this section of the Bill were to become law it would be the duty of the School Boards to carry out its provisions (see section 47 (1) of the "Public Schools Act"). The result would unavoidably be an increase in school taxes in municipal school districts and an increased contribution for school purposes to those districts from the Provincial Treasury. Section 3 of the Bill, therefore, under Standing Order 67 could only be introduced by Message of the Lieutenant-Governor.

For the reasons stated above I must find the Bill out of order.

N. W. WHITTAKER, Speaker.

On the Order being called for the second reading of Bill (No. 66) intituled "An Act to amend the 'Company Towns Regulation Act,'" Mr. Speaker delivered his reserved decision on the point of order raised by the Hon. Mr. *Pattullo* on the 23rd instant, as follows:—

Honourable Members,—Bill (No. 66) intituled "An Act to amend the 'Company Towns Regulation Act'" encroaches upon the Crown's prerogative to a degree that is surprising in so short a Bill.

Section 2 imposes duties upon the Minister of Lands and upon the Lieutenant-Governor in Council. It limits the power which section 3 of the present Act gives to the Lieutenant-Governor in Council to alter or revoke an order declaring an area a "company town." Whereas the power to declare an area a "company town" is now permissive, section 2 of the Bill makes the exercise of that power obligatory under certain conditions.

Section 3 of the Bill, if enacted, would deprive His Majesty, his servants and agents, and the general public of access to the company town wharf, wharf facilities, approaches, and ways. It imposes upon the Minister of Lands the duty of selecting a percentage of the lands, comprised in a company town area, for reconveyance to the Crown, and provides that the lands so reconveyed shall be offered for sale or lease.

I must rule the Bill out of order in the hands of a private member. (1 S.D. 20; 54; 61. 1931 B.C. Journals 128. *Desjardins*, Quebec Decisions, 231, 247, 335, 379, 383.)
