Mr. Speaker:

Your Select Standing Committee on Standing Orders and Private Bills begs leave to report as follows :-

Representations from the promoter of the undermentioned Bill were carefully considered, together with those of the Corporation of the City of Victoria, who petitioned against the passage of the Bill.

The subject-matter of the undermentioned Bill has been before the Privy Council and other Courts for a considerable time and a similar Bill was before the Legislature in the Session

The Supreme Court of this Province has restrained the engineer mentioned in the Bill from proceeding, owing to the subject-matter being barred by the Statute of Limitations.

Your Committee finds that the facts recited in the preamble of the Bill have not been proved; that to allow the Bill to proceed would be overriding the Statute of Limitations, and does not think there is sufficient cause for the Legislature taking such a course; that only in cases of grave injustice should the Legislature override the functions of the Courts; and recommends that Bill (No. 53) intituled "An Act relating to the Westholme Lumber Company, Limited, and the Corporation of the City of Victoria" be not allowed to proceed; but, recognizing the sincerity and energy of the promoter of the Bill, recommend the fees be returned.

MR. SPEAKER:

Your Select Standing Committee on Standing Orders and Private Bills begs leave to report as follows:—

That the preamble to the undermentioned Bill has been proved, and the Bill ordered to be reported with amendments.

Your Committee has given careful attention to the various suggestions from the promoters and other interested public bodies in regard to the undermentioned Bill and amendments thereto.

Your Committee has made several amendments to the original Bill to endeavour to meet many complex matters affecting the welfare of the City of Vancouver.

Representations were made to your Committee to amend the present Act to limit the powers of the Council in regard to initiating street-lighting improvements, but in view of the commendable work of town planning, now being carried on, and the fact that the powers now vested in the Corporation do not appear to have been abused, and in view of the necessity of some powers being vested in the Corporation to change and initiate improved lighting systems for the general welfare of the citizens, particularly regarding the detection of crime and the control of traffic, it is not deemed advisable to recommend any limitation of power now vested in the Corporation.

Representations were made to your Committee urging that the limitation of the appeal on assessments be removed.

Your Committee approves the principle of appeals on assessment being allowed on the question of the actual value of the property affected, but believes that, in view of the new Assessment Board being provided in the Amalgamation Bill now before the Legislature, it is not advisable to make amendments on assessment matters this year.

Amendments are submitted limiting the amount to be charged as local improvements to property affected on main thoroughfares; to make certain changes in the licence fees; to abolish plural voting; to provide for the Corporation to keep its streets in reasonable repair; and other matters.
