Sixth to tenth year full rate of 6 per cent. payable. End of tenth year accrued interest is funded and added to balance of principal owing; this total, with 6 per cent. interest, is then payable in ten equal annual serial payments. Five hundred dollars rebate is allowed at end of five years to returned soldiers, provided conditions of cultivation and fencing are satisfactory.

Gregory, R.R. 2, Chilliwack, 4 at 50 cents per day; Protestant Orphans' Home, Hillside Avenue, Victoria, 15 at 57½ cents per day; Loyal Protestant Association, 3224 First Avenue West, Vancouver, 34 at 57½ cents per day; The Alexandra Orphanage, 1726 Seventh Avenue West, Vancouver, 26 at 57½ cents per day; The Children's Aid Society, 1655 Tenth Avenue West, Vancouver, 112 maintained at actual per capita cost, which will not be known until audit has been completed by Audit Department at end of fiscal year.

- "2. In a radius between Finlay Forks and Hudson Hope extending a distance of 5 miles on either side of the Peace River, ten special firearms (trapping) licences have been issued. One of these licence-holders has a registered trap-line of approximately 100 miles.
- "3. A farmer, as defined under the 'Game Act,' can trap fur-bearing animals on his property during the open seasons declared under the Game Regulations, provided he is in possession of a special firearms licence. A farmer is given certain authority, however, under section 3 of the 'Game Act,' in respect to trapping or shooting animals or birds that are a menace to his domestic animals or birds. In dyked areas free permits can be and have been issued under section 40, subsection (1j), authorizing the farmer or a member of his family to trap muskrats which may be doing damage to his particular piece of property."

Mr. Wrinch asked the Hon. the Minister of Lands the following questions:-

- 1. Have any further payments been made on loan of \$60,000 by the Land Settlement Board to Lister Waterworks District by way of: (a) Principal; (b) interest; since March 4th, 1932? (See Journals of the House, 1932, page 41.)
- 2. What are total payments from this source since the date of the loan by way of:
 (a) Principal; (b) interest?

The Hon. Mr. Lougheed replied as follows:-

- "1, Yes. Principal, nil; interest, \$3,564; maintenance, \$381.

"The majority of copies of this report have been distributed to Game Associations and Gun Clubs in the Province, and to Game Departments in other Provinces of Canada and States of the United States. Members of the Legislature and other Provincial and Dominion Government officials have been supplied with copies of this report. A few copies of the report have been handed or forwarded to private citizens applying for same."

1932, are responsible for the care of single, homeless persons. Over eighty direct-relief camps are presently in operation by the Board, and it is anticipated further camps will have to be opened to allow of carrying out work during the coming summer.

"Section 27 (a) of 'Meat and Canned Foods Act' amended as follows:-

"'27. (a.) Canned salmon that are found by the Board of Inspection to be fresh, firm, well packed, and in good merchantable condition shall be approved, and a certificate in the form attached, marked "A." shall be issued therefor; provided that no certificate shall be issued for canned salmon that had not been landed fresh at a cannery for canning within twenty-four hours after being caught, excepting fish that has been gutted and iced immediately after being caught."

And whereas the ostensible object of the Order is to ensure the packing of sound salmon: And whereas salmon when caught in British Columbia waters and packed in ice can be landed in Boston in first-class condition:

Mr. Speaker delivered the following decision:—

Honourable Members:

I have considered the motion standing in the name of the honourable member for North Vancouver as No. 2 on to-day's Order Paper, and have reached the conclusion that the statement of facts in the preamble upon which the proposed resolution is founded are so strongly at variance with the matter complained of as to render the motion clearly out of order.

It is stated in the preamble that chapter 4 of the Statutes of 1932 provides that the Provincial Government must approve of any amending regulations issued under the Dominion Statute known as the "Meat and Canned Foods Act," and that upon inquiry it has been found that the Provincial Government has not been consulted in regard to, or officially advised of the passage of, an amending regulation passed under the Dominion Statute pursuant to Dominion Government Order in Council P.C. No. 206.

This statement is based upon a misunderstanding, or, perhaps it were better to say, a misconstruction of what, in fact, the recited Provincial Statute enacts.

Chapter 4 of the Provincial Statutes for 1932 is a brief Act of four sections. Section 2 provides, in effect, that legislation of the Dominion which has already been passed concerning

meat and canned foods shall, notwithstanding that such legislation may be ultra vires of the Dominion Parliament, have the force of law in the Province to the same effect as though such legislation had been enacted by the Province. The idea or scheme of this section is, obviously, to make effective in the Province any law passed by the Dominion which, under the provisions of the "British North America Act," might be held to be a Provincial and not a Dominion subject-matter of legislation. This section further provides that any such law (legalized as aforesaid by the Provincial Statute) shall continue in force until repealed by the Dominion authority, or until made the subject of special legislation by the Province, or until dealt with as directed by the Lieutenant-Governor of the Province pursuant to section 4 of the said Provincial Statute. Said section 4 provides, in effect, that the Lieutenant-Governor may proclaim that any ultra vires legislation passed by the Dominion authorities, but which has been made valid under the provisions of the Provincial Statute, shall cease to be law in the Province. The only power given to the Province under this section 4 is the power to cancel its own legislation.

Section 3 of the recited Provincial Statute is a repetition of section 2 as concerns future ultra vires legislation of the Dominion upon the same subject-matter.

The above is a brief statement of what, as a matter of fact, is covered by chapter 4 of the Provincial Statutes for 1932.

Accordingly, it will be perceived that this Statute contains no provision which requires that the Provincial Government must approve of any amending regulations issued under the "Meat and Canned Foods Act" of the Dominion before such regulations can become law. And, of course, any such provision, if enacted in a Provincial Statute, would be *ultra vires* of the Provincial Legislature.

The motion, therefore, is framed upon unfounded and incorrect facts, and is out of order for this irregularity. A motion affirming a fact, the incorrectness of which is clear, is sufficient to make such motion out of order. See in this connection the decision of Mr. Speaker Turcott in Desjardins' Speakers' Decisions (Quebec), bi-lingual edition, page 643, also at pages 665 and 667.

For these reasons I am obliged to rule that this motion cannot proceed.

The Hon. Mr. Tolmie replied as follows:-

Mr. Uphill asked the Hon. the Minister of Public Works the following questions:-

- 1. Is any amount paid by way of relief to unemployed persons in British Columbia; and, if yes, is there a uniform rate of relief throughout the Province, and what is the rate or rates so paid?
- 2. Is payment by way of relief granted in any case in which work is not required from the recipient?
- 3. Is varying cost of living in different areas of the Province taken into consideration in fixing rates paid for unemployment relief?
- 4. Is any amount paid by way of relief to single unemployed persons residing in their own homes or with parents: (a) In organized territory; (b) in municipalities? If yes, what are such amounts?
 - 5. Are single men who have homes or residing with parents compelled to go to relief camps? The Hon. Mr. *Bruhn* replied as follows:—
- "1. Yes; relief is given having regard to the needs of each individual and the financial resources of the Province.
 - "2. Yes, where work is not available.
 - "3. Yes: see answer to No. 1.
 - "4. Yes; see answer to No. 1.
- "5. Only where the Dominion Board of Administration regard such persons as coming under their jurisdiction and order such persons to go to camp."

Mr. Walkem asked the Hon. the Minister of Public Works the following questions:-

- 1. Was C. N. Tubman, of Victoria, employed in the New Westminster office of the Department of Public Works in 1931 and 1932?
 - 2. What was his official position?
 - 3. What was his monthly salary?
 - 4. Had he a monthly living allowance? If yes, how much?
 - 5. Did he receive a monthly allowance for the use of an automobile? If so, how much?
 - 6. Was he provided with a clerk during above period?
 - 7. If so, what remuneration did the clerk receive?
 - 8. Is Mr. Tubman still in the employ of the Government? If so, what is the remuneration?
 - 9. Does the Government supply him with a car? If yes, what is the cost?

The Hon. Mr. Bruhn replied as follows:-

"1 and 2. January 1st, 1931, to October 31st, 1931, Superintendent of Construction, Central Arterial Highway Relief Work; November 1st, 1931, to October 31st, 1932, Superintendent of

Municipal Relief Work carried out in Greater Vancouver and in the municipalities of Lower Fraser Valley, and also supervisor of Department's relief camps on right bank of Lower Fraser; November 1st. 1932, to December 31st, 1932, Chief Investigator in connection with direct relief, other than Dominion responsibility, afforded in Lower Fraser Valley.

- "3. January, 1931, to October, 1932, \$240 per month; November and December, 1932, \$180 per month.
- "4. January, 1931, to March, 1932, actual out-of-pocket expenses; March, 1932, to October, 1932, living allowance, \$30 per month; November and December, 1932, no.
 - "5. No; car provided by Government when necessary for the work.
- "6. During this period Mr. Tubman availed himself, when necessary, of such clerical services as were employed on the various undertakings supervised.
 - "7. See answer to No. 6.

- "8. Yes; \$200 per month.
- "9. Yes; car purchased December, 1932; cost \$846."
- Mr. Kergin asked the Hon. the Minister of Public Works the following questions:—
- 1. What was the total expenditure by the Department during the two fiscal years April 1st, 1927, to March 31st, 1929, in the following electoral districts: Alberni, Cariboo, Columbia. Esquimalt, and Dewdney?
- 2. What was the total expenditure by the Department during the two fiscal years April 1st, 1929, to March 31st, 1931, in the following electoral districts: Alberni, Cariboo, Columbia, Esquimalt, and Dewdney?

The Hon. Mr. Bruhn replied as follows:-

"1 and 2. See Minister of Public Works' Reports and Public Accounts for the years in question."

Mr. Pearson asked the Hon. the Premier the following questions:-

- 1. For what service was amount of \$4,480 shown in Public Accounts for year ended March 31st, 1932, page K 2, paid to J. A. Clark?
- 2. Is this the total amount received by this person for such services; and, if not, what further amount has been paid, or is due and unpaid, on this account?

The Hon. Mr. Tolmie replied as follows:-

- "1. Professional services as counsel to Committee of Legislature on Unemployment, from February 26th to April 13th, 1932.
 - "2. Yes. No further amounts due."

Mr. Cornett asked the Hon. the Minister of Labour the following questions:-

- 1. What is the total number of women and girls whose employment is governed by the Women's Minimum Wage Act?
 - 2. How many are receiving the minimum wage?
 - 3. By what means does the Minimum Wage Board ensure the observance of the Act?
- 4. Has it been necessary to take Court proceedings in any cases? If so, in how many cases, and with what result?

The Hon. Mr. McKenzie replied as follows:-

- "1. From actual figures supplied by employers for 1931 there were 18,154 women and girls receiving the protection of the Act. This total does not include farm-labourers, fruit-pickers, or domestic servants, whose employment is excluded from the jurisdiction of the Act. Figures for 1932 are now being received from employers, but complete returns will not be available for some little time.
- "2. For 1931, 3,919 women and girl employees received the minimum rate payable under the various Orders of the Board, 10,060 were in receipt of a rate higher than the legal minimum, and 4,175 were paid less than the minimum rate. This latter figure includes employees under 18 years of age, for whom lower rates are set, and employees who worked less than forty-eight hours per week and were paid on a pro-rata basis. Figures for 1932 are now being received from employers, but complete returns will not be available for some little time.

- "3. Observance of the Act is ensured by personal inspections and investigations, inspection of pay-rolls, checking of annual returns received by the Board, investigation of all complaints, and through Court proceedings. Where it was found that employees had been paid less than the legal minimum the following sums were collected for them by the Board: 1931, \$3,581.44; 1932, \$2,840.58; 1933 (to date), \$1,469.32. These amounts represent the difference between what they should have been paid and what they had actually received.
 - "4. Yes. Court cases as follows:-
 - "1931: Court cases, 20; convictions, 16; fines, \$425.
- "1932: Court cases, 11: convictions, 4; fines, \$100. Two cases dismissed, one withdrawn, three settled out of Court and arrears paid, and one pending, defendant not located and Bench warrant out for his arrest.
 - "1933 (to date): Court cases, 4; results pending.
- "For particulars of 1931 cases see Annual Report of the Department of Labour, 1931, page E 63."

Mr. Walkem asked the Hon, the Minister of Public Works the following questions:-

- 1. Was a relief camp constructed on the Kelowna-Naramata Road?
- 2. If yes, what was the cost?
- 3. What amount has been expended upon the Kelowna-Naramata Road since September, 1931?

The Hon. Mr. Bruhn replied as follows:--

- "1 and 2. No; camp constructed on eastern portion of Naramata District at a cost of \$5,221.
- "3. Approximately \$5,167.40."

Resolved, That the House, at its rising, do stand adjourned until 3 o'clock p.m. to-morrow.

And then the House adjourned at 4.55 p.m.

Section 2: Add word "cereal" after word "all" in second line.

Section 5: Schedule, Form 1, line 10: Add word "rye."

Section 7: Strike out, and in place thereof suggest section to provide for the granting of not more than one ton of seed to an individual in any one year.

Under Schedule add declaration of necessity and eliminate Form 3.

Form 2: Add word "rye."

All of which is respectfully submitted.
