MR. SPEAKER:

Your Select Standing Committee on Public Accounts and Printing begs leave to report as follows:—

Applications were received from several Departments for permission to destroy accumulated correspondence, etc., as authorized under "Public Documents Disposal Act," chapter 233, R.S.B.C. 1936, and such requests were granted.

We have gone into the matter of printing at some considerable length with the King's Printer and recommend:—

- (1.) That there be established a Custodian of Publications.
- (2.) That in the printing of Bills and changes thereon, for the convenience of members in dealing with such Bills, that the printed change be made in italics and the portion to be deleted lined through, thus showing at a glance the intended changes.
- (3.) That, as conditions warrant, consideration be given to the publication, with periodic revision, of a manual containing essential data relating to industrial and agricultural activity and opportunities for development and investment in the Province.

We would further recommend that in the interests of economy and shortage of supplies that serious consideration be given to the condensation of departmental reports under the supervision of an inter-departmental committee.

And whereas the rates for electricity are shown to be relatively high and the average use relatively low:

And whereas the water-power resources of British Columbia are estimated at 7,023,000 horse-power, ordinary minimum flow, of which only 792,363 horse-power is developed:

And whereas further development enabling reduced rates and expanded use for domestic and farm use is closely related to the provision of hydro-electric energy for industrial purposes at a low mass consumption rate:

And whereas no steps have been taken to secure engineering data necessary to determine the cost of water storage and hydro-electric installation on undeveloped water-power sites within transmission distance of potential new industries:

Therefore be it Resolved, That this House resolve itself into a Committee of the Whole to discuss the advisability of directing the attention of the Government to the need of instructing the Rural Electrification Committee to proceed with an inquiry to secure data necessary to determine the cost of producing hydro-electric energy under public auspices for industrial purposes from accessible water-power sites and an estimate of rates made possible by such installation with an interconnecting system for farm and domestic use.

A debate arose.

Mr. Asselstine moved in amendment, seconded by Mr. Bennett,—

To strike out all that follows after the word "Whereas" in the first line, and to substitute therefor the following: "in the Speech from the Throne on February 2nd, 1943, it was stated that 'action will be taken to establish a committee to survey and investigate the feasibility of developing hydro-electric power for the electrification of rural areas ':

"And whereas on April 19th, 1943, an Order in Council was approved appointing a committee to undertake the aforesaid survey and report on the same:

"And whereas the said Order in Council further expands the subjects of reference to include not only rural electrification but preliminary estimates of the capital costs of works proposed for increasing the supply and availability of electrical service, and the order of reference reads as follows:-

"'That, in order to secure reliable information in connection with the electrification of rural areas, it is deemed necessary and expedient to appoint a committee with powers to survey and report upon the extent and condition of electrical services in the Province, with particular reference to the servicing of rural areas.

"'. That the said committee be instructed to survey and report upon the following subjects:-

"'1. Rural areas in which electrical service is now available:-

- "'(a.) The source of electrical energy and the terms and conditions under which the service is furnished:
- "'(b.) Numbers of consumers presently served:
- "'(c.) Numbers of potential consumers not presently served and the reason therefor:
- "'(d.) Methods of improving the supply and availability of electrical service.
- "'2. Rural areas in which electrical service is not now available:—
 - "'(a.) Number of potential consumers:
 - "'(b.) Potential sources of electrical energy for such rural areas:
 - "'(c.) Proposed methods of furnishing service.
- "'3. The feasibility of supplying numbers of presently isolated communities from "grid" transmission systems and central production plants.
- "'4. Preliminary estimates of the capital cost of works proposed for increasing the supply and availability of electrical service.

- "'5. Estimated rates under which electrical service may be furnished under proposed plan.
 - "'6. The financial problems involved in furnishing electrical service, including:-
 - "'(a.) Whether financing of extension projects can be handled by existing utilities:
 - "'(b.) Whether rates pursuant to extensions could be carried by new consumers without concurrently increasing unduly costs to existing consumers.
 - "'(c.) If projects cannot be on a self-sustaining basis, how could they be financed?
- "'7. Any other technical and economic information in respect to rural electrification within the Province.'
- "And whereas a Progress Report of the Committee dated January 24th, 1944, has been received which sets out therein the results of their studies to date and the necessity of further investigations:

- "2. Mileage: Prince George to Manson River (reconstruction), 215 miles; Manson Crossing to Finlay Forks (new construction), 40 miles; Finlay Forks to Gold Bar (new construction), 70 miles; Gold Bar to Fort St. John (reconstruction), 99 miles; total, 424 miles.
- "3. Costs: Prince George to Manson Creek (reconstruction), \$1,427,000; Manson Creek to Finlay Forks (new construction), \$934,000; Finlay Forks to Gold Bar (new construction), \$2,415,000; Gold Bar to Fort St. John (reconstruction), \$1,132,000; total, \$5,908,000."
 - Mr. E. E. Winch asked the Hon. the Minister of Labour the following questions:—
- 1. What sum has been expended as provided for by section 11 (15B), chapter 72, Statutes of 1943, from date of operation until December 31st, 1943?
- 2. How many workmen (a) have been and (b) are now being assisted under the above provisions?

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—May it please Your Honour:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 76) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

In closing the Third Session of the Twentieth Parliament of British Columbia, I desire to express my appreciation for the care and sincerity that has characterized your deliberations.

The introduction of progressive measures for the further improvement of conditions of those in receipt of social assistance has given me great satisfaction.

I am pleased to observe that grants to cities, district municipalities, and rural areas have been increased with respect to the cost of education; that an exhaustive inquiry will be conducted into the whole field of Provincial-Municipal relations, particularly with respect to education; that provisions have been made for the lightening of the burden of taxation; remission of a percentage of automobile licence fees, and the extension of the distribution of free text-books.

It is with gratification that I note the ready acceptance of my Government to attend a Dominion-Provincial conference at Ottawa to discuss post-war plans. Your action in establishing a bureau of post-war rehabilitation and reconstruction; the creation of research departments; land grants to veterans; assistance to prospectors; provision for vocational training in conjunction with the Dominion Government; and a large programme of public works also affords me great satisfaction.

The additional privileges extended to those in the services by way of tax rebates and exemptions, thus safeguarding the interest of our men and women in the armed forces, are indeed commendable.

The construction of an outlet from the Peace River District to the Pacific Coast should inure to the economic well-being of our people.

I am pleased to note that provision has been made for an extraordinary programme of road maintenance amounting to \$1,500,000, and this sum, added to the regular vote, should assist very substantially in placing our highway system in an excellent state of repair.

The setting aside of funds amounting to \$2,000,000 for institutional buildings is a very wise measure and should materially assist in creating more adequate accommodation for those who have need of the treatment and care that these facilities will provide.

I am likewise gratified to note that regulations have been provided to promote the development of our potential oil and coal resources. Study by a Royal Commission of our forests and the industries dependent thereon will, I feel sure, be most beneficial to the people of this Province.

The decision to review further the operations of the British Columbia Electric Railway Company, Limited, and to continue to study the feasibility of rural electrification should be most valuable.

Continued improvements in British Columbia's financial position by further debt refunding and debt retirement and the resultant rise in the credit rating of the Province, together with the substantial savings effected, I am sure will commend itself to all.

I thank you for the adequate provision you have made for the public services and believe that your efforts will redound to the benefit of the people of this Province.

In relieving you of your labours, I trust that the blessing of Divine Providence will accompany you to your homes and that when this House again convenes we shall find a world at peace.

The Hon. Mr. Pearson, Provincial Secretary, then said:-

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
