Bill introduced and read a first time.

Second reading at the next sitting.

The Rules were suspended and the report adopted.

In the absence of Mr. Kergin, on the motion of Mr. Clearibue Bill (No. 51) intituled "An Act to validate and amend By-law No. 403 of the City of Prince Rupert" was introduced, read a first time, and referred to the Committee on Private Bills and Standing Orders.

On the motion of Mr. Neelands, Bill (No. 50) intituled "An Act relating to the Corporation of the District of Burnaby, British Columbia" was introduced, read a first time, and referred to the Committee on Private Bills and Standing Orders.

On the motion of Mr. W. A. McKenzie, seconded by Mr. Jones, it was Resolved,-

That an Order of this House be granted for a Return of all correspondence between the Provincial Government and the Federal Government at Ottawa dealing with the Resolution passed by this House on December 11th, 1922, touching claims for compensation for reconstruction of that part of the wagon-road between Hope and Spences Bridge, destroyed by reason of the building of the Canadian Pacific Railway and the Canadian National Railway.

The Government had a mortgage on the property of the Reduction Company, which mortgage is still in force. Messrs. Gillespie, Hart & Todd, Limited, continue to superintend the placing of the insurance by checking schedules and policies, but do not write any of the risk in companies represented by them. This, however, is not Government property, but the policies are payable to the Government in keeping with the terms of the mortgage.

"Registered mail insurance, the premiums on which amounted to less than \$1,000, was written by the firm during the above period, their tenders being the lowest."

The Hon, the Minister of Public Works presented corrected answers to the questions standing in the name of Mr. W. A. McKenzie on the Order Paper of November 8th, as follows:—

The Hon. Dr. Sutherland replied as follows:-

And it being 6 o'clock Mr. Speaker left the Chair, to resume it again at 8.30 o'clock p.m.

On the motion of the Hon. Mr. Oliver, seconded by Mr. I. A. Mackenzie, it was Resolved,—

Whereas the Canadian Department of Customs has in force a regulation providing that Canadian produce or manufactures in transit from one Province of Canada to another Province of Canada, and being transhipped at a foreign port, shall, upon the re-entry of such produce or manufactures into Canada, be subject to the imposition of Canadian Customs duties, as if such produce or manufactures were the produce or manufactures of the country where such transhipment took place, unless such transhipment had been done under the supervision of a Canadian Customs Officer:

And whereas the produce and manufactures of Eastern Canadian Provinces destined for British Columbia, and routed via the Panama Canal, are frequently transhipped at the Port of New York:

And whereas there is no Canadian Customs Officer stationed at the Port of New York, and therefore no supervision of transhipment, as required by Customs regulations, can be had at that port:

And whereas such Canadian produce or manufactures as above recited are subjected to the imposition of Customs duties upon their arrival in British Columbia:

And whereas the imposition of Customs duties as aforesaid inflicts an unnecessary hardship both upon the Eastern producer and the Western purchaser of such produce or manufactures:

And whereas the foregoing recitals are equally true in respect of the produce or manufactures of Western Canada routed through the Panama Canal via New York and destined for places in Eastern Canada:

And whereas section 121 of an Act of the Imperial Parliament, and known as the "British North America Act," reads as follows: "All articles of the growth, produce, or manufacture of any one of the Provinces shall, from and after the Union, be admitted free into each of the other Provinces":

And whereas by section 10 of the Terms of Union the provisions of the "British North America Act" were made applicable to the Province of British Columbia:

And whereas at the time of the enactment of the "British North America Act," and also at the time of the approval of the Terms of Union, there was no railway connection between the Eastern Provinces of Canada and the Province of British Columbia; and because of the above fact it is abundantly clear that it was not the intent of the Imperial Parliament that the operation of section 121 of the "British North America Act" should be limited to produce or manufactures transported between Provinces through all Canadian territory:

And whereas the Customs regulation hereinbefore referred to appears to be solely in the interest of transportation companies:

Therefore be it Resolved, That in the opinion of this House it is in the interest of all the Provinces of Canada that a Canadian Customs-house Officer should be appointed at the Port of New York, in order to facilitate the transportation of Canadian produce and manufactures via the Panama Canal.

And be it further Resolved, That in the opinion of this House the imposition of Canadian Customs duties upon the produce or manufactures of any Province of Canada and destined to any other Province of Canada (no matter by what route transported or where transhipped) is contrary to the provisions of the "British North America Act," and that such imposition should at once cease.

And be it further Resolved, That this House urge upon the Provincial Government to take such steps as it properly may to resist the imposition of Customs duties upon Canadian products and manufactures destined to British Columbia or produced or manufactured in British Columbia and destined to any other Province of Canada.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause a copy of the recitals and resolutions hereinbefore set out to be transmitted to the Honourable the Secretary of State, or other proper official at Ottawa, for presentation to His Excellency the Governor-General in Council.

The Resolution was carried unanimously.

No. 3—Corporation of the City of Victoria.

Your Committee would recommend that the petitioner be allowed to proceed with the Bill. All of which is respectfully submitted.
