The Hon. Mr. Turner presented papers in relation to the "Alien Labour Act, 1897."

On the motion of Mr. Walkem, seconded by Mr. Helmcken, it was Resolved,---

Whereas the construction of railways in the Province of British Columbia is a matter of the utmost importance to the inhabitants of the Province, as materially affecting their interests; and

Whereas occasions arise when applications are made to the Dominion Parliament for charters for railways in British Columbia, independent of any applications for the same to the Provincial Legislature; and

Whereas the granting of such charters by the Dominion Parliament may frequently conflict with the interests of the people of British Columbia, especially when the railways in question pass the International Boundary into the United States:

Therefore, be it Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying him to move the Dominion Government to oppose the granting of any charters for railways in British Columbia, unless such railway companies have first severally obtained a charter from the Provincial Legislature.

Mr. Williams moved, seconded by Mr. Semlin,-

That the Government, in granting the lands to the Nelson and Fort Sheppard Railway Company, exceeded the powers conferred upon them by the "Nelson and Fort Sheppard Railway Subsidy Act, 1892."

A debate arose, which was adjourned until Monday next.

The Hon. Mr. Turner presented a Supplementary Return re Revelstoke protection works.

Also, a Return of all creamery companies that have been financially aided by the Government, in accordance with the provisions of the "Dairy Associations Act, 1897"; the names of such companies; the location of the creameries; and the amount of the advance made to each company. Mr. Kellie asked the Hon. the Attorney-General the following questions :----

1. Is it the intention of the Government to bring in a Bill granting incorporation to the *Town of Revelstoke*, this Session ?

2. Why has action on the part of the Government been delayed?

"1. Yes; if the investigations being made are satisfactory."

Mr. Kennedy moved—That Bill (No. 36) initialed "An Act to amend the 'Liquor Traffic Regulation Act," be read a third time now.

Mr. Helmcken moved in amendment, seconded by Mr. McGregor,-

That the word "now" be struck out, and the words "this day three months" inserted in lieu thereof.
