Mr. Bowser asked the Hon. the Attorney-General the following question :---

What are the names of the old Game Wardens who received other appointments in the Service, the positions given them, and their present salaries?

The Hon. Mr. Farris replied as follows :--

"R. Gidley, appointed Acting Chief Game Inspector at \$105 per month; A. J. Hird, appointed Game Warden at \$90 per month; F. H. Butwell, Game Warden at \$90 per month; A. Carter, appointed Provincial Constable at \$85 per month (since resigned); W. J. Claridge, appointed Assistant Forest Ranger at Fernie, May 14th to October 31st, 1918, at \$100 per month; J. W. Graham, appointed Game Warden at \$95 per month (Mr. Graham's name was omitted in error from answer to question 2 in Votes and Proceedings, No. 8); A. P. Cummins, Deputy Game Warden, Sardis, in charge of the rearing of pheasants, was retained in the Service at \$95 per month."

Mr. Ross asked the Hon. the Attorney-General the following questions :----

1. What licences to hunt big game were issued during 1918 to non-residents of the Province by the Provincial constable or any other authorized official of the Department at the Government Agency at Golden, B.C.?

2. If any such big-game licences have been issued as aforesaid, what licences have been issued to non-resident Indians, giving names and date in each case?

3. If any such big-game licences have been issued as aforesaid, did any non-resident Indians, and how many, hunt under the same in British Columbia during 1918?

4. If any such big-game licences were issued to non-resident Indians in 1918, what statutory authority exists for the issuing of said licences to non-resident Indians?

5. What steps were taken to watch non-resident Indians hunting under said big-game licences and to see that they did not exceed the bag limit provided by section 10 of the "Game Act"?

6. If non-resident Indians hunted in British Columbia during 1918, what heads of grizzly bear, moose, sheep, wapiti, caribou, black or brown bear, mountain-goat, mule-deer, or deer of any other species did such Indians or any of them secure?

7. What fees have been paid by licensed non-resident Indians during 1918 under paragraph (e) of section 24 of the "Game Act," as amended by section 13, chapter 30, Statutes of 1918?

The Hon. Mr. Farris replied as follows :---

"1. Seventeen.

"2. Eleven. Hector Crowler, September 9th, 1918; Isaac Rollingmude, September 9th, 1918; Tom Powderface, September 9th, 1918; Enos Hunter, September 9th, 1918; Pater Ear, September 25th, 1918; Nathaniel Ear, September 25th, 1918; Jonas Ryder, October 2nd, 1918; Paul Amos, October 2nd, 1918; Enoch Baptiste, October 2nd, 1918; Johnny Bear Paw, October 5th, 1918; Pater Bear Paw, October 5th, 1918.

"3. Am not aware that any non-resident Indians hunted under these licences in British Columbia during 1918.

"4, 5, and 6. These licences were issued by the Government Agent and clerk in the Government Agency at Golden in error. The Department has no knowledge as to whether any of these licensees are Indians as defined by the 'Indian Act.' After it was ascertained that these licences had been issued, unsuccessful attempts were made to get the licences back, and a special detail was instructed to watch the licensees on the Alberta boundary-line to prevent them hunting in British Columbia, and, as far as I have been able to ascertain, no big game was taken or killed by the licensees under these licences.

"7. No fees have been paid."

Mr. Bowser asked the Hon. the Minister of Railways the following questions :---

1. Were tenders called for the building of twelve houses at Squamish?

2. What uses are these houses to be put to?

3. What are the dimensions of the said houses?

4. Whose tender was accepted, and the price of same?

5. Was the tender accepted the lowest tender?

6. If not, why was it accepted?

7. Who were the other tenderers, and the prices in each case?

The Hon. Mr. Oliver replied as follows :-

"1. Yes.

"2. Accommodation of P.G.E. employees.

"3. 24 x 27-4 rooms.

"4. Thos. Carson, Vancouver, \$18,989.

"5. Yes.

"6. Answered by No. 5.

"7. Ledingham & Cooper, \$31.200; Robertson & Partners, \$29,956; Cameron & Humber, \$28,140.44; Northern Construction Co., \$25,900; D. F. Russell, \$25,809; Dominion Construction Co., \$25,240; Hector McKinnon, \$25,200; Wm. McNee, \$21,600; A. W. and A. D. Snider, \$21,300. On percentage basis: Cut-to-Fit Buildings Co., Ltd., net cost plus 10 per cent.; Northern Construction Co., cost plus 5½ per cent."

Mr. Bowser asked the Hon. the Premier the following questions :---

1. Who is the present Agent-General for the Province in London?

2. When was he appointed, and what is his salary and allowance?

3. Is W. A. Blair connected with said office?

4. If so, what is his position, salary, and allowance?

The Hon. Mr. Oliver replied as follows :--

"1. Frederick C. Wade.

"2 August 15th, 1918; salary, \$666.66 per month.

"3. Yes.

"4. Secretary in office of Agent-General; salary, \$300 per month."

Mr. Bowser asked the Hon. the Attorney-General the following questions:-

1. Has a settlement been made by the Government in the suit of the Minister of Finance v. Railway Passengers' Assurance Company on the Dominion Trust Board?

2. If so, what amount was the suit settled for, and why?

3. What was the amount sued for?

4. What is the present status of the suit of the Minister of Finance v. London Guarantee and Accident Company on the other Dominion Trust Board?

The Hon. Mr. Farris replied as follows :--

"1. Yes.

"2. \$20,000; on the advice of counsel.

"3. \$200,000.

"4. Pleadings are not closed."

Mr. Pooley asked the Hon. the Attorney-General the following questions:----

1. What are the particulars of the "legal services" rendered by Sir C. H. Tupper for "constitutional matters" appearing in Vote 78 of the Public Accounts for which he was paid \$500?

2. Were said services rendered before, during, or after the Provincial general election?

3. Did the said Sir C. H. Tupper give a written opinion in the said matter?

4. Will the Department table a copy of the said opinion?

5. If no written opinion was given, will the Department table the correspondence in the said matter?

The Hon. Mr. Farris replied as follows :---

"1. Conference with the Prime Minister and Attorney-General and opinion on constitutional questions.

"2. The said services were rendered on the 8th, 12th, and 17th of August, 1917.

"3. Yes.

"4. Not deemed advisable.

"5. Answered by No. 3."

Mr. Bowser asked the Hon. the Minister of Railways the following questions:----

1. Was one Charles Erickson employed in October last as a roadmaster on the Pacific Great Eastern Railway?

2. If so, what salary was he paid?

3. Was he arrested by a Dominion police constable?

4. If so, for what offence?

5. What was the result of said arrest?

6. What nationality was said Erickson?

The Hon. Mr. Oliver replied as follows :--

"1. Yes.

"2. \$175 per month.

"3, 4, 5, and 6. The only information in possession of the Department is a letter signed by Geo. L. Courtney, late general manager, Pacific Great Eastern Railway Company, a copy of which is printed below."

Premier and Minister of Railways, Victoria, B.C.

DEAR SIR,—Last week Roadmaster Erickson was arrested by the Military Police in Squamish on account of his not having the necessary papers to prove that he was a Swede and thus exempt from military service. I believe that he was unable to produce the necessary evidence when brought before the military authorities here, and will be taken care of in Hastings Park until he is able to do so.

The matter was taken notice of in the Vancouver *World* of 12th instant, and I therefore wish to acquaint you of the facts regarding the employment of Erickson.

He was engaged a year ago by the late management, and has been employed continuously under late Superintendents Luedke and Rae. His work, I am told, has been satisfactory.

When the "Military Service Act" came into force Mr. Luedke was Superintendent, and was the official to be satisfied as to the eligibility or otherwise of employees for military service. Erickson must surely have satisfied Mr. Luedke at the time, and the question was not taken up with him afterwards either by Mr. Rae or Mr. Cameron. It may be that Erickson will be able to establish proof of his claim to be a Swede, but under any circumstances I do not think it would be advisable to re-employ him.

Mr. Ross asked the Hon. the Minister of Lands the following questions:---

1. Did one Kirby, of Chilliwack, a returned soldier, take the examination for a Forest Ranger in 1917?

2. Was he successful in said examination?

3. If so, why was he not appointed as Forest Ranger?

4. Was one Mills, of Vancouver, appointed District Forest Ranger or Fire Warden for Chilliwack District?

5. If so, why was a returned soldier not appointed?

The Hon. Mr. Pattullo replied as follows :---

"1. No examinations have been held for Forest Rangers, who are permanent officials. Examinations were held in 1917 for the selection of Assistant Rangers during the summer, recommendations from among those who took the examination being made by the Forest Protection Committee, representing the lumbermen, loggers, and the Department, as contributors to the Forest Protection Fund. Kirby took this examination.

"2. Yes; he barely got required number of marks.

"3. Appointments were made from those who passed highest. Forty-four passed and there were but nine vacancies in Vancouver Forest District.

"4. Ranger Mills was appointed before the present Government took office and his appointment was approved by the then Minister of Lands, Mr. W. R. Ross.

"5. Answered by No. 4."

Mr. Jones asked the Hon. the Minister of Lands the following questions :----

1. How many and what irrigation companies have been informed that a declaration of appurtenancy would be made since the "Water Act" was amended in 1917?

2. How many declarations of appurtenancy were made in 1917, with names?

3. How many declarations of appurtenancy were made in 1918, with names?

4. Why have declarations of appurtenancy not been made on all companies served with notices?

5. How many dyking and drainage districts have been formed in North Okanagan, South Okanagan, Similkameen, Greenwood, and Grand Forks Ridings, respectively, since May, 1918?

6. How many and what dyking and drainage districts in the above ridings have borrowed money from the Government?

7. The amount (if any) for each district?

8. What (if any) is the rate of interest?

The Hon. Mr. Pattullo replied as follows :--

"1. Two made: Peachland Real Estate & Fruit Company, Ltd., and Westbank Irrigation Company. Two under consideration: Peachland Townsite Company and Okanagan Securities Company, Ltd.

"2. None.

"3. Two.

"4. Matter now under consideration.

"5. None; but proceedings have been commenced for incorporation at Naramata, Glenmore and Rutland, and Ellison, all in the South Okanagan Electoral District.

"6. None; but several amounts have been set aside to protect several water systems.

"7. Answered by No. 6.

"S. Answered by No. 6."

Bill (No. 5) intituled "An Act respecting the Depasturing of Cattle upon Crown Lands" was read a third time and passed.

Bill (No. 19) intituled "An Act respecting the Pacific Great Eastern Railway Company" was again committed.

Reported without amendment. Report adopted. Third reading at the next sitting.

Bill (No. 22) intituled "An Act to amend the 'Fort George Incorporation Act'" was committed.

Reported without amendment. Report adopted. Third reading at the next sitting.

Bill (No. 23) intituled "An Act respecting the Municipal Election held in the City of Alberni in January, 1919" was committed. Benerited without amondment

Reported without amendment. Report adopted. Bill read a third time and passed.

Bill (No. 16) intituled "An Act to amend the 'Marriage Act'" was committed. Progress reported.

Committee to sit again at the next sitting.

The adjourned debate on the second reading of Bill (No. 17) intituled "An Act to provide for the Settlement of Differences between the Governments of the Dominion and the Province respecting Indian Lands and Indian Affairs in the Province of British Columbia" was resumed.

Bill read a second time.

To be committed at the next sitting.

The following Bills were read a second time, and *Ordered* to be committed at the next sitting:-

Bill (No. 25) intituled "An Act respecting the Craigflower School Site."

Bill (No. 26) intituled "An Act to amend the 'Probates Recognition Act.'"

Mr. F. J. A. MacKenzie asked the Hon. the Minister of Agriculture the following questions :---

1. Did the British Columbia Dairymen's Association, at their annual convention held at Chilliwack in February last, petition the Government to establish compulsory dairy-cattle insurance?

2. What answer (if any) did the Government give to said request?

The Hon, Mr. Barrow replied as follows :--

"1. No. At their annual meeting a resolution was passed appointing a committee to meet the Government and negotiate for such legislation, but this committee did not visit Victoria, and on April 17th the secretary of the association forwarded copies of the resolution.

"2. The Minister of Agriculture replied that it was too late to take action during that Session."

Mr. Giolma asked the Hon. the Provincial Secretary the following questions:----

1. For what officials was exemption secured under the "Military Service Act"?

2. At whose instance were the applications for exemption made?

3. Are the exempted officials still with the Department?

4. In the case of those who are no longer employed, what were their names, the reasons for their leaving the Service, and the dates?

The Hon. Dr. MacLean replied as follows :--

"1. (1) E. L. Small, B.S.A., District Supervisor of Agricultural Education, Surrey and Langley Municipalities; (2) H. E. Hallwright, B.S.A., District Supervisor of Agricultural Instruction, Victoria and Saanich.

"2. Application made by J. W. Gibson, Director of Elementary Agricultural Education, in behalf of the Minister of Education.

"3. Yes.

"4. All employed.

Bill (No. 54) intituled "An Act respecting the Rossland Water and Light Company" was committed.

Reported without amendment.

Report to be considered at the next sitting.

Bill (No. 53) intituled "An Act respecting the Cascade Water, Power, and Light Company, Limited" was read a second time.

To be committed at the next sitting.

With leave of the House, the second reading of Bill (No. 24) intituled "An Act respecting the Superannuation of Civil Servants" was called.

A debate arose, which was, on the motion of Mr. Pooley, adjourned to the next sitting.

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

And then the House adjourned at 4.20 p.m.
