Honourable Members,—This afternoon the Leader of the Opposition raised two questions of House privilege. The first of these was as to whether the Chairman of the Select Standing Committee on Public Accounts and Printing may, on his own initiative, arrange the proceedings of the Committee. The Chairman of any Committee may, in order to facilitate the work of the Committee, make certain preliminary arrangements; however, only the Committee is competent to direct the performance of its own functions within the Rules and within the terms of reference by the House. It is true that the Chairman may summons a witness without instructions from the Committee, and the power to do the same thing by a slightly different

method is available to each and every member of the Committee, but whether or not the witness may be heard is for the Committee to decide (vid. Standing Order 72 (1)).

The second point is whether it is competent for a member to discuss outside the House the matters which have been submitted to the Committee. Even though a matter is submitted to a Committee it is not improper for members to discuss that matter in the House if relevant to the debate (May, 16th edition, page 404). This being so, it is also not improper for a member to discuss the same thing outside of the House, but if he does so it is at his own risk, as he has not the same privilege afforded to a member making statements within the House. Furthermore, although matters before the Committee may be discussed, it must be clearly understood that the evidence submitted to the Committee or any material furnished to the Committee should not be discussed inside the House. Such evidence should not be discussed inside the House until the actual evidence itself or the material submitted is in the House before the members (May, 16th edition, page 462).

It may be necessary for me to make a further statement on this matter.

Mr. Perrault asked the Hon. the Premier the following questions:—

With respect to British Columbia Hydro and Power Authority:—

1. Has a charge been instituted with respect to customer connections in the British Columbia Hydro and Power Authority service area?

2. If the answer to No. 1 is yes, (a) on what date was this charge instituted and (b) what is the reason for the connection charge?

The Hon. W. A. C. Bennett replied as follows:—

"1 and 2. No, but policy, which has been in force in some areas of charging for connecting new premises to assist in covering the cost incurred by the Authority, has been extended to all service areas."

Mr. Perrault asked the Hon. the Premier the following questions:—

 - 2. If the answer to No. 1 is yes, what is the present frequency of the readings?

Mr. Perrault asked the Hon. the Premier the following question:—

Mr. Calder asked the Hon. the Minister of Lands, Forests, and Water Resources the following questions:—

- 1. Have the local people of Hazelton, or Kispiox, or Kispiox Valley contributed voluntary unpaid labour toward the construction of the Hazelton-Nass River Road?
- 2. If the answer to No. 1 is yes, when did this practice commence and is the Forest Service still accepting local voluntary unpaid labour?

The Hon. R. G. Williston replied as follows:-

"1. The only road construction being undertaken by the Department of Lands, Forests, and Water Resources along this route is on the Kispiox River forest-development road, and no local voluntary unpaid labour has been used on this project.

3. If the answer to No. 2 is in the affirmative, what was the purchase price?

The Hon. W. A. C. Bennett replied as follows:—

Mr. Calder asked the Hon. the Minister of Lands, Forests, and Water Resources the following questions:—

1. How many miles of road, if any, have been constructed by the Celgar Company Limited (Port Edward) from Terrace to Greenville?

2. How many miles of road, if any, have been constructed by the Celgar Com-

pany Limited (Port Edward) from Terrace to area beyond Aiyansh?

3. Has the Provincial Government received any indication from the Celgar Company Limited that it is their intention to continue construction of the Terrace-Nass River Road in order to join with the Stewart-Cassiar Road in the vicinity of Meziadin Lake?
