SIR,—Your letter of 3rd inst., enclosing a supplementary report or rejoinder to the report of the Municipality of Richmond, through their engineers, has just been received.

On the 4th instant I was advised that the bridge had sustained damage from the ice, and at once wired your Mr. Catt at Seattle :—"It is reported one or two piers and spans, North Arm Bridges, carried away by ice. Government hold your company responsible for all damage. Suggest you take immediate steps to preserve property."

To day I am in receipt of a report from the Government Road Superintendent, to the effect that several of the piers have been damaged, one of the spans carried away and fast in the ice half a mile above the bridge, and another span adjoining in a precarious condition. I have wired you and Mr. Catt to-day to the above purport, and urged you to take immediate action.

SIR,—I am in receipt of your telegram of 18th inst., stating, "If Government wishes, we will repair damage at North Arm at actual cost of work, labour, and material, and leave question of responsibility to be settled when we can confer with you."

In reply, I am instructed to say that the Government have no objection to your proposal being carried out on the distinct understanding that in case it is ultimately decided that your company are not responsible for the damage done, that you are to be paid the actual cost of repairs as represented by authentic receipts and vouchers for payments made by you in respect of the work; but, on the other hand, if it is decided that your company are responsible for the damage, under the provisions of your contract, then the cost of repairs shall be borne by you.

In any case it is, of course, understood that the repairs are to be made in a thoroughly substantial and workmanlike manner to the satisfaction of the Government.
