Mr. Gibbs asked the Hon. the Minister of Finance the following question:—

The Hon. W. A. C. Bennett replied as follows:—

"Fiscal year ended March 31st, 1935, (a) \$500,000 and (b) \$225,000; fiscal year ended March 31st, 1936, (a) \$3,950,000 and (b) \$75,000; fiscal year ended March 31st, 1937, (a) \$5,000,000; fiscal year ended March 31st, 1938, (a) \$1,000,000 and (b) \$200,000; fiscal year ended March 31st, 1939, (a) \$3,000,000 and (b) \$1,412,500; fiscal year ended March 31st, 1940, (a) \$7,707,500 and (b) \$1,854,824.15; fiscal year ended March 31st, 1941, (a) \$8,376,000 and (b) \$1,313,433.55; fiscal year ended March 31st, 1942, (a) \$141,514.54; fiscal year ended March 31st, 1943, (a) \$16,560,468.85; fiscal year ended March 31st, 1944, (a) \$3,130,494.41 and (b) \$30,000; fiscal year ended March 31st, 1945, (a) \$8,046,350.32; fiscal year ended March 31st, 1946, (a) \$5,121,304.89; fiscal year ended March 31st, 1947, (a) \$19,460,000; fiscal year ended March 31st, 1948, (a) \$19,045,000 and (b) \$381,000; fiscal year ended March 31st, 1949, (a) \$18,275,000 and (b) \$1,349,662.12; fiscal year ended March 31st, 1950, (a) \$30,000,000 and (b) \$7,241,000; fiscal year ended March 31st, 1951, (a) \$29,000,000 and (b) \$6,227,000; fiscal year ended March 31st, 1952, (a) \$65,000,000 and (b) \$3,157,000; fiscal year ended March 31st, 1953, (b) \$5,463,000; fiscal year ended March 31st, 1954, (b) \$33,804,900; fiscal year ended March 31st, 1955, (b) \$34,264,000.  - 3. Has the above building been purchased by the Government?
 - 4. If so, at what cost?

The Hon. P. A. Gaglardi replied as follows:—

- "1. Yes.
- "2. \$1,527.47.
- " 3. No.
- "4. Answered by No. 3."

Mr. Gibbs asked the Hon. the Minister of Lands and Forests the following questions:—

- 1. What was the number of permanent employees on the staff of the Department of Lands and Forests, inclusive of field staff and administrative staff, at December 31st, 1952, 1953, 1954, and 1955?
- 2. How many permanent employees on staff of the Department at December 31st, 1952, left the Department during years ended (a) December 31st, 1953, (b) December 31st, 1954, and (c) December 31st, 1955?
- 3. How many University of British Columbia graduates in forestry were taken on the permanent staff of the Department of Lands and Forests in each of years ended (a) December 31st, 1953, (b) December 31st, 1954, and (c) December 31st, 1955?

The Hon. R. E. Sommers replied as follows:—

- "1. 1952, 998; 1953, 1,069; 1954, 1,063; and 1955, 1,052.
- "2. Lands Service, (a) 40, (b) 25, and (c) 32; Forest Service, (a) 53, (b) 65, and (c) 36; totals, (a) 93, (b) 90, and (c) 68.

"3. Lands Service, (a), (b), and (c) nil; Forest Service, (a) 8, (b) 3, and (c) 3."

Mr. Gibbs asked the Hon. the Premier the following questions:—

1. In respect to the Pacific Great Eastern Railway, what was the total gross revenue from the railway for each month of 1955?

2. What was the estimated loss in revenue to the railway from the action taken by

Canadian National Railways in cutting rates to Dawson Creek via Edmonton?

- 3. As a result of the above loss of business was the railway called upon to compensate the trucking firm at Prince George for capital outlay for the so-called "piggyback" equipment?
- 4. Did the Government or the railway make investment in such equipment and, if so, how much?
- 5. Has the Government stipulated that all pipe for the gas pipe-line must move via Pacific Great Eastern Railway to Prince George?
 - 6. If so, is this to be at competitive rates or under agreed charges?
 - 7. If the latter, what is to be the rate per 100 pounds?
- 8. What amount of interest was paid on debentures issued in respect of the railway in 1955?
- 9. How much was paid from operating profit and how much from Consolidated Revenue?
- 10. In 1955, 1954, and 1953, (a) how many car-lots of logs or lumber in various forms were moved, (b) how many cars of beef and farm produce, and (c) how many cars miscellaneous?
- 11. In 1955, what sum was expended for repairs to existing trackage and rolling-stock?

The Hon. W. A. C. Bennett replied as follows:—

- "1. January, \$410,442; February, \$404,867; March, \$493,702; April, \$387,198; May, \$463,539; June, \$533,317; July, \$475,192; August, \$641,035; September, \$615,713; October, \$648,622; November, \$564,726; and December, \$472,596.
 - "2. \$10,600 loss (estimated).
 - "3, 4, and 5. No.
 - " 6 and 7. See No. 5.
 - "8. \$1,113,553.62.
- "9. \$967,303.62 from Consolidated Revenue in connection with direct obligations of the Province issued and sold prior to March 1st, 1952; \$146,250 from company in connection with bonds issued in 1954.
- "10. 1953, (a) 14,368, (b) 501, and (c) 2,347; 1954, (a) 20,056, (b) 580, and (c) 2,618; 1955, (a) 24,375, (b) 437, and (c) 3,406.
- "11. Maintenance of ways and structure, \$1,717,811, and maintenance of equipment, \$734,583."

Mr. Segur asked the Hon. the Minister of Highways the following questions:—

- 1. How many motor-vehicles were registered in British Columbia in (a) 1935, (b) 1945, (c) 1952, and (d) 1955?
- 2. How much per gallon was the road fuel tax in the years (a) 1935, (b) 1945, (c) 1952, and (d) 1955?
- 3. What was the amount received by the Government from this source in (a) 1935, (b) 1945, (c) 1952, and (d) 1955?

The Hon. P. A. Gaglardi replied as follows:—

- "1. Not under jurisdiction of Department of Highways.
- "2. Not under jurisdiction of Department of Highways.
- "3. Not under jurisdiction of Department of Highways."

- Mr. Gregory asked the Hon. the Minister of Highways the following questions:—
- 1. In the fiscal year 1954–55, how much money was spent on Provincial highways and bridges on Vancouver Island?
- 2. How much money was spent on Provincial highways and bridges in British Columbia other than Vancouver Island?
- 3. How many miles of Provincial highway were constructed and how many were reconstructed on Vancouver Island?
- 4. How many miles of Provincial highway were constructed and how many were reconstructed in British Columbia other than on Vancouver Island?

The Hon. P. A. Gaglardi replied as follows:—

- "1. \$4,271,497.86.
- "2. \$26,490,798.97.
- "3. Constructed, 15.65 miles, and reconstructed, 58.26 miles.
- "4. Constructed, 73.61 miles, and reconstructed, 258.10 miles."

Mr. Haggen asked the Hon. the Minister of Highways the following questions:—

- 1. (a) Did the Department receive any report that a bridge over the Kettle River Canyon approximately 1 mile west of Cascade had the deck drop under a school bus at any time during 1955, and (b) if so, on what date?
- 2. If so, (a) had inspection been made of such bridge prior to this date, (b) by whom was such inspection made and were any defects reported, and (c) what were they and when was report made?
- 3. (a) Are any plans being made to make such bridge safe and (b) if so, what is proposed?
- 4. Is the Minister satisfied that proper inspection of bridges is being made with sufficient thoroughness?
- 5. Is the Minister able to assure the House that timbers of bridges are given thorough inspection at fairly frequent intervals and that all bridges are kept in safe condition for normal traffic?

The Hon. P. A. Gaglardi replied as follows:—

- "1. No; but report received on December 8th, 1955, that failure had occurred in lower chord of Cascade Upper Bridge.
- "2. (a) Yes; (b) and (c) inspected by Bridge Inspector in July, 1954, and by District Engineer in August, 1954; one sill and one brace in substructure reported rotted.
- "3. (a) Yes and (b) addition of another truss frame as temporary measure and the construction of a permanent bridge as soon as possible.

" 4 and 5. Yes."

Mr. Laing asked the Hon. the Minister of Highways the following questions:-

- 1. Since April 1st, 1955, have any highway contracts been let without calling for tenders?
- 2. If so, state description, amount of contract, who was chosen instrument, and state why tenders not called.

The Hon. P. A. Gaglardi replied as follows:—

- "1. Yes.
- "2. Francis Peninsula Road, construction 1.25 miles new road, \$17,490, A. Howels; the contractor had completed the first section of this project satisfactorily the year previous; he was invited to bid on the second section, and the sum of \$17,490 being considered reasonable, was given contract on recommendation of Chief Engineer."

Mr. Laing asked the Hon. the Minister of Highways the following questions:—

- 1. In reference to the Trans-Canada Highway, how many miles are now completed up to standard?
 - 2. How many miles remain uncompleted to standard?
- 3. What total sum since the signing of the agreement has been paid by the Federal Government (a) under contracts let and (b) on previous construction incorporated in the highway?
 - 4. How soon may we expect this highway to be completed?
- 5. Has the Minister suggested to the Federal Minister of Public Works that standards be reduced so that early payments may be made on highways existing when the agreement was signed?
- 6. Since the agreement was signed what amount has been paid for acquisition of private property for relocation or improvement?
- 7. In all cases was sufficient property acquired to provide a two-lane highway only after provision for standard shoulders?

The Hon. P. A. Gaglardi replied as follows:—

- "1. 238.32 miles.
- "2. 446.73 miles.
- "3. (a) \$15,223,766.27 and (b) \$1,170,277.71.
- " 4. 1960.
- " 5. No.
- "6. \$1,123,578.06.
- "7. Ouestion not clear."

Mr. Haggen asked the Hon, the Minister of Highways the following questions:—

- 1. Was any drilling or foundation testing done during 1955 on a proposed bridge between Westbank and Kelowna over Okanagan Lake?
- 2. If so, were any modifications in design previously communicated to the press found to be desirable and, if so, what were they?
 - 3. Did any change in estimated cost result therefrom and, if so, what?
- 4. Has the Minister any knowledge of efforts being made to foist any part of bridge-construction costs on to residents of Kelowna?

The Hon. P. A. Gaglardi replied as follows:—

- "1. Yes.
- "2. Yes; change from suspension bridge to combination of causeway and floating bridge with a lift span, on final recommendation from consultant engineer.
- "3. Yes; modification in design resulted in estimated cost being reduced by about one-third.
 - " 4. No."

Mr. Haggen asked the Hon. the Minister of Highways the following questions:—

- 1. Has any right-of-way been purchased in connection with a proposed bridge across Okanagan Lake?
 - 2. If so, from whom and what are the areas and amounts paid in each case?

The Hon. P. A. Gaglardi replied as follows:-

- "1. Negotiations in progress.
- "2. See answer to No. 1."

Mr. Laing asked the Hon, the Minister of Lands and Forests the following questions:—

- 1. Has one Fuhrmann, an American citizen, acquired an indeterminate lease on some 19,000 acres of land between Dawson Creek and Fort St. John?
- 2. Was an Order in Council passed removing this land from reserve to make the lease possible?
- 3. Is it proposed to similarly release other areas in acreage of this size either for lease or sale to either Canadian or American citizens?

The Hon. R. E. Sommers replied as follows:—

"1. No; however, Mr. D. A. Fuhriman, of Dawson Creek, B.C., was granted thirty separate leases, totalling 19,179.7 acres, for grazing and agricultural purposes, each for

a period of twenty-one years from October 19th, 1955.

- "2. No; the lands over which leases have been granted in favour of Mr. Fuhriman comprised part of an area of approximately 56,000 acres which, in the interest of orderly settlement and in light of its marginal agricultural potential, was, in 1951, temporarily withheld from alienation. Consequent upon increased settlement demands and the possibilities of this particular area for ranching only under proper management, in 1955 it was considered in the public interest to make these lands available by purchase or lease and notice to this effect was published in The British Columbia Gazette and all Peace River newspapers. Mr. Fuhriman's applications to lease were received subsequent to such publication.
- "3. Yes; it is proposed to progressively make available for settlement other areas as the public interest warrants."

Mr. Haggen asked the Hon. the Minister of Lands and Forests the following questions:—

- 1. What amount, if any, is in the Grazing Range Land Improvement Fund at present?
 - 2. To which districts, if any, is it owing?

The Hon. R. E. Sommers replied as follows:—

- "1. Balance to credit of Grazing Range Improvement Fund as of January 31st, 1956, \$42,806.60.
- "2. None; the Grazing Range Improvement Fund is established under authority of section 14 of the 'Grazing Act' for the purpose of the improvement of Crown ranges throughout the Province."

Mr. Laing asked the Hon. the Minister of Lands and Forests the following questions:—

- 1. In the case of the forest management licence granted, subject to appeal, to Empire Mills Limited, what was the acreage covered by this licence?
 - 2. What was the estimated total scale in this area and of what preponderant species?

 3. Was the above estimate supported by any cruise and, if so, to what extent?
- 4. Have cruises been taken in the area covered by this proposed management licence since the licence was granted and, if so, what is now the estimated total scale in the area?

The Hon. R. E. Sommers replied as follows:-

- "1. No management licence has been granted to Empire Mills Limited.
- "2, 3, and 4. Not applicable."

Mr. Laing asked the Hon. the Minister of Lands and Forests the following questions:—

- 1. Has site for a Provincial park been purchased in South Okanagan Electoral District and, if so, what is acreage, location, from whom purchased, and what was the price?
 - 2. How were the necessary funds found for this purchase?
 - 3. When will development of the park begin?
 - 4. What body makes recommendations in respect to purchase of such park areas?

The Hon. R. E. Sommers replied as follows:—

- "1. Yes; 197.67 acres, midway between Penticton and Kelowna, purchased from Annie May Miller and Archibald Seaton Miller, of Peachland, B.C., for the sum of \$52,000.
- "2. The purchase was made by special warrant, approved by Order in Council No. 2226, dated September 13th, 1955.
 - " 3. 1956.
 - " 4. Forest Service."

Mr. Laing asked the Hon. the Minister of Highways the following questions:—

- 1. Has the Minister assured the Municipality of Burnaby that the Lougheed Highway is to be widened?
 - 2. If so, when is it proposed to start work?

The Hon. P. A. Gaglardi replied as follows:—

- "1. Yes; verbally.
- "2. Fiscal year 1956-57."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

And then the House adjourned at 5.59 p.m.
