I wish to announce that the British Columbia Power Commission proposals regarding the Upper Campbell Lake and Buttle Lake have to-day been approved by the Government, and, further, I wish to advise the House that the British Columbia Power Commission has been authorized to construct a dam below the outlet of Upper Campbell Lake to provide limited water storage initially, and, in the second stage of the project, further storage and generating capacity.

To meet the rapidly increasing power demands on Vancouver Island, the Crownowned utility has planned the further development of Campbell River, prime source of hydro-power on the Island, in this way:— (1) Construction of a large dam some 2 miles below the outlet of Upper Campbell Lake which will raise the lake-level some 79 feet.

This will provide limited storage to "firm up" the capacity of downstream generating plants.

Investigations and studies have been carried out for several months, and the dam is expected to be sufficiently advanced to permit storage of water by November, 1956, and fully completed by the following spring. Estimated cost of this initial stage is about \$9,000,000.

(2) Predicted load requirements indicate it will be necessary to build the Upper Campbell dam to permit raising Upper Campbell Lake another 30 feet in 1958, at the same time installing generating capacity at that site in the order of 70,000 horse-power.

The second stage is estimated to cost around \$10,000,000.

(3) This second raising of Upper Campbell Lake will cause flooding up-stream into Buttle Lake which will be raised about 6 feet over its extreme high level and about 15 feet over its normal high level.

In effect, one large lake, some 30 miles in length, will be formed.

It is noted that this scheme is a further step in the original plan to develop the Campbell River system to its economic limit.

The reason Upper Campbell storage has been adopted rather than the former plan of damming Buttle Lake first, and Upper Campbell Lake later, is that the power situation on Vancouver Island has changed since the original proposal was set forth nearly ten years ago and for which authority was sought by the Power Commission in 1951.

Four years ago it was anticipated that storage would be required for the period from 1953 to 1960, with generating facilities at the Upper Campbell site estimated to be needed after 1960.

Accelerated power demands resulting largely from major expansion by secondary forest industries have advanced the requirement for both additional storage and generating capacity to about 1958.

The Power Commission believes the programme is the most economic method of further developing Campbell River in the light of present costs and conditions.

The Power Commission is following its policy of the balanced use of natural resources, and in this regard fisheries and recreational features have been given due consideration in the Campbell River scheme.

So rapid has been the increase in electric-power loads on Vancouver Island that the peak demand predicted five years ago as likely to occur in January, 1957, actually was reached last December (1954)—more than two years sooner than had been expected in the 1950 studies.

The peak demand on the John Hart plant at Campbell River has more than quadrupled in the past five years.

In the winter of 1949–50 it was about 28,800 kilowatts; this winter it was 119,800 kilowatts—virtually the entire 120,000-kilowatt capacity of the plant.

There is every indication that this rapid pace of growth will continue.

In four years it is expected the peak demand on the Commission's Island system will be in the order of 200,000 kilowatts, an increase of about 67 per cent over the peak load carried this past winter and almost seven times the peak of the winter of 1949–50.

And tabled a copy of Order in Council authorizing the Power Commission to proceed with the work.

254. Resolved, That a sum not exceeding \$54,166 be granted to Her Majesty to defray the expenses of Department of Mines, Analytical and Assay Branch, to 31st March, 1956.

255. Resolved, That a sum not exceeding \$137,196 be granted to Her Majesty to defray the expenses of Department of Mines, Inspection Branch, to 31st March, 1956.

256. Resolved, That a sum not exceeding \$16,100 be granted to Her Majesty to defray the expenses of Department of Mines, Grants and Subsidies, to 31st March, 1956.

257. *Resolved*, That a sum not exceeding \$165,000 be granted to Her Majesty to defray the expenses of Department of Mines, Grants in Aid of Mining Roads and Trails, to 31st March, 1956.

The Hon. P. A. Gaglardi replied as follows:-

"Some widening of rock cuts will be done on the Stewart-Hyder Road during 1955."

Mr. Nimsick asked the Hon. the Minister of Public Works the following questions:-

1. Has the highway bridge at Springbrook been replaced by a temporary bridge?

2. If so, have plans been made for the replacement of this by a permanent bridge?

3. If yes, what plans have been made?

The Hon. P. A. Gaglardi replied as follows:-

"1. Yes.

"2. Design for a permanent bridge is in progress.

"3. Answered by No. 2."

Mr. Gregory asked the Hon. the Minister of Public Works the following questions:-

1. In the calendar year 1954, how much money was spent on Provincial highways and bridges on Vancouver Island?

2. How much money was spent on Provincial highways and bridges in British Columbia other than on Vancouver Island?

3. How many miles of Provincial highways were constructed and how many were reconstructed on Vancouver Island?

4. How many miles of Provincial highways were constructed and how many were reconstructed in British Columbia other than on Vancouver Island?

The Hon. P. A. Gaglardi replied as follows:---

"1. \$3,983,429.61 (fiscal year 1953-54).

"2. \$25,171,309.23 (fiscal year 1953-54).

"3. Constructed, 12.3 miles, and reconstructed, 48.5 miles.

"4. Constructed, 80.3 miles, and reconstructed, 263.3 miles."

Mr. Howard asked the Hon. the Minister of Public Works the following questions:-

1. For the year ending March 31st, 1955, how much money, if any, was allocated for Highway No. 16?

2. To date, how much has been expended?

The Hon. P. A. Gaglardi replied as follows:-

"1. \$1,421,000.

"2. \$1,341,794.18."

Mr. Gregory asked the Hon. the Minister of Public Works the following questions:-

1. How many miles of Provincial highway are there on Vancouver Island?

2. How many miles of Provincial highway are there in British Columbia exclusive of Vancouver Island?

The Hon. P. A. Gaglardi replied as follows:----

"Mileage of roads in British Columbia as at March 31st, 1954:-

"1. Vancouver Island (including Gulf Islands): Provincial, 2,099.05; classified, 101.82; total, 2,200.87.

"2. Exclusive of Vancouver Island: Provincial, 20,077.32; classified, 518.65; total, 20,595.97.

"Total mileage: Provincial, 22,176.37; classified, 620.47; total, 22,796.84."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

And then the House adjourned at 10.43 p.m.
