May, tenth edition, page 291, says:—"In passing Bills, a greater freedom is admitted in proposing questions, as the object of different stages is to afford the opportunity of reconsideration. * * * Upon this principle, it is laid down by Hatzell, and is constantly exemplified, 'That in every stage of a Bill every part of the Bill is open to amendment, either for insertion or omission, whether the same amendment has been in a former stage accepted or rejected. The same clauses or amendments may be decided in one manner by the Committee, in a second by the House on report, and, formerly, might have been dealt with again on the third reading."

May, tenth edition, page 472, says:—"Verbal amendments only can be made to a Bill on the third reading. When material amendments are desirable, the Order for the third reading of the Bill may be discharged, and the Bill recommitted, to introduce the amendments in Committee."

I think that the amendment of the Hon. mover is clearly out of order on report, a similar amendment having been negatived on the 28th ult., but that at the third reading stage the Bill may be re-committed, with instructions to the Committee to consider the amendment of the Hon. Member.

The Government will either deduct such amount from the final estimate coming to the Company, or else take satisfactory security from them therefor.

"(d.) The Nakusp and Slocan Railway Company have not yet received the full amount

of the debenture guarantee, but are about to do so.

"(e.) I do not think that a lien could be successfully placed upon the railway."
