"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill." Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

In closing this, the First, Session of the Twenty-seventh Parliament of British Columbia, I desire to express my appreciation for the care and sincerity which have characterized your deliberations. I am indeed grateful that legislation has been enacted which will be of benefit to the citizens of this Province.

It is commendable to note that the *Mental Health Act*, 1964, replaces all present Statutes respecting the care and treatment of mentally disordered persons and, by modernizing the legislation in this respect, permits the development of comprehensive psychiatric services.

Your authorization of the County Courts Act Amendment Act, 1964, and the Supreme Court Act Amendment Act, 1964, gives County Court Judges the jurisdiction to include criminal jury trials and the right to function as Local Judges of the Supreme Court in Vancouver, Victoria, and New Westminster.

The Jury Act Amendment Act, 1964, provides increased remuneration to jurors and alters the basis of exemption from jury service.

Provision for expanded inspection and auditing in the Credit Union Act, 1961, Amendment Act, 1964, affords further protection to credit union members.

The amendments to the *Insurance Act* and the *Motor-vehicle Act* are commendable in that maximum insurance coverage will be increased to \$50,000.

It is with gratification that I note my Government's intention to remove tolls from the Deas Island Tunnel and Oak Street Bridge as of April 1, 1964.

In approving the *Toll Highways and Bridges Authority Act Amendment Act,* 1964, the name of the Authority has been changed to the "British Columbia Ferry Authority," which now more suitably describes the Authority.

The Revenue Act Amendment Act, 1964, provides for investment, in the right of the Province, in shares up to 25 per cent of the capital of a bank to be established in British Columbia.

In order to assist home-owners who for some time have occupied their residences, the amendment to the *Assessment Equalization Act*, approved by you, will consider only the present residential use of the land rather than the higher prevailing assessment values.

You are to be commended in enacting the Fair Employment Practices Act Amendment Act, 1964, which makes provisions prohibiting discrimination against those persons between 45 and 65 years of age.

Further beneficial legislation has been enacted on behalf of municipalities in the Municipal Act Amendment Act, 1964.

By your approval of the *Public Libraries Act Amendment Act*, 1964, you have provided citizens living outside municipalities the right to use the facilities of libraries.

The Adoption Act Amendment Act, 1964, reduces residential requirements from one year to six months before the granting of the right of adoption.

In the *Underground Storage Act*, 1964, you have established regulations for the underground storage of petroleum and natural gas.

Members of the Legislative Assembly are to be congratulated in providing for continued improvements in all facets of British Columbia's interests and services, with the result that substantial benefits should accrue from these provisions and the varied legislation.

I thank you for the earnestness of your deliberations and labours and for the supplies which you have granted for the public service.

Honourable Members, I now relieve you of your legislative duties, and I trust that the blessing of Divine Providence will accompany you to your respective homes.

The Hon. W. D. Black (Provincial Secretary) then said:—

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please the Lieutenant-Governor to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
