Tuesday, January 17th, 1956.

THREE O'CLOCK P.M.

This being the first day of the fourth meeting of the Twenty-fourth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable FRANK MACKENZIE Ross, Lieutenant-Governor of the Province, dated the 1st day of November, 1955.

Prayers by the Rev. Alvin C. Hamill.

Mr. Speaker reported to the House that he had received the declaration of resignation of James Gordon Gibson, member representing the Electoral District of Lillooet, on March 10th, 1955.

Ordered, That pursuant to the Statute in such case made and provided, an entry of the declaration so delivered to Mr. Speaker be made in the Journals of the House.

The letter of the Deputy Provincial Secretary and the certificate of the Chief Electoral Officer of the result of the by-election of a member to represent the Electoral District of Lillooet were read, as follows:—

On the motion of the Hon. W. D. Black, seconded by the Hon. W. N. Chant, it was Resolved,—

That the letter of the Deputy Provincial Secretary and the certificate of the Chief Electoral Officer of the result of the by-election of a member to represent the Electoral District of Lillooet be entered upon the Journals of the House.

Mr. Donald Frederick Robinson, having been duly sworn, was introduced by the Hon. W. A. C. Bennett and the Hon. R. W. Bonner, and took his seat.

His Honour FRANK MACKENZIE ROSS, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the Fourth Session of the Twenty-fourth Parliament of British Columbia, and wish to express my pleasure in meeting with you for the first time as Lieutenant-Governor of British Columbia and in being associated with you in the discharge of your most important duties as members of the Legislative Assembly.

It is my earnest hope that, with the advice of my Ministers and with your support, I may so serve during the term of my office that the welfare of my people may be further advanced.

Since last you met, British Columbia has been favoured with a visit from Her Royal Highness the Princess Royal. This charming lady endeared herself to all during this, her first, visit to British Columbia.

I wish to express my profound regrets that death has removed a valued counsellor and a representative of my people in the person of Mr. George Churchill Moxham, member for the Vancouver Centre constituency.

At the last Session of the Legislature the member for Lillooet submitted his resignation to the Speaker, following which a by-election was held to fill the vacancy. I take this opportunity of congratulating Mr. Donald Frederick Robinson upon his election to represent that constituency. It is my sincere hope that he will enjoy serving the public, and I feel sure much benefit will be derived from the counsel he has to offer. It is pleasing to note that both the northern and southern extensions of the Pacific Great Eastern Railway are progressing according to the plans outlined at the last Session of the Legislature.

The railway extension from Squamish to Greater Vancouver should be completed this year, and the northern extension from Prince George to the Peace River Country, with favourable weather conditions, should be in operation in 1957.

The Prime Minister of my Government, other Ministers, and senior officials attended a total of not less than twelve conferences with the Government of Canada during 1955.

The financial policy pursued during the last three years has enabled my Government to effect a considerable reduction in the direct public debt and, concurrently, a most substantial related decrease in debt charges payable.

The resultant improvement in the Provincial credit is such to commend itself highly to all members of the Legislature.

During the past year the general prosperity of the Province has reached unprecedented heights, and my Government expects the year 1956 will see that record equalled or surpassed.

Since you last met, my Government has been fortunate in securing as Chairman of the Public Utilities Commission the services of the eminent economist Dr. Henry F. Angus, and also Mr. A. B. Jackson, who was appointed a member of that Commission.

Two matters of importance to the Province continue to receive the attention of Royal Commissions of Inquiry—namely, the inquiry into the disposition of Doukhobor lands and, secondly, the inquiry into matters affecting our forest resources. A third inquiry, that into the Vancouver City Police Force, requested by the Police Commission of that city appears to be almost concluded.

At the last Session it was deemed advisable to divide the Department of Public Works into two departments—one to be known as the Department of Highways and the other the Department of Public Works. Subsequently, a new Minister of the Crown has been appointed in the person of the Honourable William N. Chant to take the portfolio of the Minister of Public Works, and the Honourable Philip A. Gaglardi became the first Minister of Highways.

The plans made by my Government for the improvement of the facilities of the Mental Health Services two years ago have been implemented.

Within the next few weeks the Mental Health Centre, comprising a day-hospital and an enlarged modern Child Guidance Clinic Centre, will be completed, while additions are about to be made to the School for Mental Defectives and the Home for the Aged, Port Coquitlam.

Provision for further facilities required in dealing with mental illness will be made this year.

Further reform of correctional institutions will take place with construction this fiscal year of a new Industrial School for Girls.

The year 1958 marks the one hundredth anniversary of the famous gold-rush to the Fraser River which led to the organization of the Mainland Colony of British Columbia, an event which had such far-reaching implications for all British territory west of the Rocky Mountains.

My Government has already established an advisory British Columbia Centennial Committee, and legislation making provision for the proper commemoration of this significant event will be placed before you.

Mindful of the improvement and beautification of the capital of British Columbia, my Government intends to establish a Capital Improvement District Commission, whose objects shall be the orderly development of the Provincial capital and the surrounding districts in co-operation with the municipalities involved. Legislation will be placed before you to bring into effect the recommendations presented by Mr. Justice Clyne in his report on the Royal Commission inquiring into the matter of the distribution of milk.

You will be asked to consider measures intended to widen the scope of the activities of the Farmers' and Women's Institutes.

Legislation will be placed before you to institute a Potato-warehouse Construction Assistance Act, which will enable the Provincial Government to assist co-operatives to erect potato-warehouses in British Columbia.

An amendment to the "Amusements Tax Act" will be introduced.

Consideration will be given to the problem of providing sewage-disposal in the Greater Vancouver area.

Cognizance has been taken of the need to make accessible additional stands of hitherto undeveloped Crown timber for early utilization, and provision will be made for a greatly augmented programme of forest access roads.

During this year my Government plans the largest highway programme in the history of British Columbia, with the building of roads to make more accessible the natural resources of the Province.

This year an increased effort will be made particularly in the construction of the Trans-Canada, the Cariboo, the Southern and Northern Trans-Provincial Highways.

It is pleasing to know that the work being done under the Crown corporation for toll bridges is progressing very favourably, with bridges under construction in Vancouver at Oak Street to replace the old Marpole Bridge, the Middle Arm, the Second Narrows across Burrard Inlet, as well as bridges at Nelson, Agassiz–Rosedale, and the Okanagan Lake bridge.

In all of the works programmes, my Government is conscious of the need of creating as much employment as possible in the winter months, and contracts have been let accordingly.

An Act will be placed before you to permit further extended activities of the British Columbia Power Commission.

My Government will introduce legislation designed to promote the observance of fair treatment to all men and women in respect of their employment.

You will be asked to consider legislation under the "Annual Holidays Act."

Legislation will be introduced which will make it possible for School Boards and my Government to assist financially the Association for Retarded Children of British Columbia.

Legislation affecting branches of public service of a character designed to improve existing Acts will be placed before you.

The Estimates for the ensuing fiscal year that will be submitted to you have been framed with due consideration for economy while recognizing the necessity that exists for the development of this great Province and for efficiency in every branch of the administration.

The Public Accounts will be laid before you, which are presented for the first time in a manner to enable a more objective and simplified study.

Reports of various departments of my Government will be laid before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

R. W. Bonner, the Hon. W. N. Chant, and Messrs. Corbett, Webster, and Laing.

On the motion of the Hon. W. A. C. Bennett, seconded by Mr. Webster, it was Resolved,-

That this House expresses its sincere regret at the death of George Churchill Moxham, member for the Electoral District of Vancouver Centre, and that the Clerk do convey to Mrs. Moxham and the family of the late member the condolences and sincere sympathy of the members of the Legislative Assembly.

Prayers by the Very Rev. Bryan Whitlow.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

On the motion of Mr. Laing, the debate was adjourned to the next sitting of the House.

Prayers by the Rev. E. G. Thompson.

Mr. Speaker made the following statement:-

Honourable Members,—Yesterday in the debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, the Hon. the Leader of the Opposition referred to a statutory declaration which, he stated, according to the Vancouver Herald, was placed before the Hon. the Attorney-General on December 17th, 1955, by one David Sturdy. He referred to the subject-matter of the statutory declaration being *sub judice*. From his refusal to discuss the details of the case and his reference to the Minister of Lands and Forests, it is inferred that the matter before the Court is an action by the Minister against the said David Sturdy. He called upon the Attorney-General to explain his (the Attorney-General's) position in the matter to the House. The above may not be the exact words used by the Hon. the Leader of the Opposition, but, I believe, gives the essential gist.

There was considerable misunderstanding in the House as to how this matter would be regarded by myself.

I would allow a statement to be made by the Attorney-General or in his behalf, but within very strict limitations, following the principle that a matter which is before a Court or tribunal having judicial powers may not be discussed in the House. For instance, he might say he did nothing, but he could not say why he did nothing if, directly or indirectly, such a statement indicated an opinion as to the merits or demerits of the case before the Court. The Attorney-General would be granted no right or privilege in this matter or any other matter that would not be granted to any other member of the House, and statements may be made by any member with the same strict limitations.

The principle that matters which are *sub judice* may not be mentioned in debate is of long standing. *May*, 15th edition, page 380, states: "*Matters pending Judicial Decisions*.—A matter, whilst under adjudication by a Court of law, should not be brought before the House by a motion or otherwise. This rule does not apply to Bills."

And again at page 437: "Matters awaiting the adjudication of a Court of law should not be brought forward in debate (except by means of a Bill)."

The principle has been followed by Legislatures throughout the Commonwealth— Legislatures which, like ours, are based on the parliamentary practices of the British Houses of Parliament. For instance, in New South Wales in 1932, the late Sir Daniel Levy, then Speaker, ruled that it was "not for the Speaker to microscopically sift the relevant from the irrelevant evidence, but to liberally apply the *sub judice* rule in such a way as to prevent the mischief which that rule was intended to obviate." (Journal of the Table, Vol. 23/69.)

There is nothing mysterious about the words "sub judice." A matter is sub judice when that matter is pending before a tribunal having judicial powers. The reason for the rule that matters sub judice may not be referred to in debate or upon a motion is twofold. In the first place, it might be inferred that a breach of this rule would be not only a grave discourtesy to the Court, but also might be considered an improper usurpation of the powers of the Court or an attempt to influence the Court—an attempt of the Legislature to influence that very distinct and parallel part of government, namely, the judiciary. In the second place, it might prejudice that sacred right of Her Majesty's subjects to a fair trial before the proper tribunal.

Administration of justice is in no way impeded by the *sub judice* rule as it does not preclude other Court action, whether civil or criminal.

This ruling will be entered upon the Journals of this House. I trust you will observe it carefully.

As for the suggestion that public interest is more important than the rights of two parties to a lawsuit, although I agree with that principle, it does not seem to me that the issue in this matter is between public interest and purely private rights. There is another very important and equally respected corner-stone upon which our system of government rests and that is the liberty of the subject, and surely a subject cannot be said to have that liberty of which I speak without having, at the same time, protection against what may be found by a Judge to be defamatory statements. I am supported in this statement by what was said by Lord Atkin on behalf of the Privy Council as

reported in 1935, Volume I, Western Weekly Reports, at page 3. For that reason it has been a long-standing rule in all Legislatures of the Commonwealth that while such matters as these are pending before a judicial tribunal, no discussion can take place in the Legislature.

Honourable Members,—The honourable member for Mackenzie has mentioned the subject of forestry. In view of the fact that this natural resource is under the consideration of a Commission at the present time, I would suggest that you deal with this subject as little as possible.

It might well be that the Commissioner could say—although I don't think that the present Commissioner would do so—that if we are going to discuss this matter on the floor of the House, there is little object in his pursuing the subject. Again, and this is important, comment coming from the floor of the House could affect the evidence being laid before the Commissioner and that would be most unfortunate.

Technically, this matter, in view of the fact that it is in the hands of a Commission, could be regarded as *sub judice* and I would ask you to very carefully regard this aspect of discussion of our forestry policy.

Part of our system of government is that the Legislature exists for the purpose of seeing that the affairs of the Province are properly operated and administered. To that end we appoint committees and commissions, and it would be obviously foolish to upset the work of a commission appointed by this House by unrestrained debate. It might even be termed an avoidance of your responsibilities as members of the Legislative Assembly.

Wherever this system of government operates, it is the custom to refrain from discussion of the subject-matter before a commission. In fact, in Great Britain the matter is strictly avoided in all respects.

3. Did any organization, individual, or group of individuals, other than the Department of Labour, provide, free of charge, in whole or in part, transportation or accommodation to the said Board?

4. If so, what is the name, or names, of the organization, individual, or group of individuals who provided this transportation or accommodation?

5. Day by day, during the time that the Board left Vancouver for these Queen Charlotte Island hearings until they returned, what specific transportation and accommodation was provided by each of the organizations, individuals, or group of individuals referred to in No. 4?

The Hon. L. Wicks replied as follows:-

"1. Yes.

"2. Juskatla and Aero Camps.

" 3. No.

"4 and 5. Answered by No. 3."

Mr. Howard asked the Hon, the Minister of Labour the following questions:----

1. Since March 15th, 1955, did the secretary of the Provincial Advisory Committee on Indian Affairs, Mr. Reginald Kelly, resign from his post?

2. If so, when did he resign and for what reasons?

3. Has he been replaced and, if so, (a) by whom, (b) when, (c) at what salary, and (d) what qualifications does the new secretary have with respect to Indian affairs?

The Hon. L. Wicks replied as follows:-

"1. Yes.

"2. August 12th, 1955; for personal reasons.

"3. Yes; (a) Miss Joanna R. Wright; (b) September 1st, 1955; (c) 3,636 per annum; and (d) Miss Wright has worked in the office of the secretary since it was established in October, 1950, and has made a thorough study of Indian affairs during the past five years. In September, 1951, the secretary was granted sick-leave and Miss

Wright carried out his duties for eleven months. Miss Wright has had considerable experience in dealing with native peoples through voluntary work done over a number of years in India. Miss Wright has been trained in public relations work, and as a naval intelligence officer during the war in the Women's Royal Naval Service she had specialized experience in correlating information and writing reports. These qualifications have been invaluable in carrying out the functions of the 'Indian Inquiry Act.'"
