3. Has any system of testing safety lamps been adopted by the different coal companies, and, if not, is it the intention of the Government to see that some system is adopted at earliest moment, and also a systematic and safe method of locking safety lamps?

"1. On the 27th of May last the following wire was sent to Mr. Henry Hall, H. M. Inspector of Mines in Lancashire, England :-

"'Kindly write me particulars of the best non-flammable blasting powder used in gaseous and dusty coal mines. Also, any information about dust explosions you consider important. (Signed)

"' EDW. GAWLER PRIOR,

" Minister of Mines."

"Mr. Hall is the acknowledged authority in Great Britain on dust and gas explosions, and the causes of same.

"2. The Government is waiting to see the evidence given at the Fernie inquest before taking any action.

"3. No special system of testing safety lamps is in vogue in British Columbia, but the matter is receiving the attention of the Government.'

Mr. Speaker *Pooley* gave the following ruling on a point of order raised yesterday with reference to the third reading of Bill (No. 99) intituled "An Act to amend the 'Mineral Act,'" which had been moved in the absence of the Member having charge of the Bill, and without his authority :—

Bill (No. 99) initialed "An Act to amend the 'Mineral Act," stood on the Order Paper for third reading.

Mr. Martin, the senior Member for Vancouver, had charge of the Bill.

When this Bill was called up for third reading on 19th June Mr. *Martin* was absent, and Mr. *McInnes*, the Member for North Nanaimo, without the authority of the Member in charge of the Bill, moved the third reading, as the Session was drawing towards its close and he desired to facilitate business.

Mr. Martin, upon his return to the House, objected to the course pursued by the Hon. Member from North Nanaimo, and asked to have the Bill reinstated on the Orders of the Day in the position in which it was, as he desired to make a motion with regard thereto, on the ground that the Member for Nanaimo had no authority to move the third reading of the Bill, and the third reading had been passed by mistake.

Mr. *McPhillips* objected, on the ground that the Bill having been read a third time it had passed out of the jurisdiction of this House.

As an Order of the Day results from the vote of the House upon a question put from the Chair, the right to move an Order of the Day, to a certain extent, belongs to the House at large, and is not vested solely in the Member who has charge of the Order. In his absence the question thereon may be moved by another Member. *May*, 10th Ed., pp. 248-249. E. D., vol. 305, p. 353.

Whereas Canada, the greatest of the self-governing dependencies of the Empire, whose extensive seaboards on the Atlantic and Pacific Oceans render naval protection of vital importance to her very existence, has from the very beginning of her history had the benefit of such protection afforded by the Royal Navy without contributing anything to the cost of maintenance thereof:

And whereas the further continuance of such a state of affairs is not only undignified, but it is incompatible with the present standing of our country as a prosperous nation: And whereas British Columbia, the largest of the Provinces of Canada, embraces within its boundaries the whole of Canadian territory bordering on the Pacific Ocean, and is therefore more concerned in the naval supremacy of the Empire than any other Province of Confederation:

Be it therefore Resolved, That the time has now arrived when Canada should assume her fair share of the cost of the naval protection afforded as above-mentioned :

And be it further Resolved, That the contribution to be made by Canada towards the attainment of the above object should primarily take the form of establishing and maintaining reserves for the Royal Navy at such points in the Dominion as are best suited for that purpose, and, if possible, that training ships for boys should be supplied and maintained at these points:

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, requesting him to communicate with His Excellency the Governor-General in Council, asking him to take such steps as will bring about the attainment of the above objects.

Resolved, That the House, at its rising, do stand adjourned until 12 o'clock, noon, to-morrow.

And then the House adjourned at 11:55 o'clock, P. M.

His Honour was pleased, in His Majesty's name, to give assent to these Bills.

The same was announced by the Clerk of the House in the following words :--

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then the Honourable Mr. Speaker addressed His Honour the Lieutenant-Governor as follows :----

MAY IT PLEASE YOUR HONOUR :

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government, and humbly beg to present for Your Honour's acceptance a Bill (No. 111) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say :---

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following Speech:----

Mr. Speaker and Gentlemen of the Legislative Assembly:

In relieving you from further attendance upon your Legislative duties at the termination of a more than usually protracted Session, I thank you for the time and care you have bestowed upon the consideration of the important matters that have occupied your attention.

Since the opening of the House we have had to deplore the loss, through death, of the late Speaker, the Honourable John Paton Booth, who had endeared himself to all by his many sterling qualities of heart and mind.

I trust that the negotiations to be entered into between my Ministers and the Dominion authorities upon the Fisheries Question will lead to a settlement which may be lasting and of benefit to those engaged in this important industry in this Province.

It is to be hoped that the railway legislation passed, after such careful consideration, will prove beneficial, and will secure the speedy construction of the various railways so greatly desired, and so necessary to the welfare of the Province.

I deeply regret the lamentable accident which occurred so recently at the coal mines in the Crow's Nest Pass. You have shown how much you shared in the general feeling of grief that pervaded the Province, and at the same time you have given your earnest attention to the best means of preventing the recurrence of similar calamities.

The Redistribution Act recently passed has evidently received the most careful consideration, and I believe that this measure will commend itself to the electors of the Province.

It is with a deep feeling of devotion and loyalty to the person of our Most Gracious Sovereign that we witness the approach of the day of His Majesty's coronation, an event which will be memorable in the history of our country, and which will be observed with loyal enthusiasm throughout the Empire. May He be spared to us for many years to come.

I congratulate you on your thoughtful remembrance of the devoted young men who have given their services in South Africa, and contributed their share in bringing about the peace for which we are all so thankful.

I thank you for the liberal provision you have made for the prosecution of public works in the Province, which, I trust, will be carried on with due regard to efficiency and economy.

I now take leave of you, in the earnest hope that, under the blessing of an all-wise Providence, prosperity and happiness may attend you.

The Hon. Mr. Prentice, Provincial Secretary, then said :--

Mr. Speaker and Gentlemen of the Legislative Assembly :

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
