## Tuesday, February 11th, 1947.

THREE O'CLOCK P.M.

This being the first day of the second meeting of the Twenty-first Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable Charles Arthur Banks, Lieutenant-Governor of the Province, dated the 7th day of January, 1947.

His Honour Charles Arthur Banks, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious speech:—

 $Mr.\ Speaker\ and\ Members\ of\ the\ Legislative\ Assembly:$ 

I welcome you to the Second Session of the Twenty-first Parliament of British Columbia.

Since last you met, we have enjoyed the opportunity of welcoming to the Province our newly appointed Governor-General, His Excellency Field Marshal the Right Honourable Viscount Alexander of Tunis, and Her Excellency the Viscountess Margaret. This brilliant soldier, his charming consort and family endeared themselves to all during their sojourn. Canada is indeed fortunate in having such a distinguished representative of His Majesty the King.

We were likewise favoured with a visit from another famous military leader, Field Marshal the Right Honourable the Viscount Montgomery of Alamein. This great leader, under whom so many of our Canadians served during the Second World War, was accorded a reception reflecting the high esteem in which he is held and expressing the public's gratitude for the part he played during perhaps the most perilous period in our history.

I take this opportunity to welcome to this Legislature two new members, Air Vice-Marshal Leigh Stevenson and Mr. Albert R. MacDougall, who were elected during the past twelve months to replace two valued members who were taken from our midst by their untimely deaths. I am sure that my Government will benefit from their counsel in the deliberations that are to take place on matters of importance.

I am gratified to note that the negotiations between the Dominion and the Province on taxation and social welfare have been concluded satisfactorily. In consequence of these discussions, you will be asked to endorse an agreement that will remove the threat of double taxation, without impairing the Province's constitutional rights and,

at the same time, provide additional income to assist in maintaining our high living standards and meet our increasing needs. Coupled with the ratification of this agreement is the assurance by the Dominion Government that the proposals for improving old-age pensions and other social services, as well as the plan for high-level employment, will be considered as soon as contracts have been signed by a sufficient number of Provinces.

Negotiations with respect to debts owing by the Province to the Dominion likewise have been successful, the Dominion Government having agreed to cancel 50 per cent. of the direct relief debt, representing a sum of \$8,000,000. Arrangements also have been made for the retirement of the remainder on a long-term basis, part non-interest bearing and part at low interest. In consequence of this, my Government will give consideration to a proportionate reduction in the cost of direct relief within cities and municipalities.

I am pleased to observe that in addition to the basic tax formula upon which my Government and that of the Dominion have found agreement, there will be paid to the Province 50 per cent. of the corporation tax collected from certain electric and gas public utility companies.

The Dominion also has agreed to relinquish the gasoline tax, leaving this field to the Province. The additional revenue from this source will be used exclusively for hard-surfacing, rebuilding, and extension of our highway system.

The Report of Mr. H. Carl Goldenberg, who was appointed sole Commissioner to inquire into Provincial-Municipal financial relations, will be placed before you, and my Government has given assurance that immediate action will be taken in connection with the Commissioner's findings.

Since last you met, the Government has taken steps to ascertain the most economic route to the Peace River country in connection with the proposed extension of the Pacific Great Eastern Railway, and you will be informed as to the progress that has been made.

The accomplishments of the British Columbia Power Commission with respect to power-development and rural electrification will be reviewed, and legislation will be introduced to increase the capital by \$10,000,000 to improve administration of the Act and to simplify expropriation procedure.

A comprehensive programme will be outlined to encourage qualified persons to settle on the land for the further development of our agricultural resources.

Legislation will be introduced enabling the Province to embark on a well-planned land reclamation and irrigation programme in co-operation with the Dominion Government through the extension of the benefits of the "Prairie Farms Rehabilitation Act."

The Royal Commission appointed to inquire into irrigation, dyking, and drainage problems has completed its work, and its report will be placed before you. Legislation in connection therewith will be submitted.

You will be asked to adopt other recommendations of the Royal Commission on Forestry in order to establish sustained yield, development of Provincial parks, the protection of our forests, and to require owners of logged-off Crown-granted lands to undertake reforestation.

Provision will be made for the carrying-out of a more comprehensive survey and mapping programme essential to land utilization, geological and mining needs, water power, irrigation, and general development of our resources.

Encouraging progress has been made by my Government in assisting farmers with land-clearing, and it is proposed to extend and widen the scope of this service.

As a result of an exhaustive study, there will be presented legislation amending the "Petroleum and Natural-gas Act" in order to encourage prospecting and development of our potential oil resources. I am pleased to advise you that my Government has taken steps to secure consideration, by the Board of Transport Commissioners, of the plea by British Columbia for the removal of the mountain differential in railway freight rates and to protest any general increase as applied for by the two transcontinental railways unless financial need can be proved.

My Government has submitted to the Court of Appeal questions as to whether the Provincial Government can impose taxation for the purpose of fire-protection upon Esquimalt and Nanaimo Railway Belt lands and a severance tax upon timber cut thereon. Counsel for the Government and the Esquimalt and Nanaimo Railway Company have been heard by the Court, and the decision is now awaited.

Provision will be made for a comprehensive programme of public works, including buildings and roads, to supplement the already large number of important projects undertaken in the past twelve months.

You will be asked to increase appropriations so that the Department of Trade and Industry may widen its promotional campaigns to develop tourist travel and to encourage investments in industry.

The merit of the work carried on by the British Columbia Scientific and Industrial Research Council has received wide recognition, and it is proposed to make possible, through additional funds, a widening of its activities.

I am pleased to note that my Government has appointed an industrial and trade representative to the United Kingdom so that British Columbia may develop to an even greater degree trade with Great Britain. My Government has invited representatives of the timber trade in the United Kingdom to visit the Province and acquaint themselves with our forest industry, thus bringing about a greater appreciation of British Columbia's ability to meet their requirements.

It is with pleasure that I note that my Government is co-operating with the Canadian Red Cross Society in establishing the first blood-donor service in Canada to provide free transfusions.

I am also pleased to learn that my Government plans to extend full-time health-unit service to cover the whole Province during the next two years, and that provision has been made to carry out the first half of the programme this year.

The committee of the Legislature appointed at the last Session to study the "Provincial Elections Act" will submit its report, and my Government will place before you legislation to amend the existing Statute in order to bring into effect those recommendations deemed most acceptable for the improvement of election arrangements.

The reports made by two Royal Commissions inquiring into the activities of life and health insurance and accident benefit societies will be placed before you, and legislation dealing with the recommendations will be submitted for your approval.

Legislation for the establishment of a Department of Fisheries will be introduced, thereby giving full recognition to the value of our fishery resources, which are so important to the economy of the Province.

Modification of the "Industrial Conciliation and Arbitration Act" will be recommended in amending legislation, thus bringing about a further improvement in labour-employer relations.

You will be asked to review the liquor laws of the Province.

Provision will be made to render greater assistance to rural areas in connection with audivisual education, while efforts also will be made by my Government to stimulate physical and recreational activities in the communities.

Further expansion of the prospectors' grub-staking programme will be carried out to uncover the mineral wealth of the Province, and increased appropriations will be asked for the purpose of extending and improving mining roads and trails. The rise in prices of several of the base metals and silver is causing renewed activity in the mining field.

I am gratified to observe that geological work will now be accepted as assessment and development under the requirements of our Mineral and Placer-mining Acts in lieu of actual physical prospecting and mining operations.

You will be advised regarding the progress that has been made by the Public Utilities Commission of its audit and investigation for rate-structure purposes of the British Columbia Electric Railway Company's operations.

The strong financial position of the Province has been maintained, and the Dominion taxation agreement will stabilize our revenues for the next five years. The marketing of Provincial bonds during the past year, particularly those for the financing of power-development and rural electrification, reflects the continued strength of British Columbia's credit.

The Public Accounts will be presented and Estimates for the ensuing year will be submitted.

Minor legislation designed to improve existing Acts will be placed before you. I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rev. J. L. W. McLean, M.A., Moderator of the Synod of British Columbia of the Presbyterian Church in Canada.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of Mrs. *Rolston*, the debate was adjourned to the next sitting of the House.

Mr. R. H. Carson presented the Report of the Special Committee appointed under the "Elections Committee Enabling Act, 1946," as follows:—

#### REPORT.

LEGISLATIVE COMMITTEE ROOM, February 14th, 1947.

#### MR. SPEAKER:

Your Special Committee appointed under the "Elections Committee Enabling Act, 1946," being chapter 25, begs leave to report as follows:—

Your Committee has held several meetings both in Vancouver and Victoria.

Before entering upon its work of revising the present electoral system, a questionnaire in the form which is appended hereto was sent to about 3,000 persons and organizations throughout the Province. The answers and comments which have been given in response to this questionnaire have greatly assisted your Committee.

Your Committee held a special sitting in Vancouver from October 31st to November 2nd, 1946, when representations were made and briefs were presented by many organizations and individuals.

Having received this whole-hearted assistance from the public of the Province and after its several meetings your Committee begs to recommend:—

- 1. That the present Elections Act be repealed and that new legislation be enacted which will incorporate the recommendations herein made.
- 2. (a.) That the provisions of the present Act relating to the qualification and disqualification of voters be retained except where amended by the recommendations herein contained.
- (b.) That the residence qualification for a voter be amended to require that he has resided in Canada for twelve months, in the Province for six months, and in the electoral district for thirty days immediately preceding the date on which the voters lists close prior to an election.

- 3. That Chinese and Hindus who are at present disqualified only by reason of their racial origin and who are otherwise eligible shall be entitled to vote. Messrs. Winch, Straith, and Gargrave wish to be recorded as opposed to retaining any racial discrimination under the Elections Act.
- 4. That Doukhobors who are, or have been, members of the armed forces, or who have been rejected by the armed forces, together with their wives and descendants, who are otherwise eligible, shall be entitled to vote.
- 5. That native Indians who are, or have been, members of the armed forces, or who are not resident on a reserve be entitled to vote; and that the word "Indian" be more explicitly defined; and that all Indians who have been enfranchised by the "Indian Act" of Canada be entitled to vote in the Province. Your Committee begs to recommend that further study be given by the House to the matter of the further extension of the franchise to Indians and the right of Indians to have representation in the Legislature.
- 6. That the franchise be extended only to those persons who have an adequate knowledge of the English or French language.
- 7. That a Chief Electoral Officer who shall supervise elections and administer the Elections Act shall be appointed by the Lieutenant-Governor in Council; and that he hold office during the pleasure of the Lieutenant-Governor in Council.
- 8. That the Registrar-General of Voters and District Registrars be appointed as at present; and that the Registrar-General be in charge of a Central Registry of Voters where a complete register of all voters in the Province is maintained.
- 9. That a system of perpetual registration be instituted and that all residents of the Province who are twenty-one years of age or over be required to register within thirty days of the Proclamation of the new Act. Persons failing to so register should be subject to a penalty not exceeding ten dollars unless they have valid reasons for default. Persons coming to the Province should be required to register within six months and persons coming of age should be required to register within thirty days of their twenty-first birthday.
- 10. That all existing voters lists be cancelled; and that all eligible persons be required to apply on an application form which they shall personally sign; and whose signatures shall be witnessed only, without the necessity of an oath being taken before a Commissioner. Adequate facilities should be provided for this original registration in all electoral districts.
- 11. That copies of all application forms be kept at the Central Registry of Voters; and that voters be required to give notice of change of address.
- 12. That the Department of Vital Statistics be required to provide the Registrar-General of Voters with information as to deaths, marriages, and changes of name and any other necessary information.
- 13. That a registration card be issued to each registered person, which shall show the person's name, address, and occupation and the electoral district. This card shall bear a registration number which shall be the permanent number of such person. The card need not be carried at all times, but may be required to be produced at the time of voting. The card will be endorsed by the voter for identification purposes. Persons who are not eligible to vote may secure non-voters' cards of a distinctive colour. That provisions be made that a registered voter who is unable to produce his card at his polling-station may take an oath that he is a registered voter and thus obtain a ballot.
- 14. That a system of compulsory voting be instituted with appropriate penalties for default failing a reasonable excuse.
- 15. That there be a period of not less than fourteen days between the announcement of an election and the closing of the voters lists. That a period of twenty-one days be provided between the closing of the voters lists and nomination-day. That the

present twenty-one-day period between nomination-day and polling-day, and between polling-day and the final count remain unchanged.

- 16. That there be a special Court of Revision for removal of names only, which shall be held at least twelve clear days before nomination-day.
- 17. That there be no other Courts of Revision but that the Registrar-General of Voters and District Registrars be empowered to deal with objections or other matters of revision at any time.
- 18. That a notice be sent to each voter who fails to vote at an election requiring him to give reasons for his failure to vote within six months of the date of election. If default continues the voter's registration shall be cancelled and if he is still resident within the Province he is then subject to the usual penalty for failure to register.
- 19. That suitable automatic office equipment and machinery be provided for the Central Registry of Voters and for District Registries to permit of greater efficiency in the making and maintaining of voters lists.
- 20. That circumstances do not require the re-enactment of provisions similar to section 6 relating to deserters, section 8 relating to unemployment relief camps, and section 18A relating to active service voters.
- 21. That each Returning Officer shall hold office permanently during good conduct; and that he be provided with adequate remuneration for these duties; and that he be required to report each year to the Chief Electoral Officer regarding any necessary revisions in his district; and that he be paid such special remuneration on the occasion of elections as may be fixed by the Lieutenant-Governor in Council.
- 22. That in electoral districts having less than 10,000 registered voters, the nomination-papers of candidates be signed by not less than twenty-five registered voters; and in other electoral districts nomination-papers of candidates be signed by not less than fifty registered voters; and that signatories of nomination-papers be required to sign with their usual signatures, giving their addresses, occupations, and registration numbers; that no proposer or seconder be required on nomination-papers.
- 23. That persons giving clerical or other assistance to candidates be permitted to be paid without disfranchisement or other penalty.
- 24. That three days be provided for an advanced poll to be held on the Thursday, Friday, and Saturday of the week prior to an election. Advance polls should be provided for the convenience of trainmen, mariners, fishermen, and other persons who by reason of the nature of their employment are unable to vote on election-day. The number and location of such polls should be in the discretion of the Chief Electoral Officer.
  - 25. That absentee voting be provided for.
- 26. That ballots cast at advance polls and absentee ballots be not counted on election-day, but be sent to the respective Returning Officers to be counted at the final count; and that Returning Officers be advised after the close of balloting on election-day of the number of absentee ballots cast.
- 27. That in each hospital where it is deemed necessary by the Returning Officer a polling-station be provided to permit of voting by the hospital staff and by patients who are able to attend at the polling-station.
- 28. That provision be made for the sending of a notice to each voter, just prior to an election, of the time and place of voting.
- 29. That transfer certificates may be issued by Returning Officers to Deputy Returning Officers and Poll Clerks who, on election-day, may be assigned to work away from their own polling-places; and that transfer certificates may be issued similarly to scrutineers when requested by a candidate or his agent; and that such Deputy Returning Officers, Poll Clerks, and scrutineers be permitted to vote by ordinary ballot upon surrendering such transfer certificate. That, failing such transfer certificates, such persons be entitled to vote by absentee ballot.

30. That an absentee ballot be in the form previously used by overseas active service voters, so that a voter will write upon the ballot the name of the candidate (or candidates, in case of an electoral district where more than one candidate is to be elected) whom he wishes to elect. Before receiving his ballot an absentee voter shall be required to take an oath to be provided on the ballot envelope in which his ballot shall be sealed.

That the procedure for absentee voting be generally similar to that now set forth in sections 113 and 114 of the present Act.

- 31. At the final count, and before opening ballot envelopes of absentee voters or advance-poll voters, the Returning Officer shall first satisfy himself that each such voter is eligible to vote and has not otherwise voted. These ballots should be counted in large groups so as to preserve the secrecy of the individual ballot.
- 32. That each candidate shall be required to make a return showing the total of his election expenses, the same to be accompanied by the candidate's or his agent's declaration.
- 33. That every registered voter who does not have four consecutive hours free from his employment between the hours of the opening and the closing of the polls on election-day shall be given sufficient time off from his employment, with pay, so that he shall have four consecutive hours during voting hours in which to vote. The employer shall have the discretion as to what hours shall be taken for this purpose; and suitable penalties shall be provided in the event of contravention by an employer. This provision will make it unnecessary for election-day to be a public holiday.
- 34. That the Lieutenant-Governor in Council be given authority to issue such regulations as may be necessary under the Act.
- 35. That certain provisions of the Elections Act have become archaic and it is necessary to modify them in accordance with modern requirements; namely, sections 150, 160, 161, 163, 165, 166, and 180.
- 36. That the Act come into force by Proclamation in order that sufficient time may be provided to arrange for the necessary registration of voters within thirty days of the Proclamation.
- 37. Your Committee gave careful consideration to a proposal to introduce a form of postal ballot which might permit of voting by sick and infirm persons and persons who might be out of the Province on election-day. However, your Committee considers that the postal ballot is open to serious difficulties and no recommendation is being made at this time.

Mr. E. E. Winch asked the Hon. the Attorney-General the following questions:—

- 1. How many first offenders under the age of 20, 25, and 30 years respectively were committed to Oakalla during 1946?
  - 2. How many of the same joined the "Star" group?
  - 3. How many are in this group at the present time?
  - 4. What provisions exist for supervised evening occupations?

The Hon. Mr. Wismer replied as follows:—

- "1. Under 20 years, 168; between 20 to 24 years, 229; between 25 to 30 years, 143.

The figure under Child Welfare Division includes 332 wards, for whom the Province assumes full financial responsibility, and 325 non-wards, for whom the Province assumes full financial responsibility for 277 and partial financial responsibility for 48."

Mr. Corsbie asked the Hon. the Minister of Public Works the following questions:—

- 1. Has the Provincial Government requested the Dominion Government to build a telegraph or telephone line along the Pine Pass Highway as part of the Dominion Government telegraph system?
- 2. If yes, has the Dominion Government communicated any plans to the Provincial Government for such service?
  - 3. If yes, what are such plans?
- 4. If no, have any other plans been made by the Provincial Government to provide a communications system along this highway?

The Hon. Mr. Carson replied as follows:--

- "4 No"
