SESSION 1950

Tuesday, February 14th, 1950.

THREE O'CLOCK P.M.

This being the first day of the first meeting of the Twenty-second Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable CHARLES ARTHUR BANKS, Lieutenant-Governor of the Province, dated the 13th day of December, 1949, the members having been sworn took their seats.

His Honour CHARLES ARTHUR BANKS, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Hon. Mr. Pearson, Provincial Secretary, said:-

Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. Mr. Johnson, member for New Westminster Electoral District, addressing himself to the Clerk, moved, seconded by Mr. H. E. Winch, first member for Vancouver East Electoral District, that Mrs. Nancy Hodges, second member for Victoria City Electoral District, do take the Speaker's chair and preside over the meetings of this Assembly, and it was so Resolved.

E. K. DeBeck, Esquire, the Clerk of the House, having declared Mrs. *Nancy Hodges* duly elected, she was then taken out of her place by the mover and seconder, and conducted to the chair, where, standing on the upper step, she expressed her grateful thanks to the House for the great honour they had been pleased to confer upon her by choosing her to be their Speaker.

And thereupon she sat down in the chair, and the mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect (standing on His Honour's right) then spoke to the following effect:—

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges; especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Hon. Mr. Pearson then said:-

MADAM SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their respective proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

Madam Speaker and Members of the Legislative Assembly:

In opening the First Session of the Twenty-second Parliament of British Columbia, I welcome many new members whose knowledge and experience I feel sure will benefit greatly the deliberations of this House.

Since the Legislature last convened, there has been admitted to Confederation a tenth Province, namely, Newfoundland. It is with gratification that I note my Government has marked this historic occasion by announcing its intention to present a mace to the Legislature of the new Province and that you will be asked to consider an appropriate message to accompany this gift.

Outstanding success attended the recent Dominion-Provincial Conference called for the purpose of considering ways and means to amend our constitution and make it a truly Canadian document. A formula was devised enabling a Continuing Committee of the Conference to submit to a later plenary session a proposal which it is hoped will be acceptable to the Dominion Parliament and all Provincial Legislatures.

A Dominion-Provincial Conference on economic matters has been called for the fall of this year, and I am pleased to learn that my Government has indicated its willingness to attend.

It is with satisfaction that I note the completion of the Hope-Princeton Highway. I feel sure that this new link with the Interior of the Province will prove of great economic value.

There will be placed before you legislation enabling my Government to enter into agreement with the Government of Canada to share responsibility in connection with projects designed to alleviate the existing housing shortage. Concurrently, there will be submitted legislation enabling cities and municipalities to participate with my Government in the housing plans devised by various districts to meet their particular needs.

There will be submitted a proposal designed to establish closer liaison between our native Indians and the Government in all matters coming within the jurisdiction of the Province.

As a result of the decision of the Privy Council, you will be asked to consider legislation in respect to taxation on Esquimalt and Nanaimo Railway Belt lands.

It is the hope of my Government that before the conclusion of the Session, you will be enabled to consider an agreement between the Dominion and Provincial Governments with respect to the construction of the Trans-Canada Highway.

Legislation will be submitted ensuring the proper maintenance of the reconstructed dyking system in the Fraser Valley and elsewhere in the Province on which public money has been spent with such beneficial results.

A Bill will be placed before you seeking amendments to the "Hospital Insurance Act" with the object of improving administrative procedures under this Act.

Provision will be asked to assist the University of British Columbia to continue with its building programme.

The Public Accounts will be presented and Estimates for the ensuing year will be submitted.

Legislation affecting various branches of public service will be placed before you. I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Bishop of British Columbia.

The Speaker reported that, to prevent mistakes, she had obtained a copy of His Honour's Speech.

The Speaker read a letter from the Speaker of the Knesset, the Legislature of Israel, and directed that it be entered in the Journals, as follows:---

"TEL-AVIV, September 6th, 1949.

" The Speaker,

" Legislature of British Columbia, Victoria.

"SIR,—I was very happy to meet Mr. Harold Winch, M.L.A., the leader of the Opposition in your Parliament, and to receive the greetings which you, on behalf of your Legislature, were kind enough to send to Israel. Ours is a very young state and we are very keen to learn from the example of the Legislative Assemblies which have grown up during the past century in the wide areas of the British Commonwealth of Nations. I am happy to avail myself of his visit for conveying to you heartfelt greetings on behalf of our people.

The letter of the Deputy Provincial Secretary and the certificate of the Chief Electoral Officer of the result of the election of members to represent the respective electoral districts of the Province in the Legislative Assembly at the general election was read, as follows:— " OFFICE OF DEPUTY PROVINCIAL SECRETARY,

MADAM SPEAKER:

This is the first time in the history of Canada that a Province has given a vote to an Indian people. When our request was placed before the Legislature just before the last Provincial election, the members without hesitation accepted us as equals to vote with the rest of the people of British Columbia.

As soon as this happened, we called conventions of all the Indian people in the different parts of the Province. Delegates from all reserves and places went there gladly.

Very little opposition was made to this wonderful first opportunity that was given to us for the first time in Canada.

We organized Indian Deputy Registrars to get the Indian vote ready over the whole Province.

The white man had done this work for many years, but this was the first time the Indian had done it, and we were assisted in every way.

You can believe me when I tell you what a big job it was, when you remember how Indian villages are scattered in the bays, inlets, islands, rivers, and mountains. Our Indians appointed as Deputy Registrars by the Government went to every village and place, and every person that wanted freely to vote was put on the List. Those that felt that they did not want to go on were not forced in any way. The few that did not want to go on, some of them told us afterwards that they would go on the next time. I feel and know that the granting of this first franchise to our people is the beginning of giving them many privileges which they have not had in the past.

As president, and on behalf of the Native Brotherhood of British Columbia, I wish here to thank the Legislature for giving the Indian people the right to vote for the first time.

CHIEF WM. SCOW.

MADAM SPEAKER:

The white people have been in Canada for over 300 years. In Eastern Canada there have been many wars fought between the white man and the Indian, and many people were killed on both sides from time to time.

This condition did not exist between the white man and the Indian in the Province of British Columbia. The Indian greeted the white man, the stranger, as a friend, and treated and dealt with him throughout as a friend and guest.

No real trouble between the Indian and the white man has existed in British Columbia. We settle our differences by agreement. We still have some difficulties which we hope to settle by agreement and peaceably in the future.

I wish to agree with my friend, Mr. William Scow, the president of the other large Indian organization in British Columbia, called the Native Brotherhood of British Columbia, when we asked for the vote in British Columbia, Mr. Scow, acting for his people, and I, acting for my people, worked harmoniously together first in asking this Legislature for the vote and then organizing all different conventions to get all our people on the voters list.

I agree with Mr. Scow that when we first started to get organizations together, it seemed a great task. Our own Indians were appointed Deputy Registrars.

Through delegating our authority, we performed a task that seemed like impossible in the short time we had at our disposal.

Every Indian in every village and settlement was asked to get on the list of his own free will. A few did not wish to do so. There was no coercion of any kind. Those few who did not want to get on, some have told me since that they now want to get on the next time.

On behalf of the North American Brotherhood, of whom I am president, I wish to thank this Legislature for giving the Indian people of British Columbia the vote.

That the Standing Orders in respect to the petition of Reginald Atherton, George Gorstice Bruce, Harold Merrifield Clarke, John Fife Coulter, Charles Lionel Davenport, Thomas Paul Dunlop, John Floyd Fox, James Alfred Marsh, Edward William Maudsley, William Curry McCalpin, John Hall Weeden, Francis William Dollman, Henry Fielding Green, Harold Bliss Everett, and Arthur Henry Parkinson for leave to introduce a Private Bill intituled "An Act to incorporate The Certified Public Accountants' Association of British Columbia" have been complied with, and your Committee recommends that the petitioners be allowed to proceed with the Bill.

Mr. *Morrow* presented the Sixth Report of the Select Standing Committee on Standing Orders and Private Bills, as follows:—

REPORT NO. 6.

LEGISLATIVE COMMITTEE ROOM, February 28th, 1950.

MADAM SPEAKER:

Your Select Standing Committee on Standing Orders and Private Bills begs leave to report as follows:----

That the Standing Orders in respect to the petition of the Royal Plate Glass and General Insurance Company of Canada for leave to introduce a Private Bill intituled "An Act to amend the 'Royal Plate Glass Insurance Company of Canada Act, 1906,'" have been complied with, except with respect to deposit with the Clerk of the House within the time required, the petition, copies of the Bill, and requisite fees, and your Committee recommends that the Rules in this respect be suspended, and that the petitioner be allowed to proceed with the Bill.

All of which is respectfully submitted.

The report was read and received.

By leave of the House, the Rules were suspended and the report adopted.

Mr. E. E. Winch asked the Hon. the Minister of Public Works the following question:-

During each of the past five years, what sums were spent in Burnaby and Dewdney ridings respectively for (a) construction and (b) maintenance of roads in which the Government has sole or partial responsibility?

The Hon. Mr. Carson replied as follows:-

"Burnaby Electoral District, 26.88 miles: 1944–45, (a) \$2,913.17, (b) \$13,355.85; 1945–46, (a) \$9,324.29, (b) \$16,860.18; 1946–47, (a) \$32,720.28, (b) \$23,000.92; 1947–48, (a) \$181,163.42, (b) \$59,364.27; 1948–49, (a) \$439,586.13, (b) \$54,270.39. Dewdney Electoral District, 248.01 miles: 1944–45, (a) \$31,958.91, (b) \$72,116.93; 1945–46, (a) \$87,841.81, (b) \$94,476.74; 1946–47, (a) \$49,573.40, (b) \$107,682.57; 1947–48, (a) \$467,583.89, (b) \$203,195.40; 1948–49, (a) \$341,121.51, (b) \$499,620.75 (this last amount includes costs of storm damage, \$273,597.88)." Mr. E. E. Winch asked the Honourable the Minister of Agriculture the following questions:-

1. How many land-clearing tractors are available under provisions of the "Farmers' Land-clearing Assistance Act"?

2. In what areas are they located?

3. What acreage has been cleared in each year respectively since the introduction of the scheme?

4. What is (a) the basis of cost to the farmer and (b) the terms of payment?

The Hon. Mr. Bowman replied as follows :---

"1. Eighteen crawler-type tractors operated during the 1949 season in six outfits of three units each.

"2. (a) Skeena-Omineca, (b) Prince George-McBride, (c) Cariboo, (d) Salmon Arm-Revelstoke, (e) Cranbrook, Nelson, Arrow Lakes, and (f) Nanaimo-Parksville. NOTE.—In the late fall several machines were moved to Westbank to clear land for a V.L.A. settlement project.

"3. It is estimated that the following acreages have been cleared in each year: 1946, 1,900 acres; 1947, 6,650 acres; 1948, 5,303 acres; 1949, 6,119 acres; total, 19,972 acres.

"4. (a) Hourly rates based on horse-power of tractors used; (b) (i) cash, (ii) half cash, or (iii) one-third cash. NOTE.—Where initial payment is one-half or one-third, balance is payable in two equal annual instalments."

Mr. H. E. Winch asked the Hon. the Premier the following questions:-

1. Does the Premier's office prepare and circulate a bulletin to departmental officials dealing with Government business and (or) activities and speeches of the Premier and (or) activities of or speeches of Cabinet Ministers?

2. If so, what is the purpose of same?

3. Did the Premier's office issue a bulletin under date of February 17th entitled "Highlights of Premier's Policy Speech" to any departmental officials?

4. If so, (a) is this policy also followed in issuing bulletins on Cabinet Ministers' speeches, (b) private members' speeches, and (c) Leader of the Opposition's speeches?

5. Does the Premier's office issue any release to weekly newspapers on Government affairs or activities of Cabinet members?

6. If so, is any reference made to the view-point of "His Majesty's Most Loyal Opposition" and, if so, is the official Opposition consulted?

7. If such release is made to newspapers, is it handled directly through the Premier's office or through an advertising agency and, if through the latter, under what estimate?

8. If not distributed through the Premier's office or through an advertising agency employed by the Government, is it released through an agency employed by a political party?

9. If so, what party and what advertising company?

The Hon. Mr. Johnson replied as follows :---

"1. A news-letter is prepared by the Premier's office primarily for the weekly press and anyone who desires a copy. The news-letter is prepared much in the same manner as the official press statements that are prepared for the metropolitan dailies from time to time. The news-letter covers Government action and Government policy. Coverage of speeches is confined to Ministers of the Crown and only then when the subject of the speech deals with Government policy.

"2. Purpose of the news-letter is to keep the public informed of Government action and Government policy.

"3. Yes; upon request as follows: Bureau of Economics and Statistics, Deputy Minister of Trade and Industry, Deputy Minister of Lands, and the Travel Bureau.

"4. (a) No, except when policy is outlined; (b) no; and (c) no.

"5. See answer to No. 1.

"6. See answer to No. 1.

"7. Directly through the Premier's office.

"8. See answer to No. 7.

"9. See answer to No. 7.

"NOTE.—The copies of the weekly news-letter are on file in the Premier's office for the past several years and are open to inspection by the Honourable the Leader of the Opposition if he so desires."

Mr. Haggen asked the Hon. the Minister of Public Works the following questions:-

1. What was the total number of (a) gallons of gasoline, (b) gallons of diesel oil, (c) gallons of lubricating-oil, and (d) pounds of grease purchased by the Department of Public Works in the Grand Forks-Greenwood riding from April 1st, 1949, to December 31st, 1949?

2. What was the total value of each of the above purchased by the Department from (a) the Imperial Oil Company, (b) the Shell Oil Company, (c) the British American Oil Company, and (d) the Standard Oil Company in the Grand Forks-Greenwood riding from April 1st, 1949, to December 31st, 1949?

The Hon. Mr. Carson replied as follows:-

"1. (a) 29,567 gallons, (b) 9,123 gallons, (c) 1,245 gallons, and (d) 1,000 pounds.

"2. (a) Imperial Oil Company: Gasoline, \$4,405.96; diesel oil, \$1,634.82; lubricating-oil, \$1,336.32; and grease, \$106.35. (b) Shell Oil Company: Gasoline, \$1,358.64; diesel oil, nil; lubricating-oil, \$92.80; grease, \$13.14. (c) British American Oil Company: Gasoline, \$1,154.40; diesel oil, lubricating-oil, and grease, nil. (d) Standard Oil Company: Gasoline, \$1,832.83; diesel oil, \$372.24; lubricating-oil, \$15.80; and grease, nil."

Mr. Harding asked the Hon. the Minister of Public Works the following questions:---

1. What was the total amount, if any, expended by the Department of Public Works in Deer Park of the Rossland-Trail riding for the year 1948–49?

2. What were (a) the names of the persons employed and (b) the amounts received by each for 1948-49?

3. What was the cost, if any, of building the trail to the Natural Arch from the Arrow Lakes?

4. What is the mileage of the above trail?

The Hon. Mr. Carson replied as follows :---

"1. \$4,639.53.

"2. (a) and (b): G. A. Walker, \$1,141.91; F. Briggeman, \$619.47; G. Hamblin, \$102.02; R. Hamblin, \$147.23; A. Kent, \$275.58; A. Law, \$407.10; R. Mottershead, \$377.49; A. A. Phelps, \$166.33; C. Williamson, \$220.61; A. Worley, \$117.03.

"3. \$306.43.

"4. Approximately one-half mile."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.
