Mr. Duncan asked the Hon. the Minister of Lands the following questions:-

1. What are the names of the members of the Committee representing the manufacturers who sit with departmental officials to report upon applications received for permit to export logs, and what are the respective names of the concerns to which they belong?

2. What are the names of the members of the same Committee representing the loggers, and to what concerns do they respectively belong?

The Hon, Mr. Pattullo replied as follows:-

"1. The members of the Committee representing the manufacturers who sit with departmental officers to report upon applications received for permit to export logs vary from time to time, but are such as are nominated from time to time by the manufacturers.

"2. Similar procedure is followed with respect to representatives of the logging industry."

Mr. Esling asked the Hon. the Minister of Railways the following questions:-

1. If any charges have been made by one Edward Rossiter against the administration of the Railway Department under the Premier as Minister of Railways, have such charges been referred to Price, Waterhouse & Co. to be reported upon in connection with the audit of transactions between the Pacific Great Eastern Railway and the Northern Construction Company?

2. How many, if any, such charges have been so referred?

3. What are the full details of each charge and against whom are they directed?

The Hon. Dr. MacLean replied as follows :---

"1. No charges have been made by Edward Rossiter against the administration of the Railway Department.

"2 and 3. Answered by No. 1."

Mr. W. A. McKenzie asked the Hon. the Minister of Public Works the following questions:-

1. Were tenders called for the stone-work in connection with the new Science Building at Point Grey?

2. If so, in what newspapers did such notice appear, and in how many issues was notice inserted?

3. If so, how many tenders were received, and what was the amount of each tender?

4. Which firm received the contract?

5. What firm is doing the work?

The Hon. Dr. Suthcrland replied as follows :--

"1. Yes.

"2. Contractor obtained competitive bids on instructions of Minister for supply of stone.

"3. Two tenders received. Keast & Allan, cut stone and rubble in place, \$134,332.62; alternate bid f.o.b. scow, \$96,204.67. Granite Island Quarries, cut stone and rubble in place, \$157,369.50; alternate bid f.o.b. scow, \$117,249.18.

"4. Keast & Allan, supplying stone f.o.b. scow.

"5. E. J. Ryan Contracting Company, Ltd."

Mr. Esling asked the Hon. the Minister of Finance the following questions :----

1. What is the total amount of money handled by: (a) Department of Industries; (b) Land Settlement Board, since the Boards were organized?

2. Who audited the accounts from time to time?

3. Was the person (or persons) a chartered accountant?

The Hon. Mr. Hart replied as follows :---

"1. (a) Total advanced to Industrial Development Fund, \$1,025,000; (b) total advanced to Land Settlement Board, \$5,783,873.21.

"2. Accounts audited under supervision of Comptroller-General.

"3. Yes, Comptroller-General is a chartered accountant."

Mr. Esling asked the Hon. the Minister of Finance the following questions :--

1. What is the total amount of money received by the Liquor Control Board since its organization?

2. Who audited the accounts, and when?

3. Was the person (or persons) a chartered accountant?

The Hon. Mr. Hart replied as follows :-

"1. To September 30th, 1923, \$21,370,557.95.

"2. Accounts audited under supervision of Comptroller-General.

"3. Yes, Comptroller-General is a chartered accountant."

Mr. Esling asked the Hon. the Provincial Secretary the following questions:-

1. On what date did the Government take over the Pacific Great Eastern, and what was the total debt at that date?

2. What is the total debt as at June 30th, 1923?

3. How much is represented by: (a) Bond guarantees; (b) construction-work; (c) equipment; (d) interest; (c) supplies?

4. Of the amount charged against interest since the Government took over the road, how much has been paid out of current revenue and how much has been paid by horrowings under Loan Acts?

The Hon. Dr. MacLean replied as follows :--

"1. February 22nd, 1918; \$23,154,816.47.

"2, 3, and 4. See Return presented to the House."

Mr. Esling asked the Hon. the Minister of Finance the following questions:-

1. How many chartered accountants are in the employ of the Provincial Government?

2. What are their names?

3. What are the dates of employment of each chartered accountant?

4. In what department is each employed, and in what capacity?

The Hon. Mr. Hart replied as follows :---

"1. Two.

"2 and 3. A. N. Mouat, August 1st, 1917; S. V. Roberts, June 4th, 1919.

"4. In the Department of Finance, A. N. Mouat is Comptroller-General. S. V. Roberts is in charge of the staff of auditors in the office of the Surveyor of Taxes."

Mr. Wallinger asked the Hon. the Minister of Public Works the following questions :---

1. Did the Government build a road from the old Wasa Road to Skookumchuck leading to a bridge over the Kootenay River above Sheep Creek?

2. Did the Government also build a bridge across the Kootenay in connection with this road?

3. Were tenders called for the bridge?

4. If so, the names, prices, and successful tenderers?

5. What did said road and bridge cost?

6. What was the necessity for this road and bridge?

7. What is the difference in mileage between Cranbrook and Sheep Creek on this road as compared with the old road via Fort Steele?

The Hon. Dr. Sutherland replied as follows :----

"1. Yes.

"2. Yes (known as Skookumchuck Bridge).

"3. Yes.

"4. W. Greenlees, \$19,530; McCharles & McDougall, \$19,989; Nickson Construction Co., Ltd., \$25,135; George Cody & John Perry, \$25,326; DeWolf & Ham Construction Co., Ltd., \$26,000.

"5. Road cost \$58,425.25; bridge cost \$19,998.34.

"6. Main highway leading to Banff-Windermere Road and points north. The splendid grade and flat open country of this route giving a low cost per mile of road, both for construction and maintenance, as compared with rebuilding the old Wasa to Sheep Creek Road; also a bridge in Skookumchuck vicinity over the Kootenay River is of benefit locally. Another prime factor in choosing this route was the fact of its lending itself to the possibility of completion before the opening of the Banff-Windermere Road; 8 miles out of 12 of absolutely flat open country made it possible to get this road opened a few days prior to the opening of the Banff-Windermere Road. Nothing comparable to this occurred in any other possible route north, all of which were thoroughly investigated.

"7. 1.8 miles shorter."

Mr. W. A. McKenzie asked the Hon, the Minister of Public Works the following questions :-

1. Has J. B. Henderson been employed as clerk of the works on the Acute Mental Hospital at Essondale since March 31st, 1923?

2. If not as clerk of works, in what capacity, if any, is he employed?

3. What salary is he in receipt of?

4. What is the total amount of money paid J. B. Henderson in connection with the Mental Hospital since date of commencement up to November 30th, 1923?

The Hon. Dr. Sutherland replied as follows :---

"1. Yes.

"2. Answered by No. 1.

"3. \$200 per month.

"4. \$3,546.62."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

Resolution and Bill reported. Bill introduced and read a first time. Second reading at the next sitting.

Mr. Hinchliffe moved, seconded by Mr. Lister,-

Whereas many returned soldiers in British Columbia are receiving treatment, either at their own expense or at the expense of the Province, or of municipalities in the Province, for illness or physical disability which is claimed to be directly or indirectly a result of war service:

And whereas many returned soldiers in British Columbia are physically unable, because of illness or physical disability which is claimed to be directly or indirectly a result of war service, to earn a livelihood for themselves and their dependents, and some of these returned soldiers are

on the verge of destitution and likely to become a charge on the funds of municipalities or of the Province:

And whereas it is publicly reported that the Government of Canada intends to cancel at an early date the pension bonus which is now being paid in addition to pensions, thus materially reducing the income of many returned soldiers, and forcing some of them to appeal to public and charitable funds for aid:

Therefore be it Resolved, That this Legislature respectfully prays the Government of Canada to review and, if found necessary, to readjust its schemes for granting pensions and treatment to returned soldiers with a view to :---

- (a.) Providing that every returned soldier suffering from disease, illness, or physical disability, resulting either directly or indirectly from war service, shall be entitled to receive at the expense of the Government of Canada such medical, surgical, or hospital treatment as his sickness, illness, or disability may require:
- (b.) Awarding to every returned soldier whose capacity to earn a livelihood for himself and his dependents is impaired, either directly or indirectly through war service, such a pension as will be sufficient to recompense him in full for such impairment of capacity to earn such livelihood, as long as such impairment lasts.

Mr. I. A. Mackenzie moved in amendment, seconded by Mr. Clearihue,-

To delete all the words of the Resolution after the word "Whereas" in the first line thereof, and substitute therefor the following:--

"Many ex-service men in the Province of British Columbia are receiving treatment, either at their own expense or at the expense of the Province or municipalities, for illness or disabilities which it is claimed is a result of war service:

"And whereas many ex-service men in British Columbia are physically unable, because of illness or disability, which it is claimed to be a result of war service, to earn a livelihood for themselves and their dependents:

"Whereas, further, it has been suggested that the present pension bonus is to be eliminated, thereby reducing the amounts payable to ex-service men and dependents very considerably:

"Therefore be it Resolved, That this Legislature respectfully prays the Government of Canada:—

- "(a.) To make permanent the present pension bonus on the pension of ex-service men and their dependents during the existence of such pensions:
- "(b.) To give explicit and detailed instructions to departmental heads of the Board of Pension Commissioners and the Department of Soldiers' Civil Re-establishment in Ottawa to assist in every way possible the operations of the newly organized Federal Appeal Board and the Soldiers' Advisers, so that all inequalities and injustices affecting treatment or pensions of ex-service men may be eliminated with the least possible delay.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution and Preamble hereinbefore set out be transmitted to the Honourable Secretary of State or other proper official at Ottawa."

A debate arose, which was, on the motion of Mr. Clearihuc, adjourned to the next sitting.

Mr. Esling moved, seconded by Mr. Schofield,-

That an Order of the House be granted for a Return of all correspondence between the Premier, as Minister of Railways, and the Chief Engineer; between the Premier and accountant; and between the Premier and any other official or clerk in the office of the Department of Railways, during the period from October 1st, 1919, to March 31st, 1920.

A debate arose, which was, on the motion of the Hon. Mr. Oliver, adjourned to the next sitting.

Mr. W. A. McKenzie moved, seconded by Mr. Jones,---

That an Order of this House be granted for a Return of all engineering reports, surveys, and findings covering the proposed routes of the Trans-Provincial Highway—i.e., the Hope-Princeton route and the Fraser Canyon route—made to date, giving estimated costs, mileage, etc.

Dr. K. C. MacDonald presented the report of the Select Standing Committee on Agriculture, as follows:—

LEGISLATIVE COMMITTEE ROOM, December 13th, 1923.

## MR. SPEAKER:

This Committee held several meetings with members of the Advisory Board of Farmers' Institutes and representatives of the United Farmers of British Columbia, members of the Bee-keepers' Association of British Columbia and the Honey Producers' Association, representatives of the Wholesale Produce Merchants, Poultry Producers' Co-operative Exchange, and President and members of the Associated Growers of British Columbia, as well as a number of other persons interested in agriculture.

During these meetings the Committee dealt with a number of resolutions which had for their object the bringing of matters pertaining to agriculture throughout the Province to the attention of the Legislature. These resolutions were very fully discussed, with the result that your Committee feels justified in recommending the following:--

Resolutions from the Advisory Board of Farmers' Institutes and United Farmers of British Columbia.

(1.) We recommend, for the consideration of the Government, that the interest on unpaid taxes do not exceed 8 per cent. per annum, and that arrangements be made to receive taxes on the instalment plan.

(2.) We recommend that full information be secured and made public with regard to the rural-credit system as it applies to the needs of British Columbia.

(3.) We endorse the attitude of the Government in its endeavours to secure cheaper fleight rates to the Coast from Prairie points on grain, and recommend that strong endeavours be put forth to secure a substantial reduction in rates to the Coast from the Interior points of the Province.

(4.) We recommend that a tax be placed on gasolene, with certain exemptions as are named in the proposed Bill.

## 14TH DECEMBER.

(5.) This Committee is of the opinion that the most rigid economy should be exercised in the expenditure of public moneys generally, and in providing public works and services only where absolutely necessary, and to this end that there should be a cessation of demands from organized bodies for expenditure of money upon measures in which such bodies may be interested for the time being.

(6.) We recommend that intending settlers be given the fullest possible information regarding the conditions existing in the Province, and that new settlers be established only in districts where transportation facilities already exist.

(7.) We recommend that the provisions of the "Sheep Protection Act" be strictly enforced, with a view to affording protection to flockmasters and obviating losses in flocks through the depredations of stray dogs.

(8.) Your Committee has from time to time received gratifying evidences of a desire on the part of rural and urban residents of the Province to purchase British Columbia products, and respectfully urges that every effort be made to further this co-operative spirit between distributers and producers.

(9.) Your Committee recommends that, in view of the apparent inequitable taxation for school purposes throughout the Province, any survey on educational subjects which may take place will include the subject of taxation for school purposes.

(10.) Your Committee notes with pleasure the gratifying success resulting from the efforts of the Department of Agriculture in establishing certification of seed-potatoes, and congratulates the potato-growers on the success of their recent show.

(11.) Your Committee further considered resolutions received from the Advisory Board of Farmers' Institutes, which resolutions had already been discussed with the various departments concerned, and strongly recommends that every effort be made to find a solution of the problems concerned. These were regarding the following: Sheep industry; amendment to "Sheep Protection Act"; "Water Act" amendment; potato extension work; local fair radius; printing of information *re* rural-credit situation; Asiatic census.

The House resumed the adjourned debate on the motion moved by Mr. *Duncan* on 13th instant, as follows:—

That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the petition from R. Binnie *et al.*, addressed to His Honour the Lieutenant-Governor of British Columbia in Council, praying for the appointment of a Royal Commission to investigate the charges referred to in said petition, and which was forwarded to the Honourable the Provin-

cial Secretary under date of December 7th, 1923, by J. F. Tener, be laid before the Members of this House for their information.

Resolution agreed to.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on 5th instant, as follows:—

Whereas it is reported in the public press that the Government of Canada has under consideration the passing of an Order in Council whereby further claims for war service gratuity, working pay, separation allowances, and other related matters, arising from service with the C.E.F. during the Great War will be outlawed:

And whereas the passing of such an Order in Council would not only be a serious breach of contract on the part of the Government of Canada, but would also lead to a confiscation of money earned by members of the C.E.F., to which money the nation has no legal or moral right, but which is the hard-earned property of ex-members of the C.E.F.:

And whereas through mislaying of documents, illness of claimants, difficulty in locating dependents of members of the C.E.F., and other reasons, hundreds of claims have not yet been settled:

And whereas there can be no justification for a refusal by the Government of Canada to pay such claims to those who may at any time in the future prove that they are justly entitled to receive payment:

Therefore be it Resolved, That this Legislature of British Columbia respectfully requests the Government of Canada to leave open the way for the presentation, reception, and payment of such claims until the last claim has been adjusted.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Honourable the Secretary of State for Canada.

Mr. I. A. Mackenzie moved in amendment, seconded by Mr. Clearihue,-

To delete all the words of the Resolution after the word "Whereas" in the first line thereof, and substitute therefor the following:—

"By Order in Council dated November 3rd, 1923, the Government of Canada limited further payments of war service gratuity to cases where applications are filed before March 31st, 1924:

"And whereas this gratuity was given to ex-service men on discharge to assist their re-establishment into civil life:

"Whereas, further, the whole question of re-establishment of ex-service men was recently reviewed by the Ralston Commission, which visited and took evidence in all the Provinces of the Dominion, and made it manifest that re-establishment of ex-service men was yet far from completed:

"Therefore be it Resolved, That this Legislature of British Columbia respectfully requests the Government of Canada to leave open the way for the presentation, reception, and payment of claims for war service gratuity, working pay, separation allowances, and other matters related to overseas service until the last claim has been adjusted.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution and Preamble hereinbefore set out be transmitted to the Honourable Secretary of State or other proper official at Ottawa."

On the motion of Mr. Clearihue, the debate was adjourned to the next sitting.

Prayers by Mr. Speaker.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on 5th instant, as follows:---

Whereas it is reported in the public press that the Government of Canada has under consideration the passing of an Order in Council whereby further claims for war service gratuity, working pay, separation allowances, and other related matters arising from service with the C.E.F. during the Great War will be outlawed:

And whereas the passing of such an Order in Council would not only be a serious breach of contract on the part of the Government of Canada, but would also lead to a confiscation of money earned by members of the C.E.F., to which money the nation has no legal or moral right, but which is the hard-earned property of ex-members of the C.E.F.:

And whereas through mislaying of documents, illness of claimants, difficulty in locating dependents of members of the C.E.F., and other reasons, hundreds of claims have not yet been settled:

And whereas there can be no justification for a refusal by the Government of Canada to pay such claims to those who may at any time in the future prove that they are justly entitled to receive payment:

Therefore be it Resolved, That this Legislature of British Columbia respectfully requests the Government of Canada to leave open the way for the presentation, reception, and payment of such claims until the last claim has been adjusted.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Honourable the Secretary of State for Canada.

And on the amendment moved by Mr. I. A. Mackenzie on 14th instant, as follows :--

To delete all the words of the Resolution after the word "Whereas" in the first line thereof, and substitute therefor the following:—

"By Order in Council dated November 3rd, 1923, the Government of Canada limited further payments of war service gratuity to cases where applications are filed before March 31st, 1924:

"And whereas this gratuity was given to ex-service men on discharge to assist their re-establishment into civil life:

"Whereas, further, the whole question of re-establishment of ex-service men was recently reviewed by the Ralston Commission, which visited and took evidence in all the Provinces of the Dominion, and made it manifest that re-establishment of ex-service men was yet far from completed:

"Therefore be it Resolved, That this Legislature of British Columbia respectfully requests the Government of Canada to leave open the way for the presentation, reception, and payment of claims for war service gratuity, working pay, separation allowances, and other matters related to overseas service until the last claim has been adjusted.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution and Preamble hereinbefore set out be transmitted to the Honourable Secretary of State or other proper official at Ottawa."

Amendment agreed to.

Resolution as amended was carried unanimously.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on 13th instant, as follows:---

Whereas many returned soldiers in British Columbia are receiving treatment, either at their own expense or at the expense of the Province, or of municipalities in the Province, for illness or physical disability which is claimed to be directly or indirectly a result of war service:

And whereas many returned soldiers in British Columbia are physically unable, because of illness or physical disability which is claimed to be directly or indirectly a result of war service,

to earn a livelihood for themselves and their dependents, and some of these returned soldiers are on the verge of destitution and likely to become a charge on the funds of municipalities or of the Province:

And whereas it is publicly reported that the Government of Canada intends to cancel at an early date the pension bonus which is now being paid in addition to pensions, thus materially reducing the income of many returned soldiers, and forcing some of them to appeal to public and charitable funds for aid:

Therefore be it Resolved, That this Legislature respectfully prays the Government of Canada to review and, if found necessary, to readjust its schemes for granting pensions and treatment to returned soldiers, with a view to :---

- (a.) Providing that every returned soldier suffering from disease, illness, or physical disability, resulting either directly or indirectly from war service, shall be entitled to receive at the expense of the Government of Canada such medical, surgical, or hospital treatment as his sickness, illness, or disability may require:
- (b.) Awarding to every returned soldier whose capacity to earn a livelihood for himself and his dependents is impaired, either directly or indirectly through war service, such a pension as will be sufficient to recompense him in full for such impairment of capacity to earn such livelihood, as long as such impairment lasts.

And on the amendment thereto moved by Mr. I. A. Mackenzie on 13th instant, as follows:-

To delete all the words of the Resolution after the word "Whereas" in the first line thereof, and substitute therefor the following :---

"Many ex-service men in the Province of British Columbia are receiving treatment, either at their own expense or at the expense of the Province or municipalities, for illness or disabilities which it is claimed is a result of war service:

"And whereas many ex-service men in British Columbia are physically unable, because of illness or disability, which it is claimed to be a result of war service, to earn a livelihood for themselves and their dependents:

"Whereas, further, it has been suggested that the present pension bonus is to be eliminated, thereby reducing the amounts payable to ex-service men and dependents very considerably:

"Therefore be it Resolved, That this Legislature respectfully prays the Government of Canada:--

- "(a.) To make permanent the present pension bound on the pension of ex-service men and their dependents during the existence of such pensions:
- "(b.) To give explicit and detailed instructions to departmental heads of the Board of Pension Commissioners and the Department of Soldiers' Civil Re-establishment in Ottawa to assist in every way possible the operations of the newly organized Federal Appeal Board and the Soldiers' Advisers, so that all inequalities and injustices affecting treatment or pensions of ex-service men may be eliminated with the least possible delay.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution and Preamble hereinbefore set out be transmitted to the Honourable Secretary of State or other proper official at Ottawa."

Resolution as amended was carried unanimously.

On the motion of the Hon, the Attorney-General, the House proceeded to the Orders of the Day.

## Memo, re Report of Select Committee on Redistribution.

The combined effect of the new paragraphs 8 and 13 is to take from Cowichan District the Cobble Hill, Shawnigan Lake, and Clo-oose polling-places and put them into Esquimalt District, and to add to the remainder of the Cowichan District the Electoral District of Newcastle.

The effect of the new paragraphs 10 and 19 combined is to take away Queen's Bay pollingplace from the Kaslo-Slocan District and place it in the Creston Electoral District.

The effect of paragraph 15 is to restore a few small polling-places to Fort George which under the Bill were included in Omineca.

The effect of new paragraph 16 is to re-establish the old boundary-line between Grand Forks and Slocan Districts, making the watershed, instead of Arrow Lakes, the dividing line between the two districts.

The combined effect of new paragraphs 18 and 33 is to divide the Kamloops District into the Kamloops and Salmon Arm Districts respectively.

The effect of new section 20 is to take a small area from Lillooet District and add the same to Kamloops District, as a better community of interest is thus obtained.

The effect of new paragraph 27 combined with new paragraph 35 is to divide Skeena and Omineca District into two separate districts.

The effect of the new section 31 is to include a small area on the east bank of the Columbia River adjacent to the City of Trail with the Rossland-Trail District.

The effect of new paragraph 40 is to restore to Yale District the town of Ashcroft, where it was formerly.

The report was received.

On the motion of the Hon. Mr. *Oliver*, it was *Ordered* that the report be printed immediately for distribution among the members of the House.

On the motion of the Hon, Mr. *Oliver*, it was *Ordered* that Bill (No. 32) initialed "An Act to amend the 'Constitution Act'" be placed on the Orders of the Day (Committee stage) for the next sitting.

The House resumed the adjourned debate on the motion moved by Mr. *Esling* on 13th instant, as follows:—

That an Order of the House be granted for a Return of all correspondence between the Premier, as Minister of Railways, and the Chief Engineer; between the Premier and accountant; and between the Premier and any other official or clerk in the office of the Department of Railways, during the period from October 1st, 1919, to March 31st, 1920.

· The Hon. Mr. Oliver rose to a point of order.

Mr. Speaker reserved his decision.

#### Mr. Hinchliffe moved, seconded by Mr. Pooley,-

Whereas certain serious charges have been made from time to time on the floor of the House and in public in regard to the construction of the Pacific Great Eastern Railway, as well as against certain Members of this House in relation thereto:

And whereas the Premier has stated from his place on the floor of the House that charges of a very serious nature have been made publicly against himself in his former capacity of Minister of Railways in this regard:

And whereas for the protection of the Province it is necessary to ascertain the truth or otherwise of these as well as of all other charges in connection with the said railway and the construction thereof:

Therefore be it Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a Royal Commission consisting of such person or persons, not exceeding three in number, as may be appointed under the "Public Inquiries Act" be appointed to investigate the said charges, and that the said Commission be invested with all the powers and authority which under the said Act may be granted, including (but so as not to limit the generality of the powers aforenamed) power and authority to investigate all the facts, figures, costs, contracts, transactions, details, and all other matters directly or indirectly relating to the construction of the Pacific Great Eastern Railway; and also into the relations and transactions between the Pacific Great Eastern Railway Company and the contractors or any other person, firm, or corporation directly or indirectly concerning the same; and further to make the fullest investigations into the personal dealings of any and all Members of this Legislature in connection with the matter under investigation; and generally to make the most searching inquiry into all matters that the said Commission may deem necessary to investigate in order to enable it to report to His Honour the Lieutenant-Governor as to the truth or otherwise of all charges or matters in any way pertaining to the said railway, its construction, or the doings or dealings of any and all persons in connection therewith.

And that His Honour be pleased to order that the report of the said Commission be printed immediately after its presentation to him, and that copies of the report be forwarded to the Members of this Legislature.

On the motion of the Hon. Mr. Oliver, the debate was adjourned to the next sitting.

## 17TH DECEMBER.

Upon the motion to commit Bill (No. 35) intituled "An Act to provide for the Imposition and Collection of a Tax on Gasolene," Mr. Speaker delivered his reserved decision on the point of order which was reported to him on 12th instant by Mr. I. A. Mackenzie, the Chairman of the Committee of the Whole on the said Bill, as follows:—

"Upon the consideration of Bill No. 35 in Committee, being 'An Act to provide for the Imposition and Collection of a Tax on Gasolene,' an amendment was proposed by Mr. *Jones* to section 3 to strike out the word 'three' and substitute 'two.'

"I understand the Chairman ruled the amendment out of order and an appeal was then taken from his ruling to the Speaker.

"Rule 99 says: 'Questions of order arising in Committee of the Whole House shall be decided by the Chairman, subject to an appeal to the House without the Committee rising.

" $Ma\mu$  (12th ed.), page 409, says: 'Order in debate in a Committee is enforced by the Chairman, who is responsible for the conduct of business therein; and from his decision no appeal should be made to the Speaker.'

"*Bourinot*, page 396, says: 'In case of an appeal to the House, the Chairman leaves the Chair immediately and reports the point in dispute to the Speaker, so that the House may decide.'

"Rule 99 is not very clear, but it is apparent that our practice is in accordance with that of the Canadian House of Commons as well as that of the Imperial House.

"Sce ruling of Mr. Speaker Manson, H.J., 1921, page 91. The point raised that the amendment is out of order, I leave to the judgment of the House.

"The following authorities which bear on the point at issue may be of some service in enabling the House to come to a decision :—

"May (12th ed.), page 462, says: 'The House can make amendments which diminish the amount of a reduction of taxation.'

"*Bourinot* (4th ed.), page 439, says, speaking of Tax Bills: 'Resolutions against the principle of such Bills may be proposed at the different stages. It is also regular to move amendments in the Committee on the Bill for the repeal or reduction or modification of any charge or duty upon the people.'

"Generally, I find nothing to prevent a member from presenting an amendment in Committee for the consideration of the House the intent of which is to reduce the amount of taxation proposed in the Bill.

"The motion is 'That the Chair be sustained."

Mr. I. A. Mackenzie stated to the House that he accepted Mr. Speaker's ruling.

Bill (No. 35) intituled "An Act to provide for the Imposition and Collection of a Tax on Gasolene" was thereupon again committed, and the Chairman resumed the Chair.

The Committee rose and reported the Bill complete with amendments.

Report to be considered at the next sitting.

Bill (No. 70) intituled "An Act respecting the Revised Statutes of British Columbia" was read a third time and passed.

Bill (No. 63) intituled "An Act to amend the 'Placer-mining Act" was read a third time and passed.

On the second reading of Bill (No. 77) intituled "An Act to amend the 'Government Liquor Act'" a debate arose, which was, on the motion of Mr. *Pooley*, adjourned to the next sitting.

On the second reading of Bill (No., 76) initialed "An Act to provide for Plebiscites on Questions relating to the Control or Suppression of Traffic in Alcoholic Liquors" a debate arose, which was, on the motion of Mr. *Pooley*, adjourned to the next sitting

The Hon. Mr. Sloan presented the Report of the Commissioner of Fisheries for the Year 1923.

Mr. Hinchliffc asked the Hon, the Minister of Lands the following questions:-

1. Have the Indian tribes of the Province been parties to the negotiations *re* adjustment of Indian reserves mentioned in the Speech of His Honour the Lieutenant-Governor?

2. Have the Indian tribes of the Province agreed to the adjustment of the Indian reserves question mentioned in His Honour's Speech?

3. Have any negotiations been carried on between the Government of the Province and the Indian tribes in pursuance of the provisions of section 3 of Statutes of British Columbia, 1919, chapter 32? If so, what has resulted from such negotiations?

4. Did the Premier of the Province in the year 1919 request that the allied tribes of British Columbia place in his hands statement of their case for the information of the Government of the Province, including conditions of equitable settlement proposed by the allied tribes?

5. Did the allied tribes in December, 1919, present such statement to the Premier?

6. Have the contents of such statement, and in particular the proposed conditions of equitable settlement, been discussed between the allied tribes and the Government of the Province?

7. With reference to the preamble of the Statute above mentioned, has final adjustment of all matters relating to Indian affairs in British Columbia been brought about?

8. If so, in what way has such adjustment been brought about?

9. In particular what steps, if any, have been taken for adjusting: (a) The foreshore rights of the Indian tribes; (b) the fishing rights of the Indian tribes; (c) the hunting rights of the Indian tribes; (d) the water rights of the Indian tribes?

10. If any such steps have been taken, what in each case has been the result?

The Hon. Mr. Pattullo replied as follows :--

"1. Negotiations *rc* adjustment of Indian reserves question took place with the Department of Indian Affairs, Ottawa.

"2. No information.

"3. Representations have been made from time to time by persons purporting to represent the Indian tribes, but negotiations towards final adjustment were made with the Dominion Department of Indian Affairs.

"4. Premier advised persons purporting to represent Indian tribes that he would be glad to receive any representations which they cared to make.

"5. Various representations have been made from time to time by persons purporting to represent the allied Indian tribes.

"6. Negotiations looking to adjustment of the Indian reserves question were carried on with the Department of Indian Affairs, Ottawa.

"7. Final settlement of all matters relating to Indian affairs in British Columbia are in process of adjustment.

"S. Answered by No. 7.

"9. These various matters are either in process of adjustment or are already settled under the Statute law.

"10. Answered by No. 9."

Mr. McRac asked the Hon. the Minister of Finance the following questions :----

1. Is one Maxwell at present Government Ageni at Revelstoke?

2. If so, when was he appointed, and at what salary?

3. Was he in the Provincial Service prior to his appointment?

4. If so, how long?

5. If not in the Service, what was the justification for his appointment, and why was some other official not promoted?

6. Did the Civil Service Commissioner approve of his appointment?

The Hon. Mr. Hart replied as follows :---

"1. Winfield Maxwell is Government Agent at Revelstoke.

"2. April 10th, 1923; \$150 per month.

"3. No; but he acted as special assessor in connection with the reassessment of lands.

"4. Answered by No. 3.

"5. His knowledge of the district, general qualifications, and excellent war record.

"6. Approval not required, being a technical officer."

Mr. Duncan asked the Hon. the Minister of Lands the following questions :---

1. What was the date of the last meeting of the members of the Committee representing the manufacturers and loggers respectively, and the departmental officials, to report upon applications for permit to export logs?

2. What are the names of the members of the Committee who represented the manufacturers at that meeting, and what are the respective names of the concerns to which they belong?

3. What are the names of the members of the Committee who represented the loggers at that meeting, and what are the respective names of the concerns to which they belong?

4. How many times has this Committee met since 1920, and what are the dates of such meetings?

5. Is the Committee re-formed to consider new applications for permit to export logs?

6. If not, why is the personnel changed from time to time?

The Hon, Mr. Pattullo replied as follows :--

"1. November 20th, 1923.

"2. R. B. Sharpe, Pacific Box Co., Ltd., Vancouver; C. J. Coulter, Westminster Mills Co., Ltd., New Westminster, B.C.; Hammond Cedar Co., Ltd., New Westminster, B.C.; Consolidated Shingle Manufacturers' Association, Ltd., Vancouver; A. R. Macfarlane, John Hanbury & Co., Ltd., Vancouver.

"3. Geo. Challenger, Challenger Timber Co., Vancouver; Grassy Bay Timber Co.; B.C. Loggers' Association, Vancouver; A. E. Munn, Northern Pacific Logging Co., Vancouver; Munn & Kerr Logging Co., Ltd., Vancouver; B.C. Loggers' Association, Vancouver.

"4. Forty-seven times. Dates for 1921: January 25th, February 15th, March 15th, April 15th, May 17th and 30th, June 15th, July 11th and 19th, August 16th, September 13th, October 18th, November 22nd, December 5th and 20th. For 1922: January 24th, February 21st, March 28th, April 18th, May 16th, June 13th, July 18th, August 1st, 15th, and 29th, September 19th, October 3rd and 24th, November 7th and 21st, December 5th and 19th. For 1923: January 23rd, February 20th, March 20th, April 24th, May 22nd, June 5th and 19th, July 3rd, 17th, and 24th, August 28th, September 25th, October 9th, November 6th and 20th.

"5. The members representing the manufacturers and loggers are renominated by these bodies from time to time.

"6. In case any member of the regular Committee is absent from any meeting, the industry nominates substitutes to attend that particular meeting."

Mr. Esling asked the Hon. the Premier the following questions :--

1. Was E. J. Rossiter Private Secretary under the Premier as Minister of Agriculture, and was he accountant for the Pacific Great Eastern under the Premier as Minister of Railways?

2. When said Rossiter left the Government service, did the Premier, as Minister of Railways, recommend him to anybody where efficiency and integrity were the prime considerations?

3. Has the Government knowledge of publicity, through a pamphlet or otherwise, to certain charges against the Premier's administration of the Pacific Great Eastern Railway and in connection with the method of certifying to vouchers of the Northern Construction Company?

The Hon. Mr. Oliver replied as follows :--

"1. Yes.

"2. A recommendation was given at Rossiter's request.

"3. Yes."

Mr. Catherwood asked the Hon. the Minister of Agriculture the following questions:----

1. How many returned soldier loans are in good standing in each of the soldier settlement areas?

2. How many have been fully paid up?

3. What has been the total amount advanced on progress loans to returned soldiers in soldier settlement areas?

The Hon, Mr. Barrow replied as follows :---

"1. The Board, strictly speaking, has no returned soldier loans in any of its development areas; all such transactions as between Board and settler are covered by agreements for sale, and therefore are registered as sales of land. Terms of payment provide for interest to com-

mence at Merville on October 1st and at Creston on November 1st, 1922. First payment of interest to be due and payable one year later; i.e., October and November, 1923. No principal is due until 1925 and same is spread over a long term of years. As none of the payments are now overdue for more than two months at the most, all of these sales to returned soldier settlers, to the number of 148, are considered to be in good standing, so far as payments are concerbed.

"2. Sixteen settlers have paid up instalments in full to date; nine others have paid cash amounts on account.

"3. \$177,261.61 has been advanced in improvement credits to soldier settlers in the two development areas referred to."

Mr. Duncan asked the Hon. the Minister of Lands the following question:-

What amount of unmanufactured timber was exported from British Columbia during November last from (a) Exportable lands; (b) non-exportable lands?

The Hou. Mr. Pattullo replied as follows :--

"(a) 2,210,201 F.B.M.; (b) 3,343,418 F.B.M."

Mr. W. A. McKenzie asked the Hon. the Minister of Finance the following question :---

What was the amount of taxes collected by the Government in the Peace River Block for the year 1923?

The Hon. Mr. Hart replied as follows :--

"As the boundaries of the Peace River Block do not conform to those of the Peace River Subdivision of the Barkerville Assessment District it is impossible to give the information."

Mr. Wallinger asked the Hon. the Minister of Finance the following questions:-

1. Who is the Government Agent at Cranbrook?

2. When was he appointed?

3. Had he been in the Service prior to his appointment?

4. If so, how long and in what capacity?

5. Was he retired from this office?

6. If so, for what reason?

7. Did the Civil Service Commissioner approve of the appointment of said Government Agent?

The Hon. Mr. Hart replied as follows :--

"1. F. A. Small.

"2. February 12th, 1923.

"3. Yes.

"4. During 1920, 1921, and 1922 he was employed at various times in a temporary capacity as Clerk and Mining Recorder during vacancies.

"5. Answered by No. 4.

"6. Answered by No. 4.

"7. Yes."

Mr. Neelands asked the Hon, the Minister of Education the following questions:-

1. How many teachers are employed by School Boards?

2. Are any of these teachers contributors to the "Superannuation Act," pursuant to the regulations required therein for them?

3. If yes, how many, and where?

4. If no, does the Government intend taking any action to remedy this condition?

5. How many teachers are in receipt of a retiring allowance as provided in the "Public Schools Act," section 50 (3)?

The Hon. Dr. MacLean replied as follows :--

"1, 3,109.

"2. No.

"3. Answered by No. 2.

"4. The matter is under consideration.

"5. One."

Mr. Hanes asked the Hon. the Provincial Secretary the following questions :---

1. Has the Government prepared plans for the alteration of the Provincial Home for Incurables at Eburne, B.C.?

2. If so, have tenders been called for said alterations?

3. If so, who were the tenderers, and what was the amount of each tender?

4. Has a contract been let for said alterations?

5. If so, to whom, and for what amount?

6. Did the Government Architect report on this building before it was purchased?

7. If so, did he give any estimate of what said alterations would cost?

The Hou. Dr. MacLean replied as follows :---

"These questions should be addressed to the Hon. the Minister of Public Works."

Mr. McRae asked the Hon. the Minister of Industries the following question :---

Did the Webber Lumber Company of Port Haney at any time borrow from the Department of Industries the sum of \$12,000, or any sum or sums, and how much?

The Hon. Mr. Hart replied as follows :--

" No."

Mr. Bowser asked the Hon. the Premier the following questions :--

1. What is the position as regards the order of the Railway Commission ordering the removal of the village of Lucerne to Jasper?

2. Is the Government making any effort to meet the wishes of the people of Lucerne in not having them transferred to Jasper?

The Hon. Mr. Oliver replied as follows :---

"1. The Board of Railway Commissioners ordered consolidation of divisional points at Jasper.

"2. Previous to the order above referred to, strong representations were made both to the Board of Railway Commissioners and the Canadian Northern Railway Company in favour of consolidation at Lucerne, B.C."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-day.
