Prayers by Rev. Baugh Allen.

The Hon. the Premier laid on the table the Report of W. H. Hayward, M.P.P., the Premier's personal representative to the Pacific North-western Immigration Convention at Tacoma. The report reads as follows:—

"VICTORIA, 26th February, 1912.

"Honourable Richard McBride, Premier, Victoria, B.C.

"Dear Sir,—According to your wish, I went, as your personal representative, to the Pacific North-western Immigration Convention, held at Tacoma on February 21st and 22nd, under the auspices of the Tacoma Commercial Club and Chamber of Commerce and the Young Men's Christian Association. There was a very large attendance of delegates, California, Oregon, Washington, and Idaho, together with British Columbia, being represented. A large number of most valuable and interesting papers were read by well-known immigration authorities, as well as the Governors of the above-mentioned States and Provinces, or their personal representatives. A lively debate at times took place, and throughout the whole Convention great spirit and attention were shown. I had the honour of addressing the Convention, the subject being 'The Immigration Policy of British Columbia,' and attempted to place clearly before the Convention our intention of keeping British Columbia a white man's country; our system of doing everything possible to place immigrants upon the land, rather than congesting the cities, by means of free education, education along agricultural lines, our system of aiding co-operative, dairy, live-stock, and poultry associations, as well as demonstration orchards:

our practical legislation enabling railroads to be built to open up our lands, as well as roads and trails to reach the railroads; and, last, our system of conservation of our timber lands and water-powers.

"Resolutions were passed asking for better educational facilities for immigrants who have no knowledge of the English language. At a banquet subsequently held, at which some 300 persons were present, including Governor M. E. Hays, of the State of Washington, U.S., I again had the honour of making an address, principally on the subject of forest-land conservation. As representative of British Columbia I received the greatest kindness and courtesy, and everywhere was shown the greatest friendliness towards the people living on the north of the forty-ninth parallel.

"Speaking of the dominant note occurring throughout all the papers read and addresses given, I think, without doubt, it might be found in the words, 'Get back to the land.'

In relieving you from the duties of the Session, it gives me pleasure to express my high appreciation of the careful and earnest manner in which you have dealt with the many and important subjects that have engaged your attention.

The provision for the construction of the Pacific and Great Eastern Railway and for the further extensions of the lines of the Canadian Northern Pacific and the Kettle Valley Railways, as well as the Agreements with the Esquimalt and Nanaimo and the Canadian Pacific Railways, will, I trust, inure to the great benefit of the Province in securing further and necessary means of communication on both the Mainland and Vancouver Island.

The Agreement for the purchase by the Province of the lands formerly granted to the Columbia and Western and the British Columbia Southern Railways will, I trust, prove a satisfactory solution of the difficulties hitherto existing in that part of the Province affected.

The measures you have adopted for the conservation and management of the timber resources and for the prevention of forest fires are calculated to further preserve to the Province one of its most valuable assets.

It is a source of congratulation that the great expansion of the revenue has enabled further and more extensive expenditures on necessary public works, and in assisting the general needs of the Province.

In now taking leave of you, let me assure you of my best wishes for your welfare, earnestly trusting that the results of your labours may prove highly conducive to the best interests of the people of British Columbia.

The Hon. Dr. Young, Provincial Secretary, then said:

Mr. Speaker and Gentlemen of the Legislative Assembly:—
