Mr. *Howard* rose on a matter of privilege relating to the Estimates of Revenue and Expenditure presented to the House for the fiscal year ending March 31, 1983.

Mr. Speaker stated he would take the matter under advisement.

Mr. Speaker delivered his reserved decisions as follows:

Honourable Members:

On the last day of the sittings of the previous Session, the Honourable Member for Skeena rose on a point of privilege relating to an answer given by the Honourable Minister of Industry and Small Business Development to a series of questions by the Honourable First Member for Victoria during oral question period. The Honourable Member then indicated to the House a motion intended to be moved if appropriate.

In its terms the motion alleges that the Honourable Minister provided "the House with a misleading answer during question period." The Honourable Member for Skeena cited, in support of the matter raised, references in the 19th Edition of Sir Erskine May appearing on pages 130–131 and 170–173, which references I have carefully examined. I have also examined the questions and answers in question which appear at page 6585 of Hansard for July 7, 1981.

It is stated in the same edition of Sir Erskine May at page 142 that the House may treat the making of a deliberately misleading statement as a contempt and cites Profumo's case wherein the offending member made a personal statement which contained words which he later admitted not to be true. On the other hand, as stated in Beauchesne's 5th Edition at page 12, the precedents are clear that a dispute arising between two members as to allegations of facts do not fulfil the conditions of parliamentary privilege. It is clear from the terms of the motion tendered by the Honourable Member for Skeena that his complaint is founded on an allegation of a misleading answer and a dispute as to allegations of facts between honourable members.

In light of the authorities which I have cited I am unable to conclude that there is a basis of a *prima facie* question of privilege.

Mr. Speaker delivered his reserved decision as follows:

Honourable Members:

Earlier today the Honourable Member for Skeena rose on a matter of privilege relating to the Estimates presented yesterday to the House on Message from His Honour the Lieutenant Governor. The Honourable Member stated the matter of privilege to be, and I quote: "The matter of privilege is that this particular document, the Estimates for the fiscal year ending March 31, 1983, is misleading in that the information contained in the back of the book is not carried forward and identified in the front of the book." The Honourable Member provided the Chair with a motion intended to be moved by him, if appropriate.

Honourable members will recall that earlier today a ruling was made by the Chair with respect to another matter of privilege raised by the Honourable Member for Skeena based on an allegation that "a misleading answer" had been given in the House to a question during oral question period. As stated in that ruling, the authorities show that a dispute arising between members as to allegations of facts do not fulfil the conditions of parliamentary privilege, although a deliberately misleading statement may be treated as a contempt. The rule applicable to statements made in the House is equally applicable to documents tabled in the House.

In any event, it would be virtually impossible for the Chair to find that the form of the Estimates, as presented to the House, could breach the privileges of the House when the House itself has previously enacted legislation specifically providing that the form of those Estimates of Revenue and Expenditure shall be prepared as directed by Treasury Board for presentation to the Assembly by the Minister of Finance.

Under the circumstances, I am unable to conclude that a *prima facie* case of breach of privilege has been established.

Honourable Members:

This morning, the Honourable Member for Comox sought to move, pursuant to Standing Order 35, that the House be adjourned to discuss a definite matter of urgent public importance, namely, the release of high unemployment figures by Statistics Canada.

Standing Order 35 provides a method by which the ordinary business slated for consideration by the House may be set aside so that an opportunity will be afforded to debate a matter where such opportunity would not otherwise arise.

The Orders of the Day indicate that priority has been given at this time to consideration of the debate on the Budget Speech. The scope of debate on the Budget Speech, ł

particularly in regard to economic matters, is broad, thereby affording an immediate opportunity to discuss the matter complained of.

As the opportunity is immediate there is no necessity for setting aside the ordinary business of the House and, accordingly, the matter would not come within Standing Order 35.

It should be noted that numerous Speakers of this House have ruled that consideration of the rate of unemployment involves an ongoing matter, thereby taking the question outside the scope of Standing Order 35. I would refer to the decision of Mr. Speaker Dowding on a similar application to be found at page 285 of the Journals of this House for 1974.

Mr. Speaker delivered his reserved decision as follows:

Honourable Members:

On Wednesday, April 7, the Honourable Member for Shuswap-Revelstoke rose on a matter of privilege relating to statements made by the Minister of Tourism during debates on that day. The Honourable Member disagreed with the allegations made by the Minister and stated (in part) his position in the following words: "Under these circumstances, I believe that my reputation has been slandered by that Member untruthfully . . ."

The Member, with leave of the House, read the motion he intended to move should a *prima facie* matter of privilege be established.

During the current session, several matters of privilege have been raised and it might be useful at this time to review certain practices which bear upon such matters.

Firstly. I would caution all honourable members against the growing practice of using matters of privilege as a foundation for the use of unparliamentary language, however inadvertent. The description of the alleged offence (and the proposed motion) must be couched in language acceptable to this House.

Secondly, a question has been raised as to whether the proposed motion should be read to the House or simply tendered to the Chair when the matter of privilege has been stated. While the Ottawa practice permits the reading of the motion as part of the complaint, our practice follows more closely the Westminster practice as outlined in the 19th Edition of May, at page 164. While it is noted that the practice in this House has not previously been clearly defined, leave of the House, direct or implied, appears to be a prerequisite for reading such a motion at the time the matter of privilege is first raised. It seems to the Chair that the English rule and the British Columbia practice call for the motion after the Speaker's intervention and, accordingly, until the Speaker finds a *prima facie* case of privilege the motion, comprise the material which the Chair must examine to determine whether the matter qualifies, *prima facie*, as a matter of privilege. Accordingly, I rule this to be the correct practice in this House relating to motions founded on a matter of privilege.

The next matter which frequently arises is the question of the Chair's right to reserve its decision. The Chair is unaware of any authority in this House or elsewhere which requires the Chair to render an immediate decision on points of order or privilege, and common sense alone would militate against such a practice. Many points of order and matters of privilege are of grave importance and require lengthy deliberation. To suggest that such decisions be rendered forthwith or that the whole process of Parliament be brought to a halt while a matter is being considered, is not in accordance with practice in this House or the authorities. I refer the members to a decision of this House recorded in the Journals of May 1980. Honourable members must accept the Chair's assurance that decisions are considered in a careful and expeditious manner. To end all uncertainty on this subject I confirm the earlier decision of the House of the Chair's right to reserve its decision.

Dealing with the specific complaint of the Member for Shuswap-Revelstoke, there is an allegation of improper behaviour at a conference by a person whom the Minister of Tourism describes as follows: "He was, I am told, the campaign manager for the Member from Revelstoke."

The Honourable Member for Shuswap-Revelstoke has advised the House that he received an invitation to the conference in question but that he was unable to attend because of other commitments and he did not send anyone to attend the conference on his behalf.

In short, the Minister says that someone representing the Member from Shuswap-Revelstoke behaved improperly at the conference in question while the Member from Shuswap-Revelstoke says that if anyone behaved improperly at the conference it had nothing to do with him and such an improper allegation amounts to a breach of privilege.

It is the Chair's view that the matter falls squarely into the category of decisions described as disputed facts, and this whole area of privilege was examined exhaustively in several rulings which may be found in the Journals of this House in March of 1975. Also, Beauchesne's 4th Edition at Citation 113 states as follows: "A dispute arising between two members, as to allegations of fact, does not fulfill the conditions of parliamentary privilege." However aggrieved a member may feel, this does not permit the Chair to extend the law of parliamentary privilege.

It is perhaps appropriate to mention here that all honourable members must bear responsibility for their statements made in this House, and it would be indeed unfortunate if reckless statements were made merely because of the immunity a member has while speaking in the Chamber. This immunity afforded each member carries with it a heavy attendant responsibility which every member would wish respected.

Under the circumstance, and in accordance with the authorities quoted above, I am unable to find the complained-of statement amounts to a *prima facie* breach of privilege.

Honourable Members:

On Monday last, the Leader of the Opposition rose on a point of privilege and alleged that the Minister of Finance had misled the House through making two conflicting statements.

One statement was referred to as being made "to the House on Budget Day and to be found at page 40". I have checked the Hansard Report for April 5, 1982, and cannot find the statement referred to by the Leader of the Opposition, nor can I find that any document containing the statement referred to has been tabled in the House.

The second statement referred to by the Leader of the Opposition was contained in answers to questions given in the Oral Question Period during last Monday's sitting:

Mr. *Barrett:* I have a question for the Minister of Finance. Has the Government decided that the long-term borrowing for B.C. Railway will be used to fund interim borrowing during 1981–82 and 1982–83 for construction of the Tumbler Ridge branch line?

Hon. Mr. *Curtis:* There are a number of matters with respect to funding of British Columbia Rail activities which are still in the developmental stage in so far as the Government is concerned, and I am afraid I cannot assist the Member further on that particular point. It is a matter of developing policy.

Mr. *Barrett:* Would it be incorrect, based on your answer, for any member of this House to state flatly that the Government has decided that the long-term borrowing forecast for B.C. Railway will be used to fund interim borrowing during 1981–82 and 1982–83 for construction of the Tumbler Ridge branch line?

Hon. Mr. Curtis: Mr. Speaker, I can give the Member no guidance on that particular question at this point.

On Monday, when the complaint was raised, I noted that the Minister of Finance was not in the House to answer the complaint. Traditionally, before making a complaint against a member, it is a correct practice to give him notice so that he may be present, or in the case of a document, to present the same so that it may be read.

Sir Erskine May's Parliamentary Practice, 16th Edition, states that it is a contempt of Parliament to deliberately mislead the House. The same text indicates that a complaint founded upon a document or publication may only be heard where the complaining party lays upon the Table the document or publication complained of. On February 19, 1974, Mr. Speaker ruled that the proceedings on a point of privilege could not be entertained unless the publication was before the House. In the case at hand, no document has been filed with the House.

In the absence of the document complained of, the Chair cannot consider its contents, nor can it compare them with the answers complained of, and accordingly, if the Member wishes to pursue the matter further, it will be necessary to use the Order Paper.
