THREE O'CLOCK, P.M.

This being the first day of the first meeting of the Eleventh Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour the Honourable JAMES DUNSMUIR, Lieutenant-Governor of the Province, dated the 24th day of December, 1906, the Members having been sworn took their seats.

His Honour the Honourable JAMES DUNSMUIR, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Honourable Mr. McBride said :-

Gentlemen of the Legislative Assembly :---

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

Mr. Price Ellison, Member for Okanagan District, addressing himself to the Clerk of the House, moved, seconded by C. W. Munro, Esquire, Member for Chilliwhack District, that D. M. Eberts, Esquire, Member for Saanich District, do take the Speaker's Chair and preside over the meeting of this Assembly, and it was so Resolved.

Mr. *Fell*, the Clerk of the House, having declared *D. M. Eberts*, Esquire, duly elected, he was taken out of his place by the mover and seconder and conducted to the Chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect :---

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Honourable Mr. *McBride* then said :----

MR. SPEAKER :

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper and prudence, he grants, and upon all occasions will recognise and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and that their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech :—

Mr. Speaker and Gentlemen of the Legislative Assembly :

It affords me much pleasure to welcome you to this the First Session of the Eleventh Parliament of British Columbia.

In view of the general prosperity which prevails throughout the Province, I deem it my first duty to express a deep sense of gratitude and thankfulness for the many blessings bestowed upon the people of British Columbia.

I am pleased to congratulate you on the satisfactory state of the Provincial finances, which will show a substantial surplus, and on the steady and continuous expansion of the industries of the Province, as evidenced by the increased production of the mines, fisheries, forests, fields and orchards.

The question of the financial relations existing between the Province and the Dominion will be submitted for your consideration, together with a report of the proceedings of the Inter-Provincial Conference held at Ottawa, the most important point in which is the acknowledgment by the Dominion Government of the right of British Columbia to "better terms."

A Bill will be submitted to you amending the Assessment Act, which will provide for decreasing the taxation on real and personal property.

The validity of the coal and petroleum licences granted in South-East Kootenay under the terms of an Order in Council dated 3rd June, 1904, having been called in question, a Bill will be brought down, in order that the situation may be dealt with.

A measure will be placed before you for the purpose of making certain amendments to the "British Columbia Fisheries Act, 1901," which it is proposed to bring into force at an early date.

In order that the youth of the Province may be enabled to perfect themselves in the arts and sciences without having to seek abroad the facilities for higher education, a measure will be submitted for your consideration, authorising the setting apart of a sufficient portion of the Crown lands to create a fund for the establishment and maintenance of a Provincial University.

You will be asked to place a sum on the estimates for the purpose of obtaining a full report on the subject of irrigation and the available sources of water supply in the "dry belt." Steps have been taken by my Government to assert the rights of the Province in the lands set apart as Indian Reserves. The correspondence and Orders in Council in connection with this matter will be laid before you.

I am pleased to inform you that negotiations are pending between the Government and certain transportation and immigration agencies, through which it is confidently hoped that a desirable class of immigrants will be secured from the United Kingdom.

The Public Accounts for the last year and the Estimates for the succeeding year will be laid before you without delay.

I commit the above matters, and all others which may be submitted to you, to your best consideration, relying upon your wisdom and prudence to deal with them in the manner which, under Divine Providence, may prove most conducive to the best interests of British Columbia.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Lord Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes :---

- 1. On Standing Orders and Private Bills;
- 2. On Public Accounts;
- 3. On Printing;
- 4. On Railways;
- 5. On Mining;
- 6. On Agriculture;
- 7. On Municipal Matters;

which said Committees shall severally be empowered to examine and enquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. *Fulton*, Bill (No. 1) intituled "An Act to amend the 'Interpretation Act," was introduced and read a first time.

To be read a second time at the next sitting of the House.

On the motion of the Hon. Mr. McBride, seconded by the Hon. Mr. Tatlow, -

Resolved, That the Speech of His Honour the Lieutenant-Governor be taken into consideration on Friday next, the 8th instant.

Fatal; scalp wound; burned face and hands; burned body; burned hands; bruised jaw; collar bone broken; broken arm; bruised arm; bruised hand; hand cut; lost finger; cut and bruised finger; broken ribs; bruised back; bruised chest; bruised and cut ribs; bruised hips; arms, legs and ribs broken; leg broken; leg bruised; leg out; foot injured; knocked unconscious.
