#### Tuesday, February 2nd, 1943.

THREE O'CLOCK P.M.

This being the first day of the second meeting of the Twentieth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable William Culham Woodward, Lieutenant-Governor of the Province, dated the 23rd day of December, 1942,

His Honour WILLIAM CULHAM WOODWARD, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the Second Session of the Twentieth Parliament of British Columbia.

Since the Legislature last convened, the people of this Province have suffered several grievous tragedies, foremost among them being the loss sustained through the untimely death of His Royal Highness the Duke of Kent while on active service. His leadership during the troublous times through which the Empire has passed was an inspiration to all. His demise caused deep sorrow in the hearts of the people, and I am gratified to learn that my Government, on behalf of the people of British Columbia, has suitably expressed its condolences to the Royal Family in their bereavement.

British Columbia, in common with other Provinces throughout the Dominion, has suffered many casualties among her sons and daughters serving with the Navy, Army, and Air Forces during the last twelve months. This was particularly so at Dieppe, where brave Canadians wrote another glorious page in an already brilliant history of gallant deeds wrought in the cause of human welfare. To those who have been stricken through the loss of those nearest and dearest to them my Government offers its sympathy, and expresses the hope that the triumph of the cause in which our men and women lost their lives so valiantly will bring solace to the sorrowing.

Since you last met, the Province has lost a faithful public servant through the death of one of my Cabinet Ministers, the Honourable Rolf W. Bruhn—a man whose kindly disposition and unselfish service to others endeared him to the hearts of all.

I regret to record the passing of Mr. Harry Johnston, member for Revelstoke. His unexpected demise removes from our midst a very able legislator.

British Columbia again had the pleasure and honour of receiving a visit from His Excellency the Earl of Athlone, Governor-General, and Her Royal Highness the Princess Alice. On this occasion, His Excellency and Her Royal Highness devoted much of their time to visiting the men and women in the fighting forces, offering inspiration and encouragement.

Events in the theatre of war during the last twelve months give rise to the hope that the United Nations have assumed the offensive we have all been anticipating so

eagerly, and which will lead, in the not too distant future, to total victory.

Much remains to be done. There lie ahead immeasurable sacrifices before we can lay down our arms and discuss the terms of peace by which it is hoped to free the world of a recurrence of the tragedies and carnage that have beset nations on all sides during the past four years.

We must address ourselves to this task, not counting the cost. We must remain resolute even though we have to face unspeakable ordeals in the days to come. Thus may we reach that haven to which our gallant men and women and our great leaders in the world of international affairs are leading us—a world of peace in which to live.

Deeply conscious of the great responsibility that war brings with it, my Government has pursued its endeavours to supplement its contribution to the nation's war programme with undiminishing vigour. This policy will be sustained until the last shot has been fired and the last subjugated nation has been liberated.

The welfare of our men and women after war has ceased is of vital concern to my Government. The Post-war Rehabilitation Council, formation of which was provided for at the last session of the Legislature, has worked diligently during the intervening months, and will submit a report on its studies.

During the past year the "Workmen's Compensation Act" has been the subject of an inquiry by a Royal Commission, and, as a consequence of its findings, remedial measures will be introduced for consideration of the Legislature.

For the betterment of employer-employee relationships and general improvement of workmen's conditions, important amendments to existing labour legislation will be introduced.

As preliminary steps in connection with post-war reconstruction and planning, two important proposals will be placed before you. Legislation will be introduced asking for authority to obtain a loan to enable the carrying-out of a comprehensive programme of public works, and action will be taken to establish a committee to survey and investigate the feasibility of developing hydro-electric power for the electrification of rural areas.

My Government has learned with gratification that the Dominion Government proposes to take steps toward inaugurating a broad system of social security; but this Assembly will be asked to endorse a petition requesting the National Government to establish immediately the health insurance plan.

Legislation will be introduced enabling the Government to advance an interestfree loan to encourage the establishment of a fibre flax industry to meet the shortage

of this product created by the war.

Further provision will be made to lighten the cost of education in unorganized territories.

You will be asked to reform the system of the lower Courts of Justice to enable the establishment of a Court of Domestic Relations.

Minor legislation of a character designed to improve existing Acts in the interest and well-being of the people will be submitted.

The Public Accounts will be presented and Estimates for the ensuing year will be laid before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Bishop of British Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the by-election of a member to represent the Electoral District of Salmon Arm was read, as follows:—

Since February 11th, 1942, what steps, if any, have been taken relative to the Boys' Industrial School: (a) To make the indeterminate sentence the rule, (b) to have the length of detention determined by the Superintendent of the School, and (c) to change the present site and provide suitable accommodation elsewhere?

The Hon. Mr. Pearson replied as follows:-

"(a.) Since February 11th, 1942, all boys committed to the Industrial School for Boys have been on indeterminate sentences, with one exception, which was a boy who for special reasons was committed on September 23rd for a period of three months. The improvement in regard to the indeterminate sentence was probably effected by a letter sent to all Juvenile Court Judges by the Attorney-General, and by closer co-operation between the Superintendent of the School and the local Juvenile Courts. (b.) The length of time a boy remains in the Industrial School depends upon a recommendation for discharge, made by the Superintendent when he is satisfied the boy can no longer benefit by the school and there is a satisfactory place to which he may be sent. The plan, before being presented to the Court, must be approved by the Superintendent of Neglected Children, and the final decision rests in the hands of the Judge of the Juvenile Court. (c.) Alterations have been made to the present buildings to meet temporary needs. The selection of a different site has been under consideration, but is dependent upon many other factors, which have not yet been determined but which are being explored."

- Mr.  $E.\ E.\ Winch$  asked the Hon. the Provincial Secretary the following questions:—
- 1. What is the (a) estimated bed accommodation and (b) number of inmates now in residence at (i.) Provincial Infirmary, Marpole; (ii.) Old Men's Home, Kamloops; and (iii.) Old People's Home, Port Coquitlam?

  - 3. If yes, what number in each case?

- "1. (i.) (a) and (b). Provincial Infirmary, Marpole: The capacity now being reduced from previous number of 164 to between 140 and 145, according to types of admission. (ii.) Old Men's Home, Kamloops (Provincial Home, Kamloops): (a) 150 and (b) 150. (iii.) Old People's Home, Port Coquitlam (Home for the Aged): (a) 150 and (b) 176.
  - "2. Yes.
- "3. Provincial Infirmary, Marpole, 70; Old Men's Home, Kamloops (Provincial Home, Kamloops), 2; Old People's Home, Port Coquitlam (Home for the Aged), 16."
- Mr. E. E. Winch asked the Hon, the Minister of Public Works the following questions:—
  - 1. Is there a rock-crusher at Essondale?
  - 2. If yes, when and from whom purchased, and the cost of same?
  - 3. When was it last used?
- 4. Is there sufficient work at this institution to warrant such equipment being retained there?

The Hon. Mr. Anscomb replied as follows:-

- "1. Yes.
- "2. June, 1939; Willard Equipment Company; cost, \$9,347.60.
- "3. June 18th, 1942.
- "4. Yes; but only until stock of field-rock now being accumulated is crushed."
- $\operatorname{Mr.} E. \ E. \ Winch$  asked the Hon. the Minister of Public Works the following questions:—
  - 1. Is there a road-grading machine at Oakalla?
  - 2. If yes, when and from whom purchased, and the cost of same?
  - 3. When was it last used?
- 4. Is there sufficient work at this institution to warrant such equipment being retained there?

Essondale, 6 and Medical Superintendent: Dr. Gee, 926 patients; Dr. Jackson (insulin), 20 patients; Dr. Davidson, 253 patients; Dr. Caunt, 557 patients; Dr. Read, 89 patients; Dr. Novak, 494 patients; Medical Superintendent, 721 patients. New Westminster, 2: Dr. Sauriol, 344 patients; Dr. Benwell, 257 patients. Saanich: Parttime physician, 282 patients.

"5. Yes."

Mr. Eures asked the Hon, the Minister of Labour the following questions:—

2. If so, how many?

3. How many of these were returned men?

4. What was the per capita cost of training these men?
