MR. SPEAKER:

Your Select Standing Committee on Public Accounts begs leave to report as follows:— Upon inquiry into the matter of the Dutch Creek section of the Kingsgate-Radium Highway, which was referred to your Committee by the Legislature under date of November 23rd, 1938, as per Resolution of the Hon. the Minister of Public Works, which reads as follows:—

"Whereas the second member for Vancouver East stated that from information which he had an overpayment had been made in connection with the Dutch Creek section of the Kingsgate-Radium Highway."

We have examined witnesses and contracts in connection therewith, and our unanimous opinion is that a difference of opinion on this work arose between the Department and the Resident Engineer as to the interpretation of the contract between the General Construction Company, Limited, and the Government.

The company was paid in accordance with the interpretation placed upon the contract by the Chief Engineer of the Government. With this decision the Committee does not disagree and consequently no overpayment has been made.

The Committee recommends that in future great care be exercised in drafting and wording specifications and contracts with the view of greater clarity.

Honourable Members,—The Honourable the Premier has raised a point of order with reference to Bill (No. 18) intituled "An Act to amend the 'Hospital Act.'"

The point is whether the Bill involves the expenditure of public money or would result in a tax or impost upon the people or any section of the people.

If it does it cannot be originated by a private member. (See S.O. 67; the "Constitution Act," R.S.B.C. 1936, chap. 49, sec. 52.)

Section 3 of the Bill provides that in all hospitals there shall be not less than one nurse for a specified number of beds.

Section 4 fixes maximum working-hours and minimum holidays for nurses.

There are many Bills that on the face of them necessarily involve public expenditure or impose a charge on the people.

I cannot determine from reading this Bill whether, if passed, it would necessitate the employment of more nurses in hospitals. It may or it may not. I could, of course, go to the Deputy Provincial Secretary and ask him whether hospitals are now employing fewer nurses than the Bill, if passed, would require to be employed, and whether nurses are now working longer hours with shorter holidays than are stipulated in the Bill, but I do not think I should take that responsibility. In my opinion it is information that should be given to the House by the responsible Minister.

Section 5 (j) may not be entirely in order, but it is a comparatively unimportant subsection, and if the Bill passes second reading a point of order could, if thought advisable, be raised, or the subsection amended in Committee of the Whole.

I therefore recommend that the Bill be allowed to proceed.

Honourable Members,—I have considered the point of order raised by the Honourable the Premier with regard to Bill No. 27.

Section 4 imposes certain duties upon Government Agents and also gives such agents a wide discretion with reference to securing the payment of wages to persons performing labour or services in connection with logs or timber. The Bill imposes a fine upon employers failing

to comply with its provisions, and provides for a prison term in default of payment of the fine. Persons selling timber from Crown-granted lands under contract to be logged or taken off must see that security for wages is deposited as provided in the Bill, otherwise such persons are to be jointly liable with the employer for payment of the wages.

A Bill imposing fines and imprisonment cannot be originated by a private member except with the consent of the Crown. (See 1932 Journals, page 75; 1936 Journals, 1st Session, page 119.) Duties and powers may not be imposed or conferred upon the Crown by a Bill in the hands of a private member without the Crown's consent. (See 1931 Journals, pages 128, 129; 1932 Journals, page 75.) The Government is responsible for the acts of its agents. The responsibility for the success or failure of the operation of this Act would, therefore, in the final analysis rest upon the Government.

I think this Bill clearly comes within the authorities cited above and, lacking the consent of the Crown, is not in order in the hands of a private member.

Whereas Mrs. Helen Douglas Smith, the honourable the second member for Vancouver-Burrard, has been unavoidably absent from attendance for a portion of this present Session while attending the Dominion Health Council at Ottawa:

Therefore be it Resolved, That the Clerk of the House be directed to pay the full sessional indemnity to the said Mrs. *Helen Douglas Smith* as if she had been present during each and every day of the Session.

The Hon. Mr. Pattullo presented Volume III. of the Report of the Commissioner of the Coal and Petroleum Commission relating to Paragraph 3 of the terms of the Commission.

On the motion of the Hon, Mr. Pattullo, the House proceeded to the Orders of the Day, "Public Bills and Orders."

Bill (No. 29) intituled "An Act to provide for the Regulation of Public Utilities" was considered as amended, read a third time and passed.

Bill (No. 34) intituled "An Act to amend the 'Industrial Conciliation and Arbitration Act'" was again committed, reported complete without amendment, read a third time and passed.

Bill read a second time and, by leave of the House, committed forthwith, reported complete with amendments, to be considered as amended at the next sitting.

Bill (No. 9) intituled "An Act to amend the 'Engineering Act'" was again committed, reported complete without amendment, read a third time and passed.

Mr. Bruhn moved, seconded by Mr. Paton,-

Whereas a Commission was appointed in 1922 to examine and report on all matters in connection with the fishing industry of British Columbia:

And whereas, amongst other things, the said Commission recommended that steps be taken to limit to some reasonable extent the licences granted to Japanese fishermen in order to safeguard the fishing industry for Canadian fishermen:

And whereas steps were taken in 1923 by the Dominion Government to implement this recommendation by the actual reduction of the number of fishing licences issued annually to Japanese fishermen:

And whereas during recent years no further steps have been taken to safeguard the industry for white Canadian fishermen, with the result that the said industry is now dominated by Japanese fishermen:

Therefore be it Resolved, That this House regrets that the Dominion Government has not seen fit to carry out the said recommendation made by such Royal Commission, and thereby has failed to preserve the fishing industry for the Canadian fishermen.

And be it further Resolved, That a copy of this Resolution be sent to the Federal Government.

A debate arose.

The Hon. Mr. Pearson moved in amendment, seconded by the Hon. Mr. Gray,-

To strike out all the words after the word "fishermen" in the fifth line, and insert the following:—

"And whereas the Dominion Government having implemented this recommendation by an actual reduction of the number of fishing licences issued annually to Japanese fishermen in the year 1923 and succeeding years:

"Therefore be it Resolved, That this House commend the Dominion Government for this action, and recommend to the Dominion Government a continuation of the policy of reduction of the number of Japanese fishing licences issued.

"And be it further Resolved, That a copy of this Resolution be sent to the Dominion Government."

The debate continued.

By leave of the House, the proposed amendment and the main motion were withdrawn.

The House resumed the adjourned debate on the motion moved by Mr. Macintosh on November 23rd, as follows:—

Whereas British Columbia is a part of the Dominion of Canada:

And whereas by agreement between the Dominion of Canada and Japan a quota of Japanese immigrants to Canada is provided for:

And whereas the said agreement is not in the best interest of the people of British Columbia:

Therefore be it Resolved, That this House urges upon the Government that it make further immediate representation to the Federal Government for the abrogation of the existing agreement in regard to immigration with Japan.

Mr. Strachan moved in amendment, seconded by Mr. Forester,—

To strike out all the words after the word "is" in the first line, and to substitute therefor the words "one of the most important Provinces of the Dominion of Canada:

"And whereas it is necessary for the social and economic welfare of our people that our population shall be ethnologically homogeneous:

"Therefore be it Resolved, That this House goes on record as being opposed to the immigration of any Japanese or Chinese into the Province of British Columbia, and commends the action of the Provincial Government in making representations to the Ottawa Government to this end."

On the motion of Mr. Maitland, the debate was adjourned to the next sitting of the House.

Mr. Putnam presented the First Report of the Select Standing Committee on Agriculture, as follows:—

REPORT No. 1.

#### LEGISLATIVE COMMITTEE ROOM,

December 8th, 1938.

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:-

Your Committee, authorized by Resolution of the Legislative Assembly dated November 17th, 1938, "to consider such matters affecting the agricultural industry as may be laid before it by the Advisory Board of Farmers' Institutes and to report its findings to this House," held four sittings, at one of which the members of the Advisory Board of Farmers'

Institutes were present and submitted certain matters of concern to the farmers of British Columbia, as follows:—

- (1.) Resolution of commendation and appreciation to the Government for opportunities afforded farmers to work out taxes on road maintenance and request that this policy be continued.
- (2.) Resolution asking that the Department of Lands give consideration to a water conservation policy with a view to storing seasonable overflow for irrigation purposes.
- (3.) A resolution recommending that the responsibility for maintenance of public schools should rest equally on all classes of the population, and urging the necessity for a revision of the present system of school taxation.
  - (4.) A resolution asking that the price of motor-car licences be drastically reduced.
- (5.) A resolution urging assistance to settlers in the purchase of power-operated landclearing machinery.
- (6.) A resolution urging the elimination of the charge for surveying land for settlement—a charge at present borne by the applicant for such land.

All of which were referred to the several departments concerned for consideration.

Inquiry into disposal of grain screenings at terminal elevators disclosed that f.o.b. prices are reasonable, and that under the present permit system ample safeguards are afforded against the dissemination of noxious weeds in the handling of grain screenings.

All of which is respectfully submitted.

FRANK PUTNAM, Chairman.

The report was read and received.

On the motion of the Hon. Mr. Pattullo, seconded by Mr. Maitland, it was Resolved,-

That this House learns with much regret of the death of James Schofield, a former member of this House, who served in the Legislature for twenty-seven years; and that the Clerk convey to Mrs. Schofield and members of his family the condolence and sincere sympathy of the members of the Legislative Assembly.

At the request of Mr. Speaker, the House expressed its approval of the Resolution by a silent standing vote.

Mr. Telford asked the Hon. the Minister of Agriculture the following questions:—

- 1. Has the Department knowledge of the costs of police services used for purposes of guarding all highways and bridges leading into Vancouver in order to prevent illegal entry of potatoes to this market?
  - 2. If yes, what was the total cost of such services last year?
  - 3. If yes, what Department was responsible for payment of such costs?

The Hon. Mr. MacDonald replied as follows:-

- " 1. Yes.
- "2. Approximately \$14,000.
- "3. Legal Department."

Mr. Shepherd asked the Hon. the Minister of Agriculture the following questions:-

- 1. Has the Coast Vegetable Marketing Board or the Department of Agriculture received at any time requests for an independent audit of the Board's books? If yes, has such an audit been made?
- 2. What was the total cost of police and inspectors at the various bridges to enforce the regulations during the past year to: (a) The Coast Vegetable Marketing Board; and (b) other departments?

The Hon. Mr. MacDonald replied as follows:-

- "1. Responsibility of B.C. Coast Vegetable Marketing Board, elected by producers.
- "2. Law enforcement under Attorney-General's Department. Approximately \$14,000."

Mr. Paton asked the Hon. the Minister of Mines the following questions:-

- 1. Is a mining school being opened in the Hope Mining District to teach lode-mining to students?
  - 2. Who will be in charge of the operation?
- 3. Has the Government taken over the old Dawson Mine, at present known as the Kettle Valley Gold Mines, for this or any other purpose?
  - 4. Is there a mill on the property, and what is its capacity?
  - 5. Was this property examined in 1936 by Professor Scholfield?
  - 6. If yes, was it favourable or otherwise? What was his report on the mill?
  - 7. Has an option been taken on the Aurum Mine?
  - 8. Is it contemplated to mill ore from the Aurum at the Dawson Mill?
  - 9. What will it cost to put the Dawson Mill in shape, and at whose cost?
- 10. What arrangements, if any, have been made with the Kettle Valley Railway to supply transportation to the Dawson Mine?

The Hon. Mr. Asselstine replied as follows:-

- "1. No information.
- "2. Answered by No. 1.
- " 3. No.
- "4. Yes. 25 tons.
- "5 to 10. No information."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-day.

And then the House adjourned at 12.55 p.m.

## Friday, December 9th, 1938.

HALF-PAST TWO O'CLOCK P.M.

On the motion of the Hon. Mr. Pattullo, the House proceeded to the Orders of the Day, "Public Bills and Orders."

Bill (No. 93) intituled "An Act to amend the 'Water Act'" was considered as amended, read a third time and passed.

Bill (No. 88) intituled "An Act to amend the 'Legal Professions Act'" was considered as amended, read a third time and passed.

Bill (No. 81) intituled "An Act to amend the 'Municipal Act'" was committed, reported complete with amendment, considered as amended, read a third time and passed.

The House resumed the adjourned debate on the motion moved by Mr. E. E. Winch on November 23rd, as follows:—

Whereas the Twenty-sixth Report of the Medical Inspection of Schools states there are 675 retarded and underprivileged children now attending school (exclusive of 450 attending special classes in Vancouver); and

Whereas it is not feasible to economically provide adequate facilities for the supervision and training of such children in schools and districts where only a few reside; and

Whereas it is essential to the best interests of the children and society in general that such children shall, so far as possible, be equipped during their formative years to adapt themselves to school and, later, adult life, and thereby enable them to become social assets instead of liabilities:

Therefore be it Resolved, That this House resolve itself into a Committee of the Whole for the purpose of considering the desirability of recommending that the Provincial Secretary and Minister of Education obtain special statistical reports from School Medical Officers,

School Boards, Public Health Officers, and Social Service Officials relative to the nature and prevalence of mental and physical handicap among children of school and pre-school age for the purpose of devising ways and means to provide suitable and adequate facilities for special treatment, training, and education of such children, in order to assist them toward a self-supporting status in adult life.

The Hon. Mr. Weir moved in amendment,-

To strike out all the words after the word "Vancouver" in the third line, and to insert in lieu thereof the following:—

"Whereas the Government is already doing its best to provide for the supervision and training of such retarded and underprivileged children:

"And whereas yearly reports thereon are furnished through the School Medical Officers, School Boards, Public Health and Social Service Officials, and the Public Health Nurses:

"And whereas the Government, being cognizant of the difficulties to be overcome owing to the great extent of territory, the sparseness of population, and the lack of facilities in districts where only a few persons reside, is already taking into consideration the adoption of a policy that will permit of a thorough personal examination of isolated schools and resident pupils:

"Therefore be it Resolved, That this House endorses the efforts of the Government in this regard and approves of the extension of the service from time to time as funds become available for the purpose."

The debate continued.

Amendment agreed to.

Motion as amended agreed to.

The House resumed the adjourned debate on the motion moved by Mr. Bruhn on November 30th, as follows:—

Whereas it is becoming more and more difficult, particularly for old persons, to be absorbed into useful, productive life of the Dominion, making it difficult for them to maintain themselves in comfort and decency:

And whereas Canada is a country richly endowed with natural resources capable of maintaining our population in a reasonably high standard of living:

Therefore be it Resolved, That this House would welcome a declaration of policy by this Government recommending to the Dominion Government that the Dominion Government adopt a policy which will lower the present pensionable age-limit for old-age pensioners from 70 years to 65 years, to the end that the older generation may be retired earlier from industrial employment and thereby create opportunity for the younger generation to be usefully and gainfully employed; and that such a policy be assisted by compulsory contribution by all employed persons between the ages of 20 years and 65 years.

And be it further Resolved, That a copy of this Resolution be sent to the Federal Government.

The Hon. Mr. Pearson moved in amendment, seconded by the Hon. Mr. MacPherson,— To strike out all the words after the word "Whereas" in the first line, and to insert the following in lieu thereof: "it is becoming increasingly difficult for elderly persons to find employment:

"And whereas a large number of persons of all ages still seek profitable employment:

"And whereas the Government of British Columbia has urged upon the Federal Government the desirability of reducing the age at which old-age pensions shall become payable:

"Therefore be it Resolved, That this House commends the Government for the abovementioned representations to the Federal Government.

"And be it further Resolved, That this House recommends to the Dominion Government that legislation be enacted to provide for: (1) A reduction of the age of eligibility for old-age pensions as soon as may be possible; and (2) the regulations under the 'Old-age Pension Act' be modified to eliminate existing hardships encountered by the aged people in obtaining pensions; and (3) initiate a national compulsory contributory insurance scheme for retirement allowances."

Amendment agreed to.

Motion as amended agreed to.

The House resumed the adjourned debate on the motion moved by Mr. Maitland on November 30th, as follows:—

Whereas it is essential that the Trans-Canada Highway be a National Canadian Highway uniformly maintained throughout Canada:

And whereas a large section of the said highway has been built in British Columbia by the Federal Government as part of the said National Highway:

Therefore be it Resolved, That this House is of the opinion that the whole of the construction and future maintenance of the Trans-Canada Highway be paid for by the Federal Government.

And be it further Resolved, That a copy of this Resolution be forwarded to the Federal Government.

The Hon. Mr. Pattullo moved in amendment, seconded by the Hon. Mr. MacPherson,—

To strike out all the words after the word "Whereas" in the first line, and to substitute therefor the words "the construction and maintenance of national highways is of primary importance to the various Provinces and to the Dominion of Canada as a whole:

"Therefore be it Resolved, That this House is of the opinion that national highways should be constructed and maintained by the Dominion Government, or, in the alternative, in co-operation with the Provincial Governments."

Amendment agreed to.

Motion as amended agreed to.

The House resumed the adjourned debate on the motion moved by Mrs. Steeves on November 30th, as follows:—

Whereas the Board of Governors of the University of British Columbia raised the attendance fees for students from \$150 to \$175, thereby making university education prohibitive for a large section of our youth:

And whereas the estimates and accounts of the University are not open to the senate of that body, nor to the public of British Columbia:

Therefore be it Resolved, That this Legislative Assembly regrets that the Board of Governors of the University of British Columbia took the action of raising the attendance fees.

And be it further Resolved, That this House resolve itself into a Committee of the Whole to consider the question of how the University can be made to serve the cause of democratic education more adequately in the future.

The Hon. Mr. Weir moved in aamendment, seconded by the Hon. Mr. Wismer,-

To strike out all the words after the figures "\$175" in the second line, and to insert in lieu thereof the following:—

"And whereas under the British Columbia University Act' the management, administration, and control of the affairs of the University are vested in the Board of Governors:

"And whereas the accounts of University expenditure are audited yearly by a Government Auditor and copies of the Auditor's report are on file at the University and may be examined at any time by members of the University Senate:

"Therefore be it Resolved, That, while the members of the Legislature sympathize with the financial difficulties of the students, this House does not deem it advisable to attempt to dictate University policy or to interfere in the internal administration of the University."

The debate continued.

Amendment agreed to.

Motion as amended agreed to.

Mr. Eyres moved, seconded by Mr. Macintosh,-

Whereas the dairy and poultry industries of this Province are struggling with the problem of the high cost of production:

And whereas one of the factors in such high cost of production is the excessive freight rate on feed-grain and mill-feeds from the Prairie Provinces to points in British Columbia:

Therefore be it Resolved, That in the opinion of this Legislature the question of the excessive freight rates on feed-grains and mill-feeds from the Prairie Provinces to points

in British Columbia is a matter fully worthy of the immediate, earnest, and sympathetic consideration of this Government, and that this Government urge the Federal Government to take immediate action to correct same.

The Hon. Mr. Pattullo moved in amendment, seconded by the Hon. Mr. Weir,—

To strike out all the words after the words "British Columbia" in the fourth line, and insert the following:-

"And whereas the Government of British Columbia has successively made representations in respect of high freight rates:

"And whereas specifically upon representations made to the Dominion Government lower freight rates were secured on fire-burnt barley, oats, rye, bran, chop feeds, mill-feed, oat hulls, middlings, screenings, and shorts under Tariff No. 145, effective as from June 24th, 1938, thereby extending the advantage of lower cost of feedstuffs to the dairymen and poultrymen of the Lower Mainland:

"Therefore be it Resolved, That this House commends this action.

"And be it further Resolved, That the matter of freight rates is one which requires continuous consideration by the Government and public bodies generally."

Mr. Maitland rose to a point of order on the amendment.

Mr. Speaker ruled that the amendment was in order.

Mr. Maitland appealed from the ruling of the Chair.

The House divided.

On the motion of Mr. Uphill, seconded by Mr. Henniger, it was Resolved,—

Whereas there is more over-hospitalization in British Columbia than anywhere in the Dominion:

And whereas hospitals throughout the country are in urgent need of funds for various articles of equipment:

Therefore be it Resolved, That this Legislative Assembly go on record as being in favour of sweepstakes, conducted by either the Dominion or any Provincial Government, 25 per cent. of the gross proceeds of which shall be allocated to a fund to be set up for the purpose of building new hospitals, purchase of equipment for, and the general solvency of, established hospitals.

Mr. E. E. Winch moved, seconded by Mrs. Steeves,-

Whereas neither Dominion nor Provincial Old-age Pension Acts require as a qualification for pension proof of the inability of children to contribute to the support of their aged parents:

And whereas resort or refusal to resort to the provisions of the "Parents' Maintenance

Act" has resulted in family disagreement or non-receipt of the pension, or both:

Therefore be it Resolved, That in the opinion of this Legislature consideration of the provisions of the "Parents' Maintenance Act" when dealing with applications for pension is not in accordance with the spirit and intent of the Dominion and Provincial Old-age Pension Acts.

A debate arose.

By leave of the House, the motion was withdrawn.

To amend as follows:-

Section 6, clause (b), last line: To strike out the words "in favour of the Minister," and substitute therefor the words "or upon the revenues derived therefrom."

Section 4: To insert after the word "Majesty," in the fifth line, the words "in the right of Canada and in favour of His Majesty in the right of the Province or in favour of His Majesty in either right"; and by inserting after the word "loan," in the eighth line, the words "and a charge upon the revenues derived therefrom."

Ordered, That the said Message, and the amendments accompanying the same, be referred to the Committee of the Whole House forthwith.

Whereas British Columbia is a part of the Dominion of Canada:

And whereas by agreement between the Dominion of Canada and Japan a quota of Japanese immigrants to Canada is provided for:

And whereas the said agreement is not in the best interest of the people of British Columbia:

Therefore be it Resolved, That this House urges upon the Government that it make further immediate representation to the Federal Government for the abrogation of the existing agreement in regard to immigration with Japan.

And on the amendment thereto moved by Mr. Strachan on the 9th instant, as follows:—
To strike out all the words after "is" in the first line, and to insert the words "one of the most important Provinces of the Dominion of Canada:

"And whereas it is necessary for the social and economic welfare of our people that our

population shall be ethnologically homogeneous:

"Therefore be it Resolved, That this House goes on record as being opposed to the immigration of any Japanese or Chinese into the Province of British Columbia, and commends the action of the Provincial Government in making representations to the Ottawa Government to this end."

Mr. Maitland rose to a point of order on the amendment.

Mr. Speaker ruled the amendment in order.

Mr. H. E. Winch moved, seconded by Mrs. Steeves,-

Whereas the Western Canada Telephone Company was incorporated March 17th, 1916, by special Act of Parliament of the Dominion of Canada; and

Whereas section 11 of said Act authorized the inclusion of the B.C. Telephone Company; and

Whereas section 15 of said Act gave the right to change the name of said Company, which right was exercised and sanctioned by the Secretary of State on November 29th, 1919; and

Whereas section 16, clause (k), of said Act gives to the Board of Railway Commissioners for Canada sole right to set and revise tolls and charges, thereby removing same from jurisdiction of the Province; and

Whereas said Company operates without competition some sixty-four telephone exchanges in forty-seven cities and towns in British Columbia, including the metropolitan area of Vancouver and Victoria, and owns and operates extensive long-distance systems, including four submarine cables from the Mainland to Vancouver Island, thereby making its administration, operation, and charges of vital concern to British Columbia citizens; and

Whereas the business of the B.C. Telephone Company is mainly in British Columbia, and the said Company, under section 17 of said Act, cannot construct, operate, or maintain lines of telephone in the Provinces of Alberta, Saskatchewan, and Manitoba without first having obtained consent of the Lieutenant-Governor in Council of the Province in which it is proposed to construct, operate, or maintain a line of telephones; and

Whereas we believe it is in the interests of the Province and its citizens that the Province should be in position to exercise jurisdiction over the B.C. Telephone Company:

Therefore be it Resolved, That this House is of the opinion that the said Act of the Dominion of Canada (chapter 66, 6-7, George V., 1916) should be repealed.

And be it further Resolved, That a humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of this Resolution and preamble be transmitted to the Hon. Secretary of State or other proper officials at Ottawa.

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I have followed closely the deliberations of this Assembly during the course of the Session, and wish to express appreciation of the careful consideration which you have given to the many matters that have been placed before you.

I feel sure that the various and important measures which have been enacted will inure to the welfare of the people of British Columbia.

I thank you for the generous supply granted for the Public Service.

In relieving you of your labours, I trust that the blessing of Divine Providence will accompany you to your respective homes.

The Hon. Mr. Weir, Provincial Secretary, then said:-

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
