 - "3. No."

 - 2. If so, what change was made?

Mr. Webber asked the Hon. the Provincial Secretary the following question:-

What steps have been taken to provide home treatment for tuberculosis patients who are not in institutions and for their families who have been exposed to the infection?

The Hon. Mr. Pearson replied as follows:-

9 GEO. 6

- "A. Medical: The Division of Tuberculosis Control of the Provincial Board of Health provides the following medical services to tuberculous patients not in institutions:—
- "1. Stationary out-patient clinics situated in Vancouver, Victoria, and Tranquille. A new stationary clinic will shortly be opened in New Westminster.
 - "2. Travelling clinics, four in number, visit eighty centres in the Province.

"The following services are rendered:-

- "(a.) Free medical treatments and check-ups, including laboratory examinations, X-ray examinations, physical examinations, and specialists' care, including dentistry, eye, ear, nose, and throat, genito-urinary, dermatology, and bronchoscopy.
- "(b.) Consultive advice to rural areas in between visits of travelling clinics. A local doctor may have an X-ray film taken of any tuberculous patient or any contact when he deems it essential and refer this with a consultation form to any centre of the Division of Tuberculosis Control for an opinion.
- "(c.) Pneumothorax treatment is available in any of the stationary clinics and in strategic centres throughout the Province, so that any out-patient may receive this treatment free. During 1944 over 6,000 pneumothorax treatments were given by the clinics of the Division.
- "(d.) District nursing: Follow-up in the patient's home is carried out by the district nurses of the local health services. At the present time approximately 80 per cent. of the population of British Columbia is covered by the public health nursing service. These nurses visit the homes, give instructions in techniques, arrange for examination of patients and contacts, etc.
- "(e.) Social service: In the areas not covered by public health nurses, members of the Social Assistance Branch carry out the follow-up work. In other areas they give advice on social problems when called in by the public health nursing service.
- "(f.) Patients discharged from institution: All patients before discharge from institution are discussed at a medical conference. Full medical details are sent to the area to which the patient is going in order that follow-up may be carried on by the clinics and the public health nursing service. In addition a social analysis is made of that patient and family and arrangements completed for the care of the patient prior to the patient's discharge.
- "(g.) Statistical follow-up: A careful system of statistical follow-up is carried out by the Division whereby follow-up forms are sent out at regular intervals in order to know the medical and social circumstances of all known cases of tuberculosis in the Province.
- "(h.) The Division acts as consultants from a medical standpoint for the Department of Veterans' Affairs, the Department of Indian Affairs, and the British Columbia Security Commission.
- "(i.) Patients under private physicians are followed up through the public health nursing services and the Social Assistance Branch and consultive advice is given by the Division of Tuberculosis Control upon request to any private physician.
- "(j.) Medical supplies, such as sputum cups, paper handkerchiefs, dressings, and medicines, are provided where necessary.
- (k.) Literature is provided to all patients, giving instructions in home techniques, exercise rules, etc.

"B. Social:-

92

- "1. Financial assistance granted to (a) patient if he has to stop working and (b) family as long as the need exists.
- "2. Basic allowance: (a) Basic allowances according to the size of the family; (b) the families do not have to be destitute, some savings are permitted; (c) basic allowances are either mothers' allowance, social allowance, or old-age pension; (d) they receive free transportation to and from clinics if needed; (e) boarding home care where necessary.
- "3. Special tuberculosis allowance: (a) The basic allowance is supplemented by the tuberculosis allowance which is an additional allowance granted to patients and to members of his family if they have been infected; (b) it can take the form of (i.) extra food, (ii.) extra rent, or (iii.) allowance to meet extraordinary expense, such as house-keeper, etc.
- "4. Paid by: (a) If patient resident of a municipality the Province pays 80 per cent. of all costs; (b) if patient is not resident of a municipality Province pays 100 per cent. of costs.
- "5. Help with personal difficulties and emotional problems: (a) Close link is maintained between the patient in hospital and his family and help extended by the medical social worker in hospital to the patient and by the field worker to his family in order that social and emotional and financial problems do not present obstacles in his recovery; (b) his attitude toward his disease, treatment, hospitalization, rehabilitation, and family worries is considered; (c) the special part that the Provincial Government plays is in the planning, co-ordinating, directing, and supervising of the various workers and resources in the community toward this end, and the provision of some eighty-four field workers throughout the Province who handle this as part of their generalized service.
- "6. Rehabilitation: (a) Planning for this is started as soon as a patient is diagnosed and continued with the patient until he is self-supporting again and has gained self-confidence; (b) suggestions of the doctors are carried out by the medical social workers and the eighty-four field workers under the Social Assistance Branch, who assist those patients who live outside of Greater Vancouver; (c) special courses can be arranged for patients showing promise and good prospects from the medical aspect."
