Mr. Robinson asked the Hon. the Minister of Trade and Industry the following questions:—

1. What do you mean by regional industrial development?

2. What is the advertising programme regarding industrial development?

The Hon. E. C. Westwood replied as follows:-

"1. Briefly stated, regional industrial development means the promotion, where possible, of new industries in areas throughout the Province where raw materials, transportation, labour force, and markets and other factors make it appear reasonable that industrial development would be successful.

"2. The advertising programme regarding industrial development is carried on through the media of suitable magazines and newspapers in Canada, United States, United Kingdom, and Europe; in the case of Europe, the advertising copy is in the language of the country concerned."

Mr. Robinson asked the Hon. the Minister of Trade and Industry the following questions:—

1. What was the total revenue from tourist travel in British Columbia last year?

2. What does the Federal Government allocate to carry on tourist promotional work?

The Hon. E. C. Westwood replied as follows:-

"1. The estimated total revenue from tourist travel in British Columbia last year is \$90,000,000.

"2. Total vote of the Federal Canadian Government Travel Bureau is not known; last year this agency spent \$1,000,000 in tourist promotional advertising; this year, it has announced plans to spend approximately \$1,300,000 for the same purpose."

Mr. Gibbs asked the Hon. the Minister of Health and Welfare the following questions:—

1. (a) Is it necessary for legless persons to personally import the two-seat special chairs which they require, and (b) are they required to pay Federal excise and sales tax plus Provincial sales tax on these importations?

2. Are imported Braille books for the blind subject to Federal excise and sales tax plus Provincial sales tax?

The Hon. E. C. F. Martin replied as follows:---

"1. Special chairs for legless persons would be exempt from tax under section 5 (f) of the Act, as they are considered to be ' equipment designed solely for the use of cripples or chronic invalids."

"2. The Act does not provide any exemption for imported Braille books for the blind."

Mr. Gibbs asked the Hon. the Minister of Health and Welfare the following question:—

How many persons in British Columbia were in receipt of assistance allowances paid by the Provincial Government in the fiscal year 1955-56 in each of the following classifications: (a) Old-age Assistance allowances, (b) blind persons' allowances, (c) Old Age Security recipients of cost-of-living bonus, (d) Old-age Assistance recipients of cost-of-living bonus, (e) blind persons' cost-of-living bonus, (f) disabled persons' allowances, and (g) disabled persons' cost-of-living bonus?

The Hon. E. C. F. Martin replied as follows:-

"As at March 31st, 1956: (a) 7,156, (b) 455, (c) 25,456, (d) 6,917, (e) 420, (f) 685, and (g) 677."

Mr. Gregory asked the Hon. the Minister of Health and Welfare the following questions:-

1. How many residents of British Columbia are in receipt of the Federal Old Age Security pension (if the information is available to the Minister)?

2. How many residents of British Columbia in receipt of the Federal Old Age Security pension receive any cost-of-living bonus from the Province?

3. Report.

LEGISLATIVE COMMITTEE ROOM, March 25th, 1957.

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:-

Your Committee met representatives from the Advisory Board of Farmers' Institutes and heard the presentation of a list of resolutions as submitted by it. Careful consideration was given to these resolutions and—

> (1) Recommends that, due to the steady encroachment of urban dwellings and industry into the better farm lands of this Province, the Government make a further study into the scale of values for assessment of farm lands on the basis of productivity or rental value of the land rather than on the basis of real-estate value with the view in mind that farm lands be preserved for farming purposes:

- (2) Due to the fact that the "Milk Act" is now before the Court and that the Federation of Agriculture has retained an economist to study the whole question of milk prices, this Resolution be tabled until the Court's decision has been reached:
- (3) Your Committee recommends that the Provincial Government be urged to make it possible for the British Columbia Power Commission to undertake such power projects as will enable them to provide adequate rural electrification throughout the Province at reasonable cost to the consumer:
- (4) This Committee is of the opinion that adequate low-rate insurance is already available for all farm tractors in British Columbia through regular licensed insurance companies:
- (5) Your Committee feels that the matters as stated in this Resolution are not entirely factual and, therefore, recommends that it be tabled:
- (6) Your Committee recommends that the Provincial Government pursue further the possibility of clearing the land for agricultural purposes to induce more settlement of our agricultural areas:
- (7) Your Committee recommends that the Department of Forests and the Department of Mines be asked to give consideration to the location of private logging and mining roads so that these roads may, where practical, be located to the best advantage for future development of the area:
- (8) Due to the steady deterioration of conditions in the field of agriculture, this Committee commends the Provincial Government for its action in contesting the increase in freight rates, the economic inquiry into the Interior vegetable industry, and the Royal Commission examination of the tree-fruit industry. The beneficial findings of the Royal Commission on the dairy industry were noted and it was recommended that these actions be continued and broadened with further representations to the Federal Government in those fields that are primarily under Federal jurisdiction.

And whereas information is available on these methods now in use the world over:

Therefore be it Resolved, That in the opinion of this House the Government should consider the advisability of introducing legislation, at the earliest possible date, to ensure that when animals and fowls are slaughtered commercially for food, humane methods are used.

Standing on the Order Paper in the name of Mrs. *Haggen*, was withdrawn and the following substituted therefor:—

"To strike out all words after 'House' in the second line of the second paragraph and insert the following: 'The Government of Canada be requested to give consideration to amending the Criminal Code so as to prohibit slaughter of food animals in packing houses without stunning prior to bleeding, and to give due consideration to the religious requirements of ethnic groups in Canada.""

The Hon. L. Wicks presented the Annual Report of the operations and activities of the Railway Department for the Year*ended December 31st, 1956.

The Hon. L. Wicks presented the Fortieth Report of the Workmen's Compensation Board of the Province of British Columbia for the Year ended December 31st, 1956.

Pursuant to Order, the Hon. the Minister of Finance presented a Return of copies of all communications, papers, and documents between all branches of the British Columbia Government and any person or organization or company pertaining to the Rocky Mountain Trench development scheme referred to by the Hon. the Minister of Lands and Forests.

Mr. Gibbs asked the Hon. the Minister of Highways the following questions:----

1. What, to date, is the cost of the highway bridge improvements at the immediate south end of Pattullo Bridge; were tenders called for this work; and, if so, were any extras paid and how much?

2. What, to date, is the cost of the cloverleaf highway work at the immediate north end of the Lions Gate Bridge; were tenders called for this work; and, if so, were extras paid and how much; when is the job to be completed?

3. What is (was) the cost of the concrete bridge over the Capilano River; were tenders called for this work; and, if so, were extras paid and how much?

The Hon. P. A. Gaglardi replied as follows:-

"1. \$24,419.99; traffic signal and channelization, fiscal year 1952–53; channelization done by Departmental forces; traffic signals installed by commercial firm, no tenders called.

"2. \$322,896.89; yes; yes, \$3,224.90; March 8th, 1957.

"3. \$453,159.65; yes; yes, \$9,295.16."

Mr. Gibbs asked the Hon. the Minister of Highways the following questions:---

1. What is the total sum in contracts let on the Kitimat-Terrace Highway?

2. How much money has been expended on this road to date?

3. What is now the expected date for completion of this highway?

The Hon. P. A. Gaglardi replied as follows:-

"1. \$2,689,587.24, plus Hirsch Creek Bridge, \$149,892.49; total to date, \$2,839,-479.73.

"2. \$757,515.66 in progress payments, January 21st, 1957.

" 3. Late 1957."

Mr. Gregory asked the Hon. the Minister of Agriculture the following questions:---

1. How many dairy-farm inspectors are employed?

2. What is their monthly cost in wages, cars, and expenses?

3. How many are technically trained men?

4. In how many cases have inspectors ordered milk off the whole-milk market?

5. Of those so ordered, how many have been reinstated?

6. Were they reinstated on appeal or were plant improvements effected?

7. How many registered producers are there and how many registered distributers?

The Hon. W. R. T. Chetwynd replied as follows:---

"1. Six.

"2. (a) Wages \$250 per man, and (b) car and other expenses, \$156.38 per man to December 31st, 1956.

"3. All men chosen for actual farm experience; each inspector received an intensive course of training and instruction; all operate under supervision and guidance of a Departmental Veterinary Inspector.

"4. In the Milk Board areas, from January 1st to December 31st, 1956, 590 licences to ship to the fluid market were suspended because of the unsatisfactory condition of premises where the milk was produced and for other reasons.

"5. January 1st to December 31st, 1956, 86 reinstated.

"6. All reinstated only when reinspection showed necessary improvements effected. (NOTE.—As at December 31st, 1956, 458 licences to ship milk to the fluid market had been cancelled and 46 were under suspension; it is estimated that at least 75 per cent of the producers and producer-vendors shipping milk to the fluid market undertook minor or major improvements to dairy barnyards, etc., or in methods of handling, cooling, and storing milk, all of which contributed to the present high standard of the milk being sold in British Columbia.)

"7. At December 31st, 1956, 3,066 registered producers and 77 registered distributers."

Mr. Strachan asked the Hon. the Minister of Education the following questions:-

1. What was the total expenditure made in the Province for education in the years 1954 and 1956 respectively?

2. What portion of the above sums were expended on (a) ordinary expenditures and (b) capital expenditure?

3. What portion of the sums mentioned in No. 1 were contributed by (a) the Provincial Government and (b) the city and district municipalities?

The Hon. L. R. Peterson replied as follows:---

"1. 1954, \$54,478,136, and 1956, \$69,231,799.

"2. 1954, (a) 46,919,093 and (b) 7,559,043; 1956, (a) 57,744,997 and (b) 11,486,802.

"3. 1954, (a) \$19,149,756 and (b) \$35,568,131; 1956, (a) \$27,035,507 and (b) \$22,820,672."

In reference to the Stewart-Cassiar Road:-

1. What total payments on this project have now been made to the firm of Wade & Wells Limited?

3. Since March 2nd, 1956, what sums have been paid, to whom, and for what purpose in respect to this road?

4. What is the present stage of engineering surveys on this road and is there a target date for completion?

5. How much was spent by the Government in 1956 in grading and gravelling the portion of this road already constructed?

6. Has the Government been officially advised that the Federal Government will contribute to the cost of the road?

The Hon. W. K. Kiernan replied as follows:---

"1. \$651,862.06.

"2. \$1,574,913.44.

"3. Pathfinder Engineering, surveys, \$330,862.42; G. Willcock, caretaker, \$756.12; Fred Loucks, transportation of equipment, \$7,504.20; Wade & Wells, purchase of equipment, \$34,070.50; Cassiar Asbestos Corporation, gravelling, grading, etc., \$10,156.98; Christy's, lumber, \$491.40; British Yukon Navigation Company, freight, \$4,000; and Highway Department, wages, materials, and equipment rentals, \$19,011.62.

"206A. (1) Notwithstanding anything contained in the 'Sunday Observance Act' or in any other Statute or law of the Province, where a by-law passed under subsection (2) hereof is in force and subject to its provisions, it shall be lawful for any person between half-past one and six o'clock in the afternoon of the Lord's Day, commonly called Sunday, to provide for or engage in any public game or sport for gain, or for any prize or reward, or to be present at any performance of such public game or sport at which any fee is charged, directly or indirectly, either for admission to such performance, or to any place within which the same is provided, or for any service or privilege thereat, that is specified in such by-law and which, but for this section, would be lawful under section 6 of 'The Lord's Day Act (Canada),' or to do or engage any other person to do any work, business, or labour in connection with any such public game or sport which but for this section would be unlawful under section 4 of 'The Lord's Day Act (Canada).'

"(2) (a) The Council may pass a by-law declaring subsection (1) to be in force throughout the city or in such part or parts thereof as may be specified in the by-law; and upon such by-law coming into force, subsection (1) shall apply throughout the city or in such specified part or parts as the case may be.

"(b) The application of subsection (1) shall be limited to such public games or sports as are specified in the by-law.

"(c) The by-law shall not specify horse-racing as a public game or sport.

"(d) Where subsection (1) applies in specified parts of the city, the limitation authorized by clause (b) hereof may differ in different parts.

"(e) The by-law may reduce the period of time between half-past one and six o'clock mentioned in subsection (1).

"(f) The by-law shall provide for the regulation and control of the public games and sports specified in it, and may provide for the regulation and control of any matter or thing in connection with such public games and sports.

"(g) (i) No by-law passed under this section shall be repealed until the following question has been submitted to the electors: 'Are you in favour of the repeal of the by-law passed under the authority of the "Vancouver Charter" that regulates public games and sports for gain on the Lord's Day?'

"(ii) The Council may submit the question set out above to the electors at any annual election.

"(iii) Upon the presentation of a petition requesting that the by-law passed under this section be repealed, signed by at least ten per centum of the electors of the municipality, the Council shall, at the next annual election, submit to the electors the question set out in subclause (i).

"(h) Any petition mentioned in clause (g) (iii) above shall be deemed to be presented when it is lodged with the City Clerk, and the sufficiency of the petition shall be determined by him, and his certificate as to its sufficiency shall be conclusive for all purposes: Provided, however, that a petition that is lodged with the City Clerk in the months of November or December shall be deemed to be presented in the month of February next following."

By leave of the House, on the motion of the Hon. R. W. Bonner, seconded by the Hon. W. D. Black, it was Ordered that the Rules be suspended to permit the moving without notice of the following motion:—

"That in considering Bill (No. 66) intituled 'An Act respecting the Operation of Motor-vehicles and respecting Highway Traffic ' in Committee, the provisions of Standing Order No. 84 be suspended to permit the passing of sections in groups, provided there is no dissent."

Motion moved and agreed to.

Bill (No. 66) intituled "An Act respecting the Operation of Motor-vehicles and respecting Highway Traffic " was committed, reported complete with amendment.

By leave of the House, on the motion of the Hon. R. W. Bonner, the Rules were suspended and the Bill considered as reported, read a third time and passed.

By leave of the House, on the motion of the Hon. R. W. Bonner, seconded by the Hon. W. D. Black, it was Ordered that the Rules be suspended to permit the moving without notice of the following motion:—

"That in considering Bill (No. 24) intituled 'An Act respecting Municipalities' in Committee, the provisions of Standing Order No. 84 be suspended to permit the passing of sections in groups, provided there is no dissent."

Motion moved and agreed to.

Mr. Shirreff presented the Report of the Select Standing Committee on Labour, as follows:---

REPORT.

LEGISLATIVE COMMITTEE ROOM, March 27th, 1957.

MR. SPEAKER:

Your Select Standing Committee on Labour begs leave to report as follows:-

Whereas the Select Standing Committee on Labour was directed by this House to make certain inquiries into problems of welfare, health, and housing as they pertain to the Indian population of British Columbia, giving particular attention to the matter of vocational, technical, and apprenticeship training of our native people:

And whereas your Committee on Labour has met six times during the current Session to consider these matters, and has heard witnesses and testimony concerning these problems from various informed individuals:

Waten 27th, 1937.

And whereas the Committee notes in the 1956 Annual Report of the Provincial Advisory Committee on Indian Affairs, which was tabled in the present Session of the Legislature, that additional health services are continuing to be made available to Indian reserves by arrangement with the Federal Government:

And whereas your Committee notes in this same report that a pilot study is now being undertaken by the Provincial Government of the Okanagan and Lytton Indian Agencies with the view to determining, in conjunction with the Federal Government, as to how increased welfare services can be made available to Indians living on reserves in British Columbia:

Be it therefore Resolved, That the attention of the Federal and Provincial Governments now be directed to increasing facilities and assistance to Indians for vocational, technical, and apprenticeship training, with special emphasis being placed on nursing, business, automotive training, and building construction courses which will in time, it is considered, result in improved conditions on Indian reserves and in the integration of native people into an industrial economy.

Your Committee also recommends that where willingness and aptitude are evident, Indians should be encouraged to take vocational training and every encouragement should be given to Indians to benefit from the same educational facilities which are available to other residents of British Columbia.

The Committee also recommends that notices of vocational training programmes be sent directly to Indian Superintendents of all Indian Agencies in British Columbia and that suitable literature be distributed directly to Indian Band Councils giving information and guidance for would-be applicants for such training. That increased Federal financial assistance be given to those Indians attending vocational training centres who are not in receipt of benefits under Schedule M of the existing Federal-Provincial Agreement whereby those unable to pay their own expenses are given financial assistance for board and travelling expenses.

That vocational training be made more readily available to Indian women and suitable courses for them be included in any new vocational training centres planned in the Province.

That it is the opinion of the Committee that the Federal Government be requested to pursue an effective promotional programme of vocational apprenticeship training amongst the Indians of this Province.

All of which is respectfully submitted.

H. A. SHIRREFF, Chairman.

The report was read and received.

Mr. Speaker presented the Annual Report for 1956 on behalf of the Provincial Library, Provincial Archives, and Central Microfilm Bureau.

Mr. Gibbs asked the president, Pacific Great Eastern Railway, the following questions:---

1. Were the condensed financial statements, 1956, filed with the Legislature by the president the only statements prepared and submitted to the president by the auditors?

2. If so, why were the detailed statements similar to those filed with the Legislature in 1956 not prepared for submission to the president?

3. If not, it is requested that the complete statements as submitted by the auditors be filed with the Legislature.

The Hon. W. A. C. Bennett replied as follows:-

"1. No.

"2. Detailed statements were prepared and submitted to the president."

Mr. Gibbs asked the Hon. the Minister of Health and Welfare the following questions:--

1. In the year 1956, what is the total of all hospital deficits reported to the Minister of Health and Welfare?

2. Have special grants been made to any hospital boards to cover deficits and, if so, state which, and amount?

3. Have any hospital boards advised the Minister of a decline in standards made necessary by the wage-freeze order and, if so, what hospital boards have so advised?

The Hon. E. C. F. Martin replied as follows:-

"1. Not all hospitals have yet filed preliminary financial reports for 1956, and relatively few have forwarded their financial statements after audit; it is, therefore, not possible to provide this information.

" 2. No.

"3. Not aware of any hospital board advising that standards would decline below those approved at the time present control policies instituted."

Mr. Gregory asked the Hon. the Attorney-General the following questions:-

In the case of the recent increase in liquor prices:-

1. What was the increased cost per bottle to the Liquor Control Board resulting from distillers' price increase for each of the following brands: (a) Aristocrat, (b) Crown Royal, (c) B.C. Double Distilled, (d) Seagrams 83, and (e) Royal Calvert?

2. How much was the Liquor Control Board's selling price of each of those brands increased following the distillers' increase?

3. When was the strength of liquor sold in Government liquor stores reduced to 30 under proof and why was it reduced?

4. Did the Liquor Control Board import a quantity of vodka in connection with the visit of a group of Russian dignitaries in 1956 and, if so, on whose instructions was it imported, what was its strength, and at what price was it sold per bottle?

5. Why does the Liquor Control Board not regularly offer vodka for sale to the patrons?

6. Would the Board import vodka if requested by a regular patron?

The Hon. R. W. Bonner replied as follows:-

"1 and 2. Distillers' price increases were absorbed in general revision of selling prices of lines enumerated, except Royal Calvert, which is not listed in this Province.

"3. December 17th, 1942, by the Dominion Government; prior to this date the strength of a number of brands was 30 under proof.

"4. Yes, at the request of the Corporation of the City of New Westminster; strength and selling price in conformity with established practice.

"5. Vodka is not listed by the Liquor Control Board.

"6. Answered by No. 4."

Mr. Strachan asked the Hon. the Provincial Secretary the following questions:-

1. What election expenses were declared by the central committees of (a) the Social Credit Party, (b) the Liberal Party, (c) the Progressive Conservative Party, and (d) the Co-operative Commonwealth Federation, pursuant to section 177 of the "Provincial Elections Act"?

2. What election expenses were declared by the candidates representing (a) the Social Credit Party, (b) the Liberal Party, (c) the Progressive Conservative Party, and (d) the Co-operative Commonwealth Federation in the respective electoral districts, pursuant to section 175 of the "Provincial Elections Act"?

The Hon. W. D. Black replied as follows: ---

"1. Social Credit, \$118,618; C.C.F., \$12,837.29; Liberal, \$35,019.92; Labour Progressive Party, \$2,364.92; Progressive Conservative, \$10,538.68.

Mr. Shelford asked the Hon. the Minister of Highways the following questions:— With respect to the Northern Trans-Provincial Highway:—

1. (a) What mileage of new construction was completed to Department standards in the Fort George District east of Prince George in each of the years 1955 and 1956, and (b) what was the cost in each case per mile?

2. (a) What was the total mileage constructed in the Fort George District west of Prince George in each of the years 1954, 1955, and 1956, and (b) what was the cost in each case per mile, exclusive of paving costs?

3. (a) What mileage was constructed to standard requirements in the Omineca East District in each of the years 1954, 1955, and 1956, and (b) what was the cost in each case per mile, exclusive of paving costs?

4. (a) What mileage was constructed to standard requirements in the Omineca West District in each of the years 1954, 1955, and 1956, and (b) what was the cost in each case per mile, exclusive of paving costs?

5. (a) What mileage was constructed to standard requirements in the Skeena District in each of the years 1954, 1955, and 1956, and (b) what was the cost in each case per mile, exclusive of paving costs?

6. (a) What mileage was constructed to standard requirements in the Prince Rupert District in each of the years 1954, 1955, and 1956, and (b) what was the cost in each case per mile, exclusive of paving costs?

7. How many miles of reconstruction to standard requirements is contemplated for the year 1957 in the following districts: (a) Fort George District east of Prince George, (b) Fort George District west of Prince George, (c) Omineca East, (d) Omineca West, (e) Skeena, and (f) Prince Rupert?

8. How many miles of paving is contemplated for the year 1957 in the following districts: (a) Fort George District east of Prince George, (b) Fort George District west of Prince George, (c) Omineca East, (d) Omineca West, (e) Skeena, and (f) Prince Rupert?

The Hon. P. A. Gaglardi replied as follows:---

"1. Fort George District, east of Prince George: 1955, (a) day-labour, 2 miles, and (b) 19,350; contract, 7.53 miles (clearing only); 1956, (a) day-labour, 7.5 miles, and (b) 16,840; contract, 11.85 miles, and (b) work incomplete.

"2. Fort George District, west of Prince George: 1954, (a) day-labour, 1.4 miles, and (b) \$58,570; 1955, (a) day-labour, 1.4 miles, and (b) \$55,714; contract, 3.01 miles, and (b) \$70,272; 1956, (a) day-labour, 3.5 miles, and (b) \$17,000; contract, 10.04 miles, and (b) work incomplete.

"3. Omineca East District: 1954, (a) day-labour, 7.6 miles, and (b) 17,107; 1955, (a) day-labour, 15 miles, and (b) 13,383; 1956, (a) day-labour, 25.4 miles, and (b) 12,033.

"4. Omineca West District: 1954, (a) day-labour, 7.2 miles, and (b) \$19,166; 1955, (a) day-labour, 14.3 miles, and (b) \$19,580; 1956, (a) day-labour, 18.8 miles and (b) \$39,442.

"5. Skeena (East) District: 1954, (a) day-labour, 12.3 miles, and (b) \$12,000; 1955, (a) day-labour, 2.5 miles, and (b) \$17,200; 1956, (a) day-labour, 15.5 miles, and (b) \$29,606. Skeena (West) District: 1954, (a) day-labour, 1.7 miles, and (b) \$42,353; 1955, (a) day-labour, 0.1 mile, and (b) \$36,000; 1956, (a) day-labour, 6.75 miles, and (b) \$9,967. In 1955 and 1956 rip-rap on Skeena–Kwinitsa section cost a total of \$96,769.

"6. Prince Rupert District: 1954, day-labour, rock fill at Galloway Rapids Bridge and new junction to Port Edwards, total cost, \$60,730; 1955, (a) nil; 1956, (a) nil,

"7. Construction and reconstruction planned, 1957 (contract and day-labour): (a) Fort George District east of Prince George, 10.5 miles; (b) Fort George District west of Prince George, 1.3 miles; (c) Omineca East, 13 miles; (d) Omineca West, 24 miles; (e) Skeena East, 6 miles; Skeena West, 12 miles; (f) Prince Rupert, not surveyed.

"8. Paving planned in 1957: Information not available for public release at this time."

Mr. Gregory asked the Hon. the Minister of Highways the following questions:----In respect to ferries operated by the Department:-

1. How many ferries are operated and where located?

2. Which are free and which apply tolls?

3. In the case of toll ferries in the last year for which figures are available, which operate (a) at a profit, (b) at a loss, and what was the profit or loss in each case?

4. In the case of free ferries, what was the cost of operation at each point in the latest year for which figures are available?

The Hon. P. A. Gaglardi replied as follows:-

"Answers to the attached questions are given in the 1955–56 edition of the Minister of Highways Report.

"1. All ferries and locations are listed with traffic returns on page N 88.

"2. All toll ferries operated by the Department are listed with revenue on page N 95.

"3. Revenue from toll ferries is shown on page N 95; operational costs are shown under Statement of Expenditure in each district; calculated from these figures the Ladner Ferry returned a profit of \$6,496.81. The following ferries operated at the losses shown (these figures do not include depreciation or interest): Agassiz (loss, \$76,115.91), Upper Arrow Lake (loss, \$87,171.94), Denman Island (loss, \$18,892.56), Kelowna (loss, \$36,403.26), Kootenay Lake (loss, \$905.16), North Bend (loss, \$20,220.56).

"4. Operating costs of free ferries were as follows: Upper Nass, \$1,618.62; Kitsault, \$149.81; Gravelle, \$4,355.32; Macalister, \$6,387.70; Soda Creek, \$9,484.04; Herrling Island, \$20.92; Barnston Island, \$31,693.05; Hansard, \$3,956.85; Isle Pierre, \$5,407.27; Black Pool, \$4,374.81; Monte Creek, \$4,075.62; McLure, \$3,978.49; Little Fort, \$4.347.59; Arrow Park, \$19,539.34; Needles, \$21,110.78; Pavilion, \$3,317.43; Big Bar, \$6,330.89; High Bar, \$4,100.75; Nelson, \$45,369.88; Harrop, \$18,648.19; Creston, \$14,344.64; Nick's Island, \$8,584.64; Glade, \$11,445.60; Francois Lake, \$42,678.79; Clayhurst, \$24,553.90; Hudson Hope, \$1,559.10; Twelve Mile, \$22,527.04; Twenty-four Mile, \$18,927.52; Castlegar, \$49,689.98; Renata, \$3,341.30; Sorrento, \$15,611.42; Cedarvale, \$5,913.52; Copper River, \$4,894.63; Kitwanga, \$5.031.56: Usk, \$5,547.96; and Lytton, \$6,309.83.'

Mr. Gibbs asked the president, Pacific Great Eastern Railway, the following questions:---

1. Did the general manager or the auditors of the Pacific Great Eastern Railway prepare statements for the years 1954, 1955, and 1956 showing the expense incurred by the railway from the following causes: (a) Derailments, (b) rock-slides, (c) flooding and washouts, and (d) construction of highways?

2. If so, it is requested that such summaries be filed with the Legislature; if not, it is requested that the summaries be prepared and filed with the Legislature.

The Hon. W. A. C. Bennett replied as follows:-

"1. No; not required under uniform classification of accounts.

"2. Detailed cost record not maintained or available."

Mr. Gregory asked the Hon. the Minister of Mines the following questions:-

1. In connection with the operations of Westcoast Transmission Company, what daily volume of gas has been contracted for export to the American fish interests at the export gate at Sumas and what period does the contract cover?

2. Is the contract price per 1,000 cubic feet to the American interests 22¹/₄ cents, dropping at full flow to 22 cents, and, if not, what is the contract price?

3. What daily volume of gas is contracted to the British Columbia Electric Railway Company for delivery to its Fraser Valley gate and what period does the contract cover?

4. Is the contract price to the British Columbia Electric Railway per 1,000 cubic feet over 30 cents, and, if not, what is the contract price?

5. Will the effect of these divergent prices be that British Columbia Peace River gas will be delivered to the industrial area of Tacoma at prices lower than to the Vancouver, B.C., area?

6. Has the original refusal of the American authorities to approve the first application of the fish authorities resulted in a reduction in price by Westcoast Transmission from 30 cents at the International gate to 22 cents?

7. Has this enforced reduction resulted in a reduction in quoted well-head prices to gas-suppliers by Westcoast Transmission Company to approximately 6 cents per 1,000 cubic feet?

8. From what companies has Westcoast contracted well-head gas in British Columbia and what is the contracted well-head price in each instance?

9. Under well-head contracts now being written by Westcoast Transmission, will Provincial Government revenue, upon full flow of the pipe-line, total as much as \$2,000,000 annually?

10. Is Westcoast Transmission a private carrier and has it the right to refuse its facilities except under contract?

The Hon. W. K. Kiernan replied as follows:-

"1, 2, 3, 4, 5, 6, 7, 8, and 10. Since Westcoast Transmission Company comes under control of Department of Transport, Ottawa, and does not come within jurisdiction of Minister of Mines, particulars as requested in Nos. 1, 2, 3, 4, 5, 6, 7, 8, and 10 are not available.

"9. Crown royalty on natural gas is arrived at by formula as set out in section 81 of the Act; at this time the volume, which is governed by the two factors, market and permissive M.P.R., is an unknown quantity and no accurate answer can be given as to royalty returns until these factors are known."

Mrs. Haggen asked the Hon. the Minister of Highways the following questions:-

1. How long is the proposed route of the Paulson-Blueberry Highway?

2. How many miles, if any, are presently under contract?

3. When is it anticipated that these contracts will be concluded?

4. How many miles, if any, of construction of this highway will be put up for tender in the 1957–58 fiscal year?

5. Is any date anticipated at this time for completion of this highway, including hard surfacing?

The Hon. P. A. Gaglardi replied as follows:---

"1. Christina Creek-Kinnaird, 48.14 miles.

"2. Presently under contract, 18.61 miles.

"3. Project 668, June 30th, 1957; Project 776, October 31st, 1957; and Project 777, October 31st, 1957.

"4. 1957-58 fiscal year, 8.76 miles.

"5. 1959."

Mr. Gibbs asked the Hon. the Premier and Chairman of the British Columbia Toll Highways and Bridges Authority the following questions:—

1. What provision is made for depreciation of bridges purchased or built by the Authority?

2. If provision is made, what is the rate per annum applied to the capital cost of each of the bridges?

3. If provision is not made, why not?

4. Is it the purpose of the Chairman to file with the Legislature at this present Session complete detailed financial statements of the operations of the Authority for the fiscal year ended March 31st, 1956?

The Hon. W. A. C. Bennett replied as follows:---

"1. None.

"2. Nil.

"3. Depreciation charges are only applicable when it is desired to show the effective capital value of an asset. The 'Toll Highways and Bridges Authority Act,' section 18, provides, however, for the recovery of capital charges on toll-bridges with a view to the ultimate removal of toll charges. The financial statements reflect this principle and show only the residual capital outlay after application of operational and subsidy credits. Sinking funds provide for the extinguishment of borrowings.

"4. See Public Accounts."

Mr. Gregory asked the Hon. the Premier the following questions:-

With reference to the answer given on March 8th, 1957, to Question No. 61:---

1. Are the Middle Arm Bridge and the bridge from Lulu Island to Sea Island one and the same?

2. Has the Government of British Columbia been offered any financial assistance by the Federal Government toward the cost of the Lulu Island–Sea Island Bridge?

3. If so, what offer was made, has the offer been accepted, and, if not, why not?

The Hon. W. A. C. Bennett replied as follows:-

"1. Yes.

"2. Yes.

"3. Pursuant to a Provincial Government request for a one-half participation by the Federal Government in the cost of a bridge between Lulu Island and Sea Island, an offer to pay one-third of the cost of the bridge up to a maximum of \$400,000 was received. Claim for financial participation deferred until bridge completed and aggregate cost determined."

Mr. Gibbs asked the president, Pacific Great Eastern Railway, the following questions:-

1. Did the general manager, staff accountant, or the auditors of the Pacific Great Eastern Railway prepare a statement showing the cost for the years 1954, 1955, and 1956 of the following: (a) Rail replacements, (b) locomotive replacements, and (c) car replacements?

2. If so, it is requested that such statements be filed with the Legislature; if not, it is requested that such statements be prepared and filed with the Legislature.

The Hon. W. A. C. Bennett replied as follows:-

"1. Yes.

"2. (a) Rail replacements: 1954, \$1,014,615; 1955, \$830,221; 1956, \$934,870. (b) Locomotive replacements: 1954, \$773,160; 1955, nil; 1956, \$791,290. (c) Car replacements: 1954, 1955, and 1956, nil." Mr. Gibbs asked the president, Pacific Great Eastern Railway, the following question:-

The above rates apply to capital cost, less estimated salvage value. These are the same rates as used by the Canadian National Railways."

2. If so, give details as to the personnel and purpose of each such trip.

3. Were all the passengers carried on these planes during 1956 travelling on Government business?

4. If not, (a) what are the names of these passengers, (b) for what reasons were they travelling, and (c) in case of accident would the Government be liable in any way for these passengers?

5. What is the flight log of the aeroplanes showing destination and passengers from January 1st, 1956, to December 31st, 1956?
