- "(3) The elimination of all fees for coverage under the British Columbia Medical Plan for all British Columbia residents 65 years of age and over; and

"(4) The establishment of intermediate and chronic care under the British Columbia Hospital Insurance Service for all those senior citizens needing those services."

The Hon. L. R. Peterson rose on a point of order, stating that, in his opinion, the subamendment was out of order for the reason that it involved the expenditure of public money without the recommendation of the Crown and thereby offended Standing Orders 66 and 67.

Mr. Speaker, quoting May, 17th edition at page 795, ruled that while the sub-amendment would involve expenditure of public money, it nevertheless was framed in sufficiently abstract terms that, if agreed to, the subamendment would have no operative effect involving public expenditure and therefore, in his opinion, did not offend the provisions of Standing Order 66.

Subamendment ruled to be in order.

The Speaker's ruling was challenged.

On the motion of the Hon. C. M. Shelford, seconded by the Hon. F. X. Richter, it was Ordered—

That this House authorize the Select Standing Committee on Agriculture to assess the impact on British Columbia agriculture of food products which are imported from other countries and from other parts of Canada, with particular reference to those products which are produced in substantial volume in this Province.

The Committee shall have the power to send for persons, papers, and records, and to hear representations from the food and agricultural industry, from Government officials, and from such organizations and individuals as may, in their discretion, appear necessary, and shall report its findings and recommendations to this House.

On the motion of the Hon. L. R. Peterson, seconded by the Hon. W. D. Black, it was Ordered—

That a Special Committee be appointed to study the Report on Expropriation made by the Law Reform Commission of British Columbia and to report to the House the preferences, if any, of the Committee with respect to the recommendations contained therein.

That the Special Committee appointed under Standing Order 68 be instructed to prepare and report, with all convenient speed, a list of members to compose the Special Committee appointed by this resolution.

On the motion of the Hon. D. L. Brothers, seconded by the Hon. Grace Mc-Carthy, it was Ordered—

That this House authorize the Select Standing Committee on Social Welfare and Education to examine and report on the definition of the tenure of office of the members of the teaching staffs in the universities and on procedures followed by the universities relating to this matter, and to make such recommendations as the Committee considers necessary.

 - 6. If so, to whom does one apply for these results?

The Hon. R. G. Williston replied as follows:

- "1. No, as the undertaking of tests and surveys to determine the extent of pollution of water, land, and air is a function of the Director of the Pollution Control Branch.
 - "2. Not applicable.
- "3. The determination of water quality for human consumption is not a function for which the Minister of Lands, Forests, and Water Resources is administratively responsible.
 - "4. Not applicable.
 - "5. Yes.
- "6. The manager of the East Kootenay Pollution Control District at Cranbrook or alternatively to the Director of the Pollution Control Branch."
- 79 Mr. Barrett asked the Hon. the Minister of Highways the following questions:
- 1. Were two engines for a new ferry to Denman Island purchased from Maratime Industries Limited?
 - 2. If the answer to No. 1 is yes, what was the cost of the engines?

The Hon. W. D. Black replied as follows:

"4. \$39,942.74 (amount paid by outside insurance companies to Government for damages to Government vehicles).

107 Mr. Calder asked the Hon. the Minister of Highways the following question:

With reference to Bell-Irving Bridge No. 2 (Project 2233) on the Stewart-Watson Lake Highway, what are the complete engineering specifications of this bridge?

The Hon. W. D. Black replied as follows:

"A 600-foot permanent bridge consisting of two 300-foot through-truss spans of galvanized steel 'Callender Hamilton' construction supported by reinforced-concrete abutments and mid-stream pier, all founded on concrete-filled steel-pipe piles. Initially a single-lane timber deck is being constructed and the final deck will be of reinforced-concrete with a 26-foot roadway width. Overhead clearance is 19 feet. Live-load rating is HS25."

108 Mr. Calder asked the Hon. the Minister of Highways the following question:

With reference to Bell-Irvine Bridge No. 1 on the Stewart–Watson Lake Highway, is it the intention of the Department of Highways to complete construction of the bridge in 1972 and, if so, when does the Department contemplate calling tenders?

The Hon. W. D. Black replied as follows:

"It is not the intention to complete the deck of the Bell-Irving Bridge No. 1 in 1972."

 - 5. Were any new bridges constructed in 1971/72?

The Hon. W. D. Black replied as follows:

Bear River Bridge (No. 1), Mile 1 from Stewart, \$1,200; (no name), Mile 20 from Stewart, \$300; Rufus Bridge, Mile 21 from Stewart, \$200; Surprise Creek Bridge, Mile 34 from Stewart, \$300; Blue River Bridge (119), Mile 20.1 from Watson Lake, Tanzeilla Bridge (174), Mile 166.7 from Watson Lake, Willow River Bridge (156), Mile 241.7 from Watson Lake, Twin Lakes Bridge (160), Mile 86.1 from Watson Lake, total cost for these bridges, \$7,642.15.
 - "3. Yes.
- "4.
