“4. Answered by answer to No. 3.”

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders beg leave to report as follows:—

That the preamble of Bill (No. 55) intituled “An Act to incorporate Shaughnessy Municipality” has been proved, and the Bill ordered to be reported with amendments.

Your Committee beg further to report that on the hearing of the said Bill before your Committee, the Corporation of Point Grey appeared by counsel and opposed the said Bill.

A compromise was then agreed upon by the petitioners to this Bill and the representatives of the Corporation of Point Grey.

Each of the parties was then heard as to the conditions on which this compromise should be effected, and, after deliberation, your Committee decided that the arrangement between them should be carried out in accordance with the amendments attached to the Bill, although the matters of the said arrangement may not have been within the purview of the notice and advertisement for the said Bill.

Your Committee also call attention that the Bill as now reported was, with the consent of the Corporation of Point Grey, amended so as to eliminate the provisions thereof providing for a separate municipality; and to provide for the repayment to the land-owners in Shaughnessy proper of a portion of the moneys expended by them in works within the portion of the municipality sought to be incorporated; and to provide for the readjustment of the wards in the Municipality of Point Grey and the future levy of taxes therein, and providing for a residential district in Shaughnessy proper; although such powers were not mentioned in the said notices and advertisement.

All of which is respectfully submitted.

Mr. *Williams* moved in amendment, seconded by Mr. *Place*, that all the words after the fifth recital be struck out, and the following inserted in lieu thereof:—

"And whereas a very large portion of the population of Canada are wage-earners:

"And whereas heretofore there has not been any representation of Labour in the Canadian Senate:

"And whereas it is advisable that Labour should be given some representation in the said Canadian Senate:



“Therefore, be it Resolved, That His Honour the Lieutenant-Governor be requested to forward through the proper channels to the Dominion Government the prayer of this House, that the number of Senators for the Province of British Columbia be increased to six, and that the additional appointments be given to accredited representatives of Labour, so as to give Labour some representation and British Columbia an equal standing in the Upper House with other western Provinces.”
